

Part-time repo man fails to pay for vehicle, jailed

A young Athens man who, along with his family, worked as a repossession agent for a Loudon car dealership was jailed after he purchased a vehicle from the dealership then allegedly neglected to pay for it despite the business owner's multiple attempts to contact him.

Brandon Scott Jenkins, 19, County Road 249, Athens was charged with hindering secured creditors.

According to an affidavit filed by Investigator Jeff Russell, LCSO-CID; on June 3rd, 2010, Brandon Jenkins purchased a 1996 Chevrolet Blazer from C&J Auto Sales, Mulberry Street, Loudon under a payment plan for






