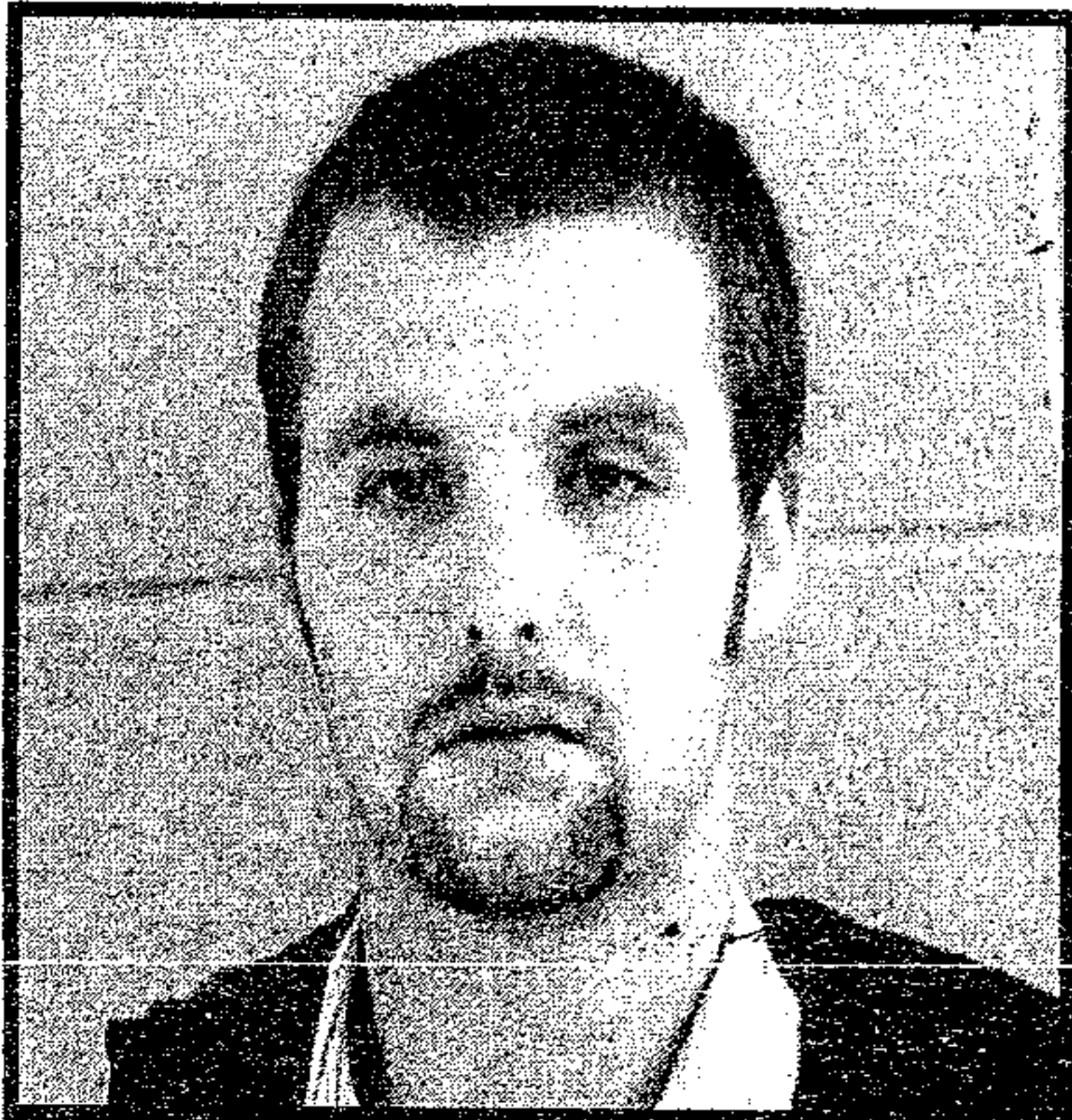

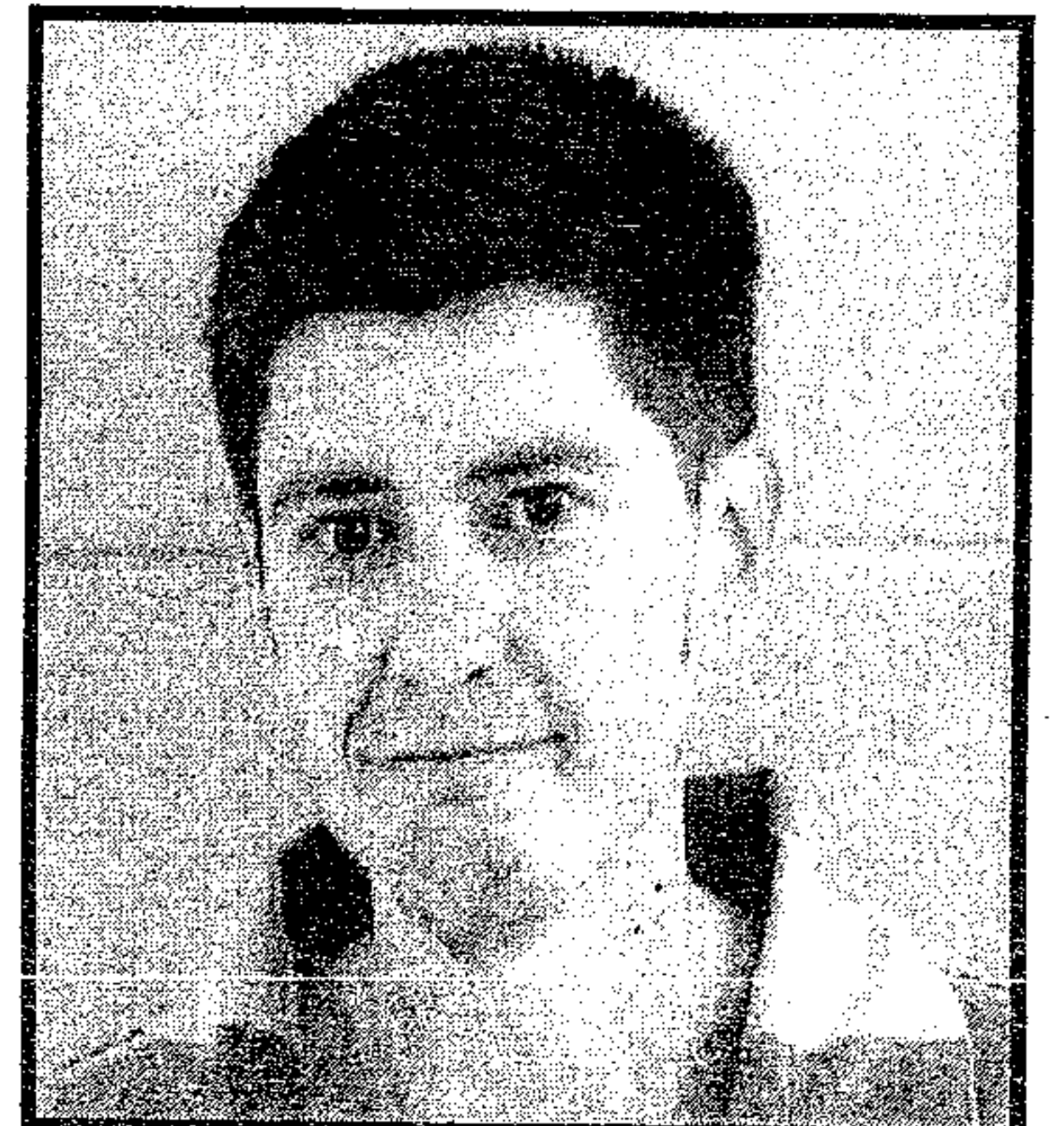
## Man charged after cashing nearly \$10K in stolen checks

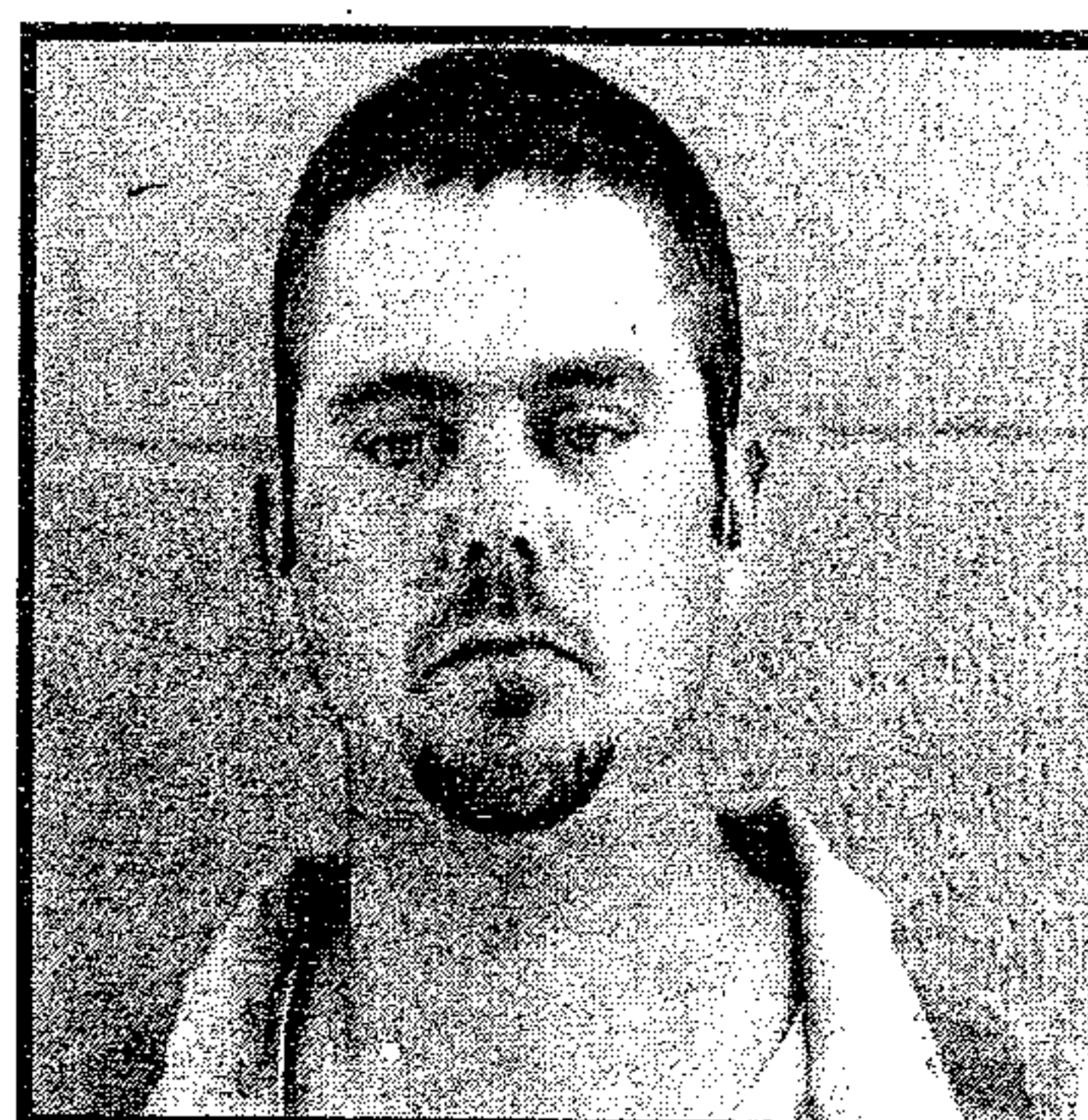

### All Pilled Up

City was charged with public intoxication.

Tommy Heath Richardson, 32, Dodwood Valley Road, Kingston was charged with public intoxication.

According to reports, Wednesday, at approximately 4:39 PM, Laura Richardson was at the Department of Human Services on Pine Top Street in Lenoir City for around three hours attempting to fill out paperwork. According to DHS employees, Richardson passed out several times on the tabletop. She had her 7 year old son with her and was unable to care for him properly.

The Department of Children's Services employees took over care of the child and placed him with a grandparent.

Sgt. Lynette Ladd, LCPD arrived on the scene and made contact with Ms. Richardson, reporting Richardson staggered and stumbled, dropped her cell phone and had difficulty holding her eyes open. Richardson admitted to taking klonopin and oxycodone.

The law woman noted there were pill bottles in Richardson's purse. One of the bottles was for 120 oxycodone 10 mg. that had been filled two days before on Monday, but there was only two pills left in the bottle. Another bottle that had also been filled on Monday for 60 flexiril 10 mg. had only 33 pills left in it and a third bottle filled the same day for 60 clonazepam 1 mg. had only 34 pills left in it.

Ms. Richardson was deemed a danger to herself and others and was taken into custody.

In the meantime, Officer Kevin Condee, LCPD also re-

sponded to the Department of Children's Services and made contact with Tommy Richardson standing in the parking lot. Mr. Richardson was unsteady on his feet, had slurred speech and had a hard time staying awake.

The officer reported Mr. Richardson was in possession of narcotic pills, which he had apparently been snorting through a straw which was also in his possession.

Mr. Richardson was considered a danger to himself and others and was placed under arrest.

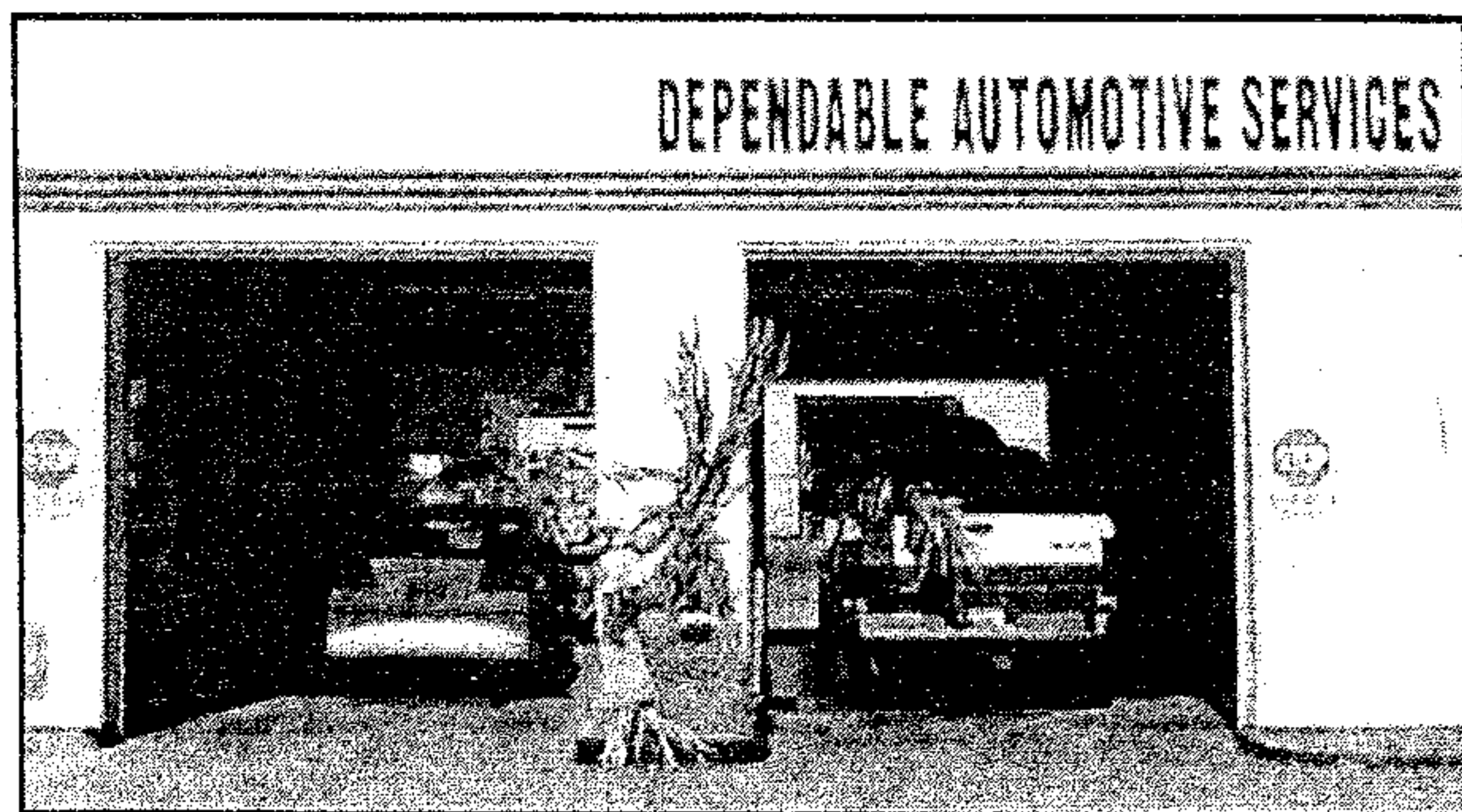

## Meeting

Commercial Fishing Advisory Committee (CFAC) that was established recently by the Tennessee General Assembly. The volunteer CFAC committee is entirely comprised of nine members of the commercial fishing community and made several recommendations to the TWRA at its initial meeting in August 2011.

Among the CFAC recommendations were eliminating the size limit restriction on big catfish and the opening of six new waters to commercial fishing. These waters are Norris, Watts Bar, upper Old Hickory, Cordell Hull, Melton Hill, and Tellico reservoirs.

The TWRA responded that the big catfish regulation also affects sport fishing. Therefore, the agency recommends seeking more input from the sport fishing public. "We will consider this recommendation by the CFAC in our discussion at our annual fisheries biologists meeting in May 2012," said Bobby Wilson, TWRA Fisheries Division Chief.

Commercial fishermen are only seeking the harvest of paddlefish in five of the six new waters CFAC recommends opening. Paddlefish are sought after primarily for

its roe which is sold as caviar in this country and abroad.

"The TWRA is mandated by the commercial fishing law (T.C.A. Section 70-2-301) to develop a plan to study the opening of new waters for the possibility of paddlefish harvest, said Wilson. Until the plan is developed and studies are completed to determine status of the paddlefish population as well as the potential effects on sport fish, the agency does not recommend the opening of any new waters at this time."

The TWRC previously asked TWRA staff to explore the options concerning the possibility of establishing a fishing guide license. TWRA staff presented three options concerning a possible fishing guide license during its September meeting held in Jackson. At this month's meeting, the TWRC elected to postpone taking any action at this meeting. However, the guide license will be addressed after a comprehensive review of all user groups in tailwaters and streams.

The 2012 sport fish regulations were approved by the commission. The regulations feature only slight changes from last year concerning size and creel limit at selected locations.

Among the changes for 2012:

- Increase the creel limit on largemouth bass at Gibson County Lake in West Tennessee from 5 to 10 fish per day.

- At Lake LaJoie and Lake Placid at Chickasaw State Park in West Tennessee, replace the current 15-inch minimum length limit on largemouth bass with a 14-18 inch slot limit and a creel limit of 10 fish per day, only 1 of which can be over 18 inches.

- At Ft. Patrick Henry Reservoir in East Tennessee, place an 18-inch minimum size limit on walleye with a creel limit of 5 fish per day.

- Redefine the Boone Reservoir boundary in East Tennessee for fish regulation purposes on the South Fork Holston River Arm from the Highway 11E Bridge to the Highway 37 Bridge at Bluff City.

In other business at the meeting, a proclamation was approved to establish the McGlothin Largen WMA. Gerald Largen has donated approximately 112 acres to TWRA and the WMA name is a combination of the family names of his parents. The McGlothins and Largens have owned the property for almost 50 years. The property is located in Roane County along the main channel of the Tennessee River downstream from Kingston. An official

dedication ceremony will be announced for a later date.

TWRA staff presented information about a recent public meeting in Kingsport and on written comments received about duck hunting near residences in the Fort Patrick Henry Reservoir area. The TWRA recommended increasing more public awareness, mainly through the erection of signs, reminding hunters of the allowed area and distances for hunting.

The TWRC also heard a presentation from Don McKenzie, a representative of the National Bobwhite Conservation Initiative, on the restoration of the bobwhite quail population. Jon Jordon, a local trout angler, made a presentation on the trout management on the Caney Fork River.

The TWRC approved an amendment to a proclamation to authorize the taking of wild hogs in conjunction with deer seasons at three additional Wildlife Management Areas. The three WMAs are Alpine Mountain, Skinner Mountain and Standing Stone State Forest, all located in TWRA Region III.

The TWRC final meeting of the calendar year will be held Dec. 8-9. The December meeting will also be held at TWRA Region II Ray Bell Building in Nashville.

recent cyber crime trends and new twists to previously-existing cyber scams:

**Fraudster Double-Dipping**

Most of us are familiar with fraud involving automobiles being sold over the Internet. A fraudster will post a nonexistent vehicle for sale on the Internet,

typically a luxury or sports car. The details of the vehicle, including photos and description, are typically lifted from legitimate websites. An interested buyer, hopeful for a bargain, responds and is told that the vehicle is located overseas. The fraudster then instructs the victim to send a deposit via wire transfer to initiate the shipping process.

In a new twist to this scam, the fraudster advised there was an issue with the initial wire transfer and sent the victim a cashier's check. The victim was instructed to cash the check and resend a second wire to a different account. Unaware that the check was counterfeit, the victim followed through as instructed by the fraudster. This resulted in the victim get-


ting duped two times and the fraudster accomplishing his "double-dipping" strategy.

Victims should be vigilant when an Internet transaction involves wire transfers and cashier's checks. Most individuals believe that cashier's checks are as good as cash and they clear the day after they are deposited. However, banks are

required to make the funds "available" in the individual's account within 48 hours, which can be days before the cashier's check clears or bounces. Once the bank makes the funds available, the counterfeit check circulates to incorrect Federal Reserve locations. Generally, the average cashier's check takes up



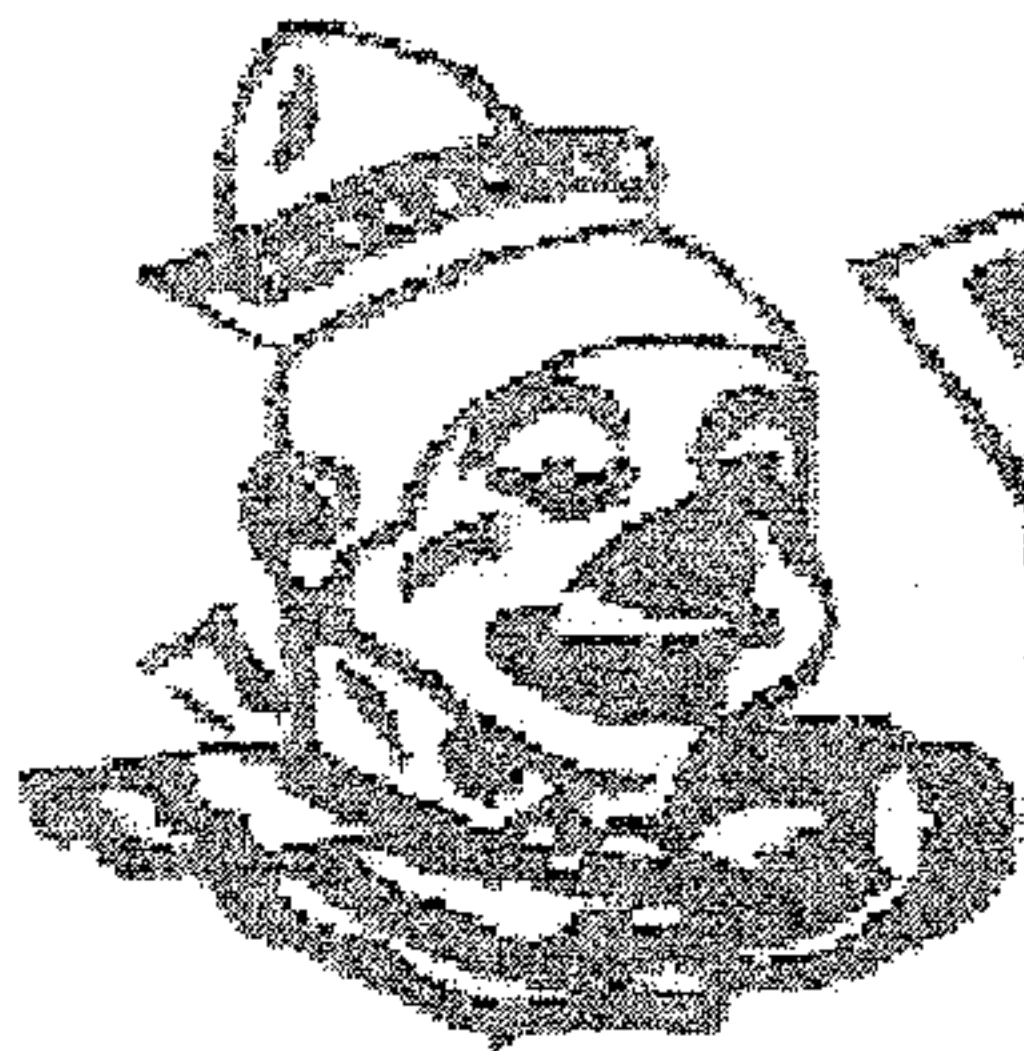

to two weeks to clear, not two days. The bottom line: fraudsters understand the U.S. banking system process and capitalize on victims' misconceptions of the term "available funds."

husband let him in and Buckner went straight to the back bedroom where the woman was laying down. The woman said Buckner came into her room and began tapping her on the head, waking her, then started demanding all of her medications. She advised she gave Buckner all the medication she had and while doing so, two white males wearing hoodies with bandanas around their faces entered the home and began demanding all of her husband's medication. One of the men had a pistol in his hand and the other had a wrench.

The woman further reported she heard a scuffle in the living room and when she

went to check on her husband, she told him to give the men his medication.

The man advised he was struck in the left eye with either a fist or the wrench during the altercation by one of the masked assailants.

When the men got the medicine and \$30 in cash from the woman they started to tie up her husband with a white cord, but apparently changed their minds and took the home phones instead. The victims stated as the men were leaving, one man stood at the door and held them at gun point until their vehicle was started outside and then all the men fled the scene.

There were several medications, \$30 cash, two Panasonic cordless phones, a .22 caliber automatic pistol, and one pack of L&M Light cigarettes taken from the scene.

Investigator Jason R. Smith, LCSO-CID; responded to the scene and began an investigation which resulted in Buckner being charged.

Andrew Lester Buckner, 21, Wilson Drive, Knoxville was charged with aggravated robbery.

According to that affidavit; on October 14th, 2011, Loudon County Dispatch received a call from a Giles Road, Lenoir City woman who advised she and her husband had just been robbed by three men at their residence. She identified one of the men as Andrew Buckner.

Detective Jason Smith responded and

spoke and spoke to the victims. The woman said Andrew Buckner threatened her with a hammer and took money and medication from the home. She stated one of the two other men, who were unidentified, struck her husband in the eye and the detective noted the victim had visible injuries. One of the men also had a handgun.

Andrew Buckner was interviewed at the Loudon County Justice Center and after having been read his rights he stated he was at the residence during the incident. Investigator Smith served the warrant and made the arrest Monday, at the Loudon County Jail.

No other charges had been filed at the time of the report.

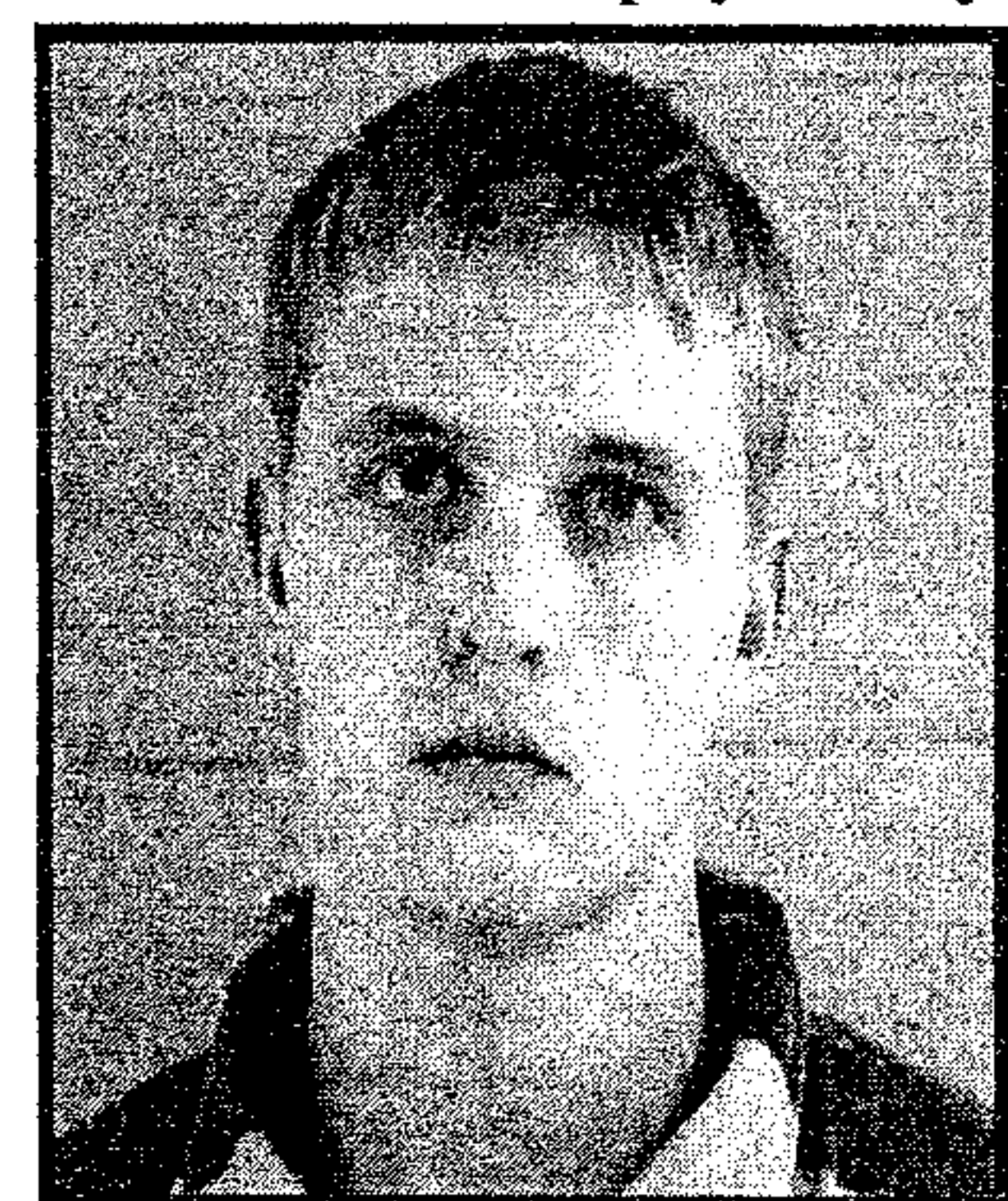
**Man charged with assailing pregnant woman**

Jarod William Julies, 20, Kelly Lane, Lenoir City was charged with domestic assault.

According to records, Officer Kevin Condee, LCPD responded to McGhee Square Apartments Saturday on a report of a domestic assault and upon arrival, spoke with Jarod William Julies, who advised he had been in an argument with his girlfriend who is five months pregnant and lives with him.
