The alleged victim involved in an altercation at the Grizzly Pig has now been charged with two counts of aggravated assault in the attack.

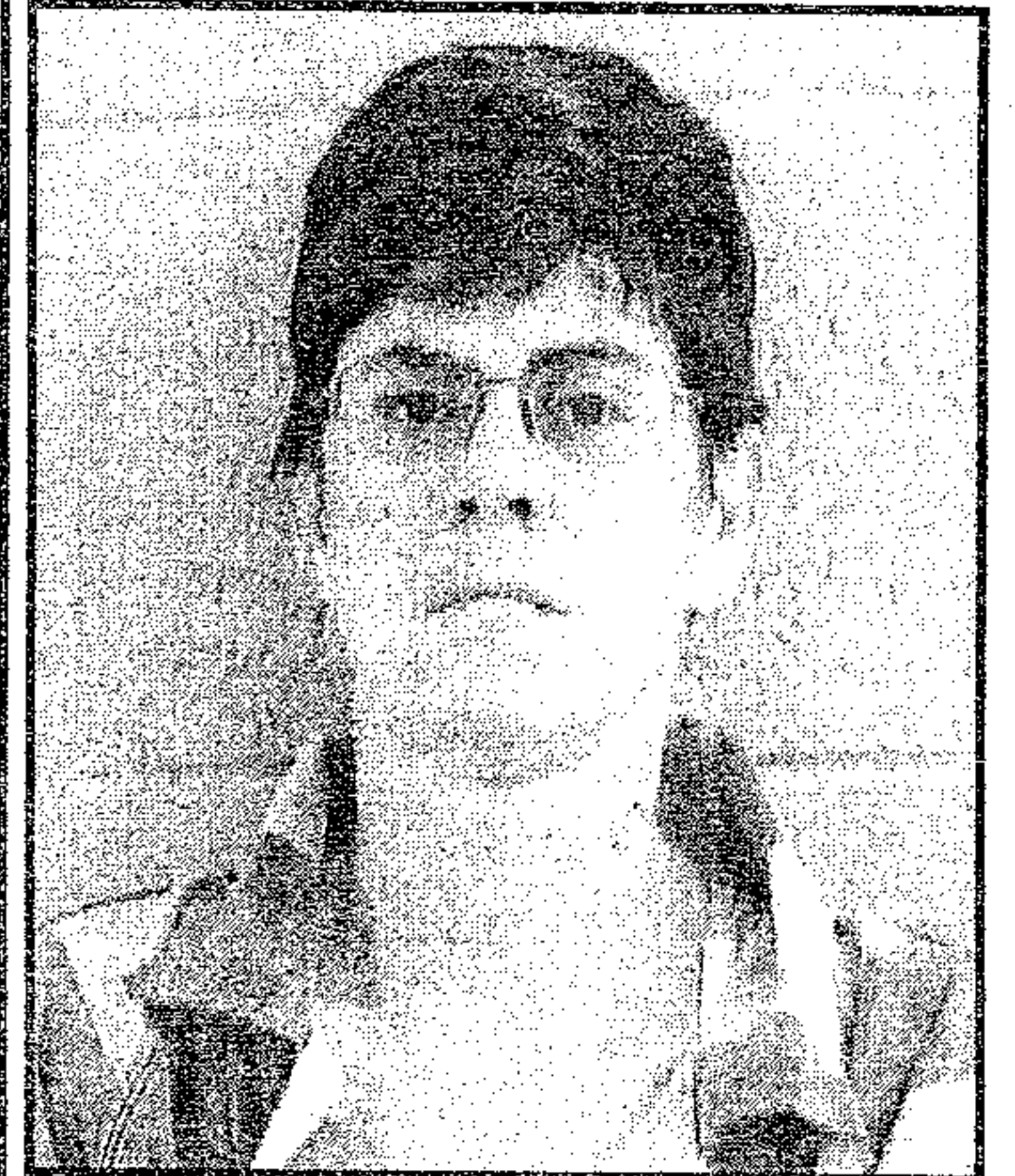
According to a warrant, filed by the female victim, she was entering the Grizzly Pig in Philadelphia when Julia Coker, the victim's sister in law, was walking out of the store. Julie Coker began to call the victim derogatory names and then she attacked the victim. Coker grabbed the victim by the hair of the head and began to repeatedly hit the victim in the face and head. The victim alleges she was also hit with something metal and attacked by Coker's sister. This attack lasted for about 5 minutes

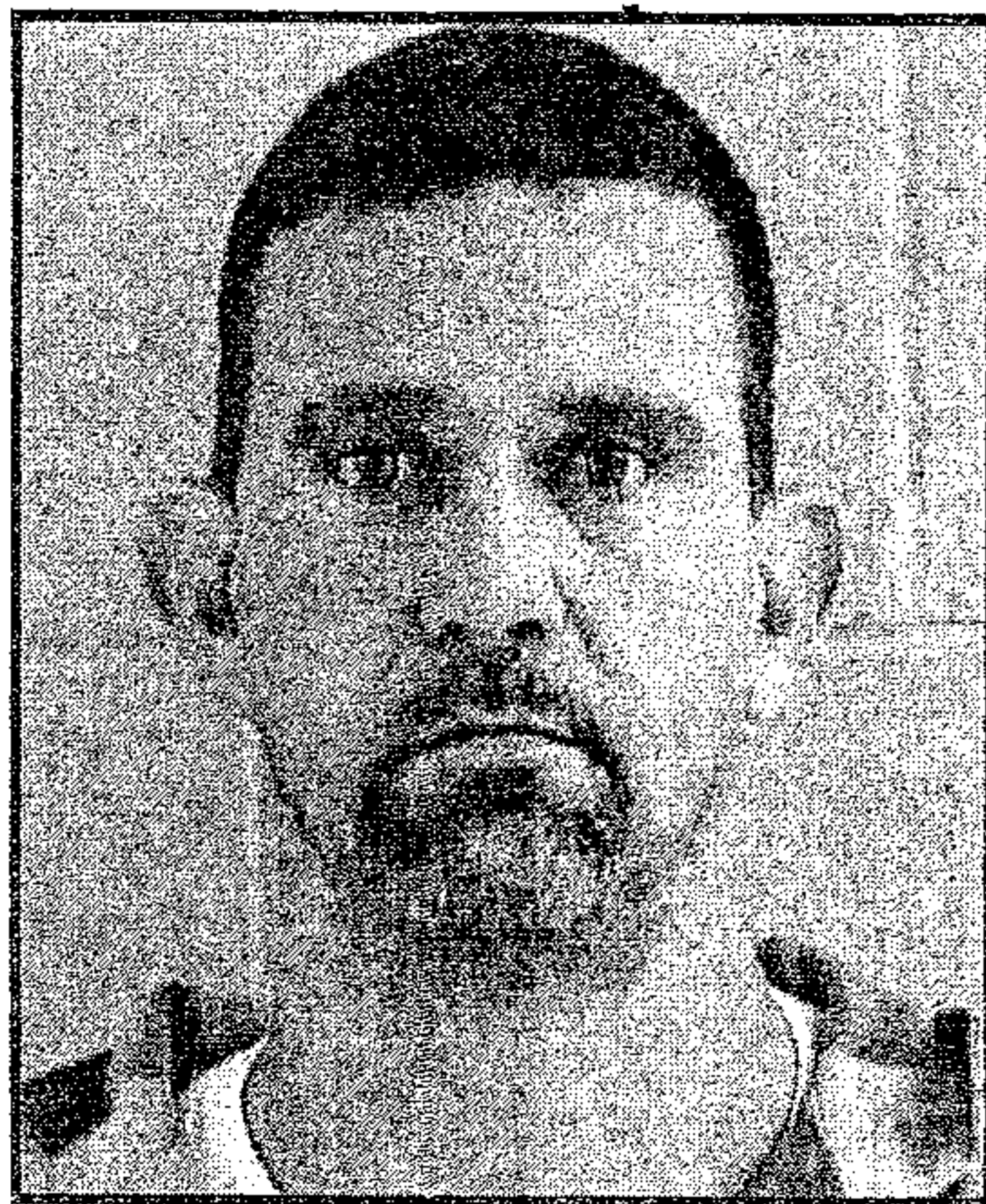

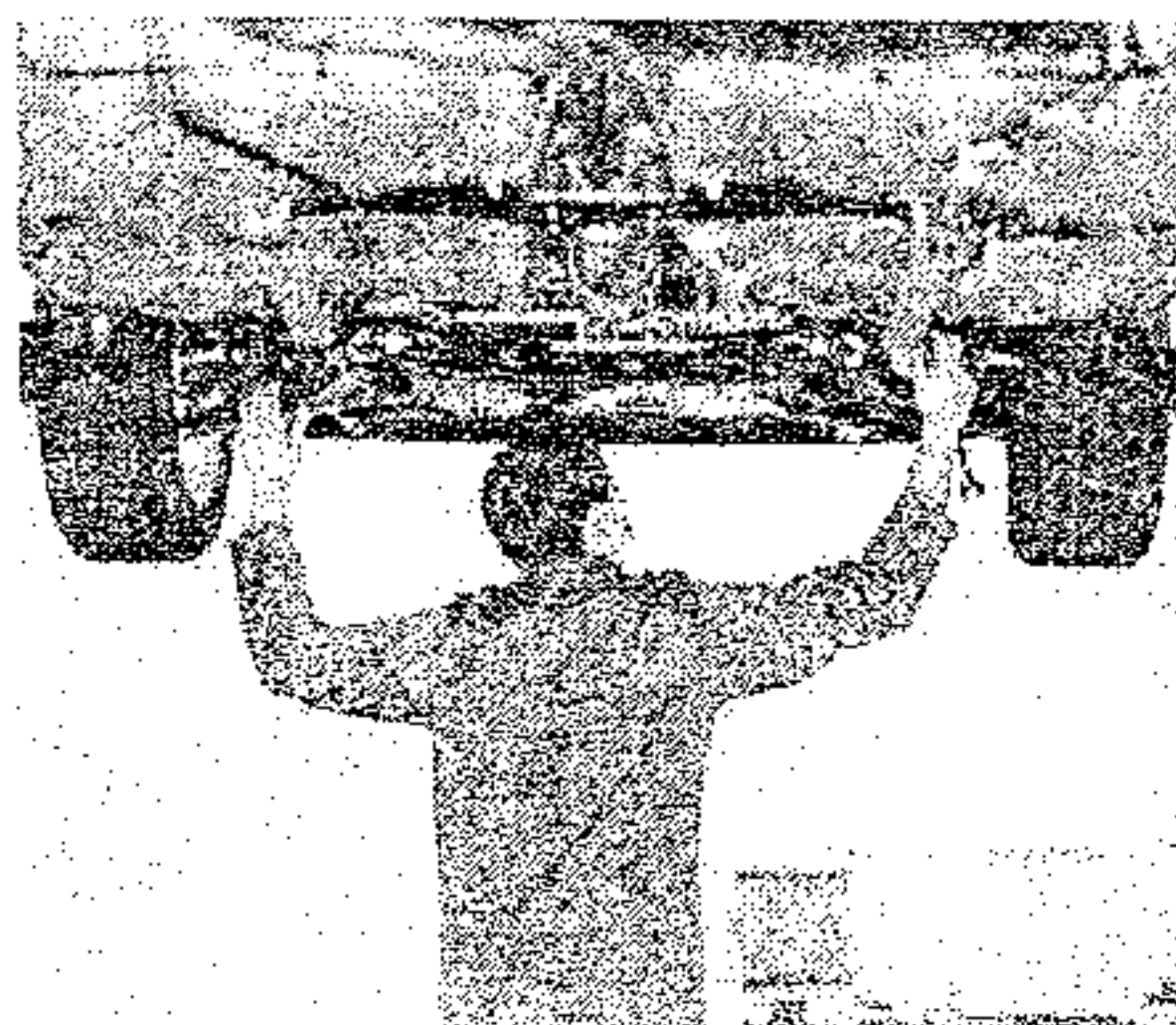

Tracy Lee Robinson, 37, of Fairview Road, Tellico Plains, was charged with promotion of methamphet-

amine manufacture and theft under \$500.

According to the report, Officer Kevin Condee, LCPD responded to Walgreen's

Pharmacy on a report of a suspicious person that was attempting to steal lithium batteries. Upon arrival the officer made contact with Tracy Lee

Robinson, who was a passenger in a vehicle driven by Jeffrey Daniel Holloway.

According to Walgreen's management, Robinson had been inside the store and was observed opening a package of lithium batteries. Before Robinson was able to conceal the batteries, she was confronted by store personnel and surrendered the batteries, saying she was going to buy them. Robinson was then observed taking pseudoephedrine product purchase cards from the shelf and walking toward the pharmacy counter. After apparently seeing the pharmacy was closed, Robinson walked out of the store but did not pay for the batteries she claimed she was going to purchase.

Holloway gave consent for a search of his vehicle and officers located a Walgreen's pseudo purchase card in the front console area. Additional evidence collected from Walgreen's personnel included the damaged pack of batteries and two additional pseudo purchase cards that Robinson had apparently taken from the shelf and left inside the store.

Holloway had waited in his vehicle and did not enter the store. Holloway gave a voluntary statement, which indicated he knew Robinson had intended to purchase pseudo and that she had planned to steal lithium batteries. Holloway also stated he knew Robinson was a meth or "ice" user. Officer Kevin Condee, LCPD made the arrest.

**Ag Enhancement Deadline Nears for Livestock Projects**

NASHVILLE — Dec. 1 is the deadline for eligible farmers to submit reimbursement requests for livestock projects approved through the Tennessee Agricultural Enhancement Program.

"It's important that farmers who are approved for livestock equipment or feed storage funding finish their projects and submit a completed reimbursement request as soon as possible," TAEP administrator Justin Bryant said. "This helps us to process their claim quicker and allows us to better utilize funds for other farm projects."

The Tennessee Agricultural Enhancement Program is a cost share initiative administered by the Tennessee Department of Agriculture to help farmers make long-term, strategic investments to increase profitability. Funding for TAEP was fully restored this year in Gov. Bill Haslam's budget, which was supported by the Tennessee General Assembly.

In August, nearly 2,300 Livestock Equipment and Feed Storage projects totaling \$8.8 million were approved for funding through the farm cost share program. Eligible livestock projects include the purchase of headgates, squeeze chutes, hay rings and other livestock handling or feed storage equipment.

Complete and accurate reimbursement requests will be processed on a first come, first serve basis. Producers should allow up to 10 weeks for processing and the minimum reimbursement request is \$250 per project.

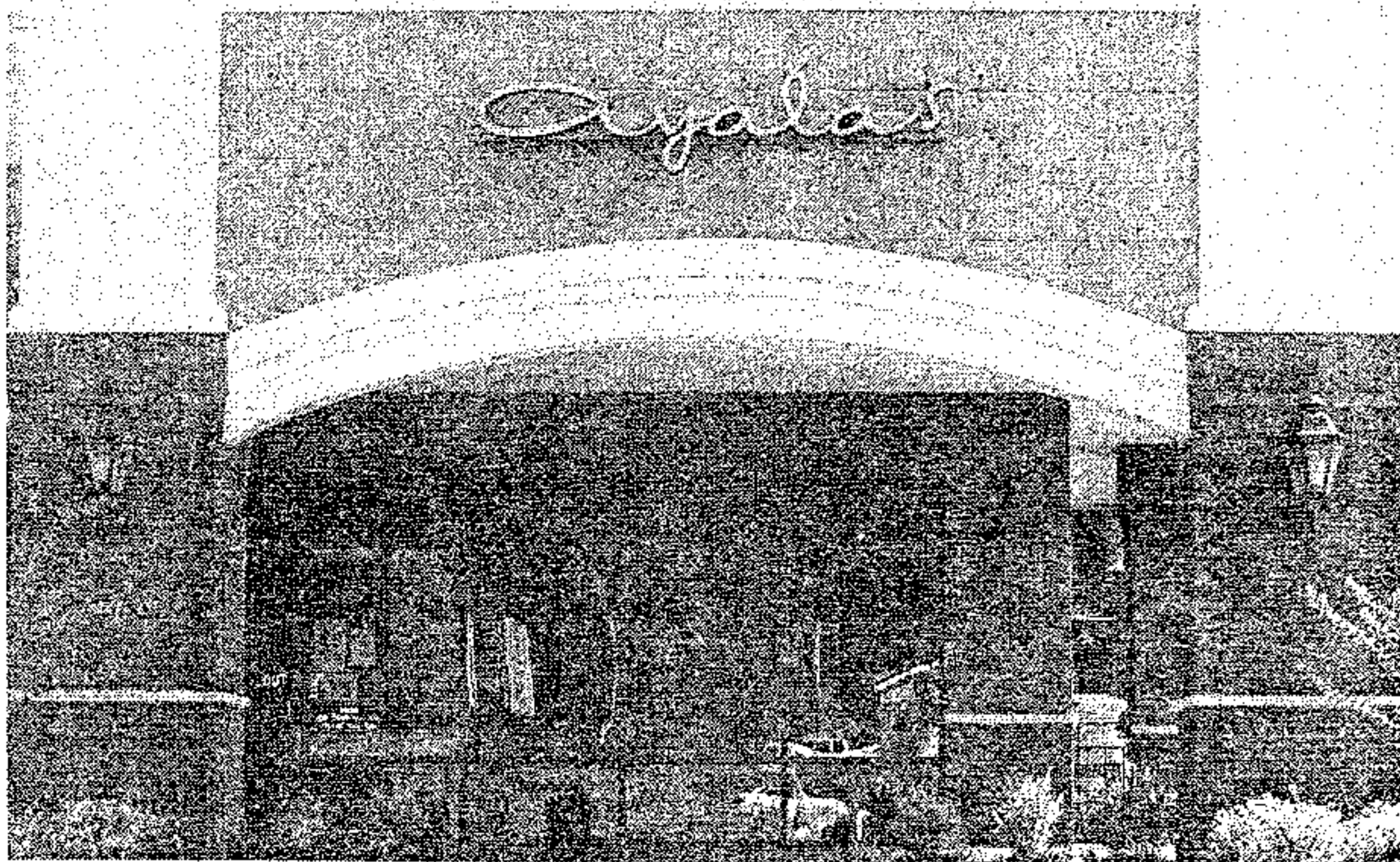

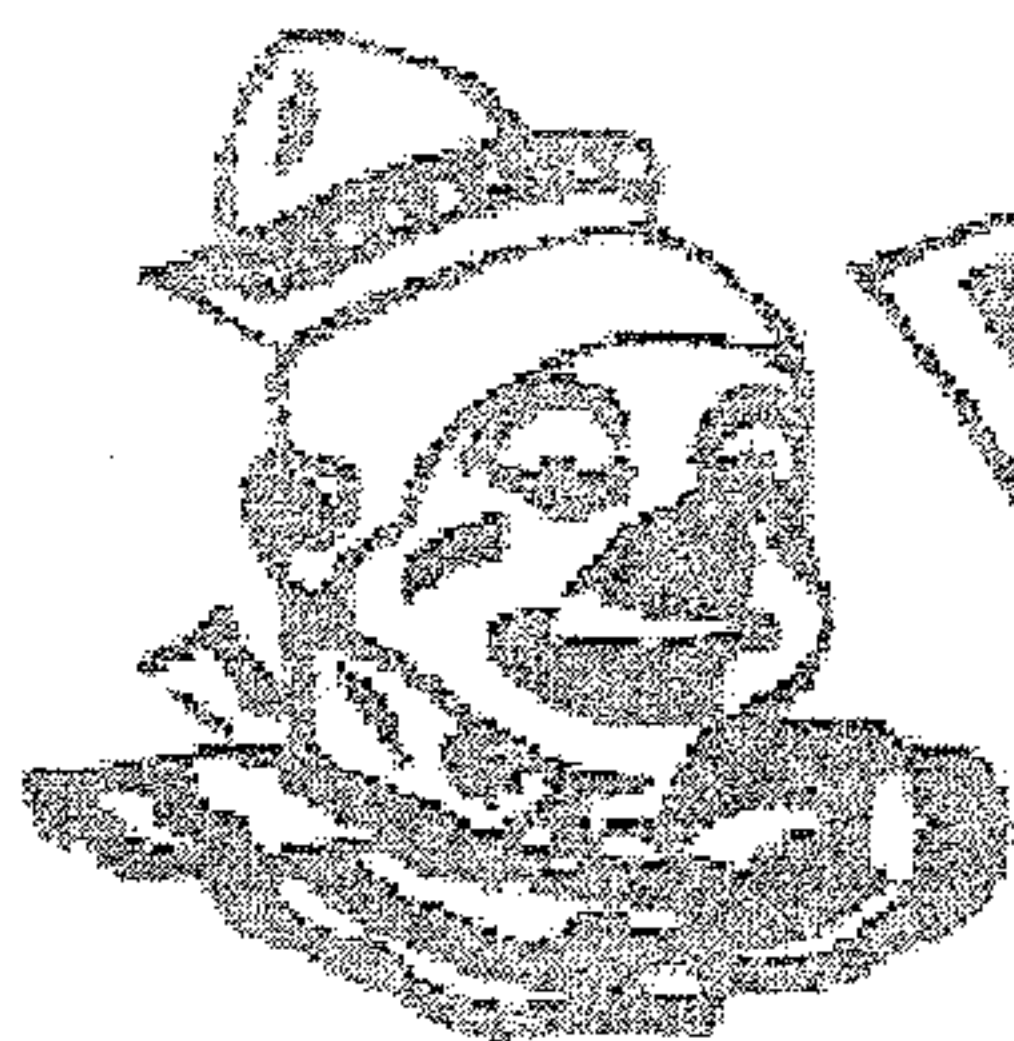
