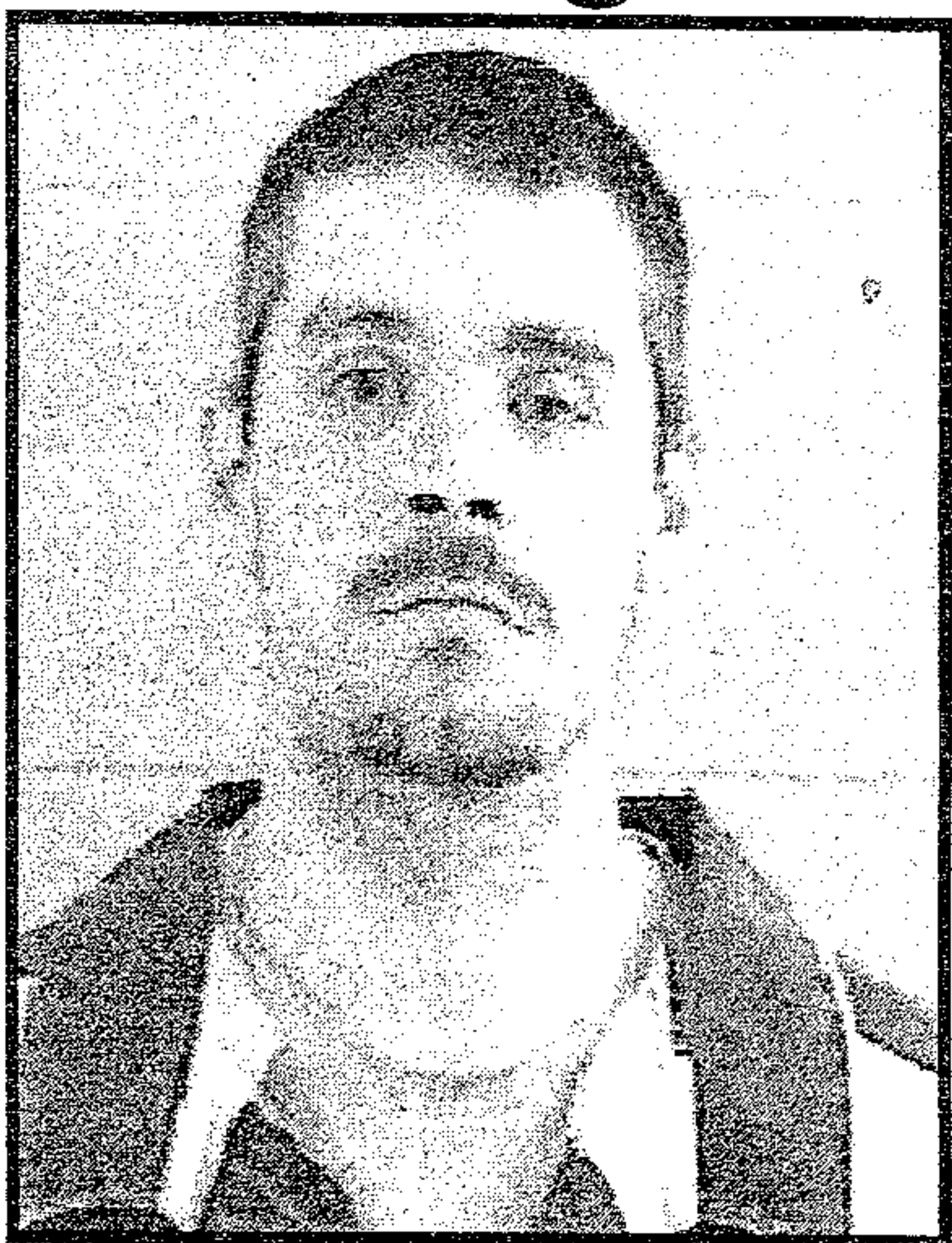
## Speeding lands couple in jail on various charges

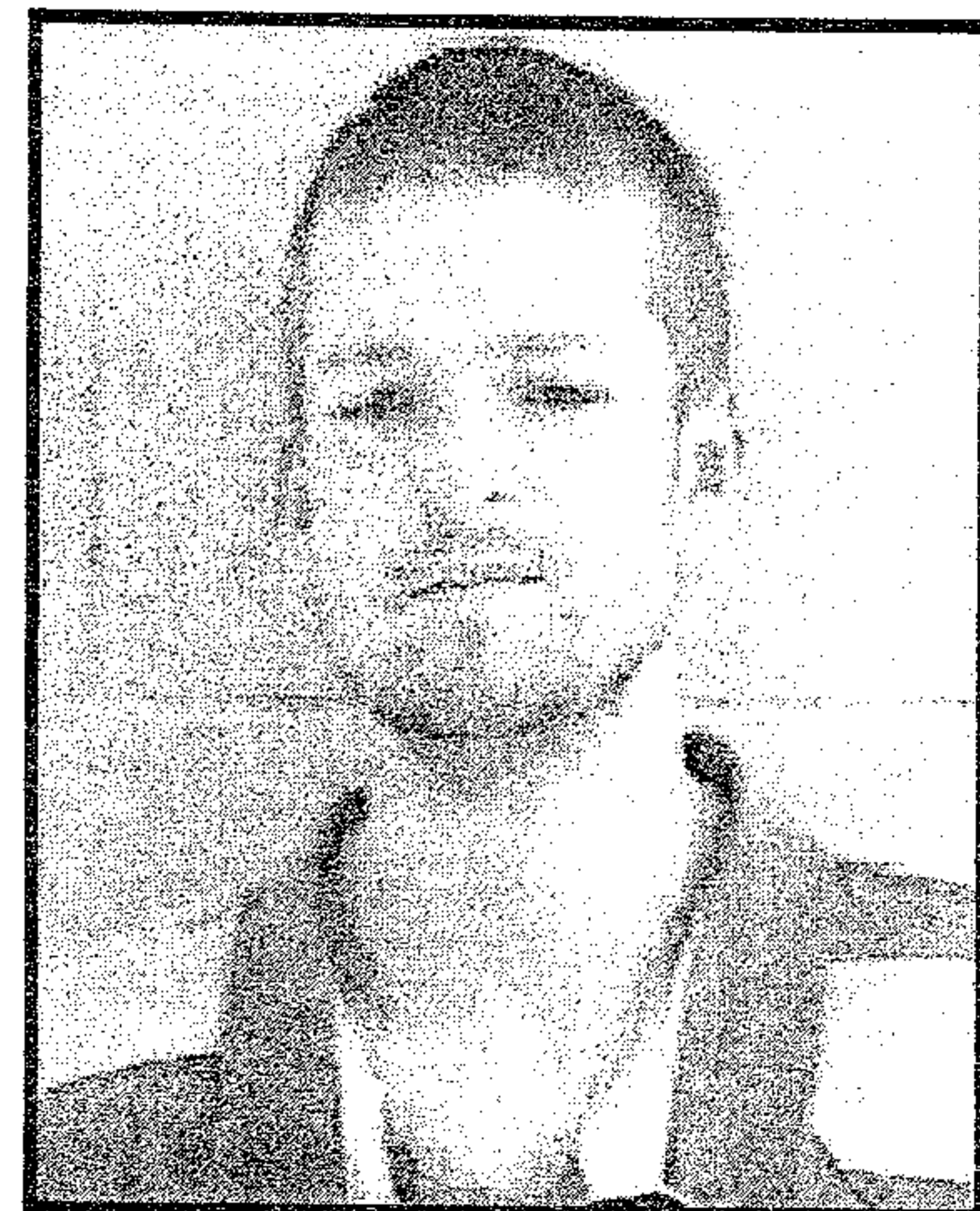

**Reid**

The report states, Monday, at approximately 9:00 PM, Deputy Mckinzie Williams, LCSO was told by two different female inmates that some of the girls in the block were snorting pills. Deputy Williams asked one of them which one had brought them in, and she stated "the one that came in a little while ago."

Deputy Williams knew it was inmate Sierra Reid because she was the only female that had come into the jail during that time to serve 29 days for violation of probation.

Upon entering B-Block, inmate Sierra Reid was laying on her bed and when asked for inmate Reid to come to the door, she hesitated and Deputy Williams heard her unsnap her jumpsuit. Deputy Williams went over to her bed, and waited for her to put her shoes on.

Inmate Reid was escorted out of B-Block into the shower room for a strip search. Inmate Reid was bent over and Deputy Williams noticed she was pulling something out of her vaginal area to her mouth region. Deputy Williams then asked inmate Reid to turn around and open her mouth. As she did, Deputy Williams pulled out a plastic baggie containing 4 different types of pills and tobacco.

The pills were believed to be hydrocodone, seroquel, alprazolam and morphine.

**Hyatt**

also of Clyde Street, was charged with possession of drug paraphernalia and possession of schedule II.

According to affidavits; on Saturday, at approximately 1:53 AM, Officer Jamie Pistole, LPD observed a gray Geo Metro that appeared to be traveling at a high rate of

speed on Ferry Street toward Ward Avenue. The vehicle then turned onto Park Street and then onto Steekee.

As the officer was trying to catch the vehicle it began going faster down Steekee Road. He turned on his emergency equipment and it continued down Steekee Road. The Geo then turned onto Grove Street off Steekee and then turned onto Clyde Street and pulled into a driveway.

Officer Pistole approached the driver and began patting him down. While patting down the driver, Steven Hyatt for weapons the officer smelled a strong odor of an alcoholic beverage emitting from his person.

Mr. Hyatt stated his license were suspended and that's why he was running. Officer Pistole placed him into custody at that time and put him in his patrol car.

At the same time Officer Pistole approached the driver of the car Officer Dennis Akins, LPD approached the passenger. Officer Akins observed the female, Miranda Hyatt drop a straw and two adderall pills on the ground under the front of the patrol car. At that time she was placed into custody for possession of schedule II adderall and possession of drug paraphernalia due to the straw having white

residue on the inside of it.

Both Hyatt's were transported to the Loudon County jail.

**Rogers**

Scott William Rogers, 25, Davis Ferry Road, Loudon was charged Thursday, with illegal possession of schedule IV klonopin.

According to records, Investigator Shane Ezell, LCSO-ND observed a white Mazda pickup traveling south on Spring Street in Philadelphia. He paced the vehicle at 30 mph in a 20 mph zone. Investigator Ezell stopped the pickup on Pond Creek Road and identified the driver as Scott W. Rogers.

Mr. Rogers appeared to be nervous and agitated. The lawman asked him if he had anything illegal in his truck and he said no, just his medication. Mr. Rogers advised he was prescribed methadone and retrieved a black zippered bag from behind the passenger seat.

Mr. Rogers gave the investigator verbal consent to search the vehicle. Three small round green pills, believed to be klonopin, were found inside one of the methadone bottles, in the black zippered bag.

Mr. Rogers advised the pills were his, but could not produce a prescription. He was taken into custody. Investigator Marty Stanley, LCSO-ND was also on scene.

**Littleton**

possession of legend drug soma without a prescription, and possession of drug paraphernalia.

According to records, Deputy Rondel M. Branam, LCSO was dispatched to Anchor Drive Saturday on a suspicious person call. While enroute, dispatch advised the person left the residence and started walking door to door in the neighborhood asking for someone by the name of Hightower. He was de-

scribed as a white male, with a white ball cap, black jacket, blue jeans and white tennis shoes and the complainant stated the man appeared to be intoxicated.

Deputy Branam came in contact with a man matching the description and identified him as Derek J. Littleton. Mr. Littleton had thick, slurred speech, his pupils were constricted to that of a pinpoint and he was very unsteady on his feet.

During a pat down of Littleton for officer safety, the deputy felt pill bottles in both of his front pants pockets. One bottle was labeled for endocet, which it contained, and the other was labeled for 1mg. alprazolam. It had 24 alprazolam, 13 white round pills with the markings 241ov believed to be 350 mg. soma, and 2 white oval pills believed to be lortab.

Mr. Littleton didn't have prescriptions for the soma, nor the lortab and was placed under arrest. A search of his shoes revealed a metal spoon with a white powdery residue and black burn marks on the bottom, both traits being consistent with that of melting a substance down for il-

legal use.

After Littleton was transported to jail, Deputy Branam searched the back seat of his patrol unit and found three more metal spoons that had the same type of markings as the other one.

**Ortiz**

Jose Gil Ortiz, 23, Mulberry Street, Loudon was charged with DUI 1st offense and driving without a license.

According to records, Saturday, around 1:21 AM, Deputy Billy Hall, LCSO observed a 1998 Pontiac Grand Am traveling at a high rate of speed on Interstate 75. The officer checked the vehicle on radar at 100 mph in a 65 mph zone and stopped it at the 77 mile marker.

The driver, identified as Jose Ortiz had glassy eyes and appeared confused. Deputy Hall spoke to him in Spanish and he still appeared confused.

When Mr. Ortiz exited his vehicle he was unsteady on his feet and used the car for balance. Ortiz had a strong odor of an alcoholic beverage on his person and performed poorly on sobriety tasks.

Ortiz could not produce a Tennessee drivers license and was placed under arrest.
