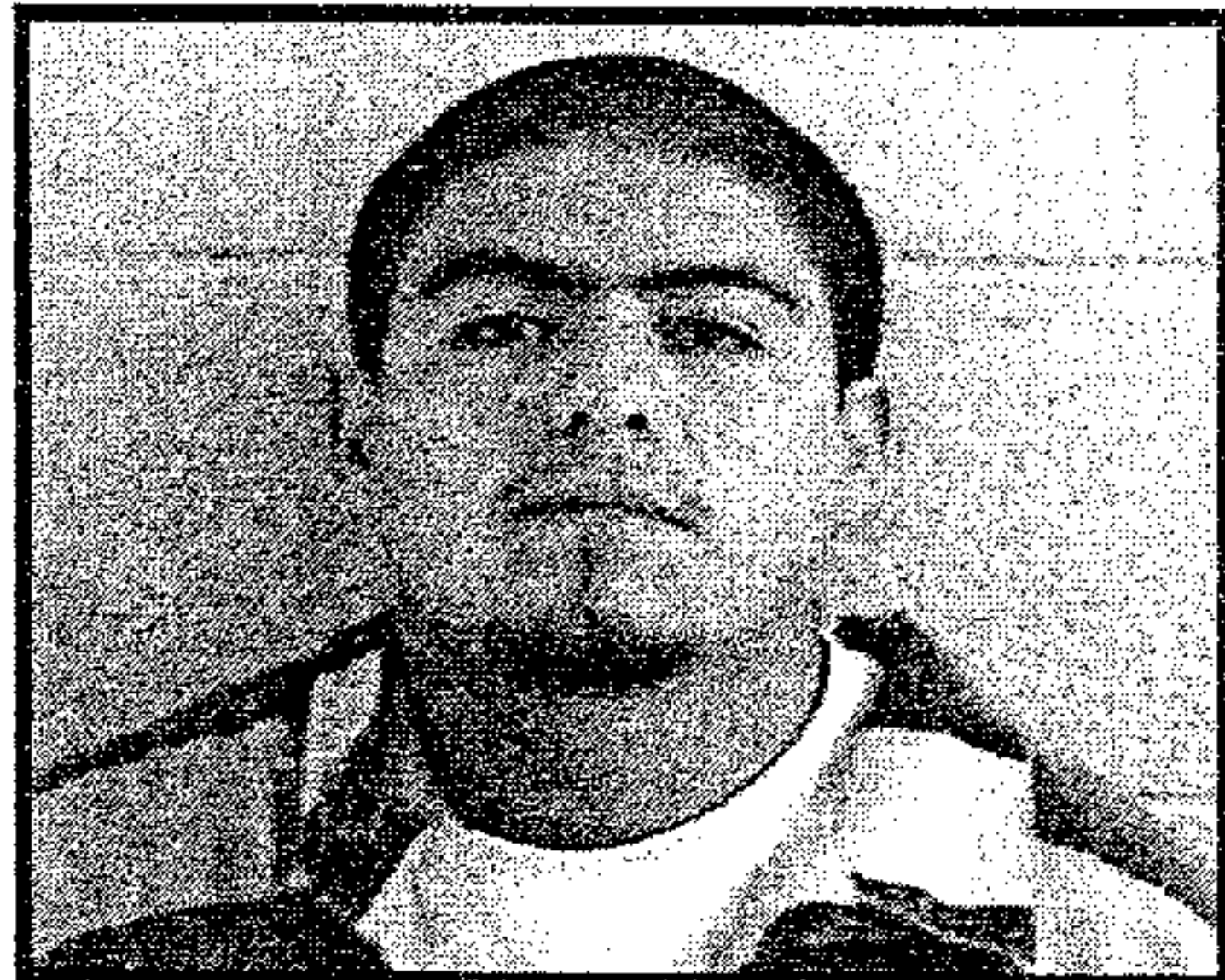

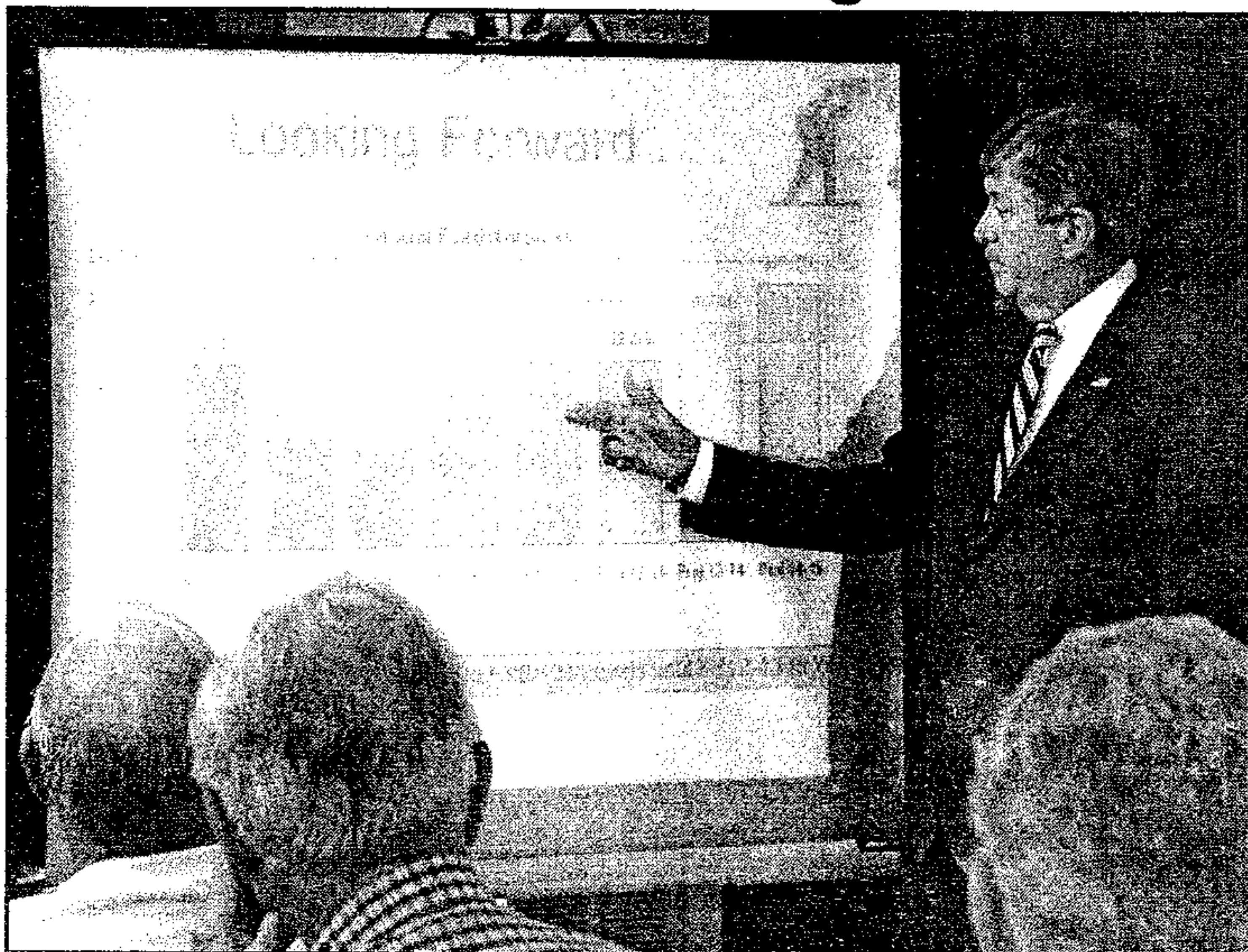


As I continue to grow

Jose Esteban Badillo-Garcia, 20, Sitzler Road, Philadelphia was charged with leaving the scene of an accident by Deputy Chuck Butler, LCSO and fleeing and evading by Agent Brendan DeBoer, 9th DTF.

According to reports,

Agent DeBoer was in the area of Natalie Boulevard in Loudon when the Loudon City Police Department received a call of a hit and run

accident and one of the vehicles, a black Ford F-150 attempting to leave the scene.

Agent DeBoer observed the vehicle fail to stop for a stop sign on Natalie Boulevard at Highway 11. He initiated his emergency equipment to try to stop the vehicle, but the vehicle failed to yield to the blue lights, increasing it's speed to approximately 50 mph.

The truck traveled approximately one mile before turning into a driveway at 11943 Highway 11. The driver was identified as Badillo-Garcia and he was taken into custody.

The victim is seeking restitution for the damage she sustained in the crash.

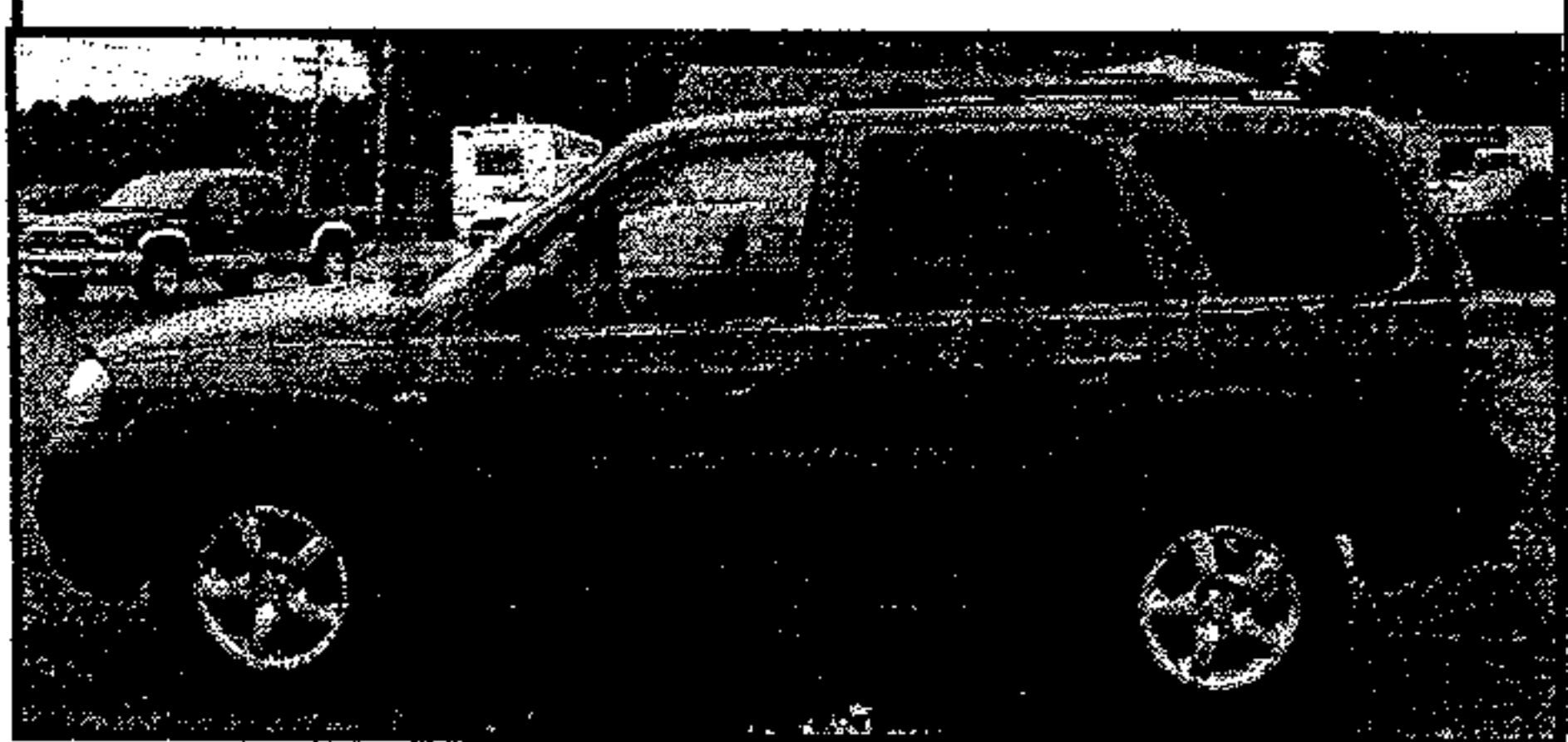

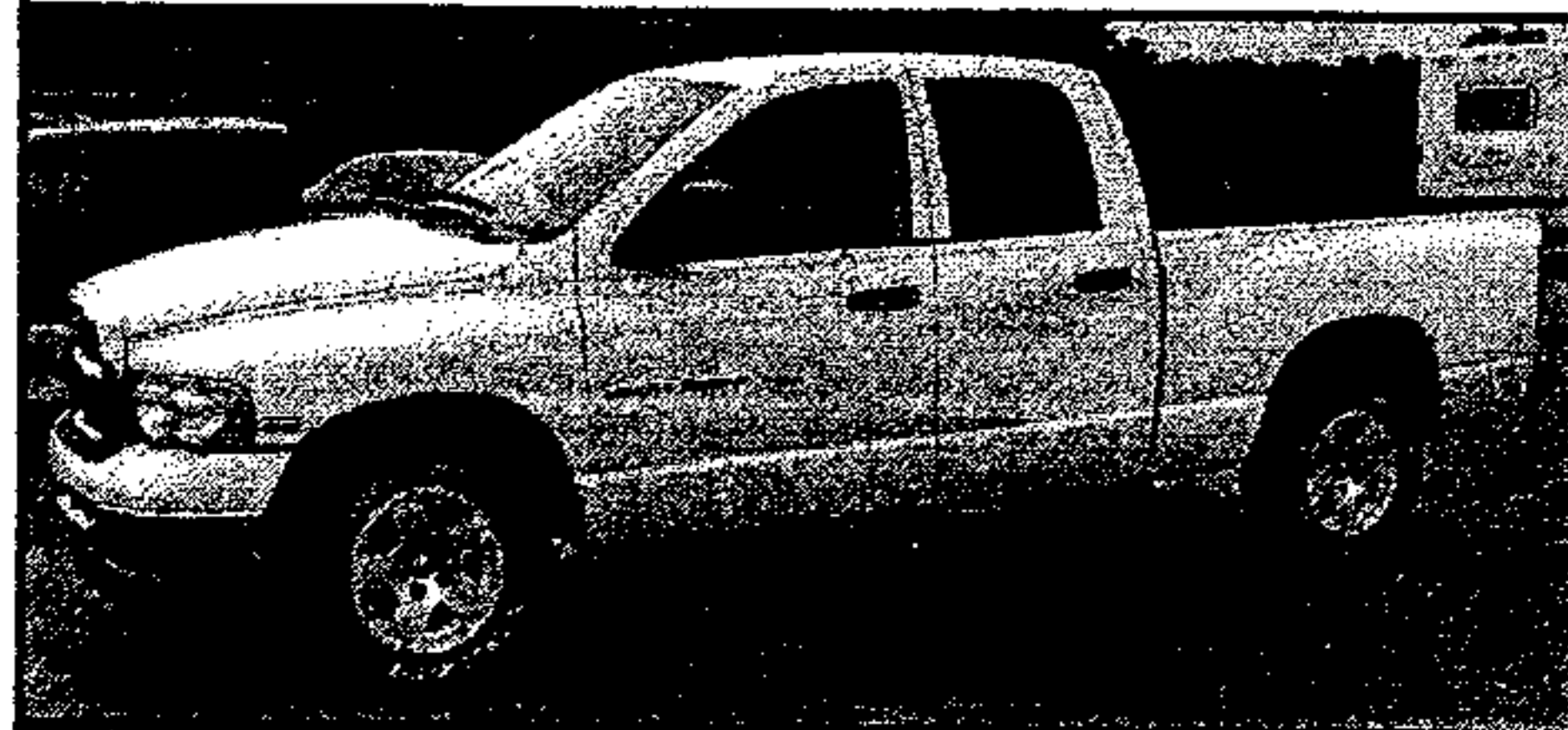

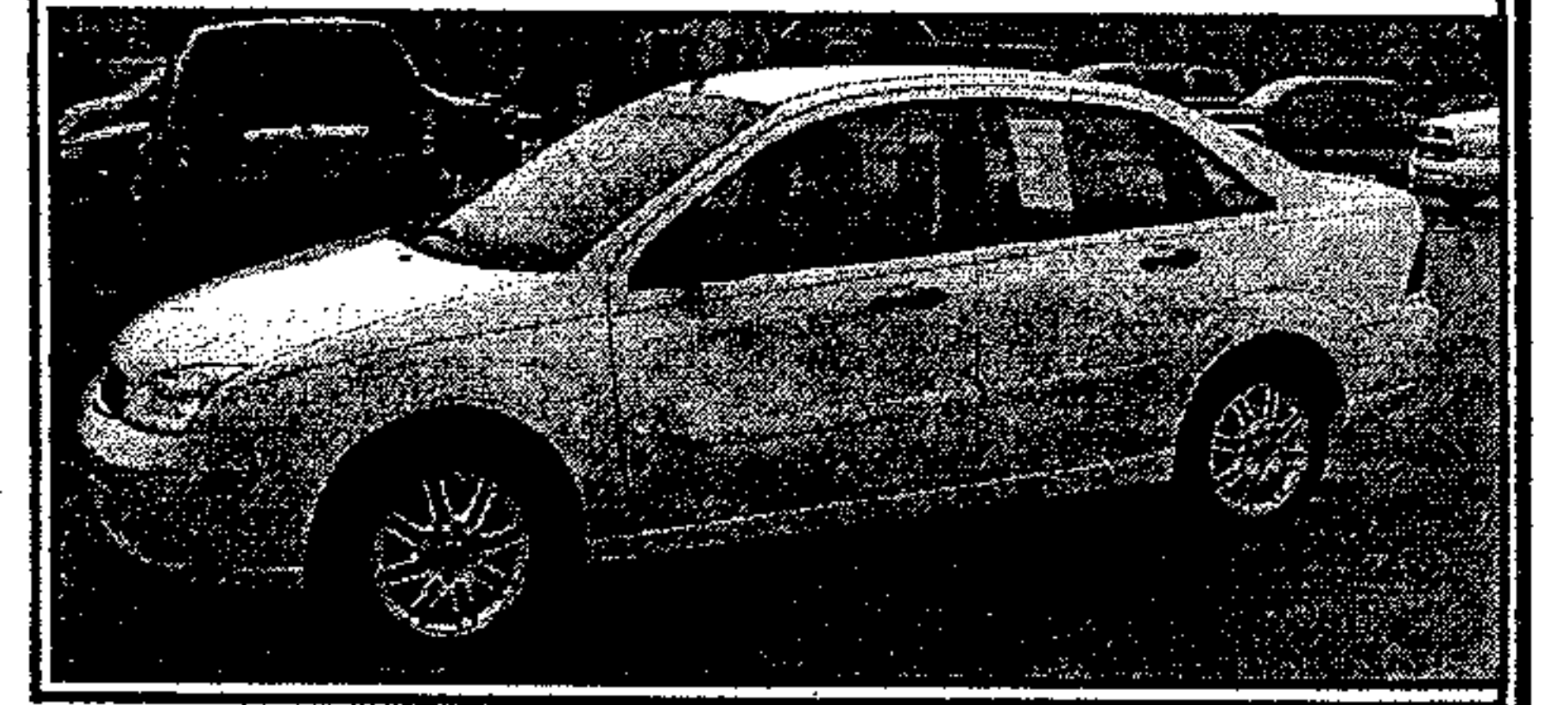

a "Known Christian" to talk very rude and short to her over a thirty cent discrepancy regarding a grocery bill. Unfortunately she had just seen this same person in our own church the day before. Is this the kind of attitudes that makes people want to know our Savior?

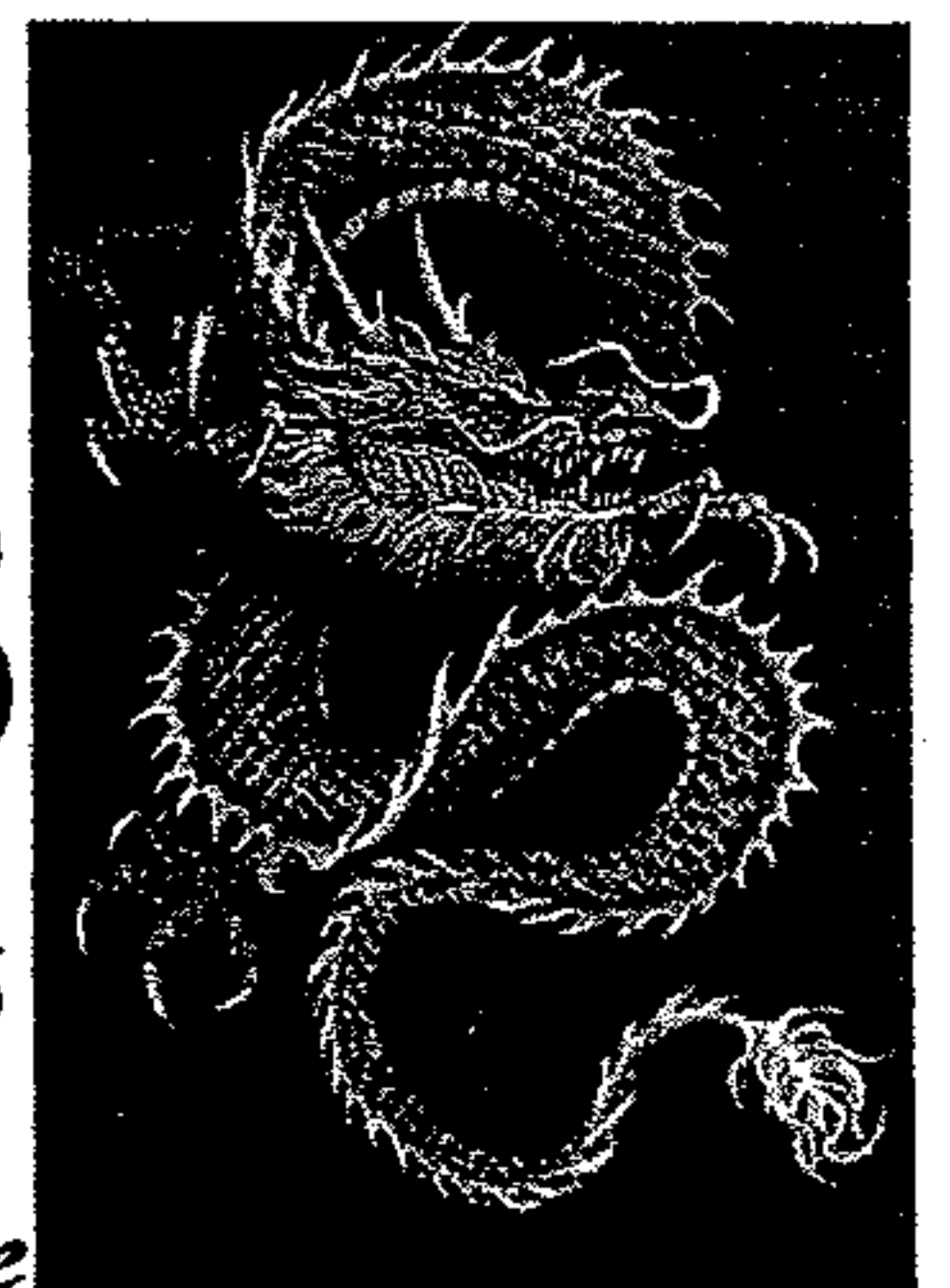

them both under the influence of intoxicants. The pair reportedly had just filled one prescription each a day earlier and should have had just under 120 pills between them, however officers found only 21 pills remained out of both scripts combined.

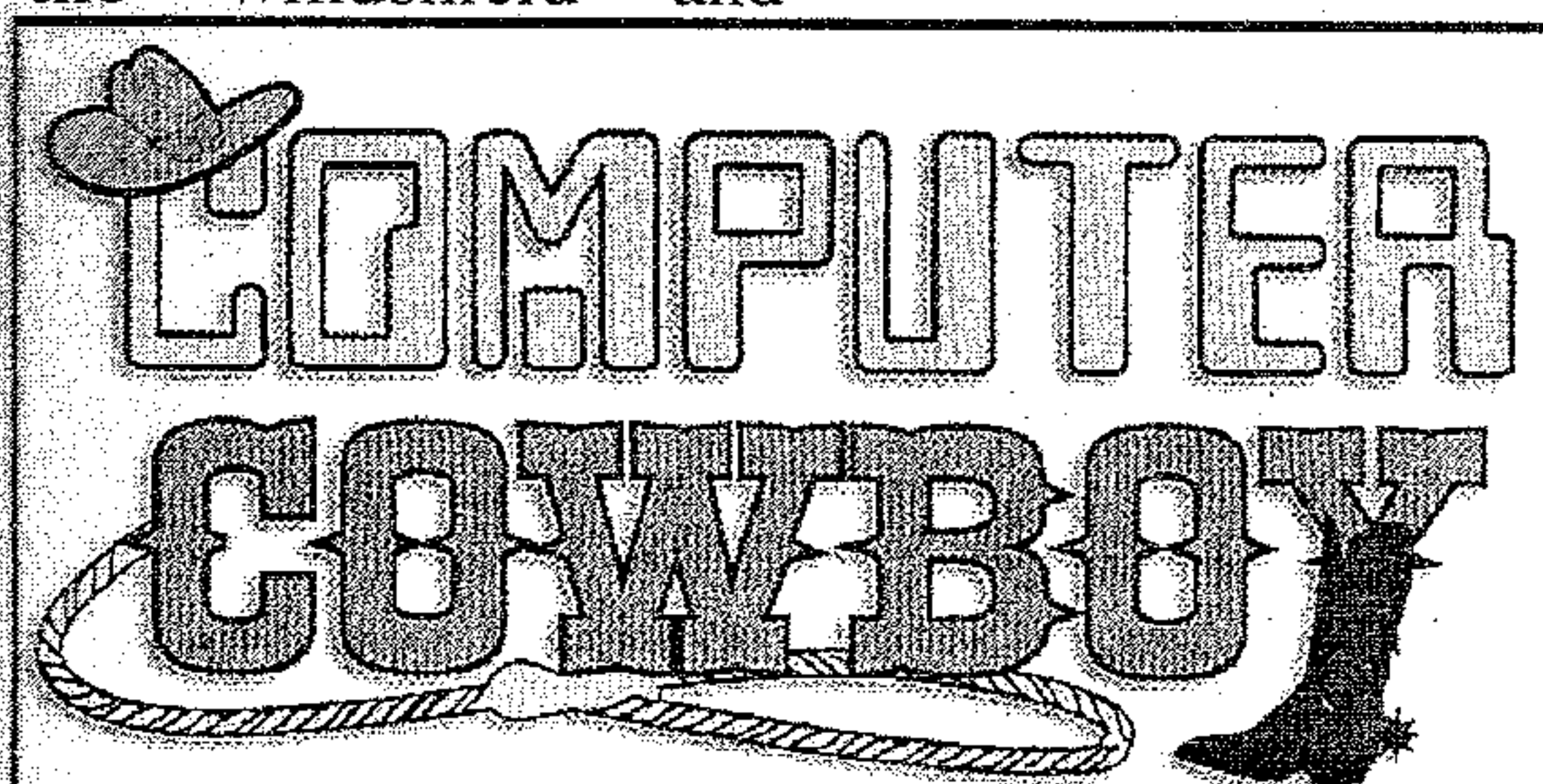

Keith Anthony Flanagan, 45, Cherry Street, Lenoir City was charged with possession of schedule II methadone.

The driver was identified as David Williams.

Mr. Williams gave verbal consent to search the vehicle. Deputy Lane found a cellophane bag in Mr. Williams mouth that contained two round blue pills with M on one

side and 30 on the other which Officer Yates identified and believed to be roxycodone.

Williams also was arrested and transported to the Loudon County Jail.
