



Burglary results in \$4K loss of property

A Philadelphia man called authorities Thursday when he returned home to find someone had broken into his home and had stolen numerous electronic items and other things totaling about \$4000.

According to reports, Thursday, around 12:25 PM, Deputy T.J. Scarbrough, LCSO responded to Fork Creek Road

in Philadelphia on a burglary call. The complainant, Mr. Charles Holt, told the officer he came home to find his back door standing open and multiple items missing from his residence.

Holt advised the missing items included several Wii games, a dark blue Toshiba laptop, an x-Box and games,

some PS3 games, about 200 DVD's, an Apple iPad, a small iPad, a 45 mm digital camera, a 15" Sony television, an iPod, and a PSP were stolen.

The estimated value of the loss was \$4000. Patrick Upton, LCSO-CID was also on scene. The crime was turned over to an investigator.

Mr. Opp performed poorly on field sobriety tasks and was read the implied consent law. He agreed to have blood drawn for blood alcohol content.



Indiana Man Indicted for Dale Hollow Boating Accident That Left 1 Person Dead, Injured 3 Others

NASHVILLE --- An Indiana man has been indicted by the Pickett County Grand Jury on multiple charges stemming from an investigation by the Tennessee Wildlife Resources Agency of a July boating accident on Dale Hollow Lake that left one person dead and injured three others.

Jopseph B. Bonomini, 23, from Lawrenceburg, Ind.,

was indicted in August on one count of vehicular homicide, three counts of aggravated assault, and one count of reckless endangerment. The crash on July 11 resulted in the death of Byron Hartman from Guilford, Ind.

Bonomini has posted a \$5,000 cash bond and has been released from the Pickett County Jail. He is scheduled to go to trial in November.


AEDC Units 1 and 2 are still used extensively for military training drill and the military use takes precedence over the hunting opportunities at the WMA.

"We are very fortunate to have opportunities to hunt these areas whenever the Air Force tells us when we can go, that's when we'll go," said Wes Winton, TWRA Manager of AEDC WMA.

It appears that the Young

Sportsman Hunt potentially scheduled for Oct. 1-2 will be open with only slight modifications. The Young Sportsman Hunt on Oct. 1-2 will be open on Unit 2. However, Unit 1 will be closed for training.

There is no official confirmation as of yet on the availability of the area for mid-October deer and turkey archery hunts as well as the first quota shotgun hunt potentially scheduled Oct. 29-30. 
