



Lying & "playing dumb" doesn't help unlicensed driver

Mario Alverez Friday, 'aka' Mario Gonzalez, 'aka' Mario Alvarez, 34, homeless, was charged with criminal impersonation, leaving the scene of an accident, driving without a license and received citations for violation of registration and failure to provide financial responsibility.

According to records, Sunday, at approximately 9:38 PM, Lt. Adam J. Yokley, LCSO observed a black Nissan Altima stopped at the intersection of Lee High Street and Highway 11 with the headlights off. As Lt. Yokley was turning his vehicle around, Loudon County 911 dispatched a call of a wreck without injury at that intersection.

A check of jail records couldn't find a Mario Alvarez ever being in the Loudon County Jail. The man was transported to jail, and once there, he was identified as Mario Friday.

Shaking & baking while waiting & waiting gets woman in heap o' trouble

Michelle Elaine Howard, 44, Crestview Drive, Madisonville was charged with initiate the manufacture of methamphetamine, possession of schedule methamphetamine for resale, possession of schedule II oxycodone, and felony possession of drug paraphernalia.

According to reports, Tuesday, around 5:18 PM, Agent Brendan DeBoer, 9th DTF noticed a female acting suspiciously at the 72 Market and Deli on Highway 72 in Loudon. The woman, later identified as Michelle Howard, was seen at the market for an extended period of time and appeared to be waiting for someone.

Agent DeBoer parked his car next to her red

Chevy Corvette and observed she appeared to be under the influence of a narcotic. She was extremely fidgety and nervous and as the agent got closer, her eyes appeared glassy and her pupils extremely dilated.

Agent DeBoer noted based on his training and experience, it was obvious to him Ms. Howard was under the influence of an intoxicant.

Ms. Howard was asked to exit her vehicle and was given some simple tasks and tests, which she failed. She declined a search of her vehicle. Agent DeBoer advised her of

her Miranda Warnings and asked if he could ask her some questions. He then asked her if she had anything illegal in her vehicle and after some reluctance, she stated there was methamphetamine and an oxycodone pill in her car.

Howard further stated there was a shake bottle, a bottle containing methamphetamine components combined, on the front passenger seat under her purse. Ms. Howard signed a consent to search form, and a search of her vehicle was performed.

Several grams of a substance that tested positive for metham-

her purse, along with a quantity of plastic baggies used for distribution, several pieces of tin foil, a digital scale, coffee filters, lithium batteries and a make shift pipe. One pill, tentatively identified as oxycodone, was found in the center console and a 16-20 ounce bot-


phetamine was found in

A check of Mr. Hampton's license revealed he's had one DUI offense within the past 10 years and six DUI offenses within the past 20 years.


Shoplifter

male passed close to the undercover vehicle and walked to an adjacent parking lot to a waiting car and then drove away. The female's demeanor and actions appeared suspicious.

Therefore, the vehicle was followed from Walgreen's to Tellico Parkway where the agent attempted to stop the vehicle for several traffic violations he had observed. The vehicle failed to stop and led the DTF agent on a pursuit through Loudon County and into Monroe County where the suspect's vehicle drove into a corn field and finally came to a rest in at a creek off of Eve Mill Road.

The three occupants in the vehicle fled on foot through the creek and the female, Arnita Sikes of Madisonville, was apprehended almost im-

mediately. Deputies from Loudon County Sheriff's Office and Monroe County Sheriff's Office arrived on scene for assistance. After a brief search a Monroe County Sheriffs K-9 and its handler, B.J. Johnson, captured Jonathon Best of Madisonville in a barn a short distance from the vehicle. Best was believed to be the driver of the vehicle and was transported to the Monroe County Sheriff's Department for a Violation of Probation.

The third suspect who was not found was later identified as Anthony Plemons of Madisonville. Plemons is facing numerous charges in Loudon County and through this press re-



lease is advised to turn himself in to the closest law enforcement agency. The three individuals involved all have pending charges for evading law en-


forcement and narcotics violations related to methamphetamine.
