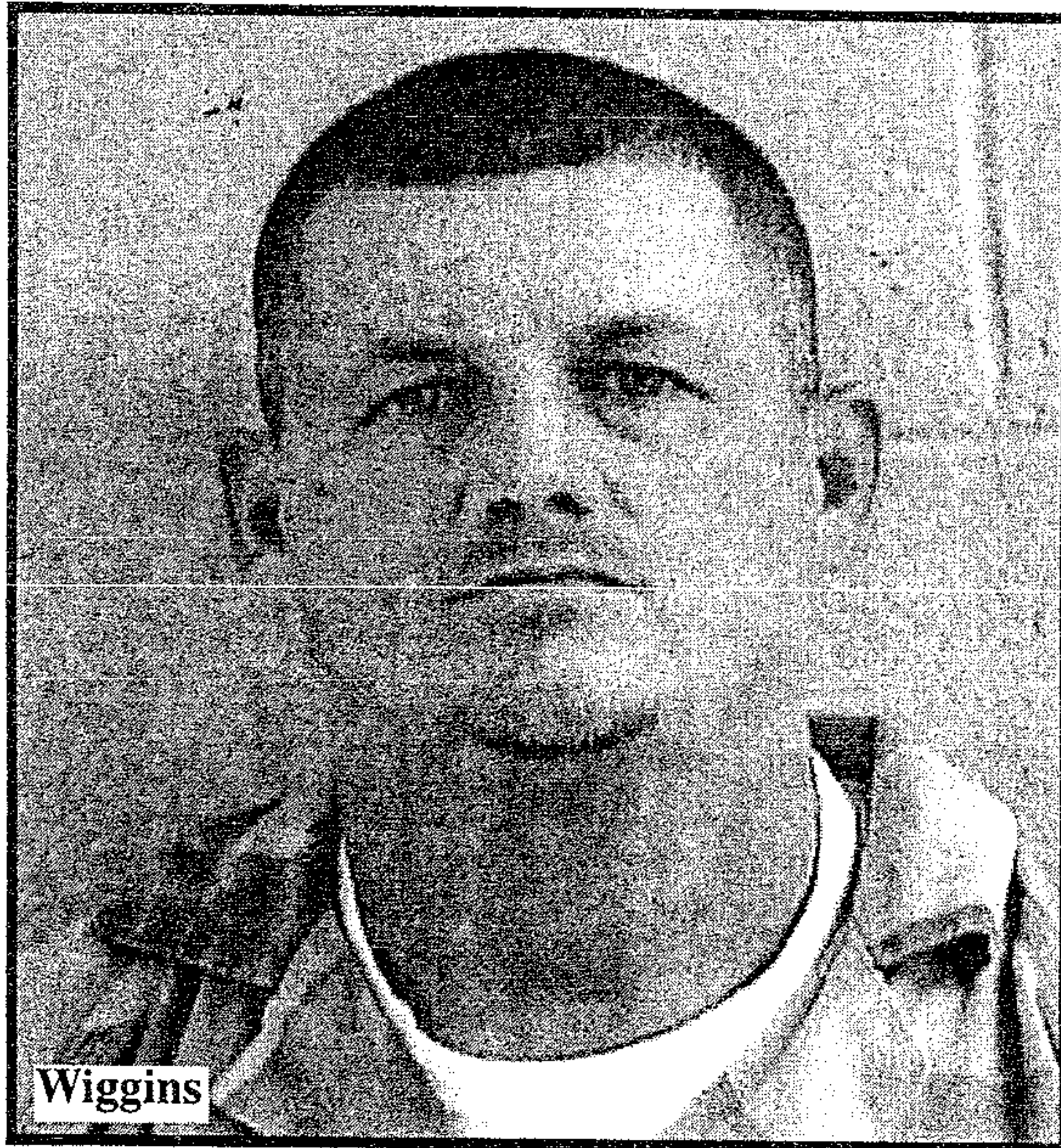

Board of Parole Audit Reveals Offenders Monitored After Their Deaths

The Comptroller released an audit of the state Board of Parole that found, at a mini-

mum, annual arrest checks were completed on behalf of 82 parolees who had been dead for

varying lengths of time, ranging from less than six months to more than 19 years. At worst, of-

ficers documented contact indicating offenders were still alive.

Butler, LCPD, charging Wiggins with Solicitation of a Minor for Sexual Exploitation, which in this case is a

Class C felony.

Additionally, Wiggins was charged with possession of Schedule IV (Marijuana) and Felon in Possession of

a Firearm.

A search warrant for Wiggins' home was obtained and executed after the arrest. Two computers, marijuana,

drug paraphernalia, guns, and audio video recording devices were seized.

The investigation is on going and additional charges are pending.

Audit

The audit also noted that many files managed by probation and parole officers were not in compliance with all board supervision requirements and were not regularly reviewed by management. In some cases, officers failed to complete or document their attempts to complete all of the required face-to-face contacts with parolees. In other cases, officers did not perform required home visits of regular offenders. The audit also showed some sex offenders tracked by GPS equipment had not been properly monitored.

"Inadequate supervision of offenders results in increased public risks and jeopardizes public safety," Comptroller Justin P. Wilson said. "If parole officers are supervising dead people, this is a waste of taxpayer dollars and makes us wonder about the supervision of parolees living in our communities."

Auditors also found a number of other is-

sues with the Board of Parole's operations, including questionable practices for providing notice of hearing decisions and upcoming board meetings.
