

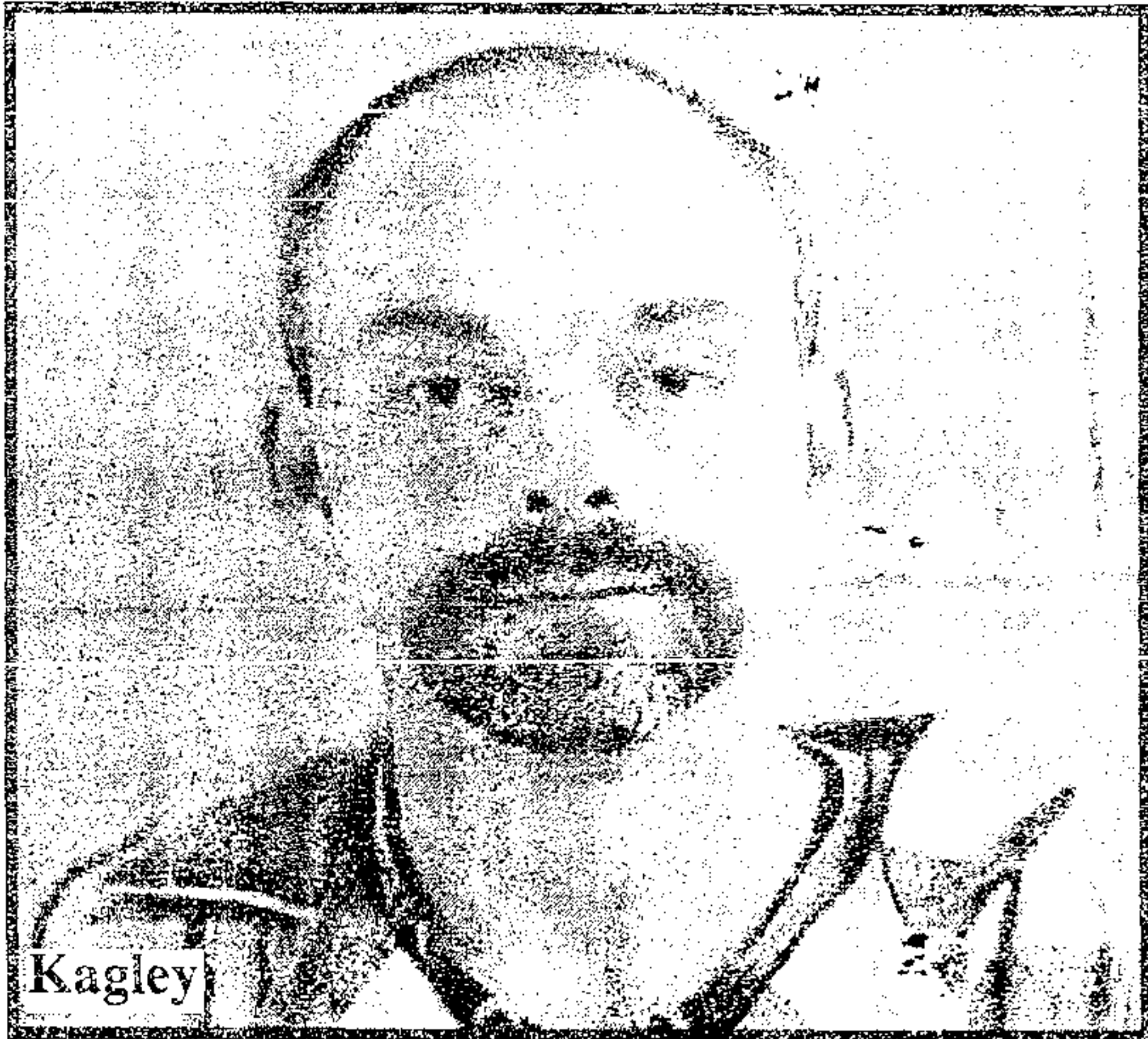

A Loudon man arrested in recent days for reportedly gluing a digit over another number on a check and passing it at a local business is now charged with hindering a creditor in connection with allegations he purchased a vehicle from a Loudon dealership and then sold it for scrap in spite of an active lien against it.

sica Parkins harvested her elk on the opening morning of the two-day youth hunt.

A ninth grader at South Greene High School, Jessica was selected to participate after being chosen in a random drawing in August. Jessica's harvested elk field dressed at 311 pounds and had a 5x5 rack size.

Two elk were harvested on the opening day of the hunt. Tony Fink of Crossville harvested a 7x6 elk that weighed 642 pounds. Rockwood resident Corbin Moore also harvested a 7x6 elk that had a weight of 580 pounds.

On the second day, Walk Kimberlin, of Kingston, took a 6x6 elk that weighed 569 pounds. Franklin resident Brian Rochelle harvested an 8x6 trophy that weighed 620 pounds. Dewayne Marbury, from the West Tennessee community of Stanton, harvested a 5x5 elk that came in at 424 pounds.

Since the historic first managed hunt in 2009, 17 elk have been harvested, all by Tennessee residents. This year marks the first time since the inaugural hunt that all five participants recorded harvests.

Five elk hunting zones were selected on the Royal Blue Unit of the North Cumberland WMA, each about 8,000 acres. The division helps ensure the harvest was spread over the entire core of the elk zone. Each hunter was assigned a zone through a random hand-held drawing. Jessica was able to choose any of the zones for her hunt and recorded her harvest in the WMA's Zone 1.

The Tennessee Wildlife Resources Agency has worked to make habitat improvements at North Cumberland WMA. The first arrival of 50 animals came in December 2000, the first elk to be in Tennessee since they were last reported in Obion County in 1865. Studies have proven that the elk herd is seeing an annual growth rate of 13-15 percent.

 nessee was awarded one permit by the U.S. Fish and Wildlife Service allowing the trapping of one Peregrine falcon for

the use in falconry beginning in 2011 in selected West Tennessee counties.

Brian Brown, of Clarksville, made the historic capture on a Friday after-

noon at around 2:30. He used a Dho-ghazza net and lured the Peregrine he has named "Belle." He brought the bird to the Tennessee Wildlife Resources

Agency in Nashville for the proper processing.

Peregrine falcons were the primary bird used in falconry for hunting in the 1800s. The population of Peregrine falcons, through state and federal conservation efforts, has recovered enough since their near-extinction in the early 20th century to allow for a limited take of these birds for the use in falconry. Tennessee was allowed to issue a pair of permits this year.

"This is a true mark of success in our conservation to reestablish the population of these birds," said Walter Cook, TWRA Captive Wildlife Coordinator. "Once again, this was an effort supported and carried out by falconers."

While being the first

Peregrine trapped in Tennessee, Belle is believed to be the one of the few trapped recently in the southeast. A Peregrine was trapped in the Jonesboro, Ark. area during the prior week. Brown plans to have Belle go through a brief training period prior to her being used as his hunting bird.

Belle weighed just under two pounds on her visit to the TWRA. Peregrines have a body length of 13 to 23 inches and a wingspan ranging from 29 to 47 inches. The Peregrine is famous for reaching speeds of more than 200 mph during its characteristic high speed dive.

The Peregrine's range includes land regions from the Arctic tundra to the tropics. It is the world's most widespread raptor.

Deputy Robert Gray, LCSO made the arrest at the Blount County Jail.

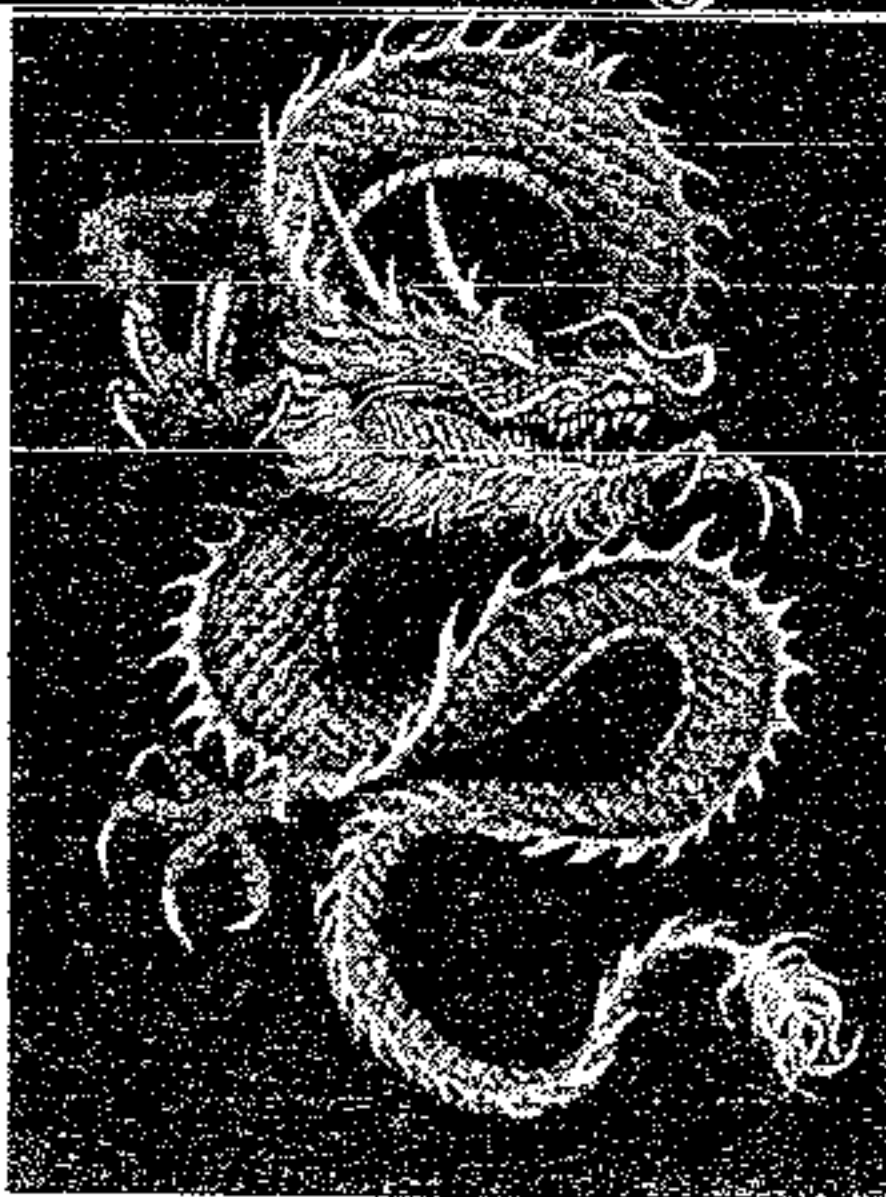

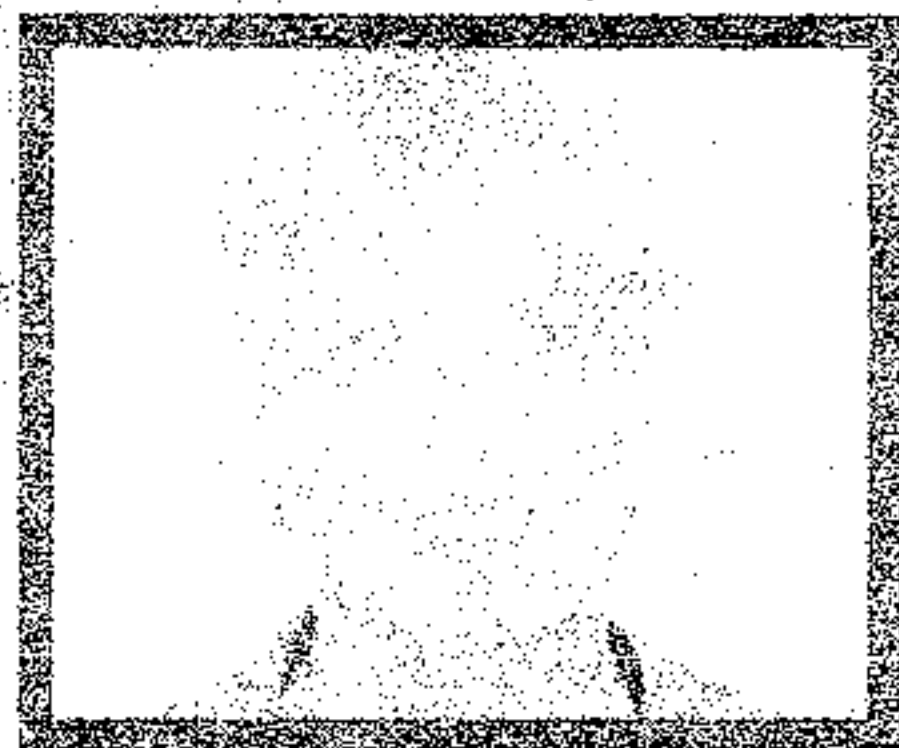

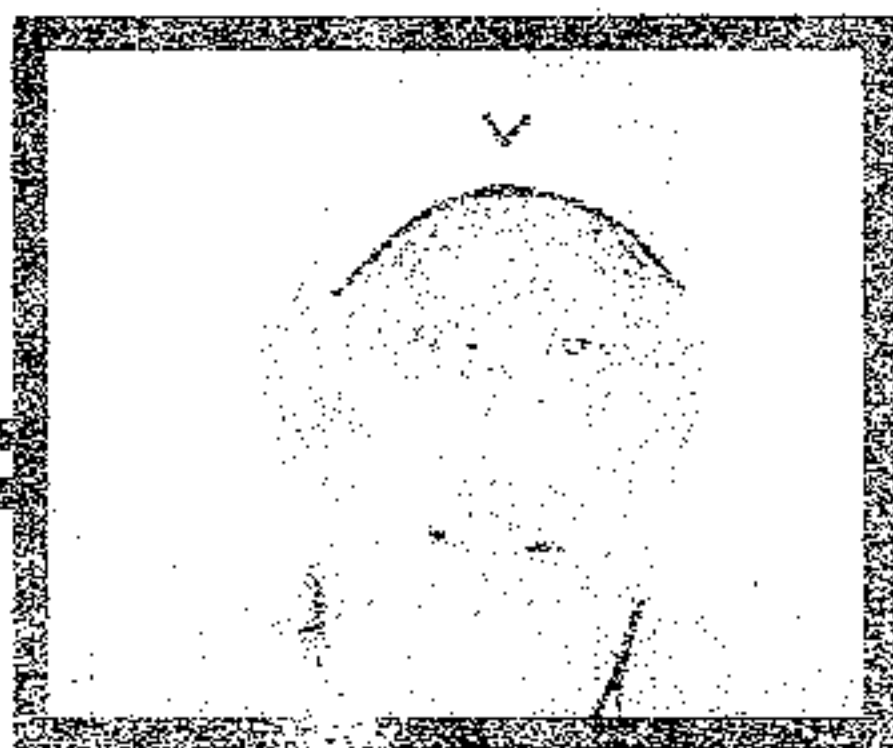
