Forest Arson Investigated in East Tennessee Counties

- Rash of November fires set in Anderson, Campbell, Hawkins and Scott Counties -

NASHVILLE - The Tennessee Department of Agriculture's Agricultural Crime Unit and Division of Forestry are teaming up in Anderson, Campbell, Hawkins and Scott Counties to remind citizens that intentionally lighting the woods on fire is a crime. A recent rash of fires in those

counties is currently under investigation as arson related.

"Arson accounts for the majority of acres burned from forest fires in Tennessee. These fires can spread quickly this time of year and endanger human life and property,"

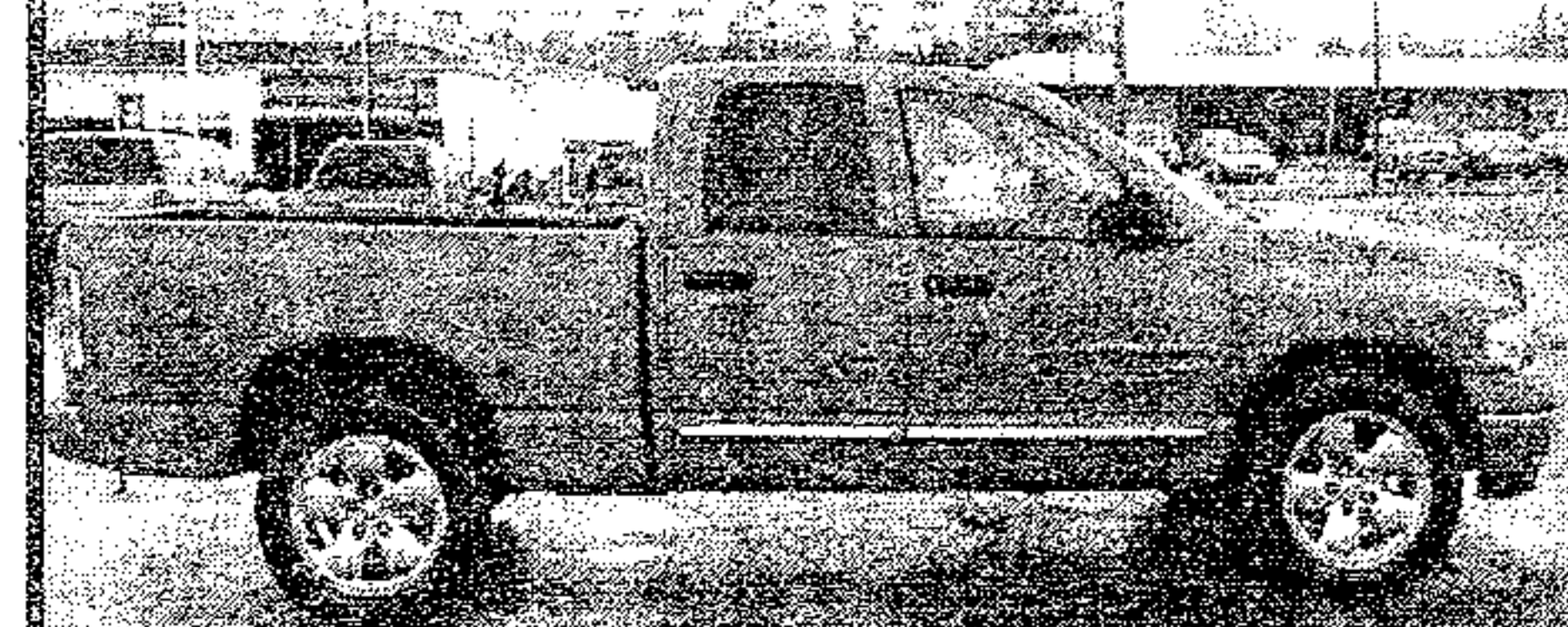

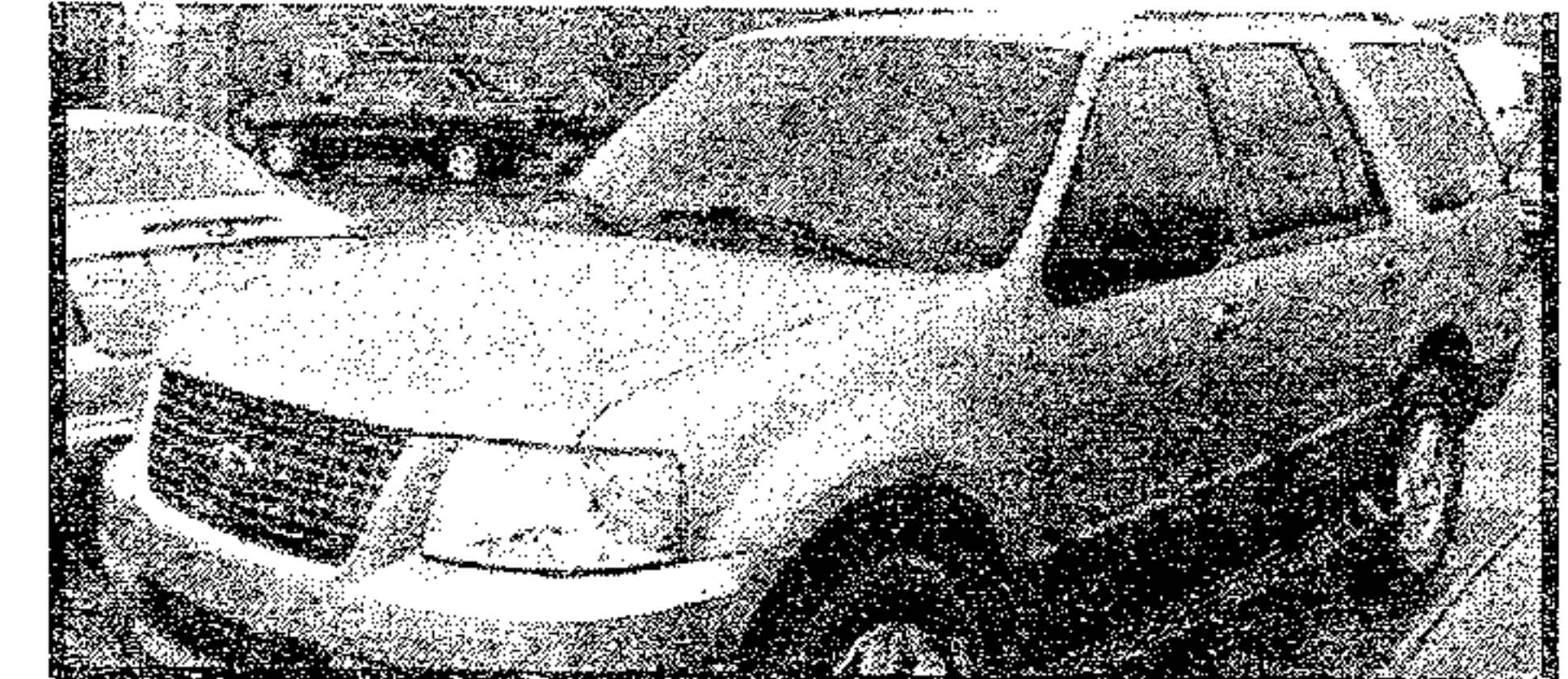

I would like to pay the person that may have it \$200 to get it back. No questions asked. I don't want to know your name or how you got it. I would like to have it back cleaned of all fingerprints unloaded with the bullets in a bag.

Also, I do not have a Private Investigator following anyone. I have already told all what the Lord has told me from day one. There is nothing which has been concealed which will not be revealed and no secret which will not be known.

In other words, you can hide your secrets from people for a little while, but God sees All and He will bring it in to the light for all to see.

From June to August Ronnie Jaynes actions were a repeat of almost 14 years ago. The same as then, he may have told his friends that if he died in a certain way and it looked like an accident not to believe it. If he has told any of his friends something like that within the last three months of his life Please Call his oldest sister Tammy at 865-986-6018. If you have the pistol please call the same number. It was part of my brother for many years and I would like to have it back.

On a final note, my brother Ronnie had a heart like our mother. He loved his family and his friends. He would go a step farther and tell us he liked us with a smile and we all loved him more than he knew.

8:16am the Loudon County 911 received a call from a male subject that there were two bombs at the Justice Center and one at City Hall and the bombs were set to go off in 6 hours from the call.

On the same day at approximately 8:48am another call was placed by the same individual and stated there were now 5 hours and 5 minutes left for the bombs to go off and that Judge Rex Dale will be killed today.

Upon further investigation it was learned the called came from a cell phone belonging to Jimmy Rolon. Upon further investigation the called were placed to 911 center were listened to and deputies advised it sounded like Chris Herman. It was also learned that Mr. Herman was scheduled for court that same day on theft charges and possible violation of probation charges. Further investigation also revealed that Mr. Herman had been associated with Mr. Rolon. At approximately 1:39pm Mr. Herman was located at the Shell station on Hwy 321 and he was

brought back to the justice center and Mr. Herman advised he placed the two calls because he thought he would be going to jail after his court today. Mr. Herman also advised he did take the phone belonging to Jimmy Rolon to make the calls. This was also supported by Mr. Rolon's statement.

Christopher Ryan Herman, 27, of West Chapel Road, Lenoir City, was charged with two counts of filing a false report and retaliation for past action. Lt. Patrick Upton, LCSO CID made the arrest and filed the charges.

said State Forester Jere Jeter. "The Ag Crime Unit provides an important presence in our

rural areas to help reduce arson activity." So far this year, a total of 1,136 fires have burned 18,935 acres in the state from all

causes. Arson accounted for 393 of those fires, burning nearly 14,000 acres across Tennessee. Since November,

more than half of those acres burned by arson (7,361) were from 40 fires set in Anderson, Campbell, Hawkins and Scott Counties.

"Forest arson is a very serious crime and we will prosecute offenders to the full extent of the law," said Max Thomas, ACU Investigation Supervisor.

Anyone with information about suspected arson activity should call the state Fire Marshal's Arson Hotline toll-free at 1-800-762-3017. Rewards up to \$1,500 are available for tips leading to a conviction. Callers can remain anonymous.

During fire season, Oct. 15 through May 15, citizens are required to obtain a burn permit before conducting any open, outdoor burning near woods or grasslands. Contact your local Forestry office or visit www.burnsafetn.org for permit and fire safety information.

Burning without a permit is a Class C misdemeanor punishable by up to 30 days in jail and/or a fine not to exceed \$50. Wildfires caused by arson are
