Habitual thief at it again in LC

An habitual thief in Lenoir City is at it again. Kenneth Justin "KJ" Collins was located at a residence in Loudon where he was apparently hiding out after yet another Lenoir City Burglary. Collins address is listed on Bon Street and he was already wanted for violation of probation when he was charged in the burglary of a business and theft. Collins violation should send him to serve his full sentence because, according to the reasons for the violation and the new charges he is a habitual criminal. Collins stole from a local business located across the street from the Lenoir City Police Department in October.

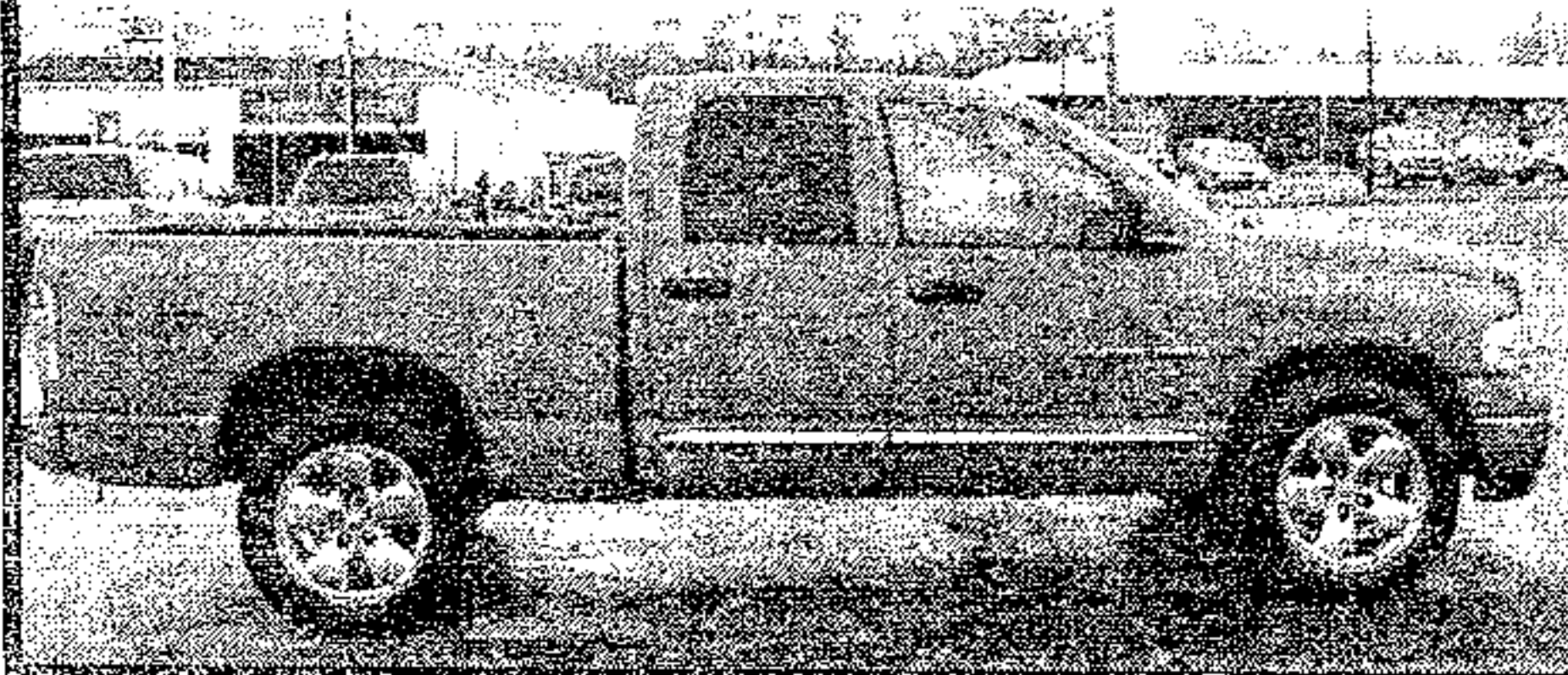

Collins

According to the warrant, sometime between October 8th and 9th between the hours

of 5pm and 8:30am KJ Collins did enter the perimeter fence of a business on Grand Street in Lenoir City. Collins then forced his

way into the building and took a Sony Visio laptop and \$125 in cash. The laptop is valued at \$704 and was taken to Pappy's Pawn Shop in

Knoxville where it was pawned for \$225. This was done without the permission or knowledge of the victim.

According to the affidavit, Kenneth J Collins was convicted May 8, 2012 of aggravated burglary, theft of property \$1000-\$10,000, theft of property \$500 to \$1000; violation of probation with original charges on June 10, 2011 of aggravated burglary x3 in the criminal court of Loudon County. He was sentenced to 3 years, consecutive to original 3 years, with effective sentence of 7 years in community corrections. Since then he has failed drug screen by admission on August 30, 2012 for opiates. Failed to attend group therapy at ETHRA; failed drug screen on October 4, 2012 due

to urine sample being below 90 degrees and was told again to attend therapy; failed to report on 9/13/12, 9/20/12, 9/27/12, 10/11/12, 10/18/12 or 10/25/12 as directed. Failed to attend treatment therapy on the same dates; failed to pay court costs, fines, and supervision fees; and failed to maintain employment the offender has not provided evidence of steady employment of any kind.

Kenneth Justin Collins, aka KJ, 29, of Bon Street, Lenoir City, was charged with burglary of a business and violation of probation out of criminal court. At the jail Collins was charged with violation of probation out of Lenoir City Court. Officer C. Parker, LCPD made the arrest at the Loudon County Jail.

According to the report, Officer Bennie Houser, LPD was dispatched to the trailer park behind the America's Best Inn for a female that wouldn't leave. She also advised the male subject had gone to Food City and had been drinking.

rants filed by Trooper Rodney Best, T1P; on Friday, April 13, 2012, while traveling on Pond Creek Road in Philadelphia Trooper

Best came upon a crash at the railroad track crossing. The trooper made contact with Alicia D. Partin, who was driving maroon vehicle

that had crashed into a guardrail.

Ms. Partin advised she was pregnant and requested she be transported to the hospital by EMS.

While investigating the crash the lawman found Ms. Partin had a passenger who had left the scene. The passenger was found at the Sunrise Inn about a half-mile down the road.

The trooper made contact with the passenger, Kristy Leigh Jaynes, and reported she was complaining of back and chest pain. Ms. Jaynes stated she was pregnant as well and also requested EMS to transport her to Ft. Loudon Medical Center.

Due to the passenger requiring medical attention the trooper re-

quested a blood draw on the driver, Ms. Partin.

A check of Partin's license showed they were suspended and Jaynes had a warrant for her arrest in Monroe County.

When Ms. Jaynes was released from the hospital she was transported to Monroe County Jail. Ms. Jaynes asked if Ms. Partin was going to be arrested, that she had been taking Oxy's and Diazepam on their way back to Philadelphia after leaving McMinn County.

The trooper noted Ms. Partin's blood tested positive for Oxycodone, Diazepam, Meprobamate, and Carisoprodol, which were not administered by EMS or the hospital at the time of the blood draw.
