## Clerk fired after break in and theft

Detective Jonathan Sartin arrested a local woman following an investigation into the late November break-in of her place of employment where several hundred dollars was stolen from the safe.

According to a warrant filed by Detective Jonathan Sartin, LCPD; on or about November 21, 2012 Lori Janene Penton was employed at the EZ Stop on West Broadway in Lenoir City. Penton had a key and after hours and before opening the store for business, and Lori Penton did take and enter the store without permission or knowledge of the manager.

After entering the store Penton took over \$400 from the safe.

Lori Janene Penton, 41, of West First Avenue, Lenoir City was charged with burglary other than habitation and theft under \$500.

Detective Jonathan Sartin, LCPD made the arrest and filed the charges.







**The Year in Review: A Look at FBI Cases, Part 1**

The FBI worked thousands of investigations during 2012, involving everything from extremists bent on terror to cyber thieves, financial fraudsters, and child predators. As the year comes to a close, we take our annual look back at some of the Bureau's most significant cases.

Part 1 focuses on our top investigative priority—protecting the nation from terrorist attack. Working with local, state, federal, and international partners, we thwarted a number of potential attacks on U.S. citizens at home and abroad.

Here are some of the top terror cases of 2012, in reverse chronological order:

**Alabama men arrested on terrorism charges:** Two U.S. citizens living in Alabama were arrested in December and charged with planning to travel overseas to wage violent jihad. The pair met online and later confided their plans to an individual who—unbeknownst to them—was a confidential source working for the FBI.

**Plot to destroy Ohio bridge:** Four men were sentenced to prison in November for their role in a conspiracy to destroy a bridge near Cleveland. The men—all self-proclaimed anarchists—pled guilty to conspiracy to use weapons of mass destruction. The group allegedly planned a series of crimes in the Cleveland area.

about it, the rightful owner went with detectives to a Lenoir City recycler where they found the stove and the thief was revealed.

According to a warrant filed by investigator Jason Smith, LCSO; the victim confronted the driver of a vehicle

exiting Houchiss Valley Lane that he noticed contained scrap he recognized as coming from his property. The victim identified the driver as

Billy Joe Hill.

The victim reported he had the subjects take the scrap back and dump it at his residence, but on the same date it was discovered an antique cook stove valued at approximately \$1200 had been taken from the property.

The victim located Billy Joe Hill at his residence on Heather Lane and asked him about the stove. Mr. Hill denied taking a stove from the property.

Two days later investigator Smith and the victim went to Green's Recycling in Lenoir City where they learned Mr. Hill had brought a stove, which he sold, for scrap to the business. The stove was identified by the victim as the one stolen from his property.
