The deputy reported the odor was not a burnt smell, however, it was a raw smell of marijuana. A search of the vehicle produced a hand rolled cigarette believed to be marijuana and approximately 6 grams of marijuana in three separate bags.

Records indicate Ms. Moreland had glassy bloodshot eyes, slurred speech and was cot-

ton mouthed. She was placed under arrest and transported to the Loudon County Jail where she refused implied consent.

Mr. Creagan had an odor of an alcoholic beverage on his person and after stating he'd smoked marijuana earlier, he was deemed a danger to himself or others if left in public and was placed under arrest.

Deputy Marty Branam, LCSO transported Mr. Creagan to the Loudon County Jail.

There will be a Dedication Ceremony and Reception in honor of the War Memorial Building being placed on the National Historic Registry.






