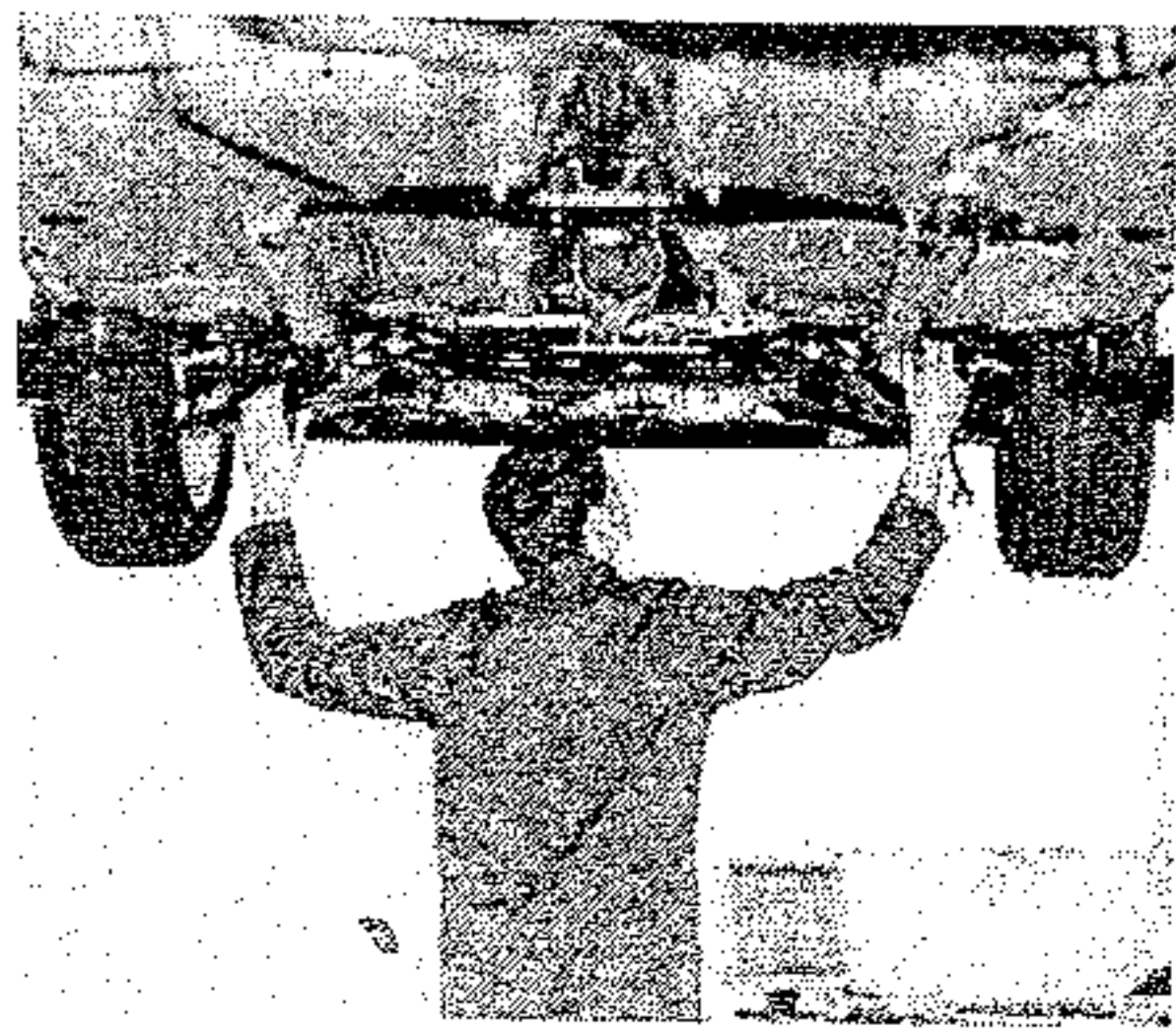

### Bad Check Writer

According to an affidavit filed by Detective Jonathan Sartin, LCPD; on or about March 31, 2012, James G. Vineyard, II wrote a check to Don White of Goodwin Building, LLC, which was signed by Mr. Vineyard and made out in the amount of \$5100.

On April 5, 2012, the check was deposited into Goodwin Building, LLC's account, but was returned for non-sufficient funds. On April 23, 2012, Mr. Vineyard was served with a notice of the returned check and was given 10 days to take care of

it, but he did not make any effort to make the check good.

Detective Sartin served the warrant and made the arrest Saturday, at Mr. Vineyard's residence.

The truck continued through the field and through a clear cut un-

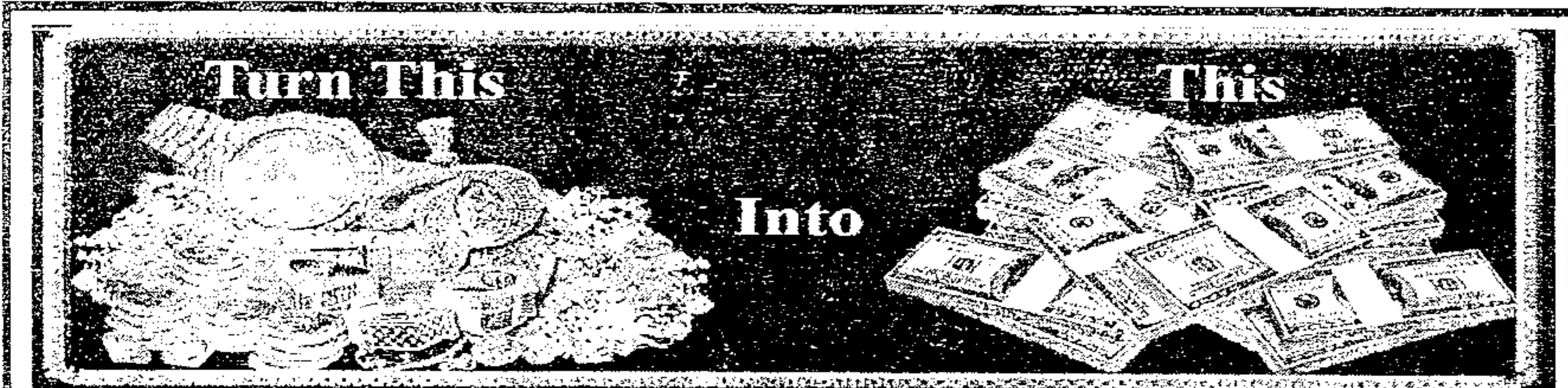
der some power lines. Deputy Branam did make contact with the passenger of the truck and he stated the driver was Michael Inman. The passenger further stated he tried to get Mr. Inman to stop and let him out, but he refused and stated he didn't have a license.

The passenger advised he was in fear for

his safety due to the way Mr. Inman was driving and because he would not let him out.

A check of Inman's license through NCIC revealed his license is currently revoked with seven prior revoked convictions.

and the same number of deaths as 2010.

The 2012 Memorial Day holiday period ran from midnight, Friday,

May 25 through 11:59 p.m., Monday, May 28. During that time, there were 10 fatal crashes that resulted in 13 fatalities. Six crashes were

single vehicle wrecks, while four of them were multiple car crashes. Ten of the people killed were vehicle occupants and three were motorcyclists.

Five of the ten (50 percent) vehicle occupants killed were not wearing safety restraints.

In 1973, 26 people were killed in traffic crashes in Tennessee during the 78-hour Memorial Day holiday period, the highest number of deaths on record. The lowest number of deaths occurred when five people were killed in traffic crashes during the 2002

Memorial Day 78-hour period.

During this year's Memorial Day enforcement period, the THP made 94 impaired driving arrests statewide. They also issued 1,139 seat belt and child restraint device citations, 1,500 speeding and 511 registration violations.

As of May 31, 2012, there have been 397 people killed on Tennessee roadways, 26 more fatalities compared to this same time last year. The last two months have shown a decrease in vehicular deaths compared to the same months in 2011, with 21 and 10 fewer fatalities in April and May, respectively.

"One traffic fatality is one too many," THP Colonel Tracy Trott said. "However, the reduction in traffic-related deaths the last two months is an encouraging sign that our highway safety enforcement, along with our partnerships with local law enforcement agencies and highway safety advocates, is making a difference."

The Tennessee Highway Patrol conducted driver license and sobriety checkpoints throughout the state during this past holiday weekend.
