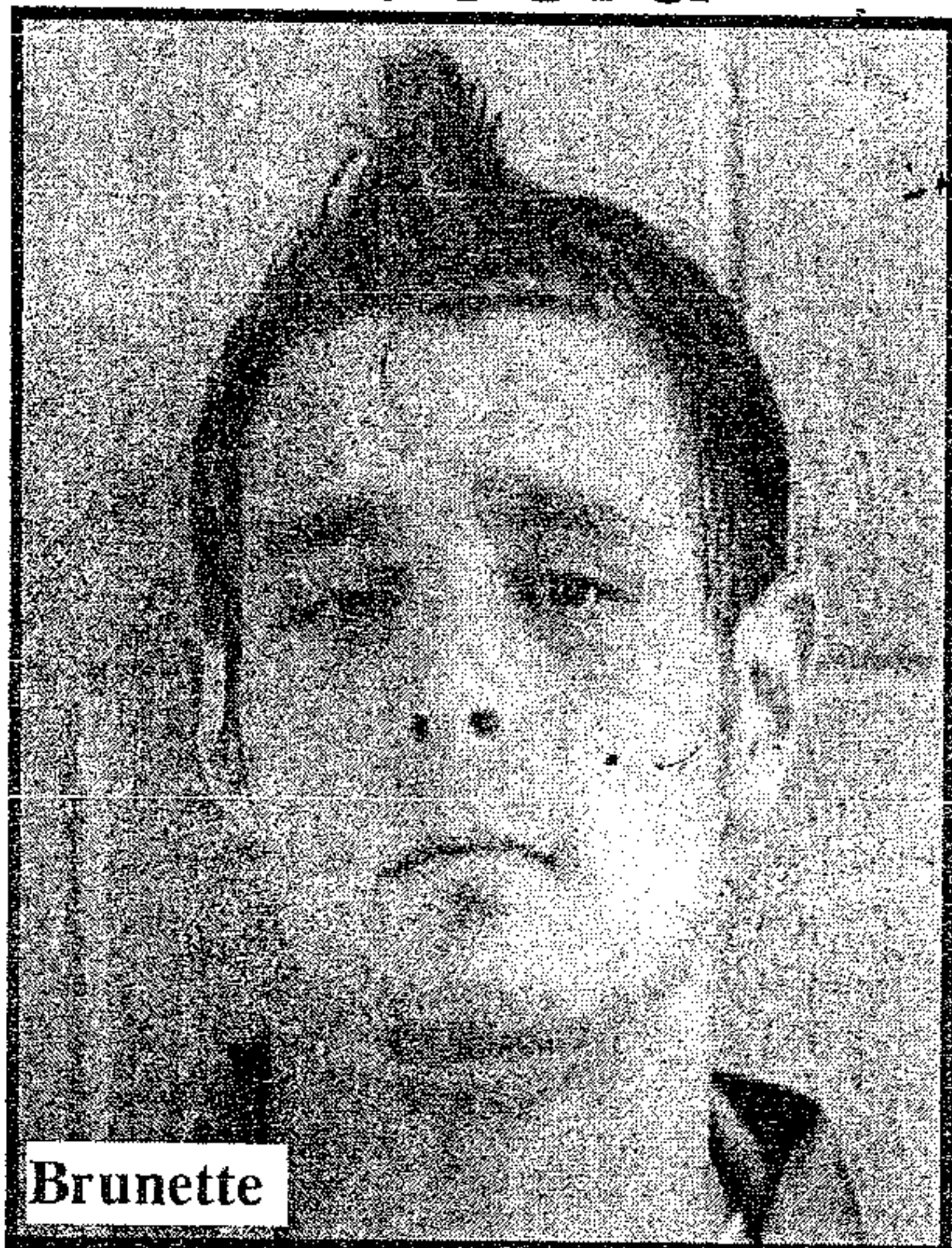

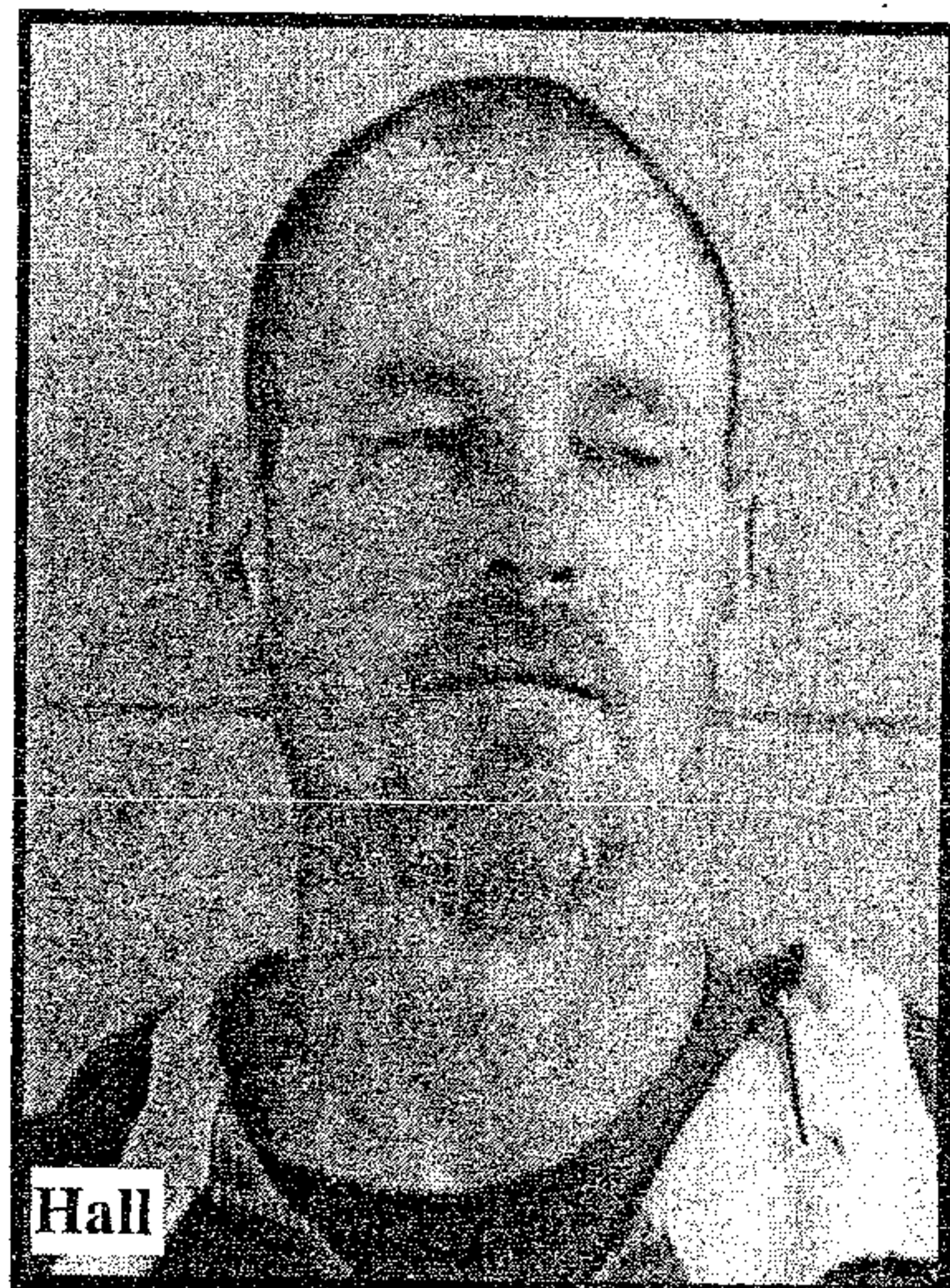
Local man goes to jail after assailing handicapped man

A Loudon man was arrested after he allegedly beat a handicapped man to the point the victim will lose sight in one eye without surgery.

Fredrick David Hall, 40, Graystone Apartments, Gay Street, Loudon was charged with aggravated assault.

According to an affidavit filed by Investigator Jeff Russell, LCSO-CID; on July 14, 2012, the victim went to visit a friend on Markwood Road in Loudon and when he arrived at the residence he

According to records, Thursday, around 12:24

PM, Deputy Billy Hall, LCSO stopped a black Cadillac Escalade on Oakland Road at the intersection of Blue Springs Road because the driver, Sharon E. Barabe, was not wearing a seat belt.

A check of her license showed them revoked in the state of Tennessee for DUI.

During their conversation, Ms. Barabe told the deputy there may be drug paraphernalia in her ve-

hicle.

A search of the Escalade produced a spoon with burn marks and a white powder residue, a needle used to inject prescription medication, and a substance that Barabe stated was morphine. The substance had been heated in the spoon and broken down for injection.

A tag also was found under the driver's front seat that came back stolen out of Monroe County.

Ms. Barabe was arrested and her vehicle was towed.

Courtney Darlene Avron-Brown, 26, Donaldson Road, Philadelphia was charged with two counts of domestic assault and resisting stop, halt, frisk or arrest.

According to reports, Deputy Ron Stegall, LCSO responded to

Donaldson Road on a domestic call and on arrival made contact with the victim, who stated Courtney Brown returned home after fleeing the residence from a prior domestic with her husband where she was the primary aggressor.

The victim stated Brown was out of control, throwing things at him, and he was in fear for himself and other members of the family.

Deputy Stegall made contact with Brown in the bedroom, where was screaming and being aggressive. He explained she was being placed under arrest due to the prior domestic and the present incident of being aggressive and to place her hands behind her back. She, however, began to fight the deputy's efforts, but was finally cuffed.

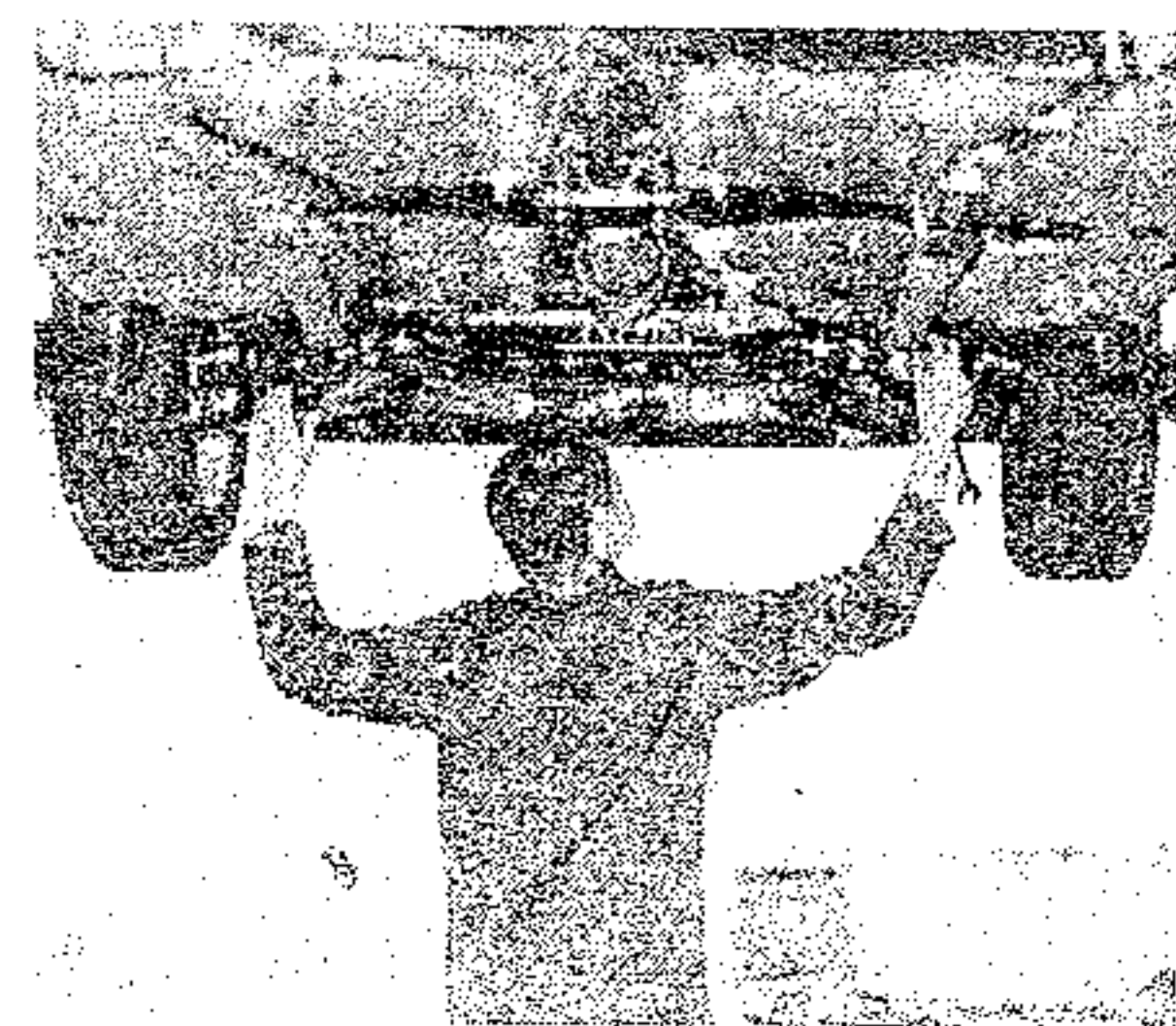
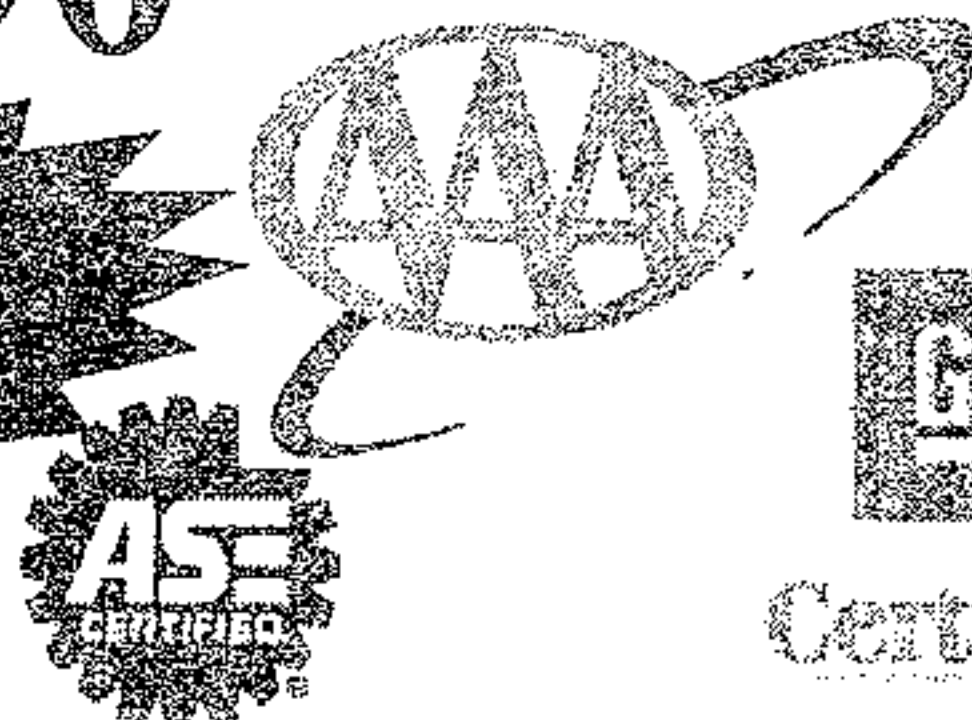

According to the victim, Mr. Hall started hitting him, knocking him to the ground, and continued to hit him until someone pulled him away. The victim has a medical condition that makes him impaired in his speech and in his movement, mainly his right hand and arm.

An individual who lives on Markwood Road reported he saw the fight and went and pulled Mr. Hall off the victim.

The victim suffered severe damage to his left eye and the area around the eye. Medical records

show the assault caused fractures to the area around his left eye and will he require surgery to keep his eye sight.

Investigator Russell made the arrest Saturday at Hall's residence.

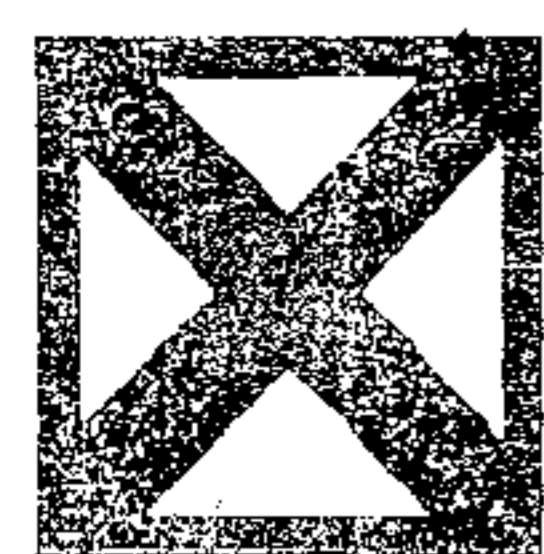

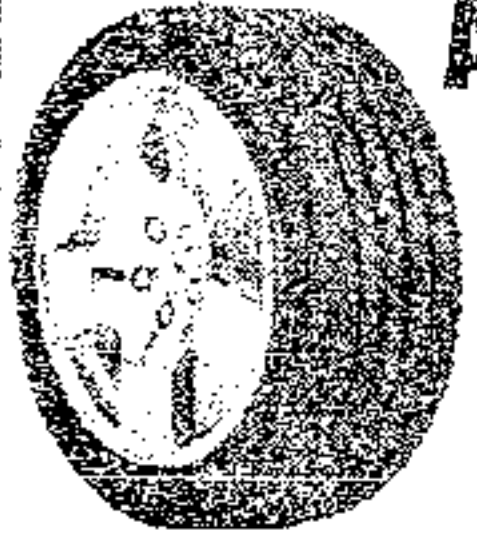

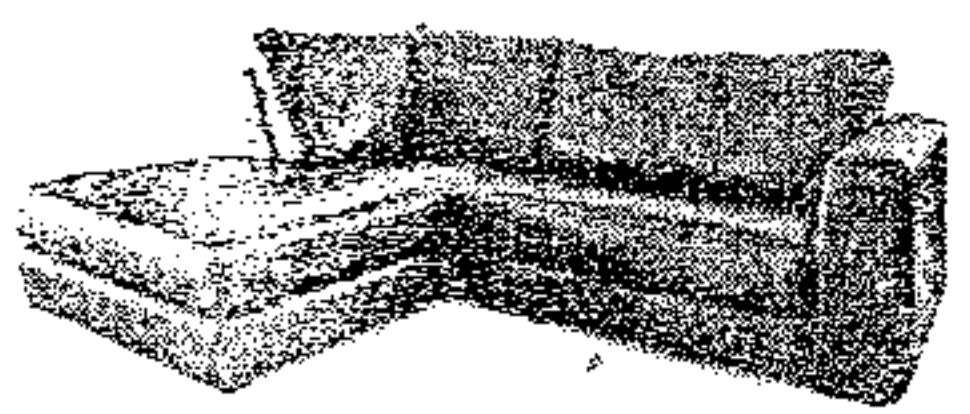

Drive, Lenoir City was charged with domestic assault, theft over \$1000, failure to appear, and two counts of violation of probation.

According to an affidavit, on May 20, 2012, Deputy Jason Russell, LCSO was dispatched to

Cedar Park Drive for a domestic dispute and upon arrival spoke with the victim who stated he and his step son, Bradley Brunette were playing Rock Band when Brunette suddenly got up, took off his shirt and started hitting him.

The officer reported the victim was bleeding from his right ear, had a bite mark on his lower left abdomen and was complaining of a sore left wrist and

Mr. Brunette had already left the scene when law enforcement arrived. He was not located.

Approximately one hour later, Brunette returned to the residence and his mother attempted to take him to the jail, but he jumped out of the car and fled again.

Additional records indicate Officer, Jason Felts, LCPD responded to a residence on Johnson Drive Saturday where he made contact with Bradley Brunette. The officer spoke with Detective Jonathan Sartin, who advised Mr. Brunette was to be taken into custody and transported to the Loudon County Jail on an investigative hold.

After being incarcerated, Brunette was charged with violation of probation out of criminal court on an original charge of statutory rape, violation

of probation out of general sessions court on an original charge of underage consumption and failure to appear out of general sessions court on an original charge of reckless driving.

On July 24, 2012, Detective Jonathan Sartin charged Brunette with theft over \$1000.

According to that affidavit, on or about July 19, 2012, Mr. Brunette was driving the victim's truck while they were working. He took the truck from 504 West Seventh Avenue in Lenoir City, but instead of following the victim to the job site, Mr. Brunette took off with the truck without permission.

The truck was found two days later at Coytee. The total amount of the theft was \$2500. Detective Sartin made served the warrant Tuesday at the Loudon County Jail.

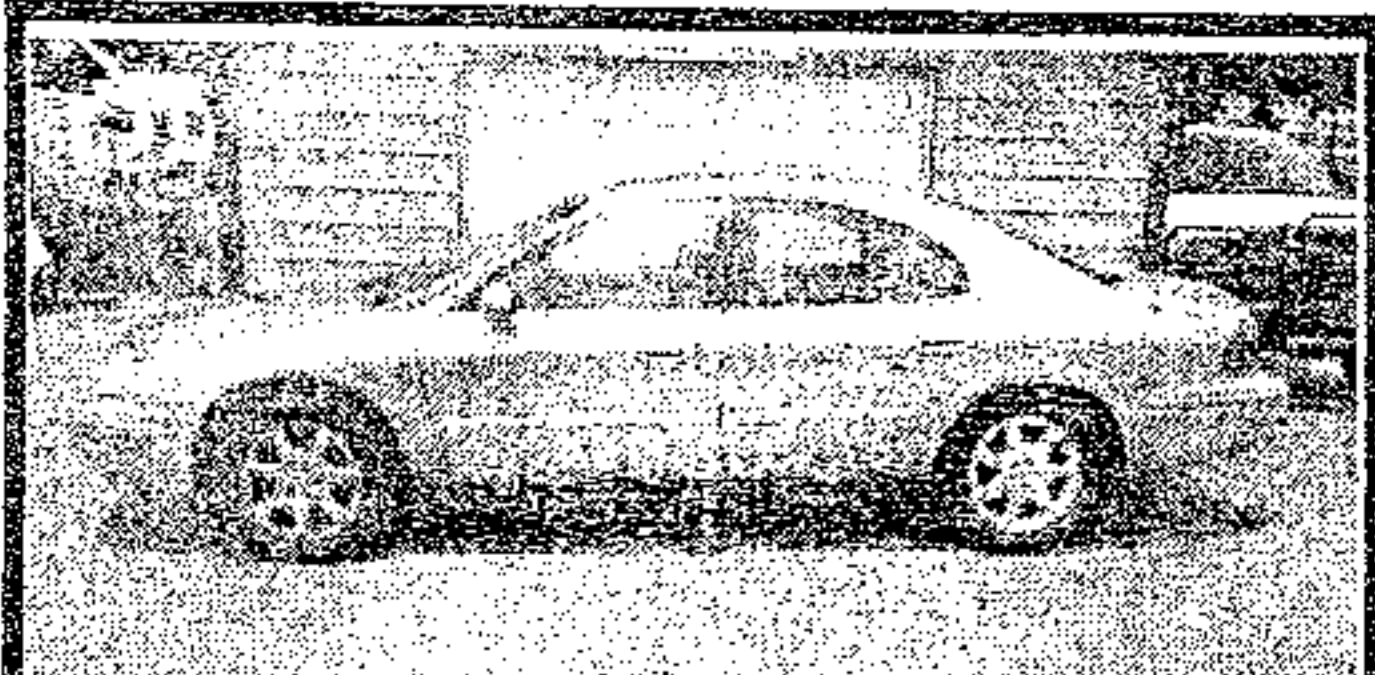
