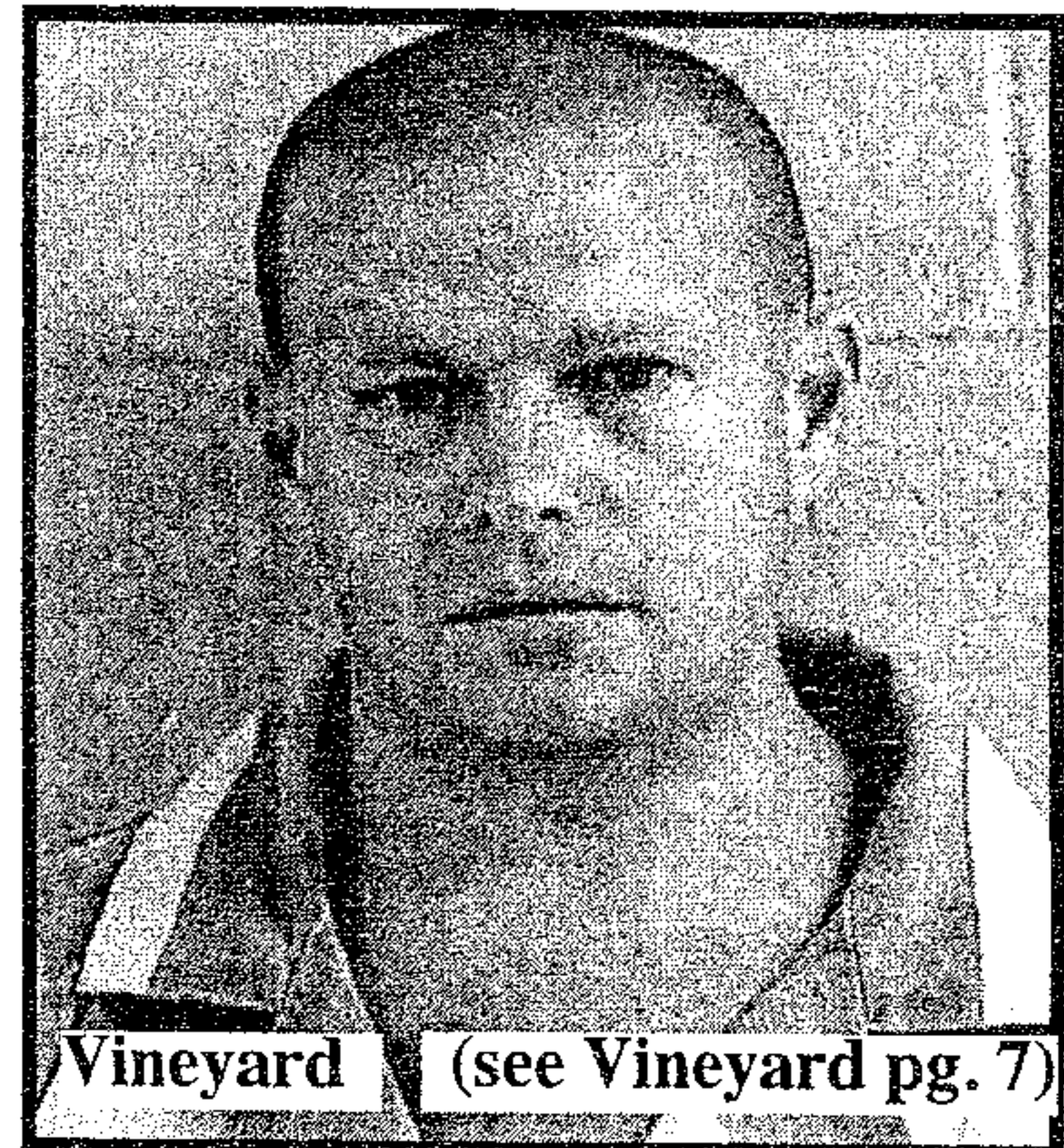

Joshua Martin Cusick, 19, Browder Hollow Road, Lenoir City was charged with aggravated burglary.

According to reports, Monday, at approximately 8:15 PM, Lt. Adam J. Yokley, LCSO was dispatched to meet officers from the Lenoir City Police Department

at 3660 Browder Hollow Road due to Officer Jason Felts, LCPD finding an individual inside a house that was vacant and for sale. Officer Felts stated he was

traveling on Johnson Drive when he noticed a door open at that residence. When he pulled up to the house he observed a white male inside the house coming from behind the refrigerator. He ordered him out of the house and identified him as Joshua M. Cusick. Mr. Cusick stated he thought someone else was inside the house.


Lt. Yokley went inside and saw the refrigerator was pulled away from the wall and a power outlet was pulled from the wall. There was also two screw drivers on the stove. The window in the kitchen was pushed up and dust on the counters had been

disturbed. There was a shoe print on the counter that was similar to what Mr. Cusick was wearing.

A small ladder was found in the back of the house outside the window Cusick had entered. Family members of Joshua Cusick identified the ladder as belonging to his grandfather.

The owner of the property was notified by phone and arrived at the residence. He stated the refrigerator was not pulled out from the wall and no tools were left at the residence. He didn't know Joshua Cusick and did not give him permission to enter the residence.

Mr. Cusick was placed under arrest and transported to the Loudon County Jail.

ing 2012 dove season. The first phase of dove season opens at noon on Saturday, Sept. 1.

Mourning doves are a popular game bird and one of the most widely distributed and abundant birds in North America. More mourning doves are harvested than all other migratory bird species combined in 39 of the continental states. In Tennessee, about 40,000 hunters harvested approximately 300,000 mourning doves last year.

Landowners can earn up to \$3,000 for providing a dove field for public hunting. These fields must be available for a minimum of three priority hunt dates in September.

TWRA began its leased dove field program in the late 1980s and the program has been very successful in providing quality hunting opportunities for hunters. In addition to leased fields, many public dove fields are provided on wildlife management areas in each TWRA region. The TWRA website has specific information about WMAs and

leased dove fields in each region.

The standard fall leased field is a harvested grain or millet/hay field to which TWRA leases the hunting rights for three priority dates. Rates paid to landowners for traditional fall leased fields will be \$75 per acre for a maximum field size of 40 acres for a total contract of \$3,000 per field. These fields will be signed up by Sept. 1.

Anyone interested in leasing a dove field to TWRA should contact their TWRA regional office. The TWRA has four regional offices across the state that interested landowners can contact. Drunken mom fails to protect son from drunken sister, both go to jail

A local mother is accused of failing to protect her young child when her allegedly drunken sister terrorized him. It was reported the mother, who also was drunk, had been gone three days and had showed up drunk while her child and one of his friends were being abused by her older sister.

Jennifer Leona Mayfield, 39, Shaw Ferry Road, Lenoir City was charged with child abuse and public intoxication.

Dawn Elizabeth Collins, 45, Markwood Road, Loudon was charged with public intoxication.

According to reports, Deputy Stegall, LCSO responded to Shaw Ferry Road Monday, on two unwanted guests who were intoxicated and scaring an eight year old child. Upon arrival, the officer made contact with an eight year old male cowering beside the residence and two females drinking in the driveway in public view.

The deputy spoke with the boy and he

stated his mother, Jennifer Mayfield, and her sister, Dawn Collins, were intoxicated and scaring him. He further stated he'd had a friend over and Dawn Collins started yelling at both of them, causing them to be afraid for their safety and his mother had let her sister abuse them and his friend left.

Collins had a strong odor of alcohol about her and when she started to raise her voice again at the juvenile she was taken into custody. While Collins was attempting to scare the boy, Mayfield did nothing to stop her.

Deputy Stegall then turned his attention to Mayfield.

According to the homeowner, Mayfield had been gone for three days and had showed up intoxicated. She had a strong odor of alcohol about and caused a disturbance after the deputy explained she was going to be charged with child abuse for allowing an intoxicated adult to terrify her eight year old son.

Mayfield was then taken into custody and both women were transported to the Loudon County Jail. DCS was contacted.

sold and crushed and he now faces another theft charge after he reportedly tried to take a Greenback man's boat without permission.

Tyson Gary Vineyard, 34, Fox Hunters Road, Lenoir City was charged with theft of property \$1,000-\$10,000.

According to an affidavit, filed by Sgt. Detective Charles Cosner, LCSO-CID on August 9, 2012, around 10:25 AM, a Lenoir City woman reported she witnessed a white male driving a red GMC Jimmy leave her residence on National

Campground Road in Greenback pulling her stepfather's boat. She stopped the male and asked him what he was doing and he advised he was picking up the boat for another party. As the woman contacted her stepfather, the male pulled from her property and traveled on National Campground to Highway 95.

The woman's stepfather stated he did not authorize anyone to take his boat so the woman contacted authorities and gave them a description of the vehicle. When the male noticed the woman was following him, he pulled into

an unknown driveway and released the boat and trailer from his vehicle.

Later that same date, Loudon County deputies located the red GMC Jimmy matching the description parked at a location in Greenback. The vehicle ID number revealed the owner of the GMC was Tyson Vineyard and during the investigation, the woman was shown a picture line up and she made a positive identification of the male who took the boat without effective consent was Tyson Gary Vineyard.

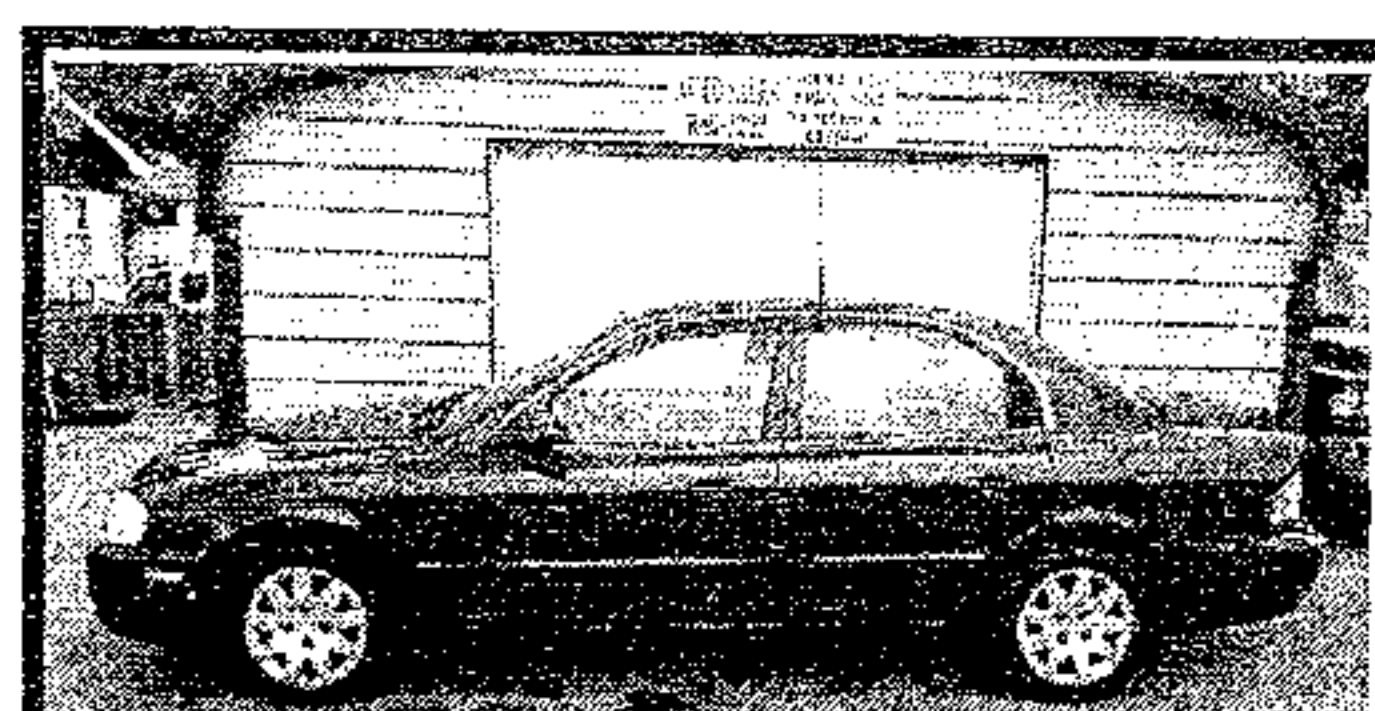

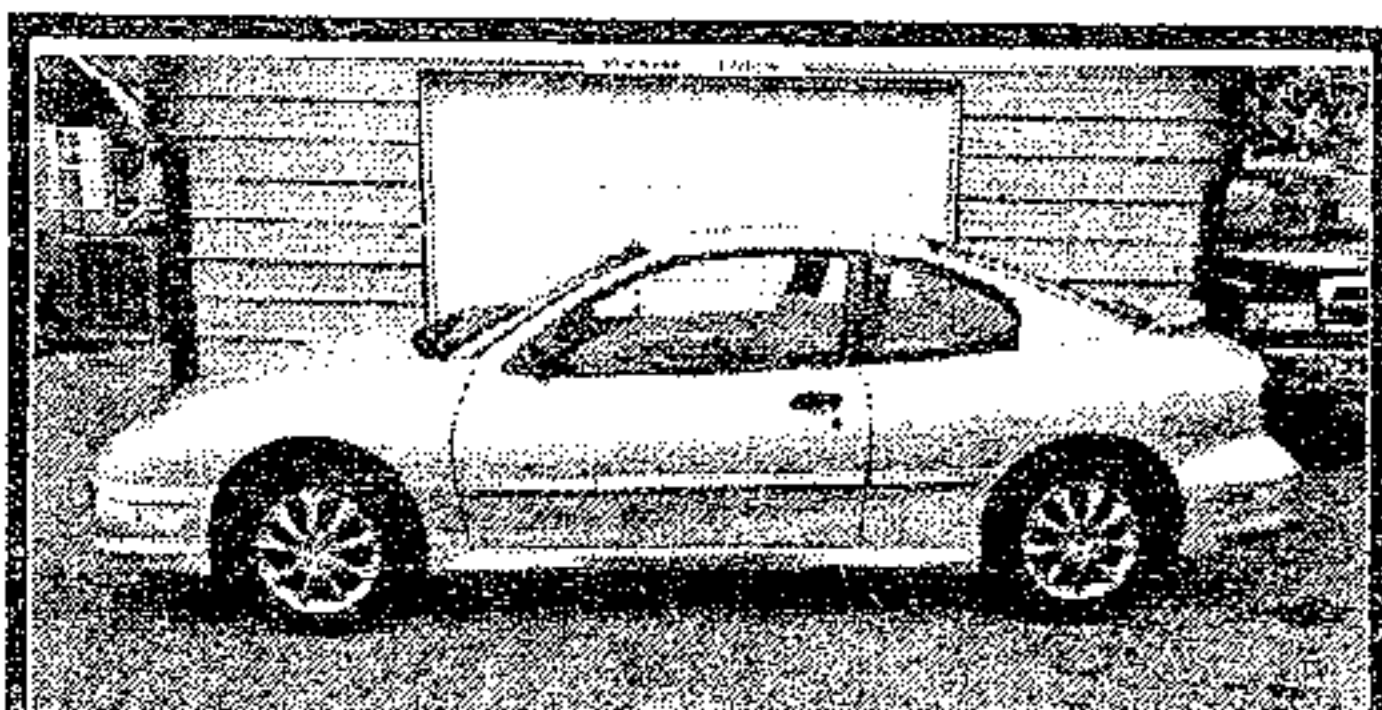

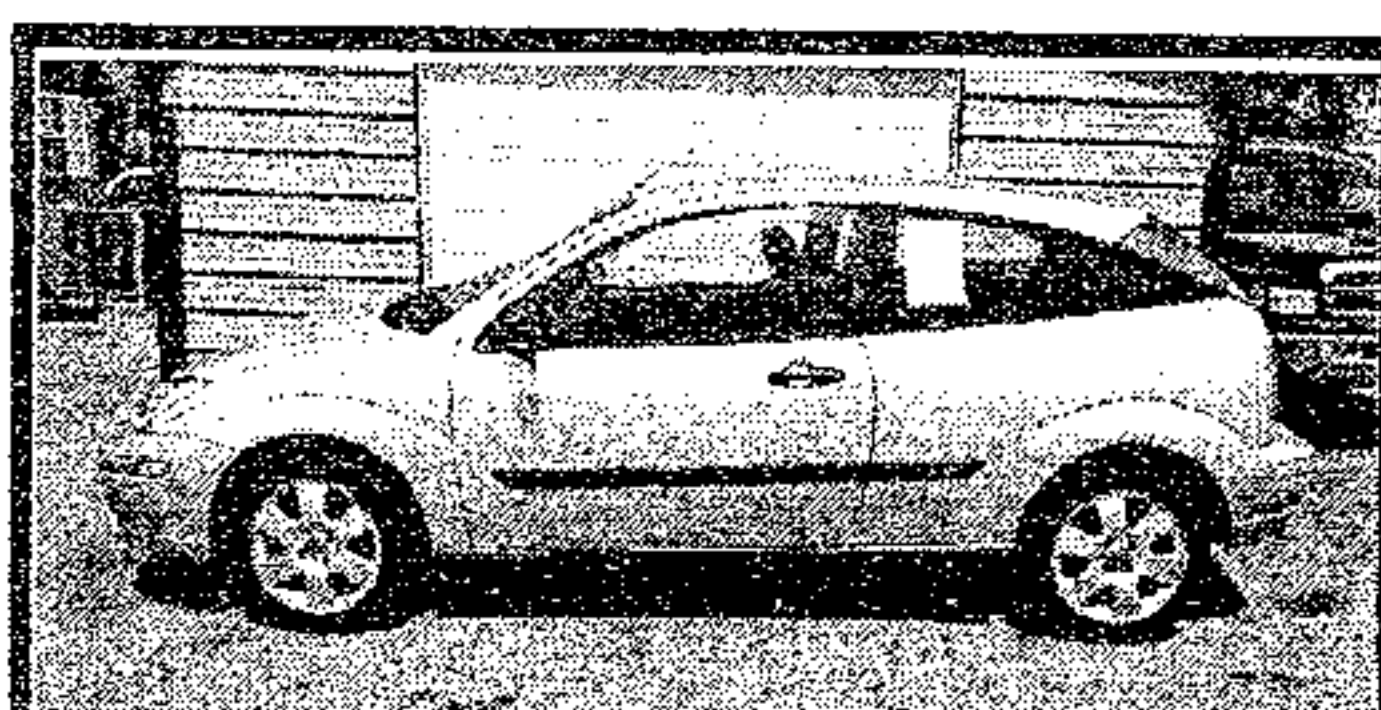
