The Deputy made contact with the driver Eric Hansard and stated that he was involved in a hit and run and has a revoked license.

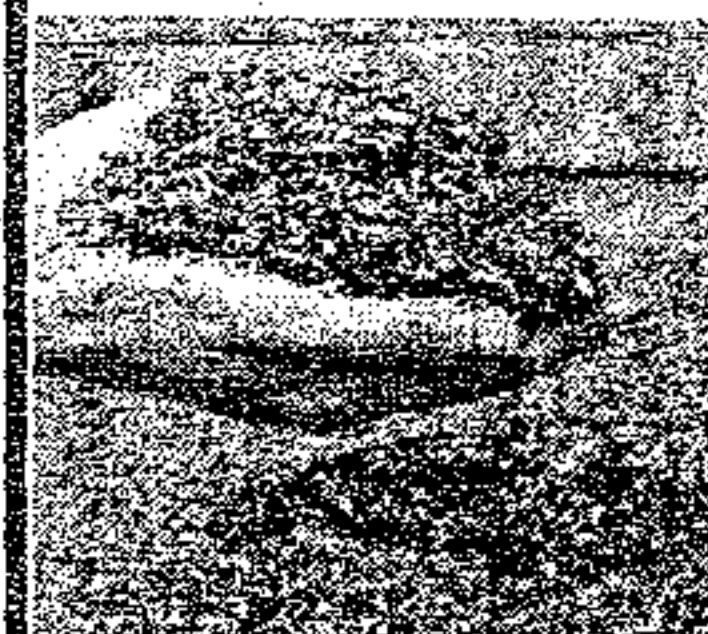

Mr. Mills left the residence and came back and started arguing and causing a scene. Mr. Mills was placed under arrest.









