

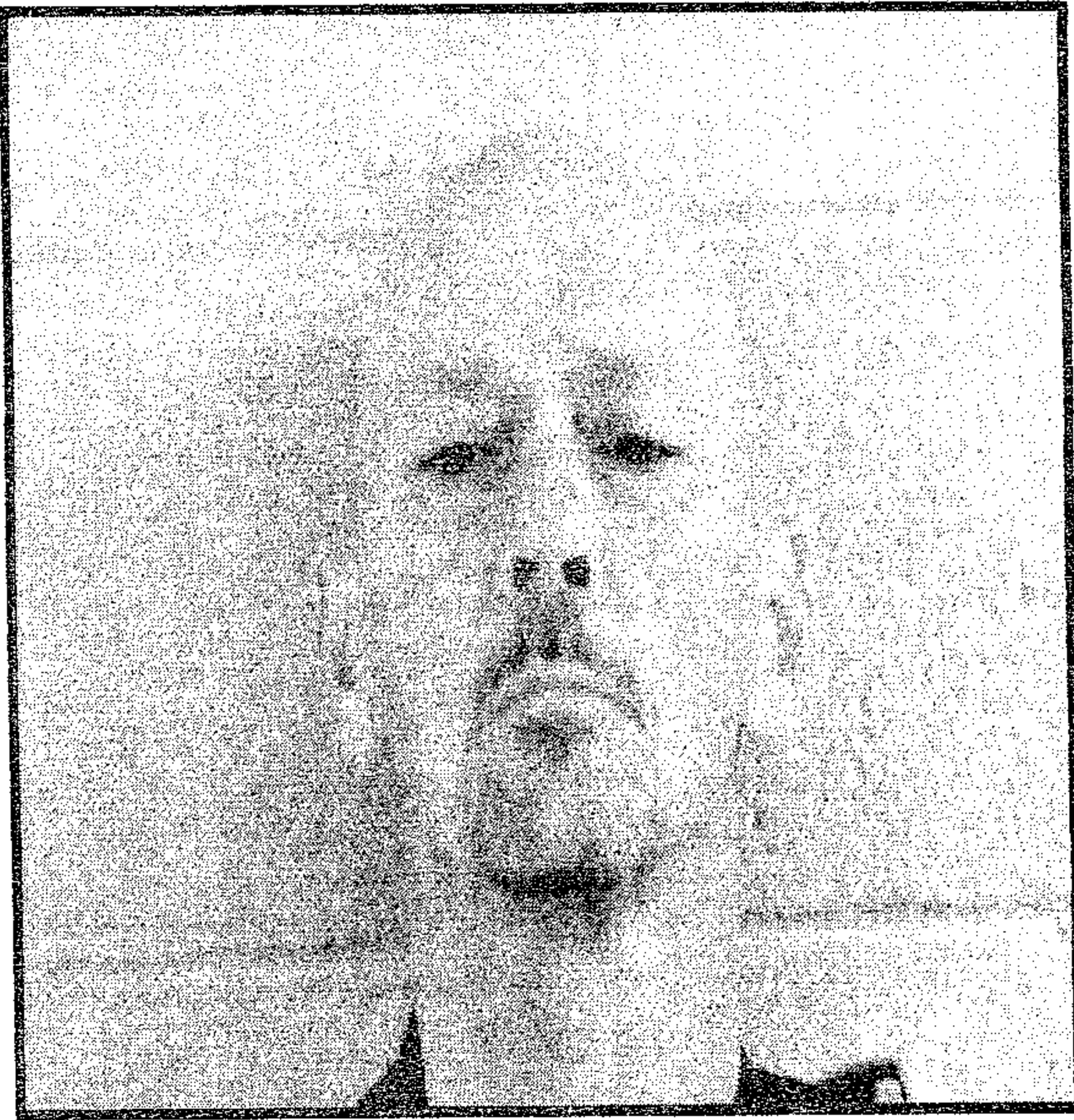

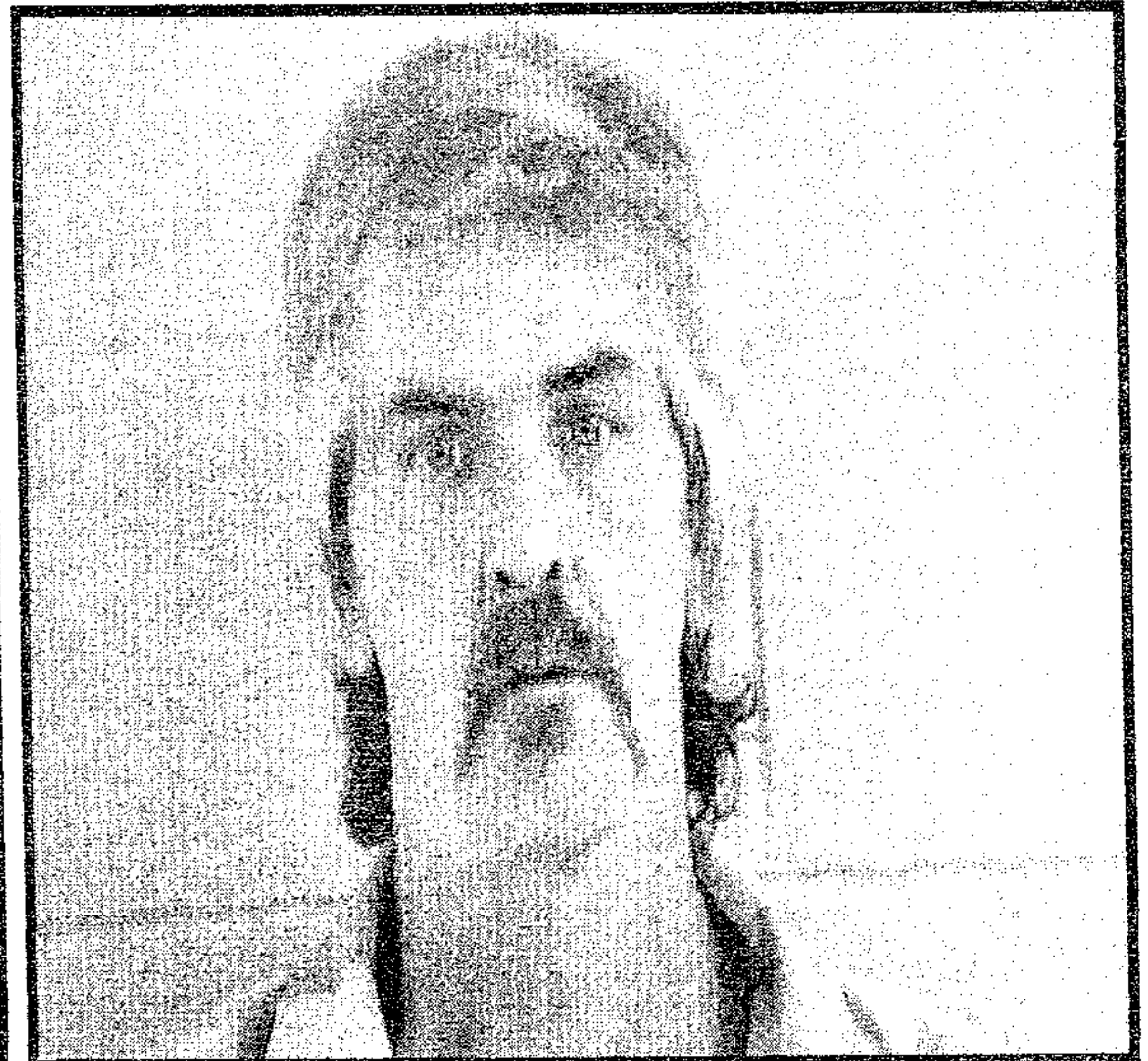
A Greenback man was charged with 2nd DUI and a weapon was found during a THP traffic stop.
