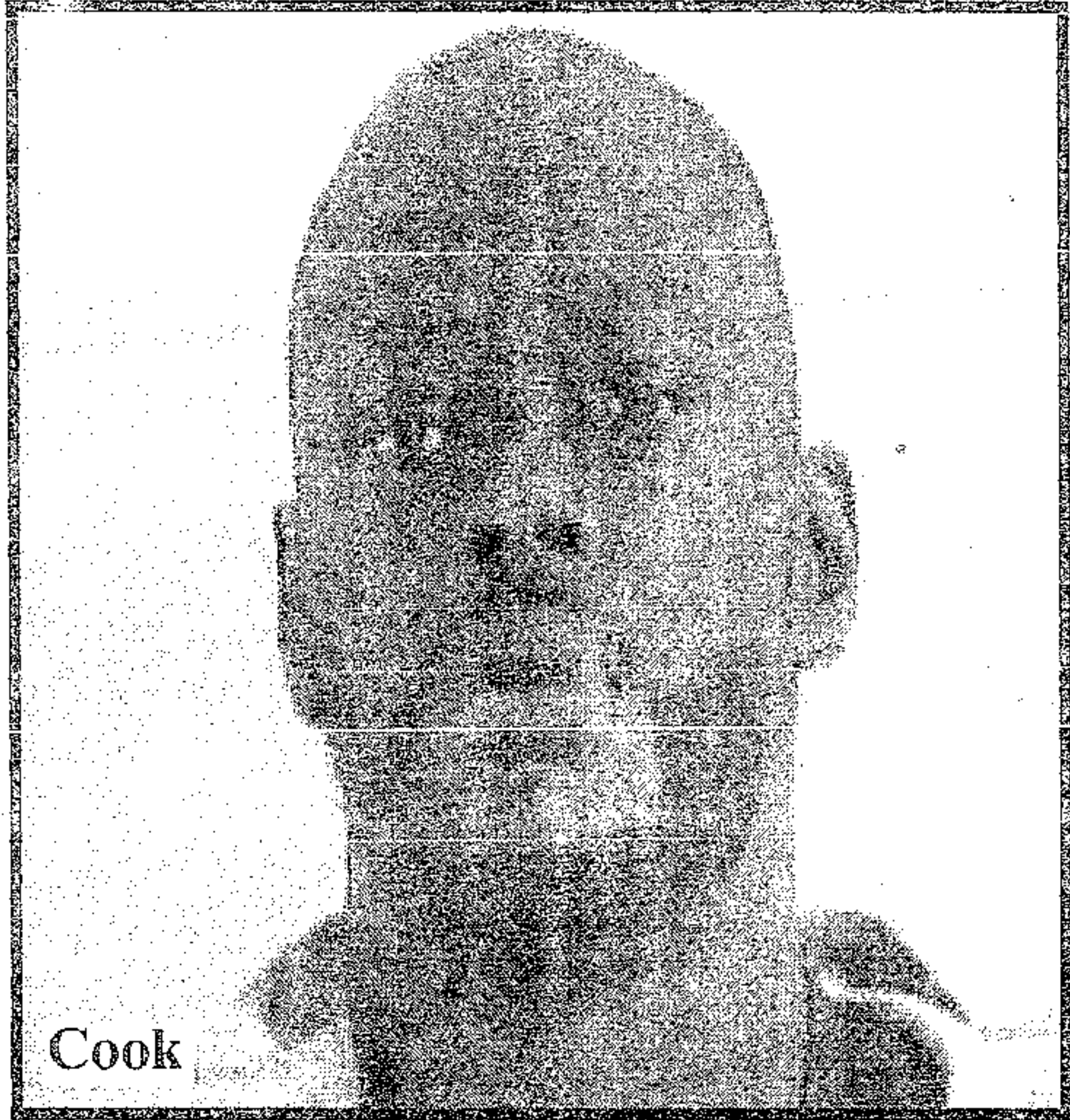

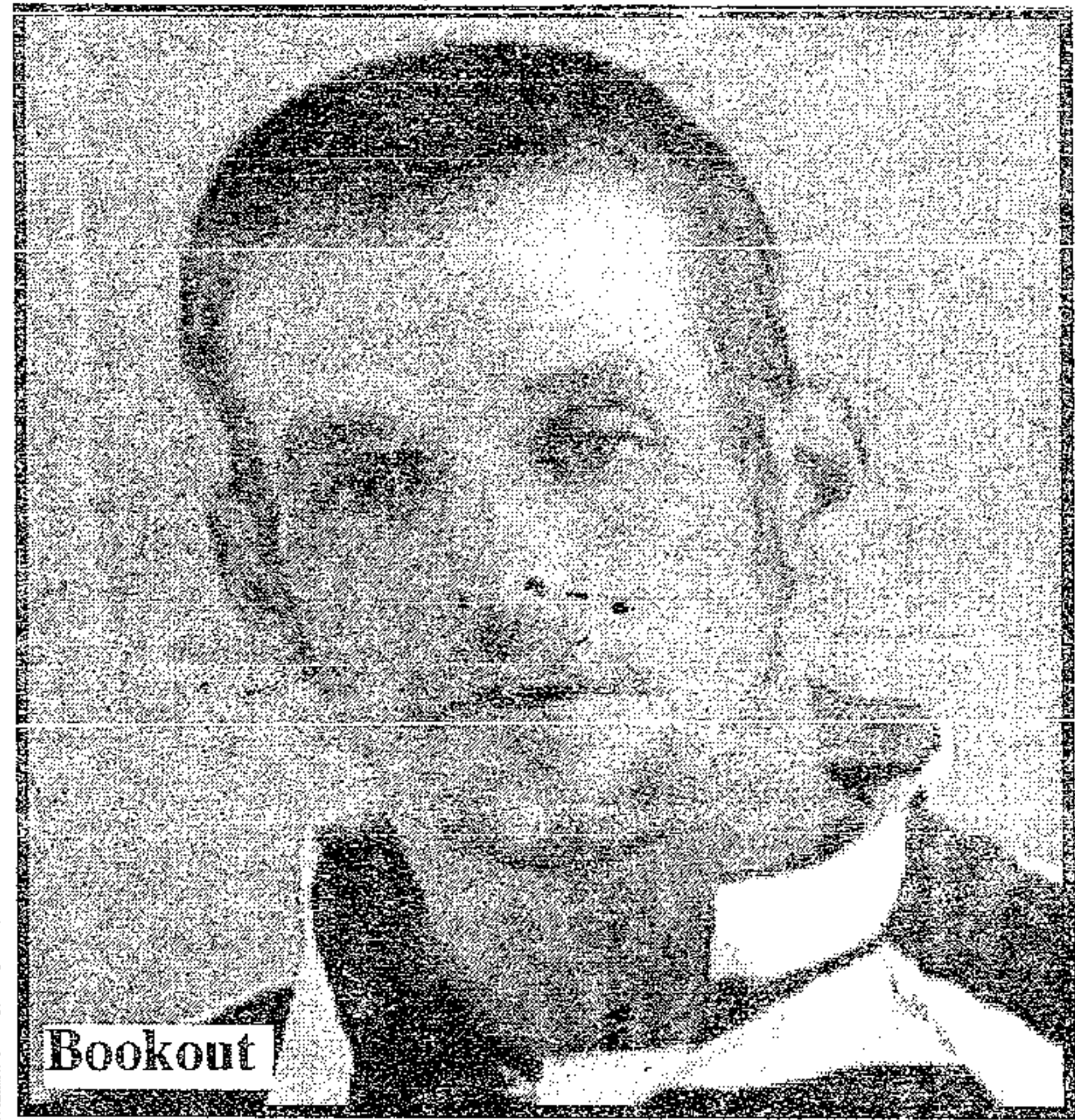

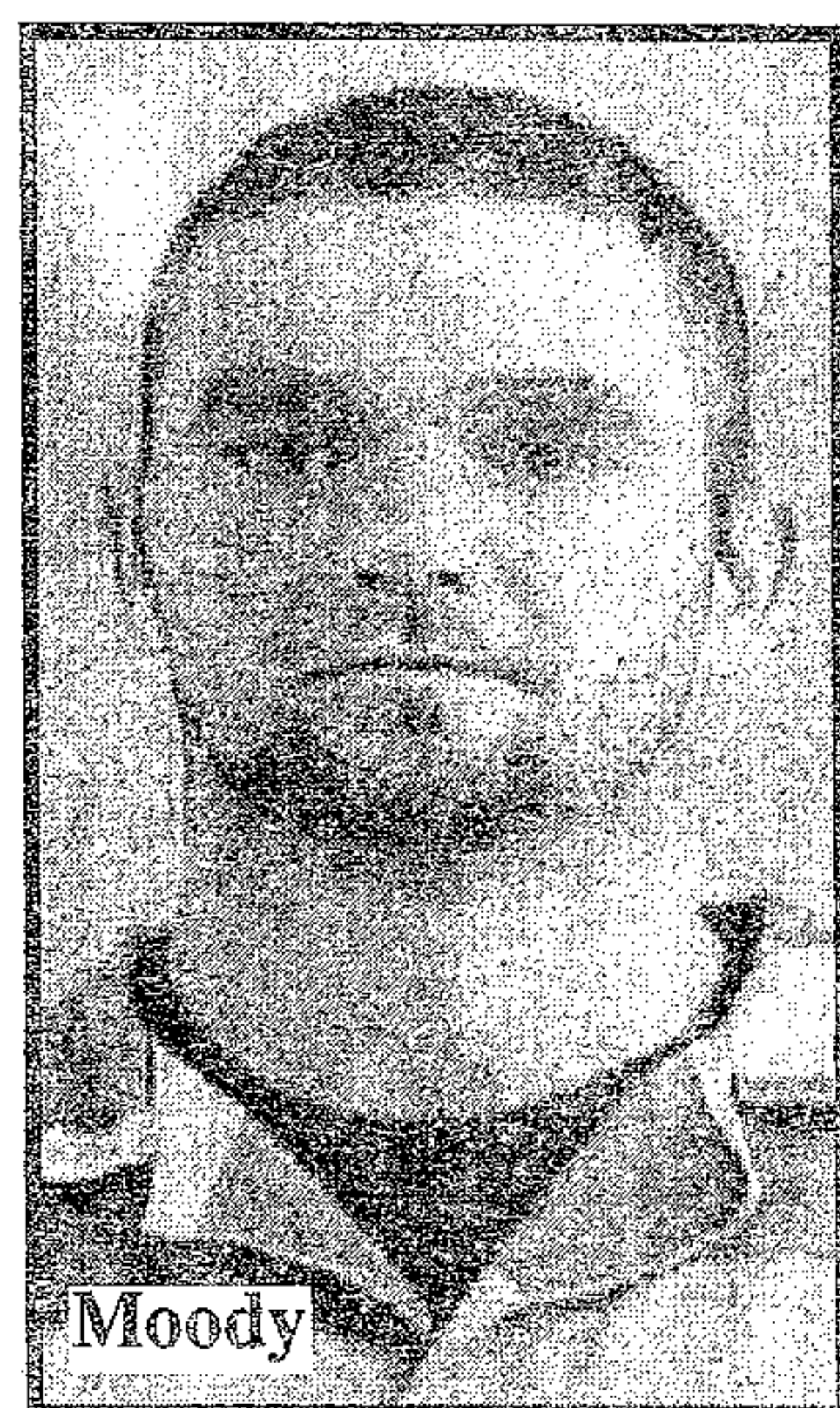

### Final Segment of 2012-13 Dove Season Underway

The third and final segment of Tennessee's 2012-13 dove hunting season is now underway. The final segment began on Dec. 19 and will continue through Jan. 15, 2013.

The daily bag limit is 15. There is no limit on collared doves. Doves not readily identifiable as collared doves will be considered mourning doves and will count toward the mourning dove daily bag limit. No person shall take migratory

game birds by the aid of baiting, or on or over any baited area. Any auto-loading or repeating shotgun must be incapable of holding more than three shells while dove hunting.

Doves are found throughout the various regions in the state, but the most concentration is in farming areas. The hunter must have on his/her person a valid state hunting license and Tennessee Migratory Bird Permit at all times while hunting. Hunters

must have landowner's permission to hunt on private land.

More information on Tennessee's dove season can be found on the Tennessee Wildlife Resources Agency website ([www.tnwildlife.org](http://www.tnwildlife.org)) under the "For Hunters" section. The 2012 Tennessee Hunting & Trapping Guide can also be viewed on the website or a copy may be obtained at any TWRA regional office or wherever hunting and fishing licenses are sold.

I have discovered, however, that the changes I have truly prayed about and felt God leading me to make have been much more successful than my usual resolutions.

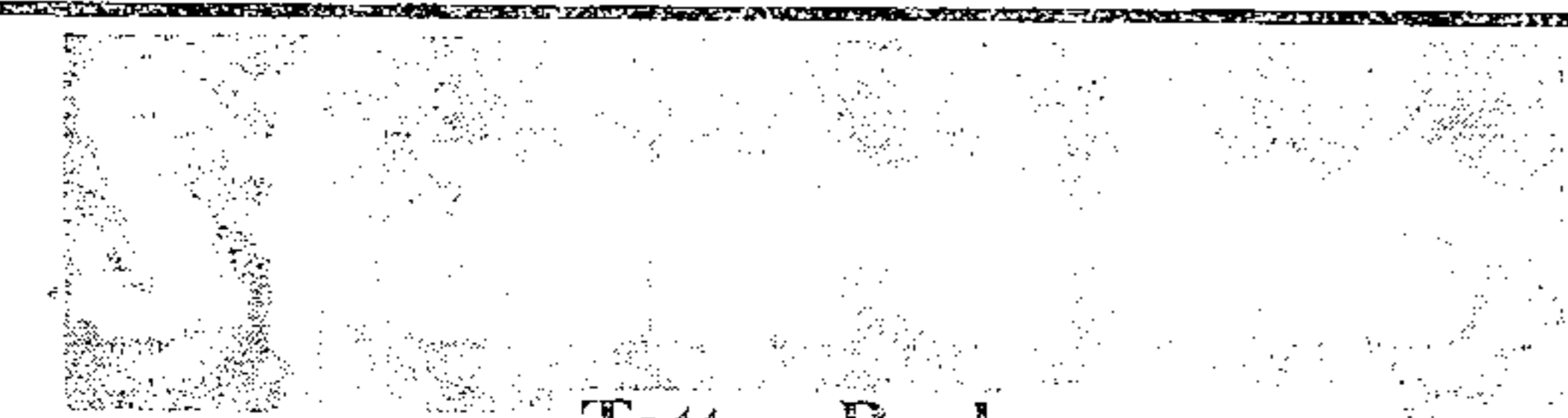

Rex Allen Hawkins, 29, of Hwy 411 South, Greenback, was charged with simple possession of mari-

juana and possession of drug paraphernalia.

Chad Price Dugan, 19, homeless, was charged with interfering with a legal writ.

According to the reports, Deputies Chris Hutchens, Jim Stegall and Tony Branson went to the residence of Rex Hawkins for a Blount

County warrant charging Rex Allen Hawkins with aggravated robbery. Upon arrival, Hawkins was seen trying to flee through the back door and was taken into custody.

At the front door Deputy Stegall met Chad Dugan and when asked if he was Rex, Dugan stated no and he had nothing to do with the residence.

As the deputies were cuffing Mr. Hawkins, Dugan started yelling, asking if they had a warrant, and at that point he was interfering with a lawful arrest and was taken into custody.

Deputies Stegall and Hutchens made the arrests.

In another set of

reports, the Loudon County Sheriff's Office Narcotics Unit conducted a search warrant at the residence of Rex Allen Hawkins located at 7203 Highway 411 South, Greenback.

An active "one-pot" meth lab was found in a kitchen closet. Two sets of digital scales, coffee filters with a white powder residue, starting fluid, mason jars, marijuana grinder and a jar containing exposed lithium strips were found in the kitchen.

A mirror with white powder residue was found, along with a razor blade, marijuana stems, rolling papers, burnt aluminum foil with residue in the living room. A white powder substance that tested positive for methamphetamine was found in the carpet.

Rex Allen Hawkins, Frank Alan Moody, Chad Price and Cheryle Ann Smith were present when officers arrived at the residence. All four were taken into custody and charged with manufacturing methamphetamine and

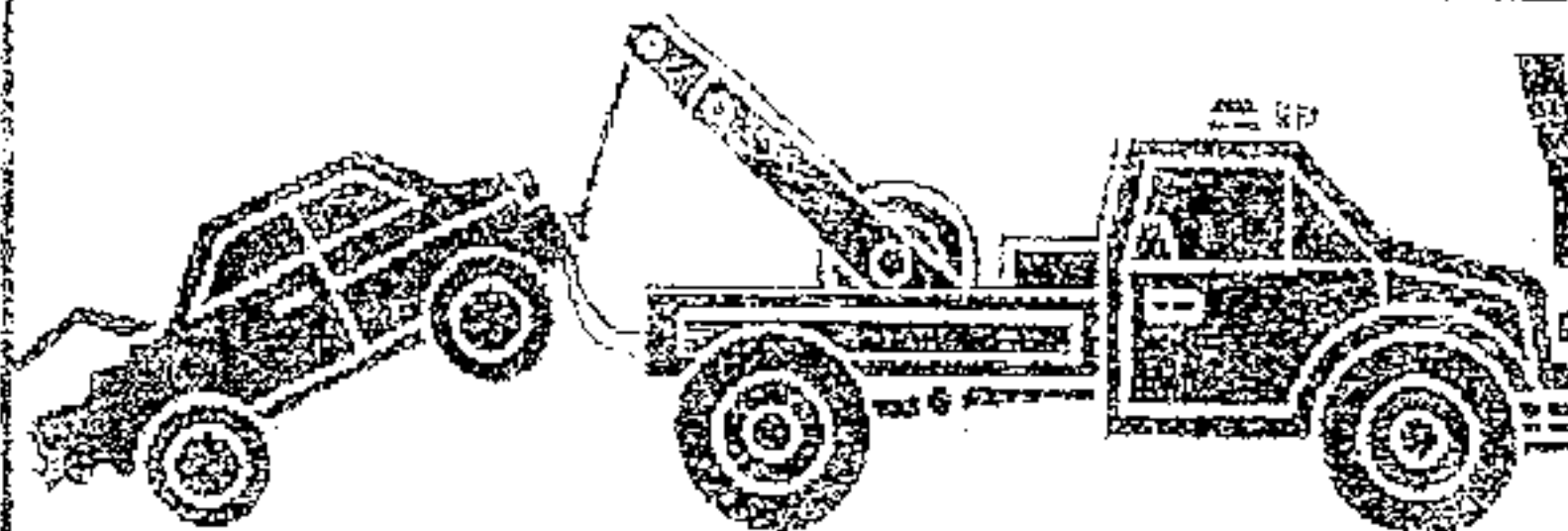
