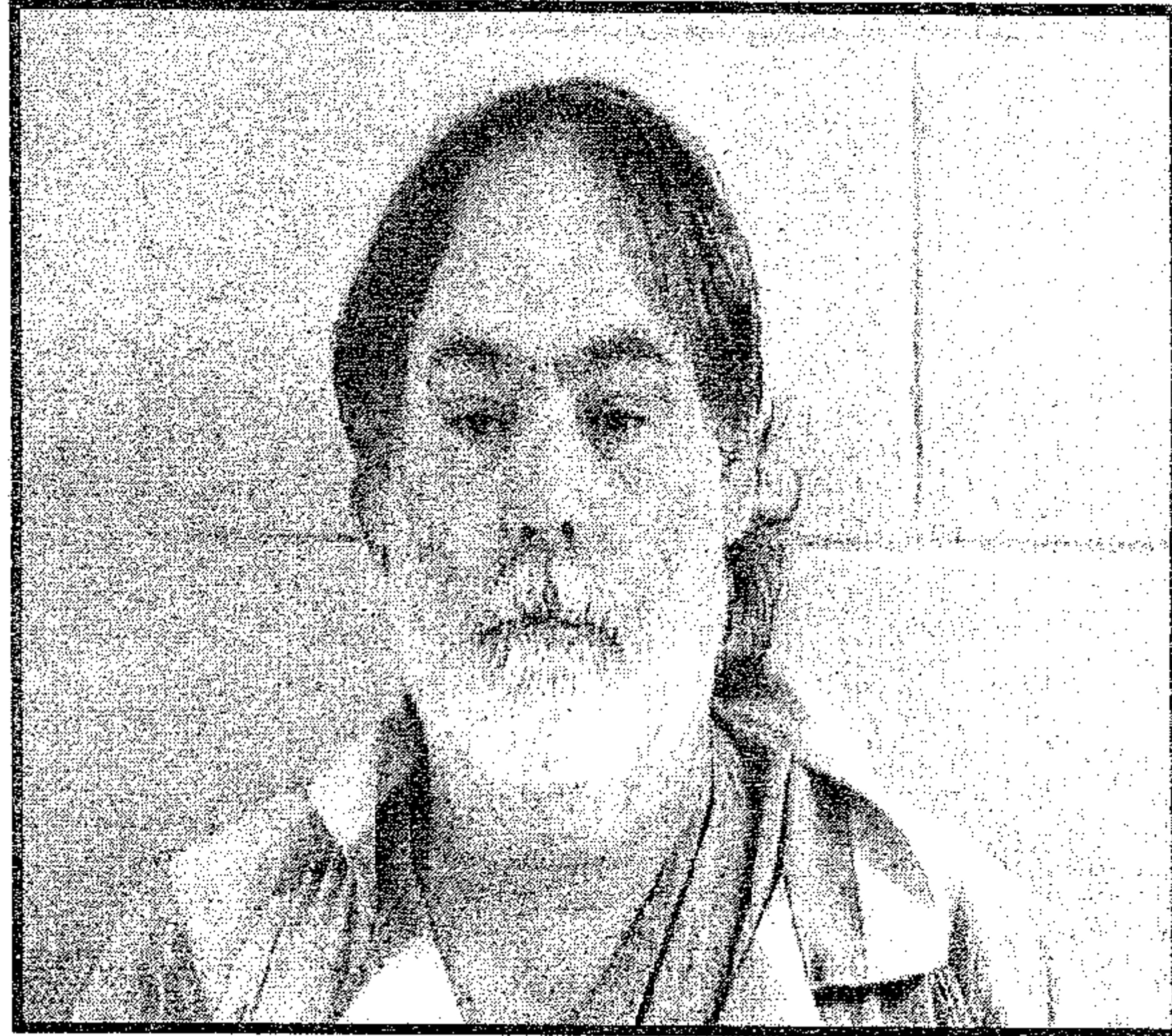

## Greenback news

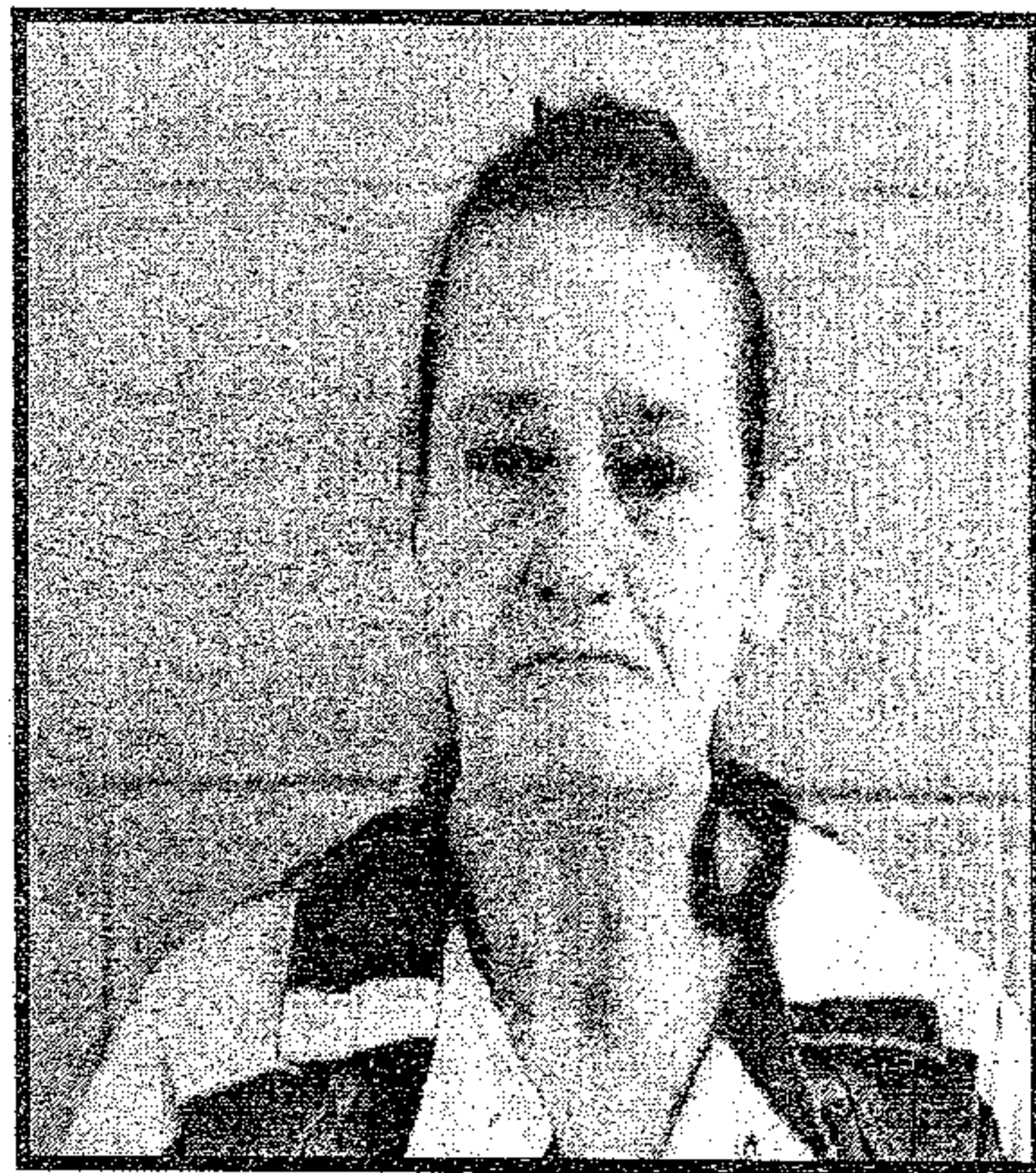
