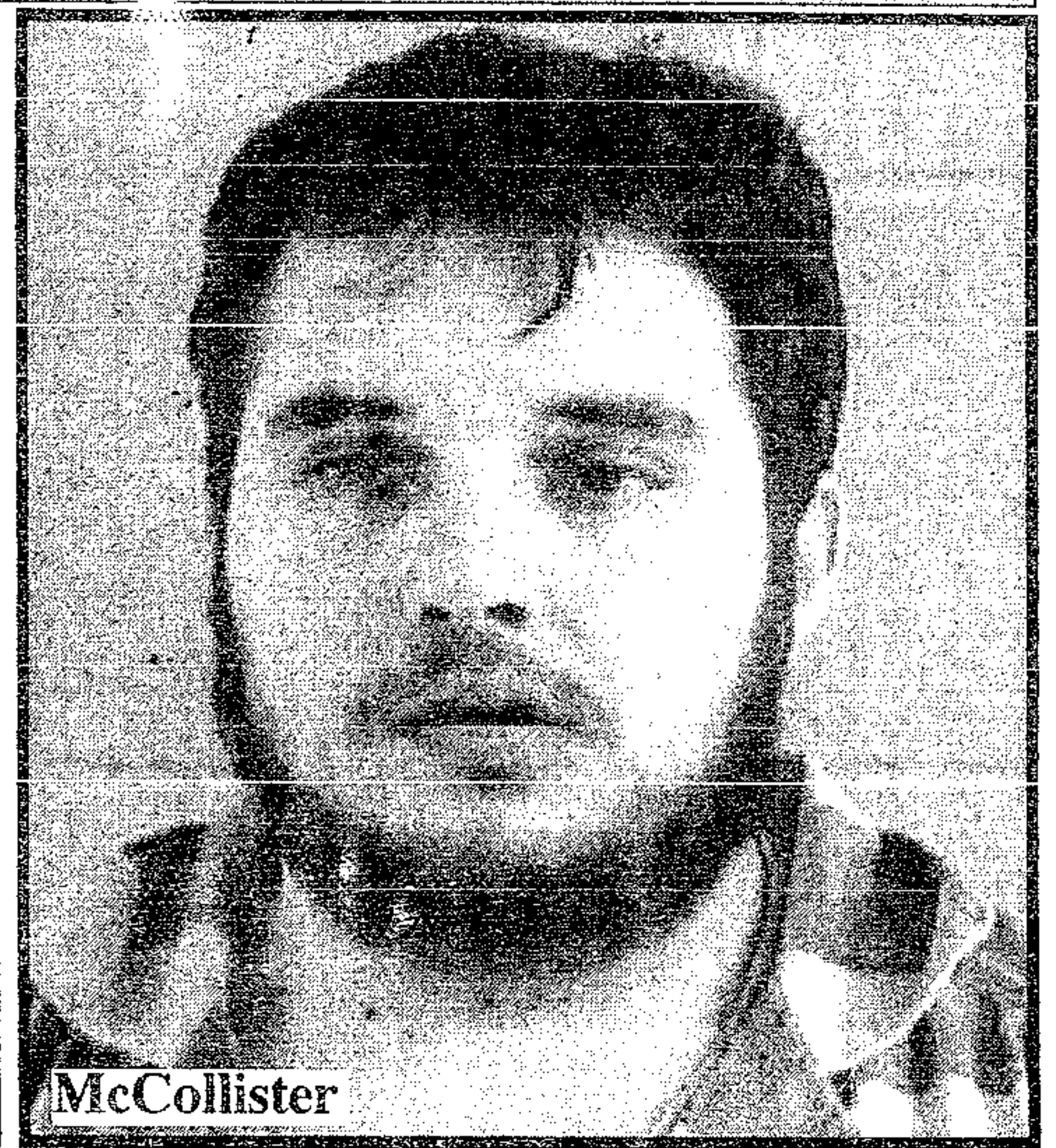

Upcoming releases include March 13-East Fork Shoal Creek (Lawrenceburg), March 21-Shelby Bottoms Park (Nashville) and Cowan City Park, March 22-McCutcheon Creek (Spring Hill) and Harpeth River

(Franklin). The Franklin stocking has been moved to Pinkerton Park at the Tennessee Highway 96 bridge.

The trout will average about 10 inches in length. The daily creel limit is seven, but there is no size limit.
