Bust

According to the report, Officer K. Sennett, LCPD was dispatched to Grayson Freedman Lane, Lenoir City for a possible drunk driver in a white pickup. The officer made contact with the vehicle and the driver was identified as Aaron Grizzle. The officer then approached the vehicle and there was a front seat passenger identified as Auburn Yates and another in the left rear seat identified as Joshua

Ferguson. Mr. Grizzle then stated to the officer he had a violation of probation and a check confirmed Grizzle had a VOP out of Lenoir City.

Mr. Grizzle and Ms. Yates began to become very nervous and moving all over. While talking to the parties a bag of 20 blue pills identified as Diazepam were located just outside the passenger side window on the ground. Three bags of a green leafy substance believed to be mari-

juana weighing approximately 40 grams were located outside the passenger window as well under the unattended vehicle next to them. During a search of the vehicle an additional 14 acetaminophen and hydrocodone were located in the rear of the vehicle in a blank pill bottle.

When Ms. Yates was brought to the jail an additional five methadone 40mg pills, in one bag and one in another bag were located in her bra.

Aaron Jerry Grizzle, 31, of Jane Way, Lenoir City, was charged with possession of schedule IV with intent to resale, possession of schedule VI with intent to resale, possession of schedule III with intent to resale and VOP.

Auburn Cassie Yates, 27, of Jane Way, Lenoir City, was charged with possession of schedule VI with intent to resale, possession of schedule IV with intent to resale, possession of schedule III with intent to resale, possession of schedule II with intent to resale. Officer K. Sennett, LCPD made the arrests.

into a penal facility. Deputy Pamela Snow, LCSO made the arrest.
