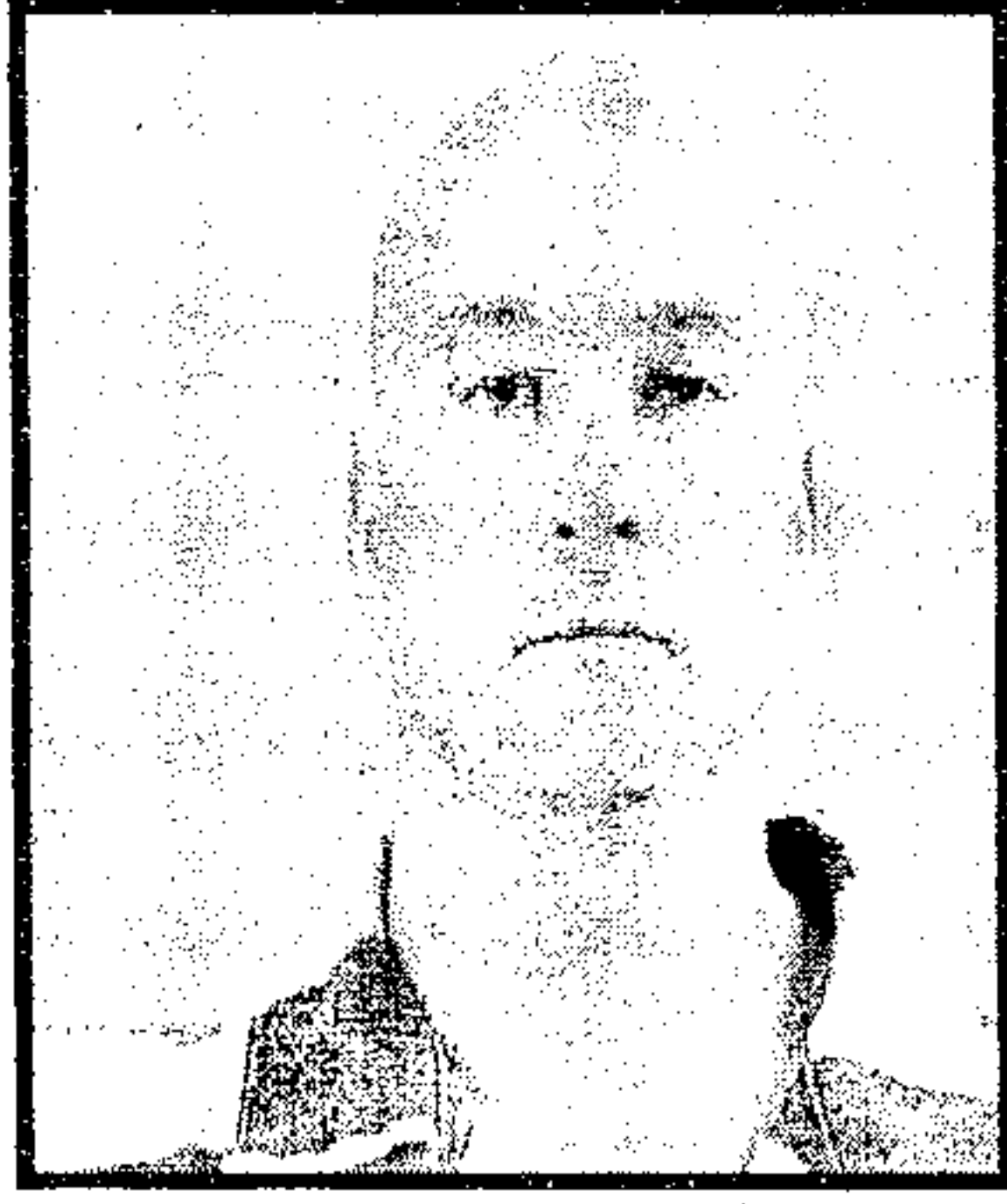

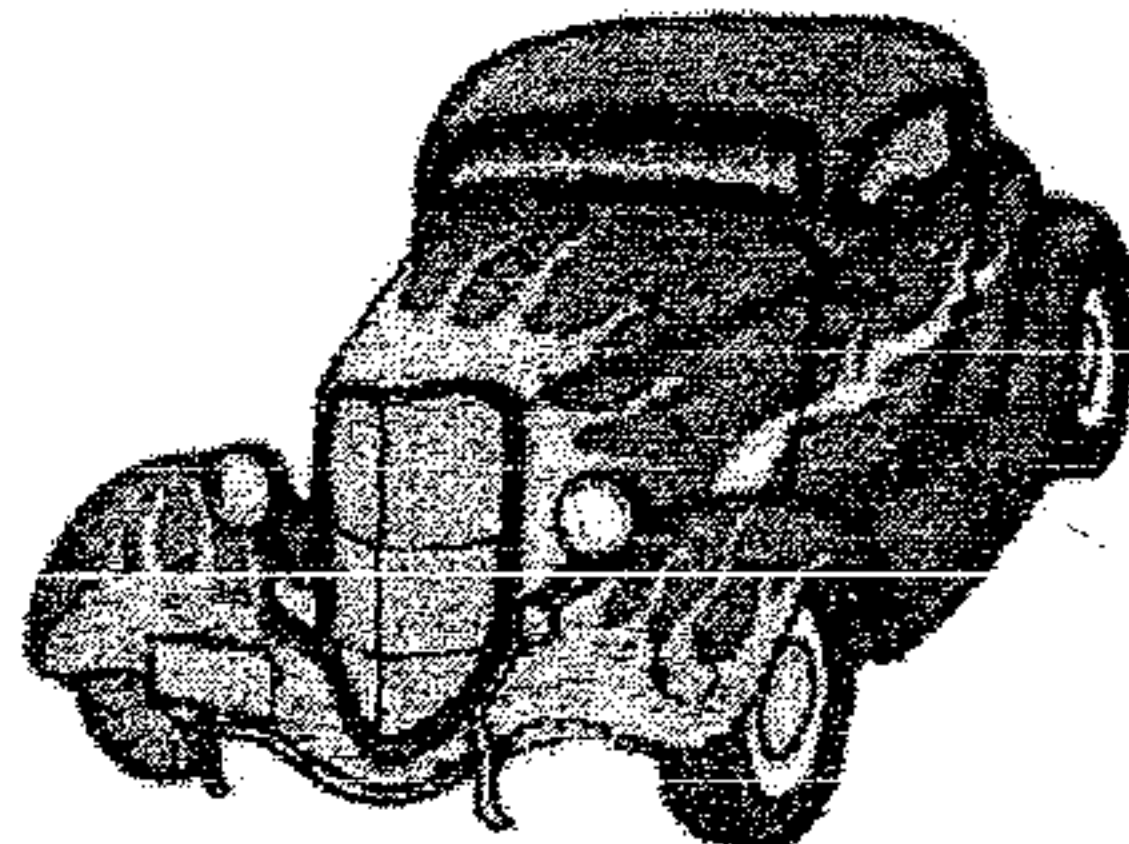
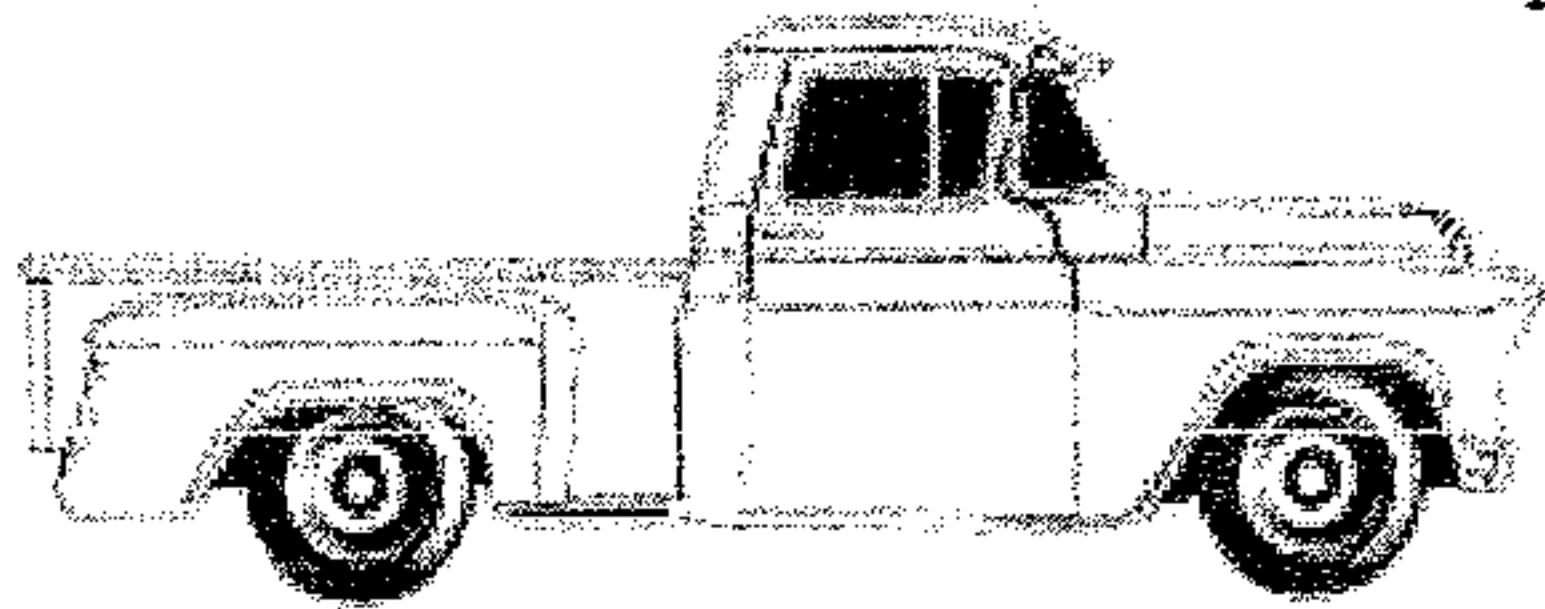

Bust

According to the reports, Investigator Shane Ezell, LCSO ND observed three females in a blue Chevy Cavalier at the Walmart in Lenoir City. A fourth female, identified as Lola Pennington was knelt down inside the passenger door talking to the passenger, Nicole Ann Gibson.

The investigator observed what appeared to be hand-to-hand transaction of narcotics. Lola walked back to her vehicle, a white Mercury Sable, and got in the drivers seat. A white male passenger identified as Michael D. Ross II. When the investigator approached Pennington

she was backing out of the parking space and would not stop. The investigator reported he identified himself, and showed proper ID yet Pennington refused to stop, put the vehicle in drive and accelerated rapidly almost striking the officer and pushed him into a parked car.

Lt. Paul Curtis activated his lights and pursued the vehicle to a location on Simpson Road. Investigator Ezell approached the three females and advised them they were being detained for suspicion of narcotics trafficking.

Christina Lynn Morgan was in the driver's seat and a check showed her license to be revoked for failure to file security after an

accident, Nicole Gibson was the front passenger and Tiajaunia Kelly Older was the back passenger. All three females were detained and Ms. Gibson produced a container containing 26 pills identified as Oxycodone, 7 white pills identified as Opana.

During an interview Gibson reported she was contacted by Lola wanting to purchase three oxycodone and one opana. Gibson reported the pills belonged to Ms. Older and she had hid the pills for her. Messages in the suspect's phones indicated the deal was a green upon by Gibson and Pennington. Gibson advised she gave

Lola three Oxycodone and one Opana. Gibson advised when the investigator approached the vehicle Ms. Older threw the pills to her and said "here".

In another interview Michael Ross reported he met Lola and asked her to get the pills. Mr. Ross also reported he ate one of the pills while they were running.

Tiajaunia Kelly Older, 47, of Webster Court, Loudon, was charged with sale and delivery of schedule II narcotics.

Michael Dewayne Ross II, 25, of O Street, Lenoir City, was charged with possession of schedule II narcotics and tampering with evidence.

Christina Lynn Morgan, 30, of Kelly Lane, Lenoir City, was charged with sale and delivery of schedule II narcotics and driving on revoked license.

Nicole Ann Gibson, 24, of Corinth Church Road, Loudon, was charged with possession of schedule II for resale (oxycodone), possession of schedule II for resale (oxymorphone) and sale and delivery of schedule II narcotics.

Lola Marie Pennington, 29, of Smal-len Road, Loudon, was charged with possession of schedule II narcotics and aggravated assault. Investigator Shane Ezell, LCSO ND made the arrests.


