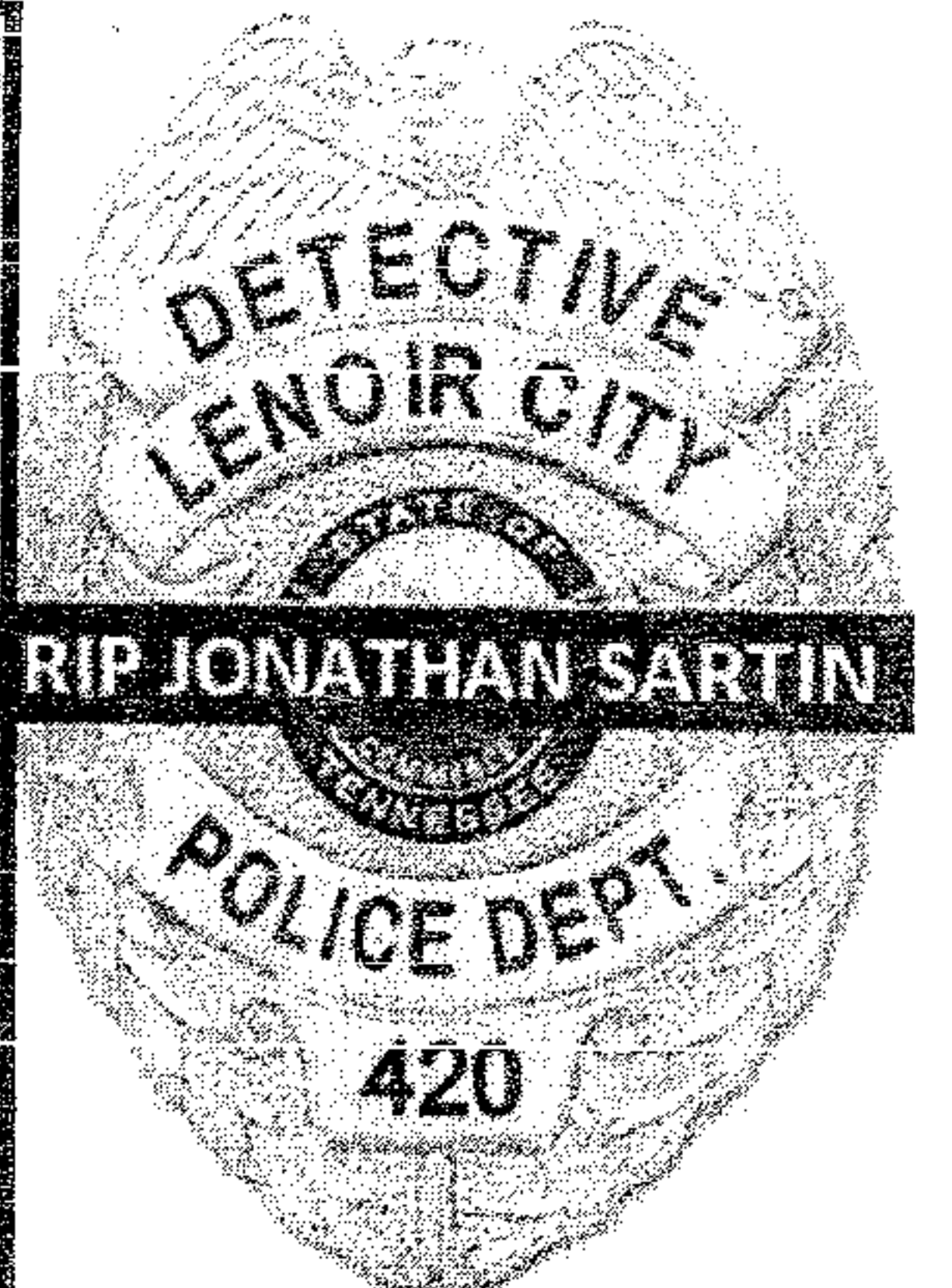
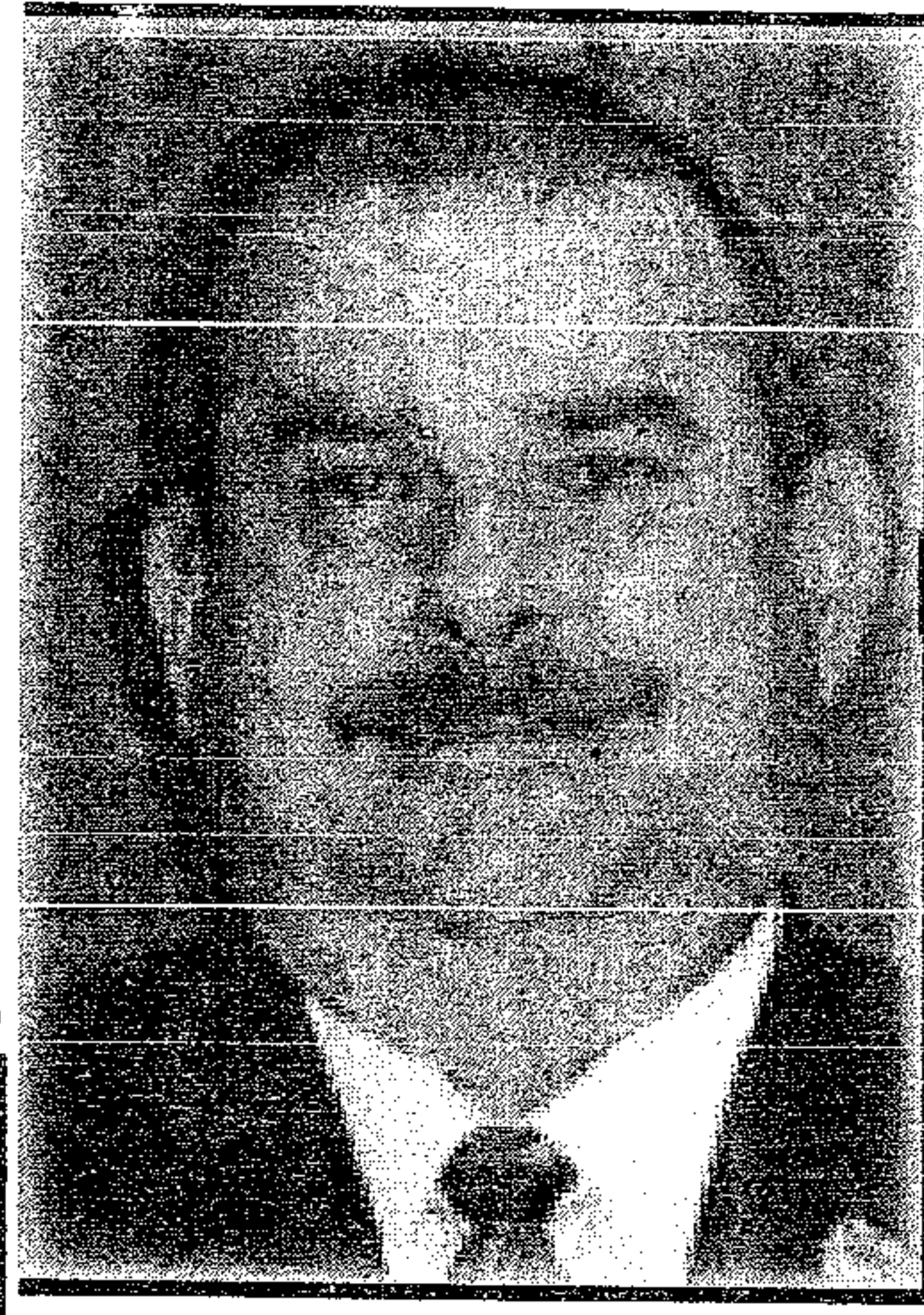
## Detective Jonathan Sartin passes Monday

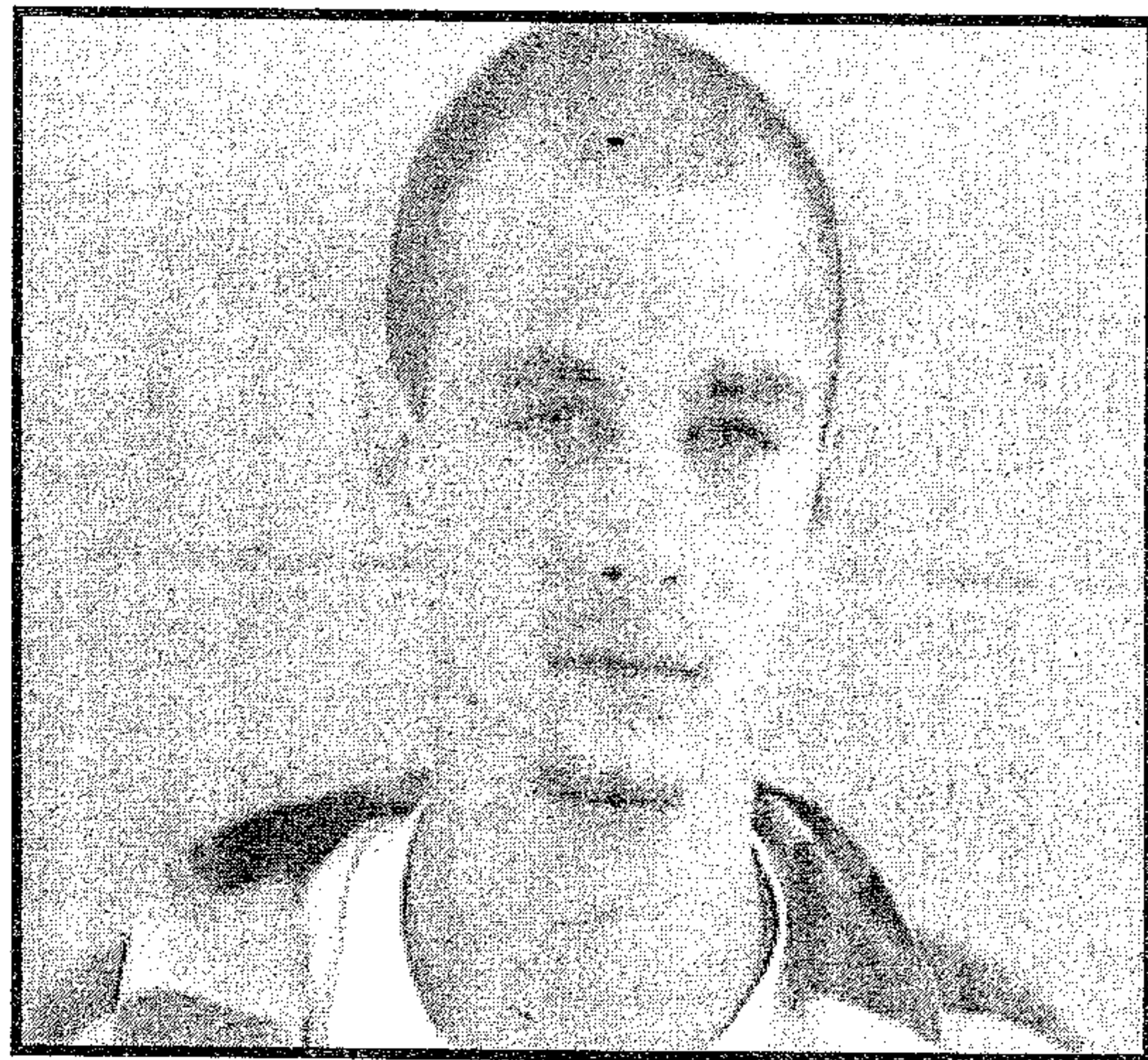

Mr. Johnson was found to have a suspended license. Deputy Charles Butler, LCSO made the arrest.

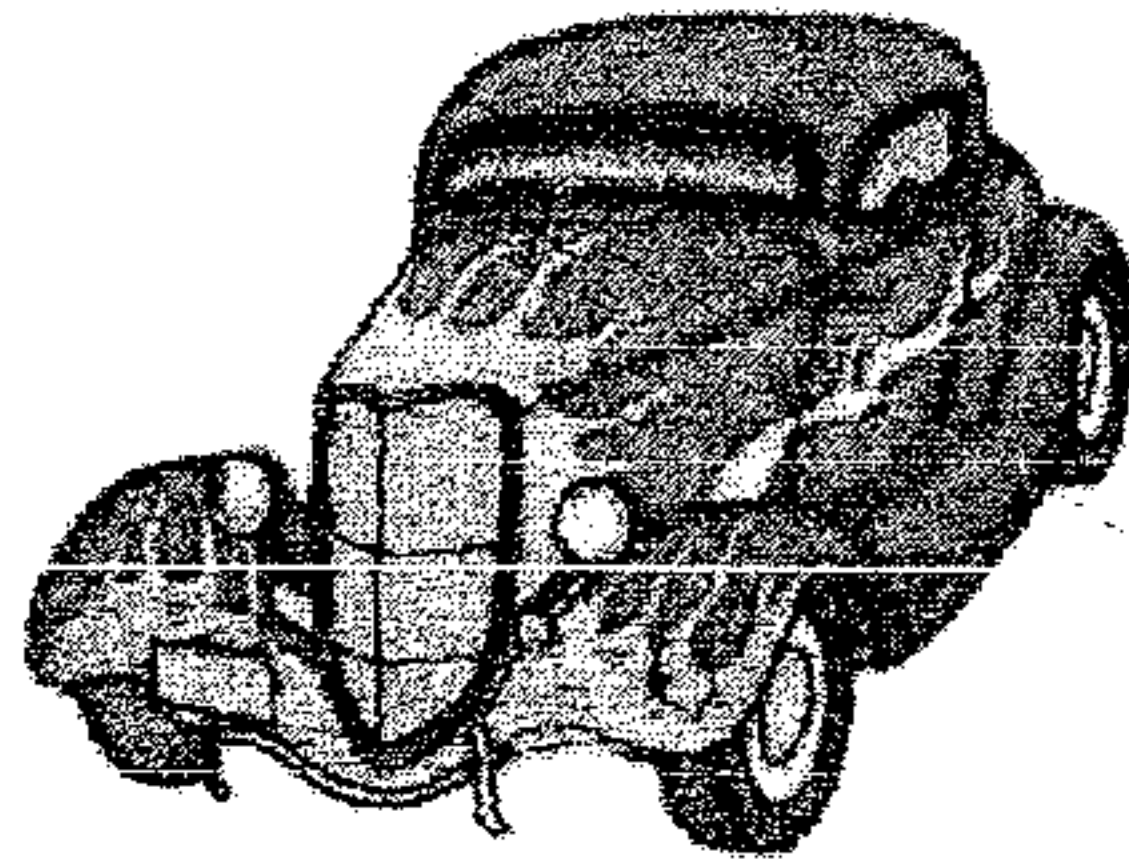
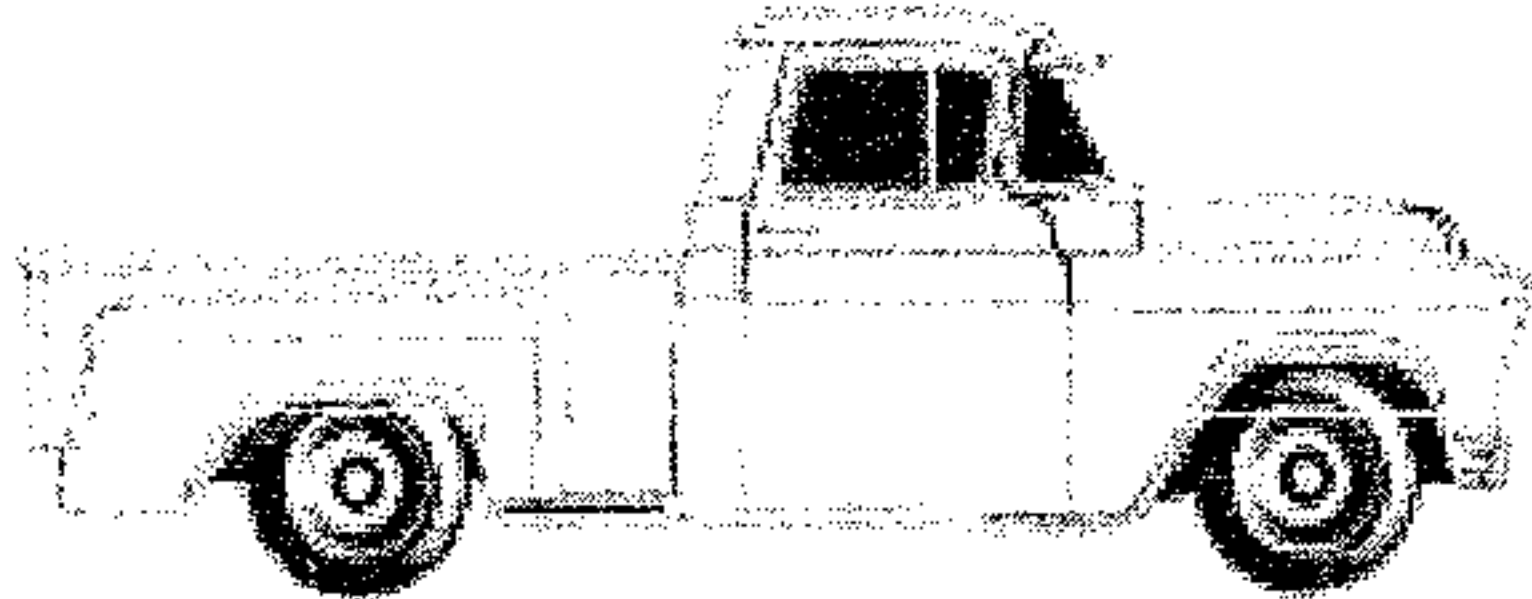

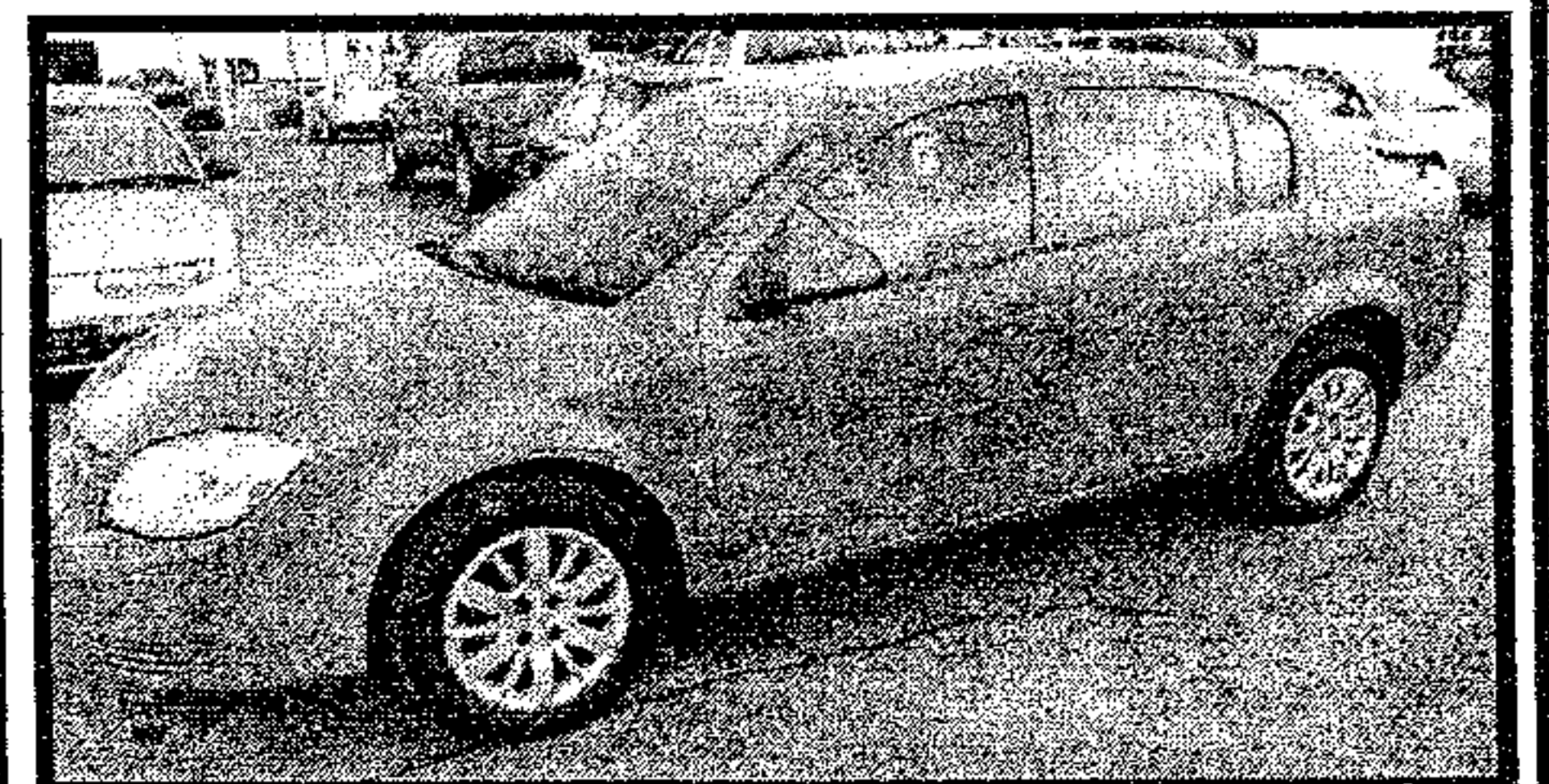
