The woman reportedly took her tips and mixed with money from the register and kept it, depriving the business of their money. The woman was also reportedly short on her register several times prior to this incident.

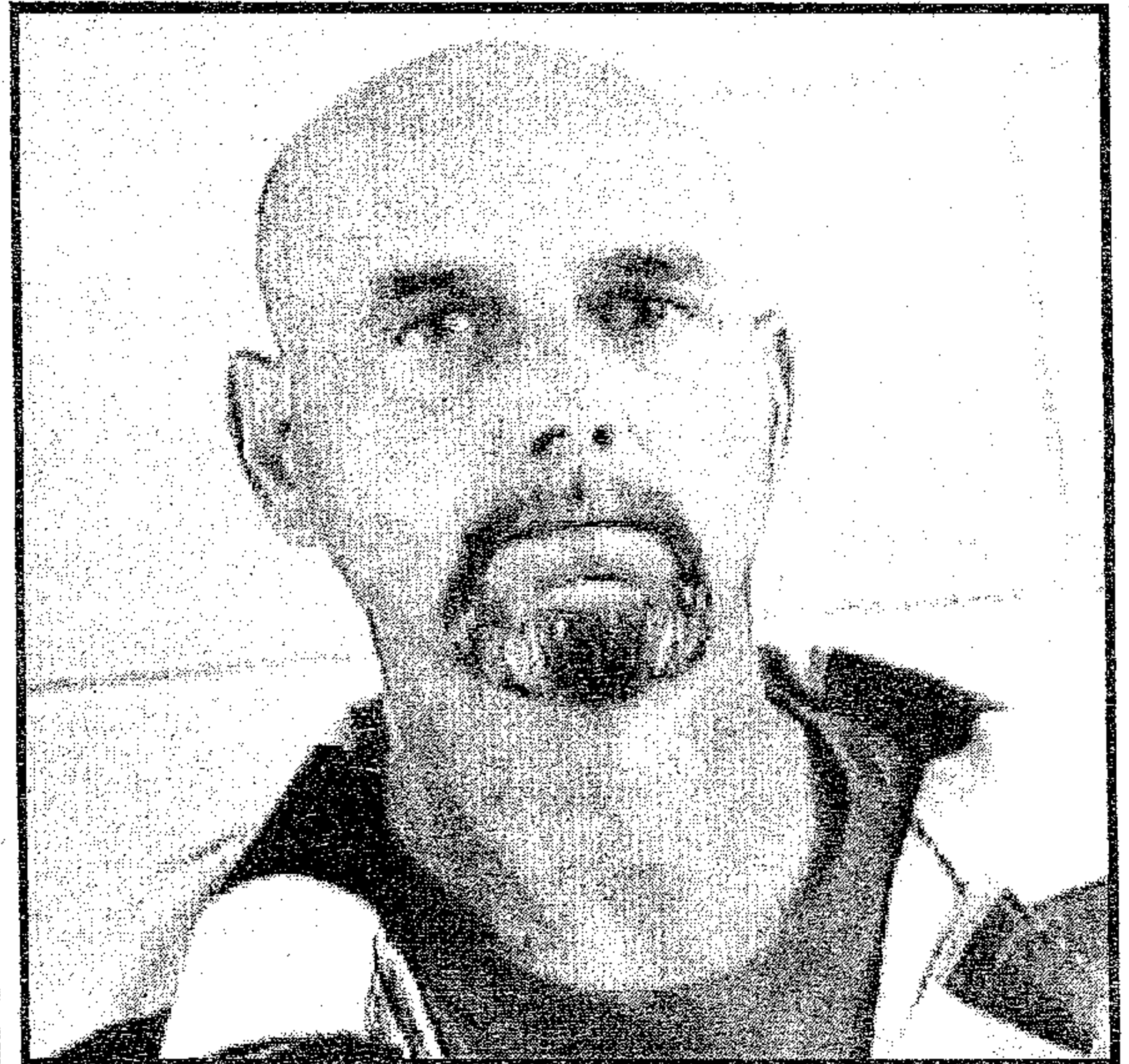

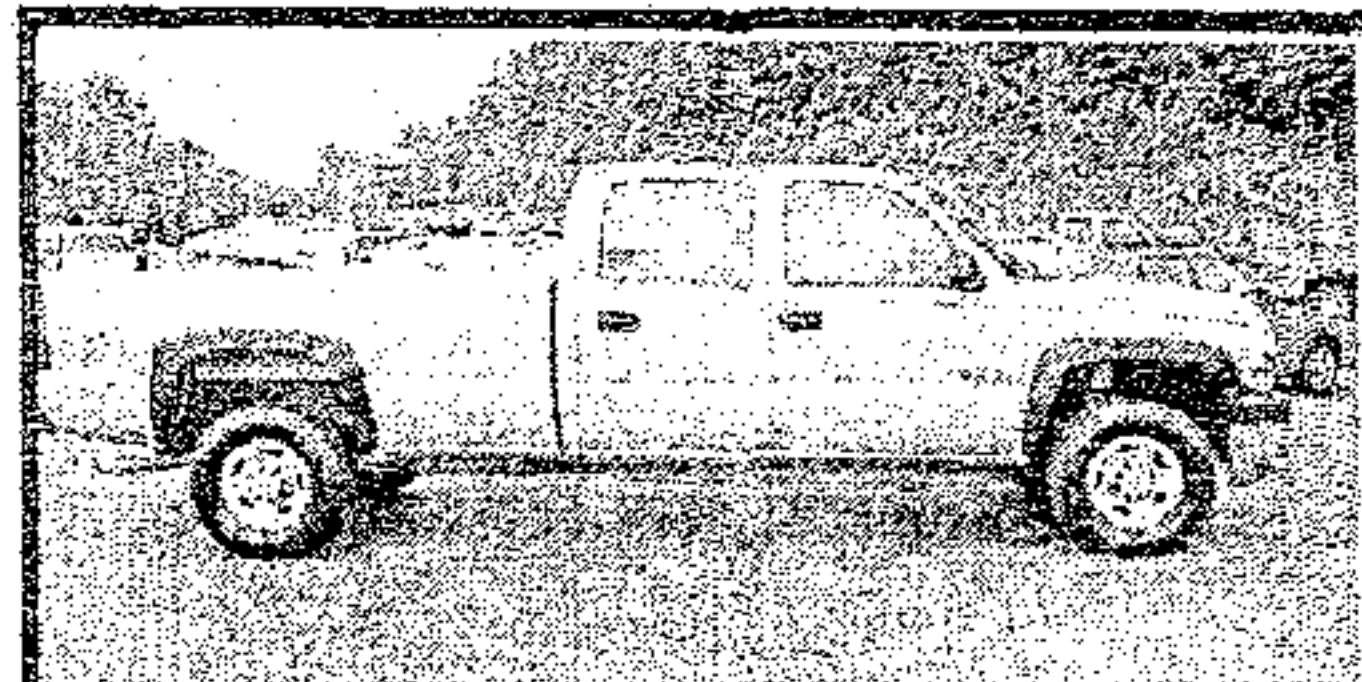

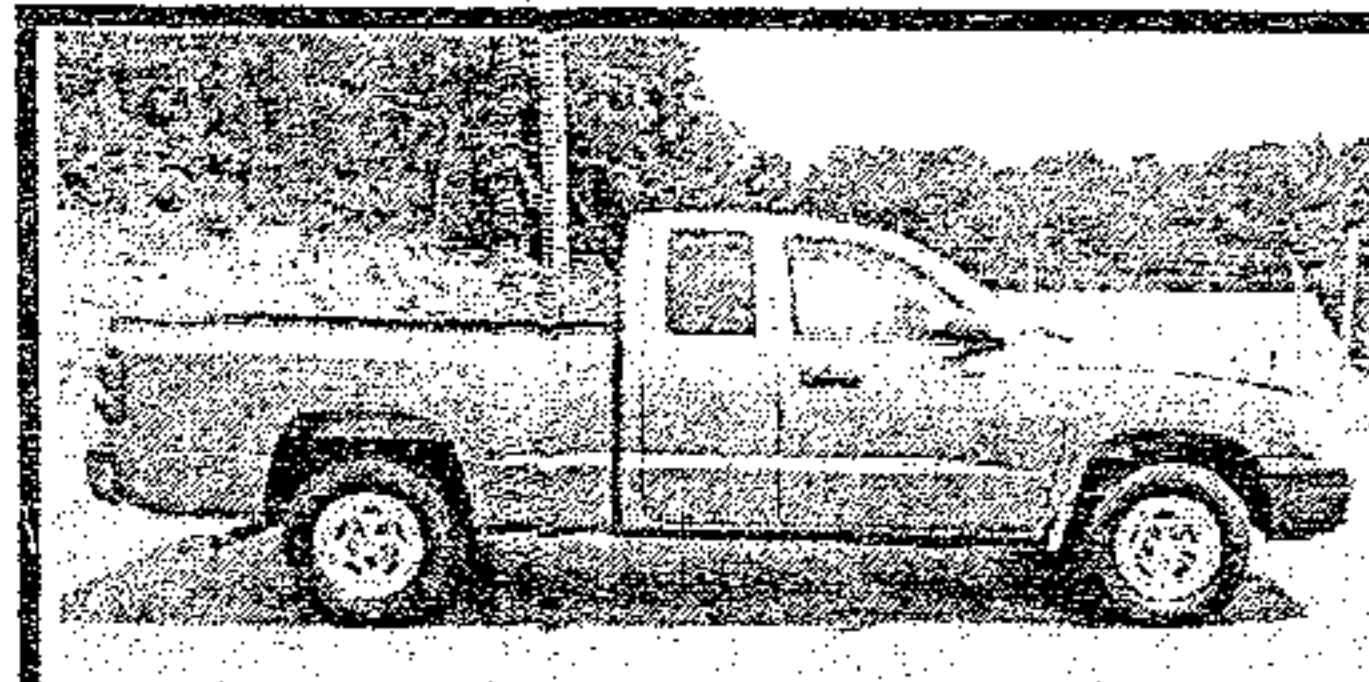
