selling as much as four kilos of the drug each month, meth was taking a toll.

"The area was being tormented," said Special Agent Dan Snow, who supervises a violent gangs and criminal enterprise squad in the FBI's San Antonio Division. "When you're addicted to meth, you will steal anything that's not bolted down to get money to

feed your habit."

In multiple Central Texas counties near Waco and Fort Hood, crime was spiking burglaries, property crimes, arsons, assaults, firearms thefts, even homicides—and when local authorities compared notes, they realized that a significant part of the crime problem resulted from the meth trade.
