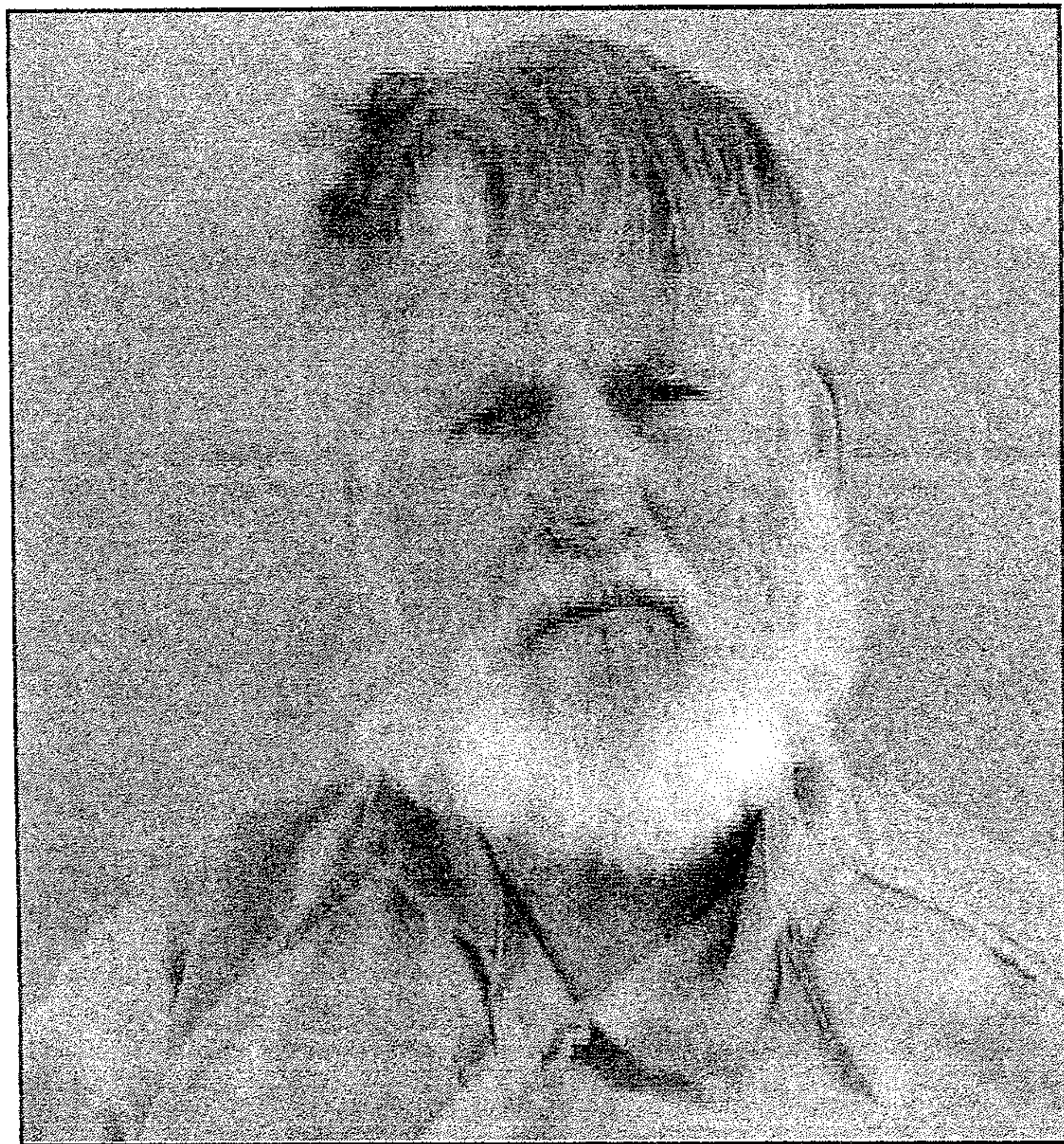


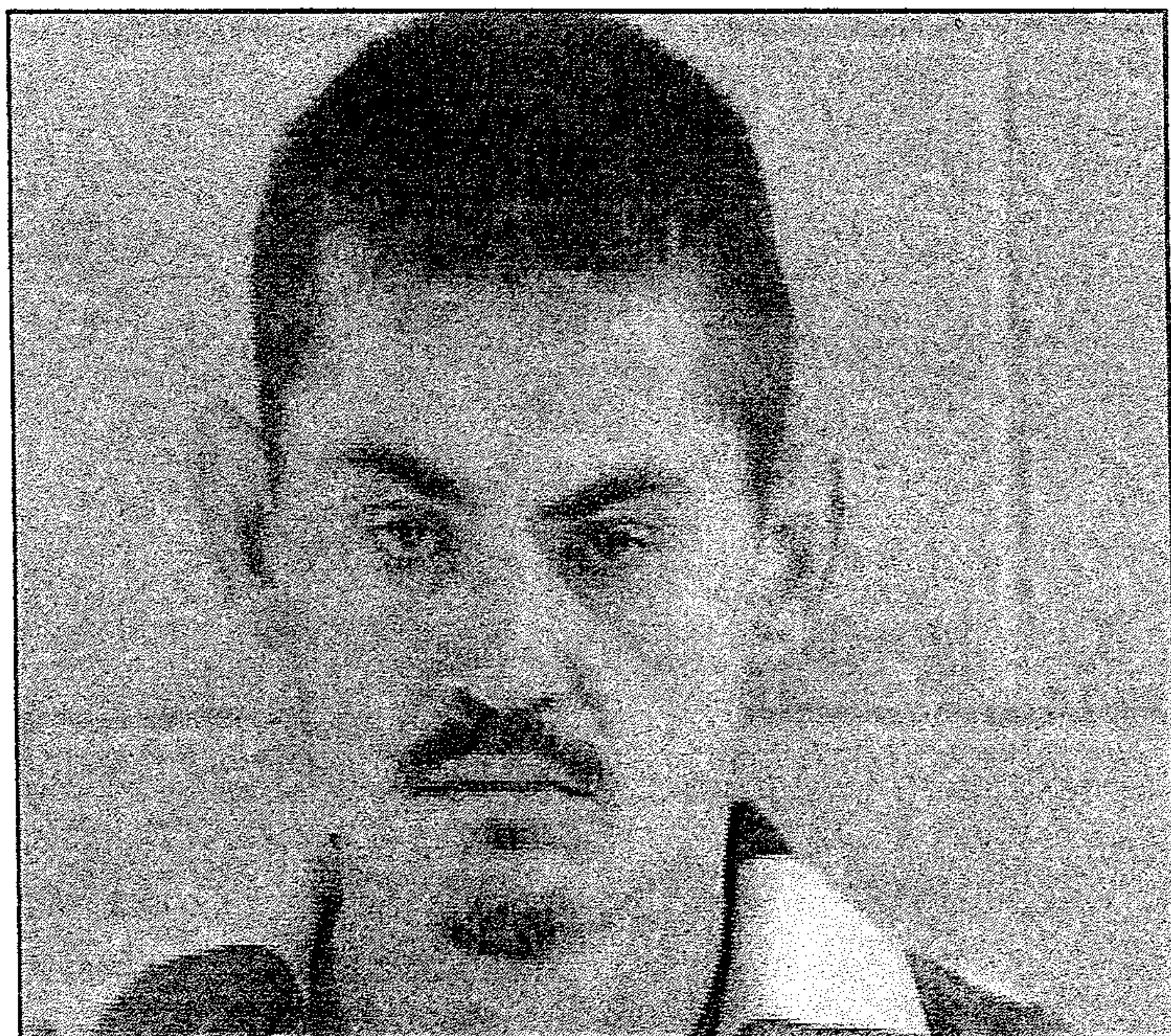

A special investigation by the Tennessee Comptroller's Office in conjunction with the Tennessee Bureau of Investigation has found that Stephanie Cunningham, a teacher for Coffee County Schools

and former treasurer of the Coffee County Education Association, stole at least \$29,096.

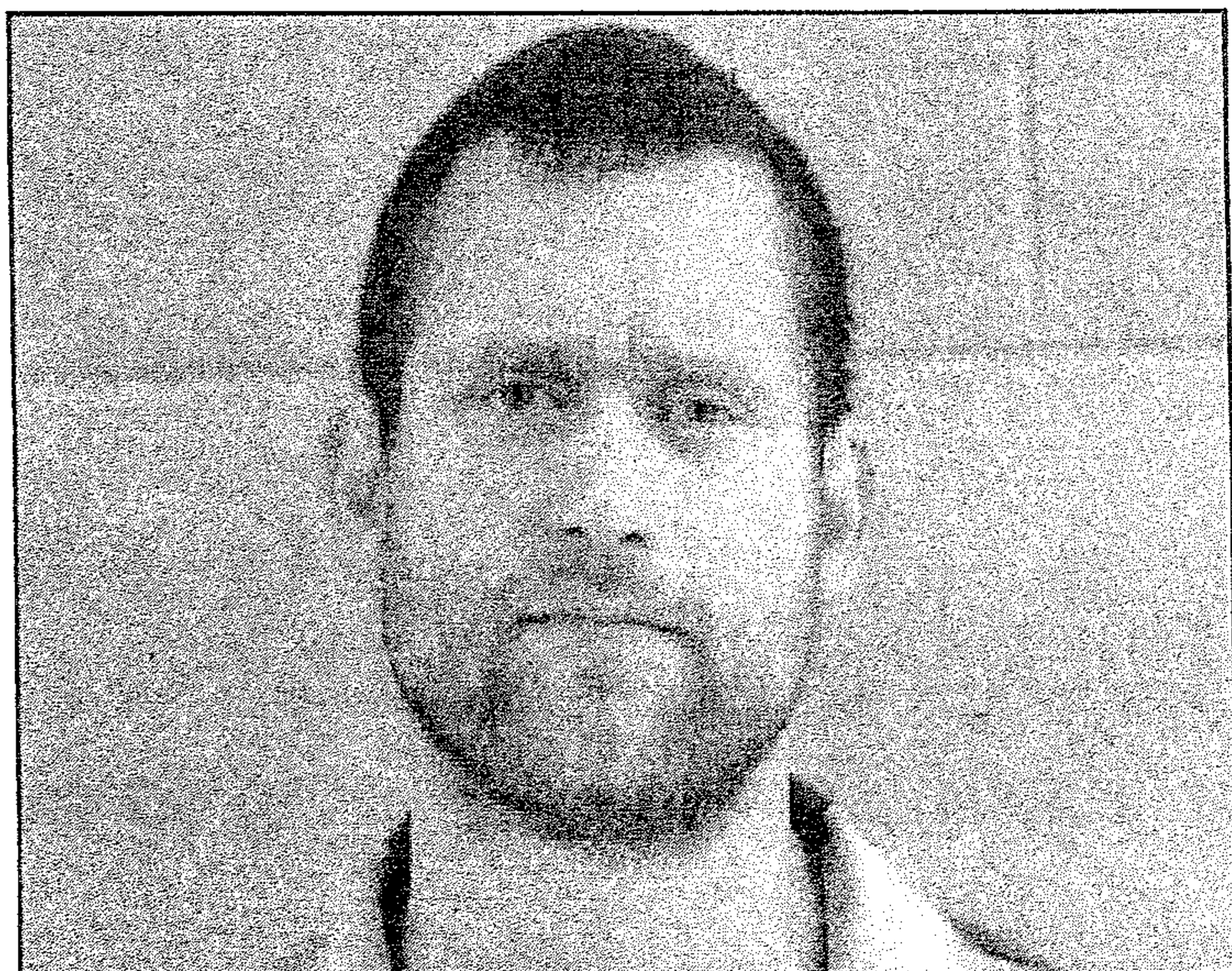
Cunningham used the association's debit card and cash for her personal benefit from May 2013

through November 2015. Cunningham admitted to Comptroller investigators that she used association money to pay for personal items.

Investigators determined that Cunningham charged meals at restaurants, jewelry, cosmetics, clothing and gift cards on the association's debit card. She also made unauthorized cash withdrawals by check and ATM, and made unauthorized transfers from the association's bank account to her personal bank account. Investigators noted that, beginning in July 2013, Cunningham began depositing personal funds into the association's bank account. These deposits totaled \$25,069. In November 2016, Stephanie Cunningham was indicted by the Coffee County Grand Jury on one count of theft over \$10,000.

"One of the best ways to stop theft is to create a system that allows for prompt detection," said Comptroller Justin P. Wilson. "One person should never be allowed to have complete control of a group's checkbook, bank account, and debit card without regular oversight. Reviewing bank statements and requiring multiple signatures on checks is a good place to

start."

### Investigations felony

Roy Neuenschwander, 68, West Sunset Drive Knoxville, was charged with Domestic Assault Felony. Deputy Craig Brewer LCSO, responded to Meadow Road West at Highway 321 to a report of a domestic assault. On arrival Deputy found victim and her husband Roy Neuenschwander in the grass area in the intersection. On getting out found that victim had a large cut on the back of her head. She stated that her husband Roy Neuenschwander started going off in the vehicle and she pulled over and told him she was not going to take him home the way he was acting. She got out of the vehicle Mr. Neuenschwander got out and then threw her on the ground where she hit the ground and cut the back of her head. She got up then called 911 and while on the phone with 911 Mr. Neuenschwander grabbed her left arm, she started trying to break it. Mr. Neuenschwander had also had blood on his face where the female was trying to get away from him and pushing on his face. Victim was transported to

the Fort Loudon Emergency Room by Priority Ambulance Service. This did happen in Loudon County Tennessee.

Dalton Major, 35, Vale Street Loudon, was charged with Domestic Assault.

Officer's from LPD, were dispatched to the area of Commerce Street (behind the dry cleaners) for a physical fight. Upon arrival neighborhood residents stated the subjects involved in the altercation was Mr. Dalton Major, and victim. Victim was located on scene. Victim stated that Mr. Major was trying to physically assault a male, however, he intervened. Officer was able to locate Mr. Major inside the residence of Vale Street. Officer also made contact with another subject in the residence a male. After separating the two Officer asked the male if he saw what happened. The male stated earlier in the day he was outside sitting in his yellow chair around a fire. At some point Mr. Major and the male were involved in a verbal argument (possibly over a missed doctors appointment). During the argument the male stated Mr. Major struck him on the right side of the head with a closed fist. Officer's did witness a knot on the side on the male's

head. A witness on scene stated he saw Mr. Major grab male victim. Mr. Major was then placed into custody and transported to Loudon County Jail. All the above actions did happen in The City of Loudon. Victim and Mr. Major are related.

### Knife

Eric Luttenberger, 26, Homeless, was charged with Aggravated Assault, and Domestic Assault. Deputy Robbie Lane LCSO, was dispatched to Jackson Bend Rd the Lazy Acres RV Park for a trespasser. Dispatch advised that the male might have a knife. Deputy arrived on scene and made contact with victims who was standing outside the RV. Victims advised that Mr. Luttenberger had showed up and refused to leave and had pulled a knife on them. Deputy made contact with Mr. Luttenberger who was standing at the table. On the ground between Mr. Luttenberger's feet was a open silver and brown knife. Deputy placed Mr. Luttenberger in hand cuffs and secured the knife. Mr. Luttenberger had a strong odor of a alcoholic beverage coming from his person. Mr. Luttenberger was very unsteady on his feet when trying to walk. Mr. Luttenberger had scrapes on his face
