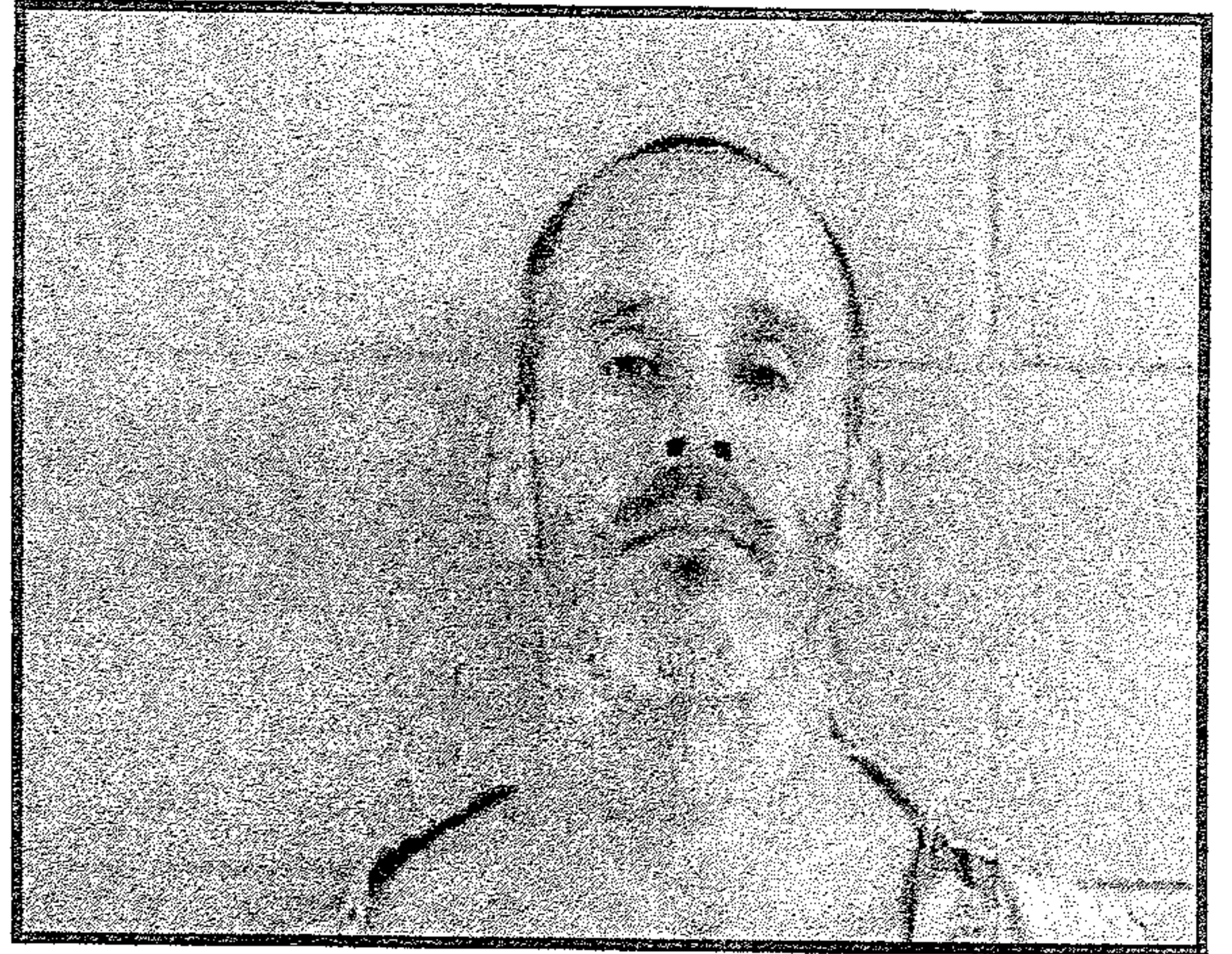

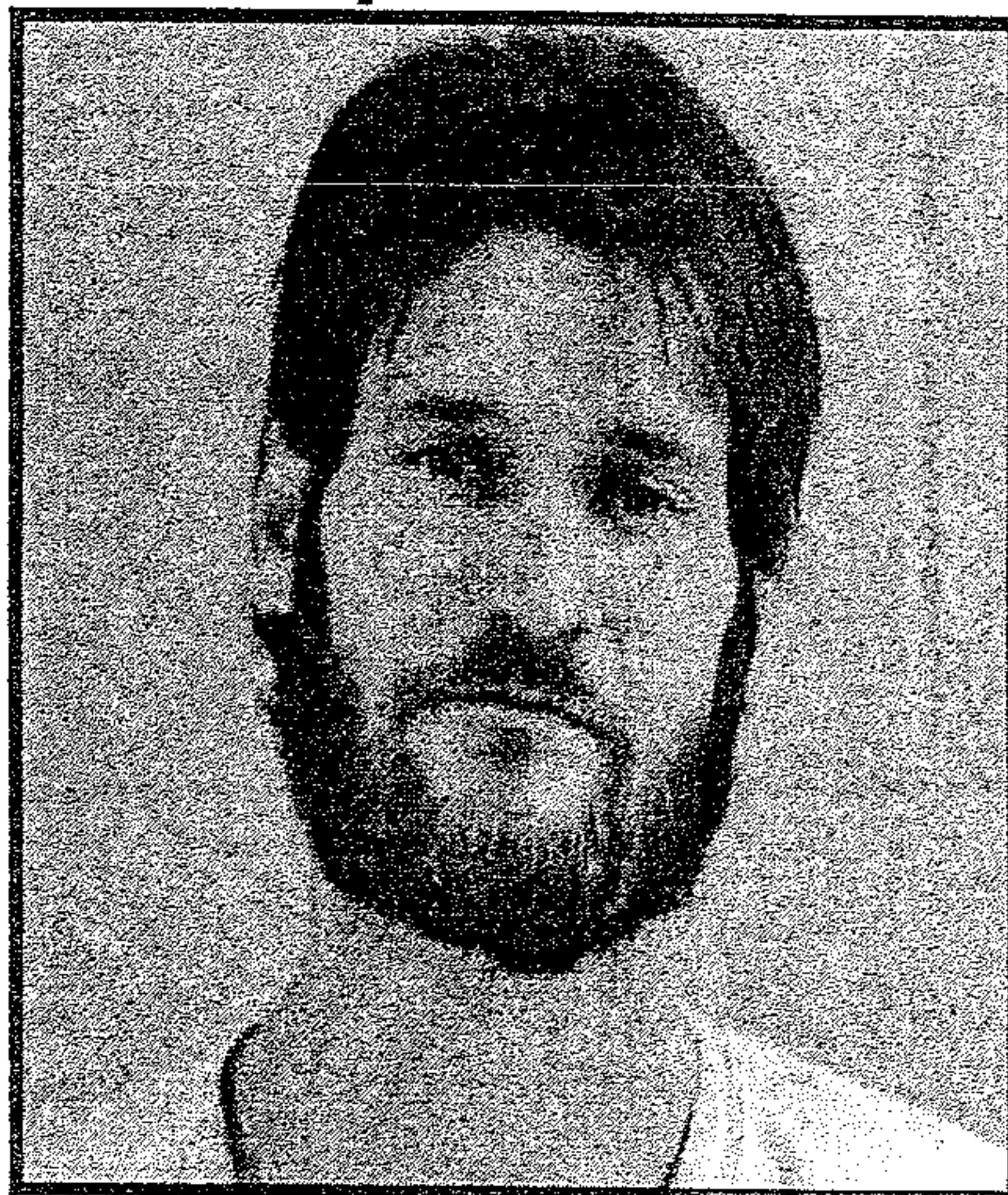

Couple sentenced to serve a combined total of over 53 years in federal prison for producing child pornography

On Dec. 16, 2016, Wesley Thomas Ryan, 28, of Fayetteville, Tenn., and Rachael Gabrielle Boyett, 21, of Taft, Tenn., were sentenced by the Honorable Travis R. McDonough, U.S. District Court Judge, for production of child pornography. Ryan was ordered to serve 360 months and Boyett was ordered to serve 280 months. Upon their release from prison, both will be under the supervision of the U.S. Probation Office for at least 10 years as well as be

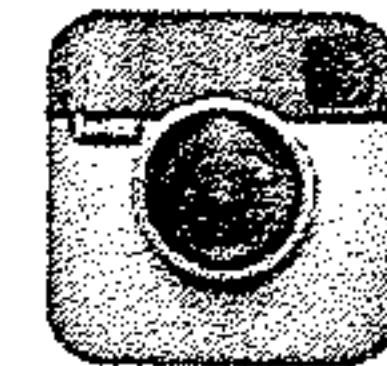

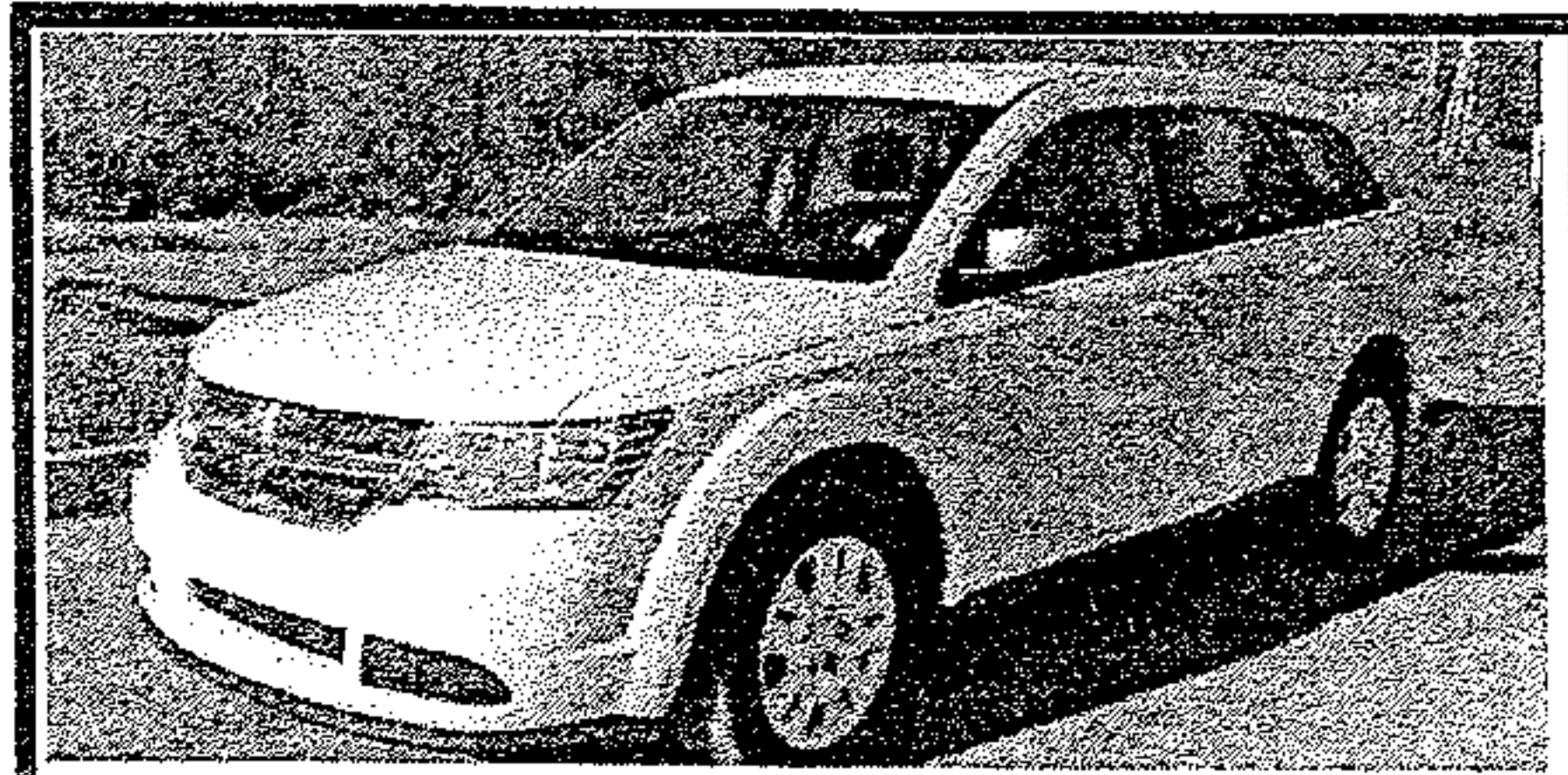

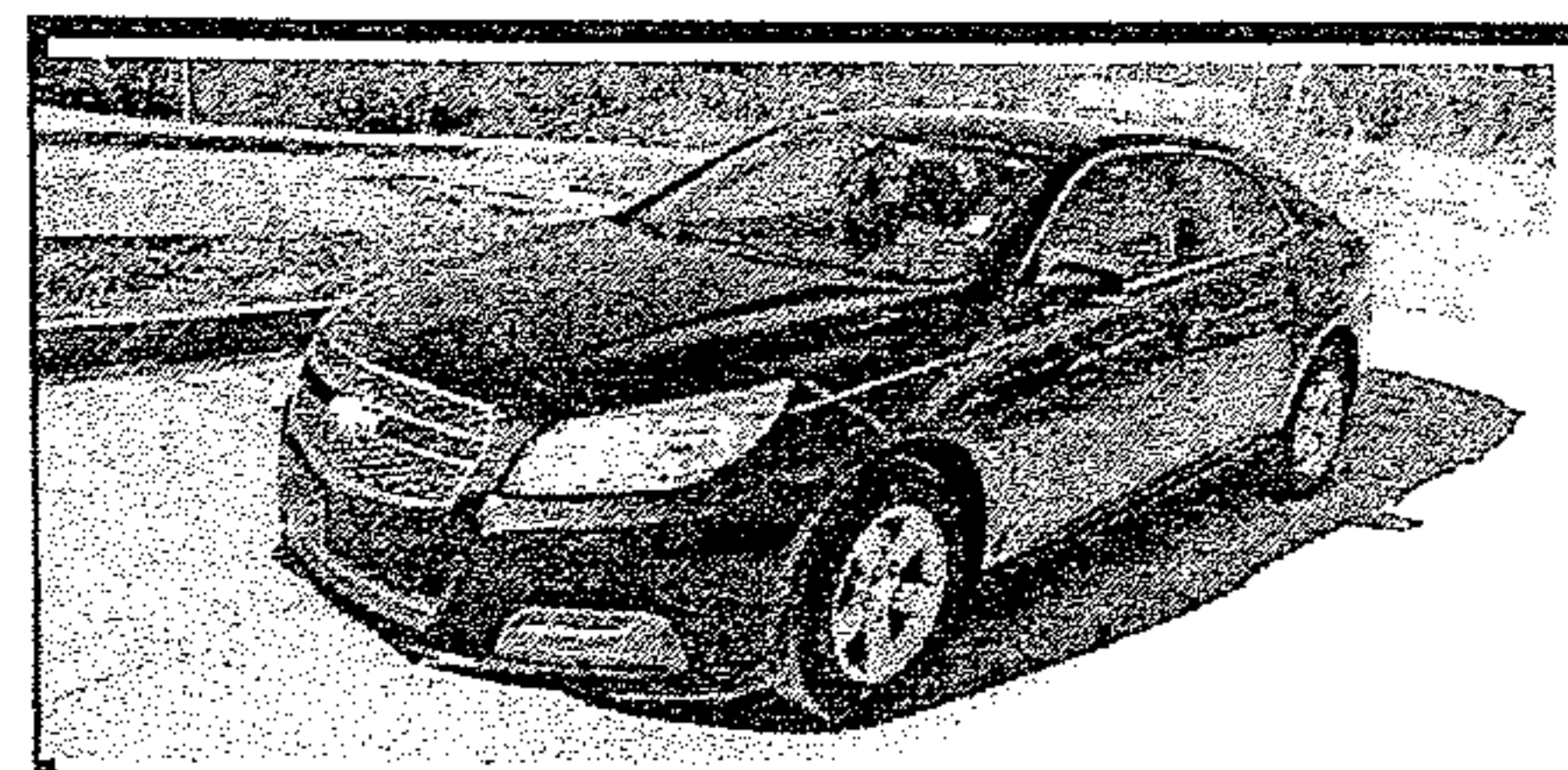

naming Matt Drudge, Alex Jones, Paul Craig Roberts, Project Veritas, Wikileaks and Natural News as being Russian propaganda fronts. (I don't even know how to speak Russian... but I do speak TEXAN!)

New alternatives to Twitter, Google, Facebook rapidly emerging: These sites won't censor you

Social media (NaturalNews) Are you hooked on social media or use it to promote your business or cause, but are sick and tired of the Left-wing tyrannical censorship of either your posts or those of real news organizations that Facebook, Twitter, Google, Yahoo and others have arbitrarily deemed "fake?"

Never fear. There are alternatives already out there, with more on the way. Besides that, these current and forthcoming sites are true free speech zones where you can say and post what you want, without the fear that it will be censored by the communist nannies who run those other "mainstream" sites.

GoodGopher.com Launched last year by Mike Adams, the Health Ranger and founder/editor of NaturalNews, this alternative media-friendly search engine has been growing in popularity ever since. GoodGopher.com is Adams' attempt to build the Internet's largest search engine for those looking to find information and news about liberty, natural

healing, central banks, food freedom, advanced legitimate science and several other topics that are not allowed in search sites controlled by zealous, censoring Leftists working with the NSA.

GoodGopher is the world's first search site that is privacy-protected and which filters out corporate media propaganda and government misinformation. The site:

- Will never spy on users
- Includes no corporate/government propaganda disguised as "news" and "information"
- Features an "Honest Relevancy Algorithm" that is applied and weighted equally across all sites, playing no favorites or blocking legitimate reporting and science from independent sources
- Never includes any promotion of Big Pharma or other toxins/poisons
- Is not corporate-owned

And if you're an independent media owner or journalist, you can submit your own sites to be indexed by GoodGopher's search algorithms. GAB.ai

Developed by free-speech advocate Andrew Torba, GAB.ai is a Twitter-style network that combats censorship by allowing users to post whatever they want, saying what they want and expressing themselves as they want.

"If I had to pick a single event that pushed me over the edge to take action, I would have to say it was the suppression of conservative sources and stories by the incredibly biased Facebook Trending Topics team," Torba said in an interview with Charlie Nash of Breitbart News.

Right now the site is very much in its beta form and there is a wait-

ing list of at least 186,955 after this writer signed up to join. So clearly, as the site gains more attention and the focus on free, unlimited speech grows, so, too, will GAB.ai.

Seen.life Another social media site that continues to grow because of its dedication to free speech and privacy is Seen.life. Its creators vow to never gather and/or sell users' personal information, and "we don't let search engines data mine your posts if you want to make that choice," the site notes. Creators also want users to know that once they delete a post on Seen.life, it's gone, because they don't retain it.

The site also features "Unity," a "reward token" redeemable on Seen.life that is built for sharing elsewhere as well. You can also chat live and get free Internet calling.

Adams says that's not all.

"We will be launching a YouTube alternative before the end of this year," he noted, giving users an alternative to the censorship that takes place on Twitter (which banned Breitbart Tech editor Milo Yiannopoulos, a gay, vocal supporter of President-elect Trump and a strident conservative).

"The Internet is rapidly fracturing, polarizing into two separate universes. On the left side, rooted in delusion and censorship, you have Google, Facebook, Twitter and YouTube," said Adams, noting that NaturalNews.com is one of the sites targeted in recent assaults on free speech. "On the right, you have respect for free speech, intelligent discourse and practical problem solving to contribute to a better society."
