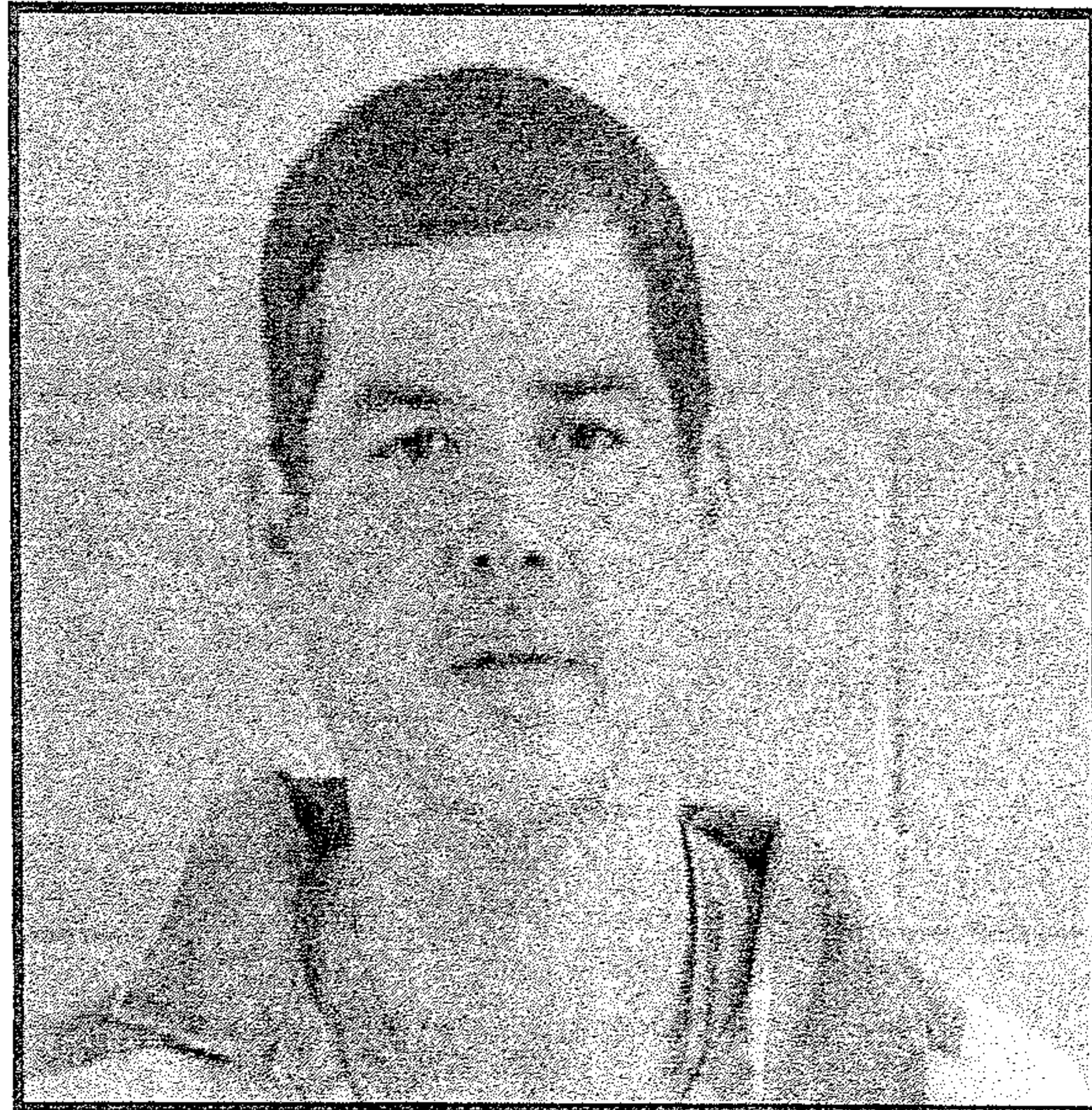

## Road rage ends with shots fired after object thrown into car!

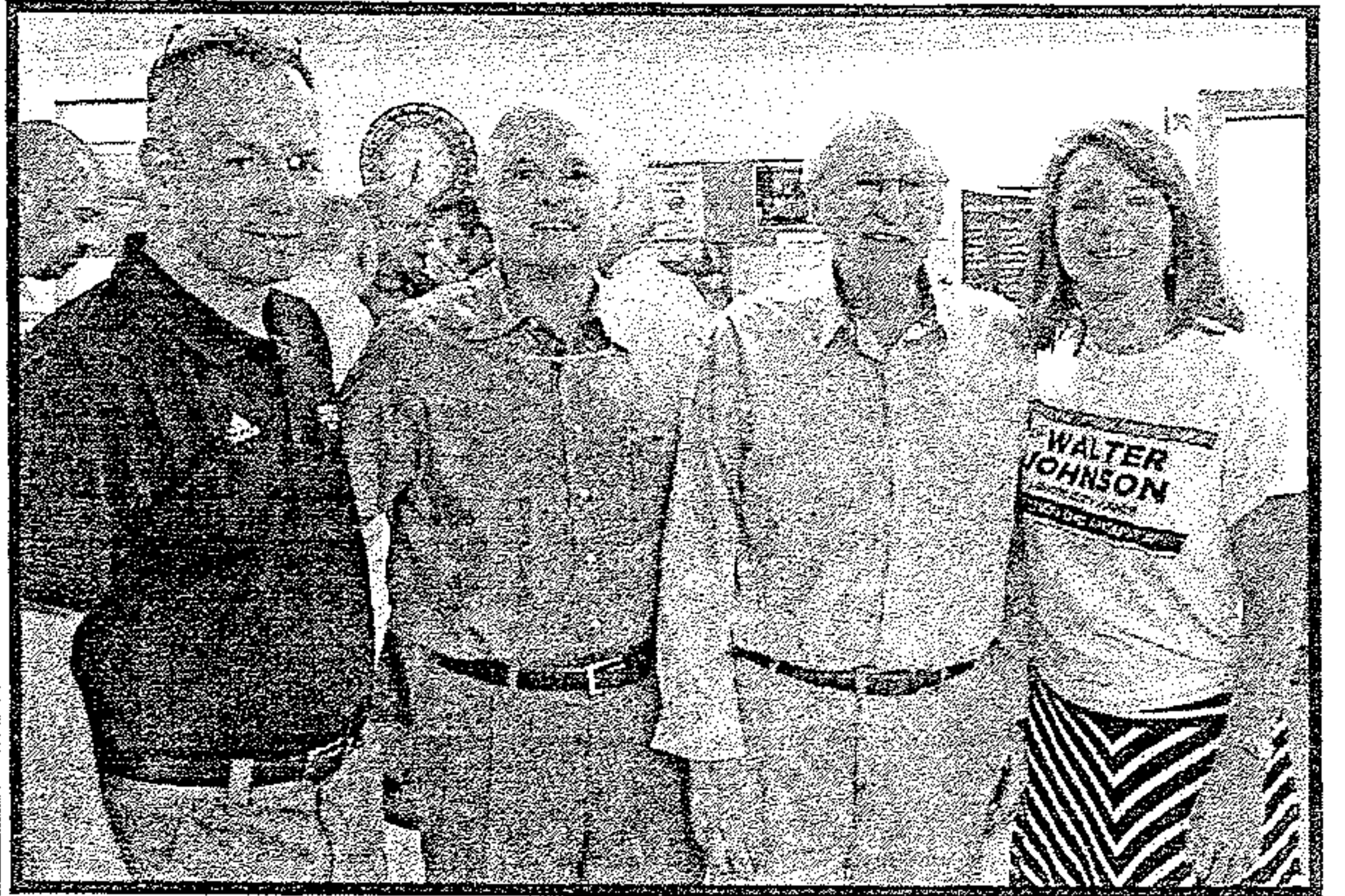

In a world where the default seems always to be criticism – pointing out what someone has been doing wrong – this passage is like gold for our individual Christian faith journey. When did you last hear from someone, “I’m glad for you. I am thankful you are a follower of Jesus Christ. I have heard of how your faith has done good work?” Or, “Thank God for your congregation, I hear you are walking boldly into mission and ministry beyond your four walls as well as to your own members?”

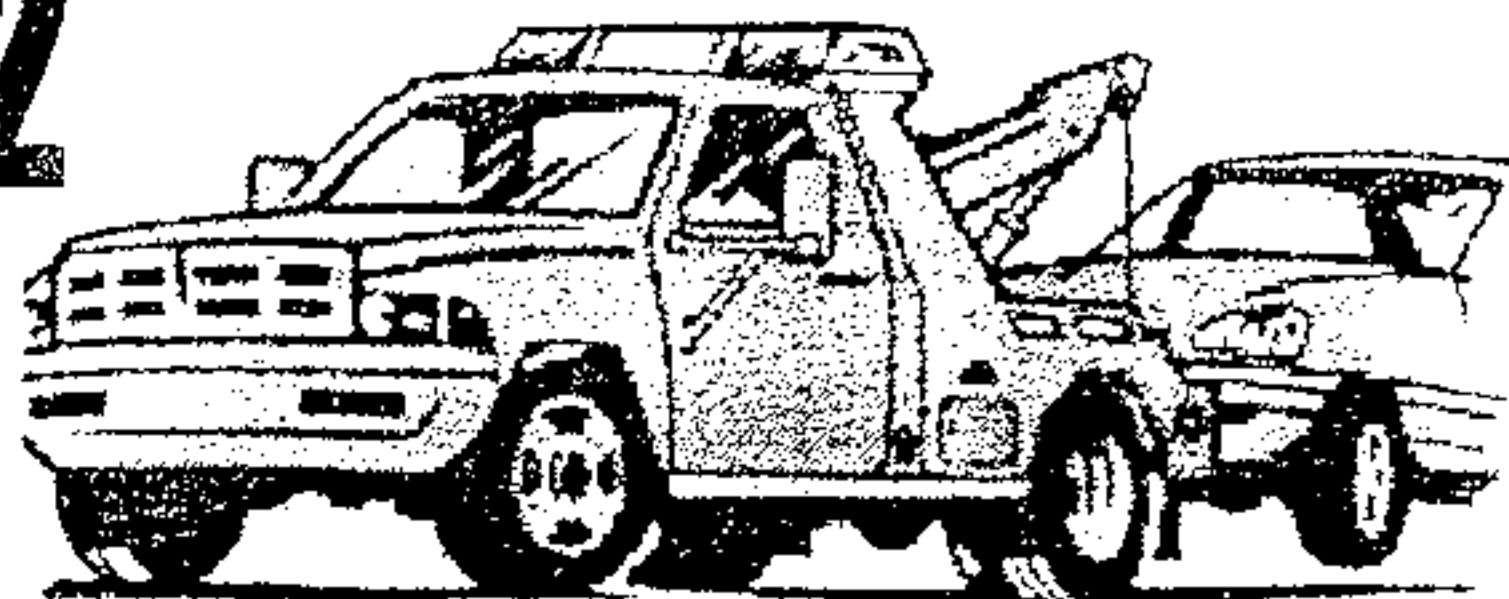

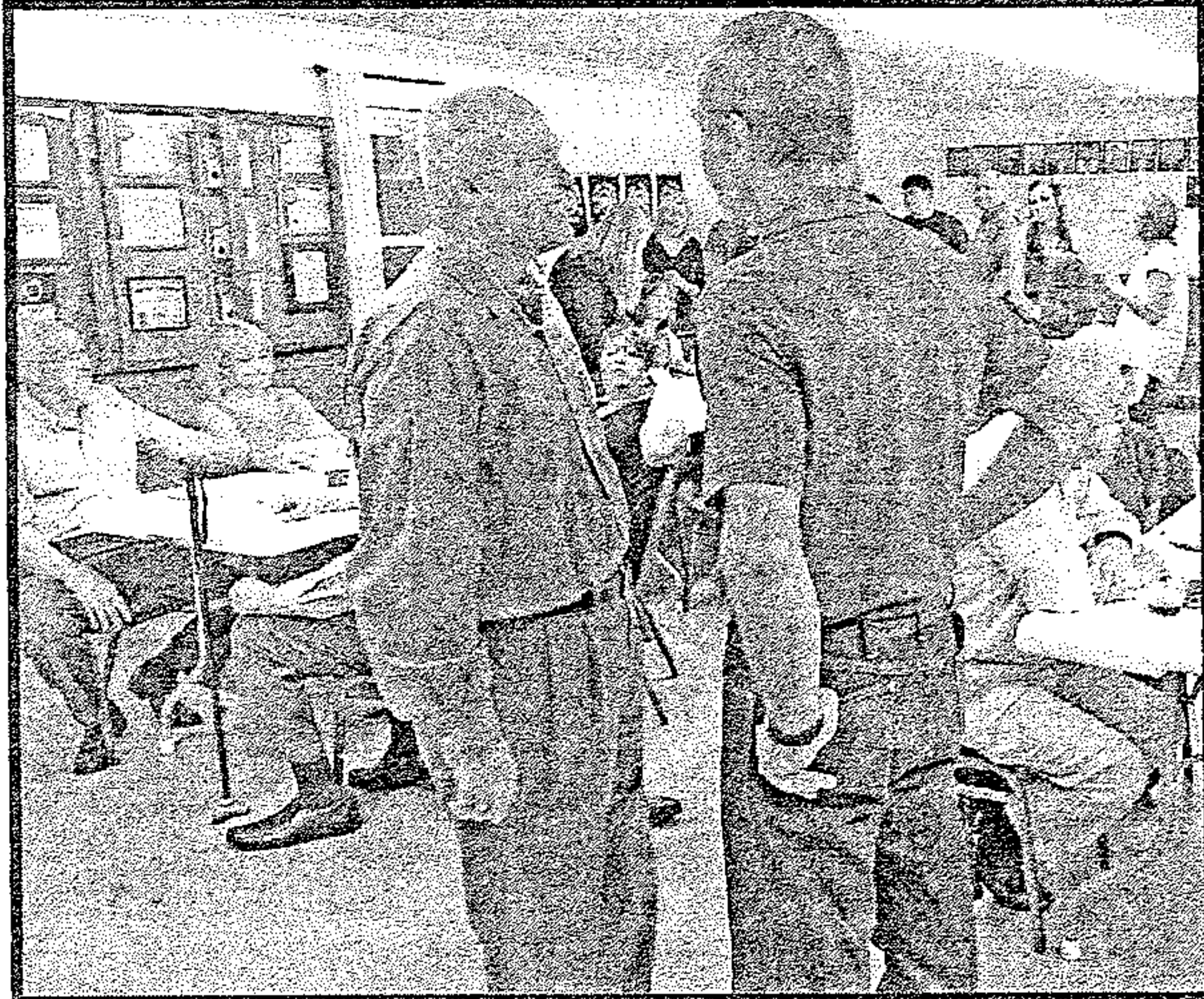
Candidate for Lenoir City Mayor Walter Johnson held a gathering this past Friday at the Highland Park Ruritan Building on Hwy 321. Despite the
