Kathy Stegall, 37, Elm Avenue Rockwood, was charged with DUI. Trooper







Dylan Daggett, 18, West 9th Avenue Lenoir City, was charged with Domestic Assault, and Vandalism.

Officer Jason Arden LCPD, responded to west 9th avenue to investigate a domestic complaint. Upon arrival Officer was met by victim who stated that her son, Dylan. Daggett awakened

her claiming to have locked the keys in her 2006 Saturn Vue and broke the front window. Victim stated the Dylan then told her that he'd seen the devil and was instructed to kill her and his sister. Victim explained that she became fearful for the safety of her and her daughter and notified the police. Officer then spoke to Dylan who stated that he did see what he be-

lieved to be the devil and was told to kill his family. Mr. Daggett stated further that he punched the windshield, breaking it and kicked / pulled the left front bumper, dislodging it. The damage to the vehicle was visible and Mr. Daggett was placed under arrest for domestic assault and vandalism. Mr. Daggett was then transported to the Loudon county jail without further inci-

dent. Mr. Daggett does have pending domestic assault and vandalism charges from 06/28/2016. This did occur in Lenoir city, Tennessee.

#### **Investigation Highlights Need for Volunteer Fire Department Oversight Report Examines Hillsview VFD in McMinn County**

A new investigation by the Tennessee

Comptroller's Office reveals several issues within the Hillsview Volunteer Fire Department (HVFD) that could have been avoided with improved administrative and financial oversight.

Investigators are questioning \$6,414.87 that was spent by HVFD without adequate documentation to determine if the money was used for legitimate purposes or for the personal benefit of its members. HVFD checks were written to Walmart, Lowes, Midway Mart, Staples, Auto Zone, Dollar General, Ace Hardware, and Little Caesars. Other checks were noted as "reimbursements" to various HVFD members.

Investigators also found HVFD violated state law when it raffled a television and a .22 rifle during fundraising events. The Tennessee Nonprofit Gaming Law only authorizes qualified nonprofits to conduct certain games of chance, including raffles. HVFD is not a registered not-for-profit organization.

Comptroller investigators identified numerous deficiencies in HVFD's financial operations. These include allowing one member to have too much control over financial transactions, not keeping an official cash journal, signing checks prior to making a purchase, failing to deposit all fundraising collections, and not issuing receipts for collections.



Buckner did have knowledge that the check belonged to victim, who is now deceased. Buckner gave his TVA Credit Union card to Alexander Mihaly to deposit the check into Buckner account. Buckner did admit he knew the check was stolen from a mailbox, and he did spend the money, except \$400.00 which he gave to Mihaly. Buckner did state he held the check in his hand prior to it being deposited, and the

victim name was on the check. Sgt. Lynette Ladd LCPD, made the arrest.

all of Tennessee's volunteer fire departments receiving public funds are required to file an annual financial report with the Comptroller's Office and the local governments from which they receive funding. HVFD has not submitted an annual financial report.

"Volunteer fire departments must show a basic level of financial responsibility that includes keeping receipts and recording transactions," said Comptroller Justin P. Wilson. "I am pleased to see McMinn County

and HVFD leaders indicate they are making improvements. We strive for government to work better."

The Comptroller's findings and recommendations have been reviewed with the district attorney general for the Tenth Judicial District.






