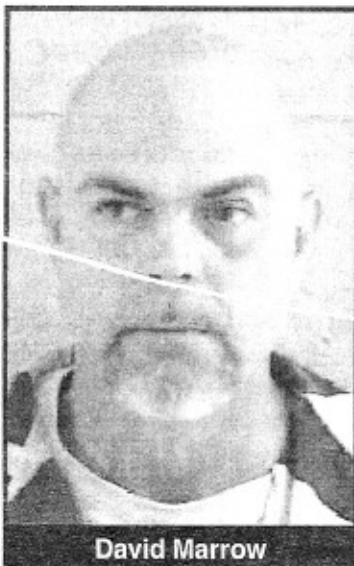

These messages were written in a manner to attempt to convince the victim to come

On stopping the vehicle the driver was identified as Robert Dennis Key. The officer had prior knowledge Key's license is revoked for DUI. Clayton G. Jarrod 28, Ellis Road, Lenoir City was charged with driving on revoked license and possession of schedule IV.

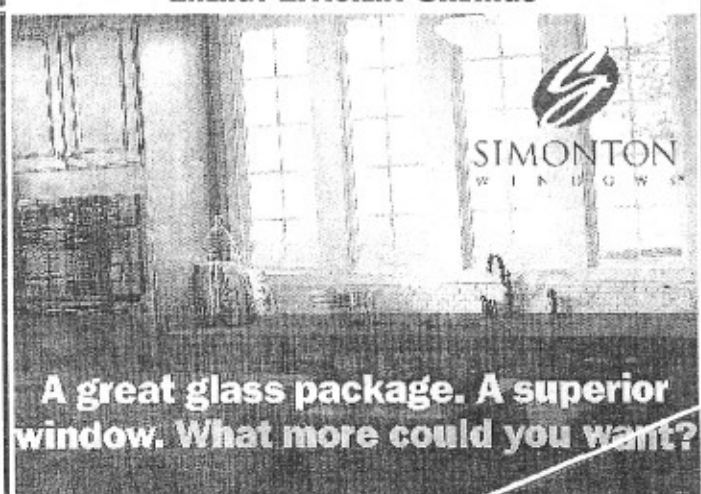
