Continues to Prove its Value in Fighting Crime

Last month, a Tennessee state trooper arrested an Illinois man wanted for questioning in a Kentucky murder. The FBI's National Crime

Information Center, or NCIC, had a key assist in the arrest—the state trooper, after spotting a suspicious vehicle at a rest stop, ran the license plate through the NCIC database and received word back quickly that

the car had been stolen by a suspect in a Kentucky homicide. A chase ensued, but ultimately the suspect in this case with connections to three different states was taken into custody.

Today, the FBI's NCIC system—created to give

our law enforcement partners access to a computerized index of documented criminal justice information whenever and wherever they need it—celebrates its 50th anniversary. Launched on January 27, 1967, the NCIC database, accord-

ing to Assistant Director Stephen Morris of the Criminal Justice Information Services (CJIS) Division, is “a cornerstone of the CJIS Division's information-sharing efforts, providing a lifeline to our local, state, federal, and tribal partners 24 hours a day.”

The information in the NCIC database can also help law enforcement officers perform their duties more safely—for instance, notifying them if the person in the car they are about to approach might be armed and dangerous.

In the beginning, 15 state and city computers were tied into the Bureau's host computer in Washington, D.C. At the time, NCIC contained just over 350,000 criminal justice records across five different files—wanted persons, stolen articles, stolen vehicles, stolen license plates, and stolen/missing guns. The very first NCIC hit came in May 1967, when a New York City officer radioed in a request for a search of a license plate. Within 90 seconds, he was informed that the car had been stolen the previous month in Boston.

By 1971, all 50 states were connected to NCIC and began making inroads in combating crimes that crossed state lines. And over the next three decades, the database expanded and adapted as new technology and new information needs emerged. For example, in 1975, a new file was added to record the details of missing persons cases. In 1980, Canadian warrants were added to the database. In 1999, a major technological upgrade—known as NCIC 2000—added new capabilities, including the ability to store digi-

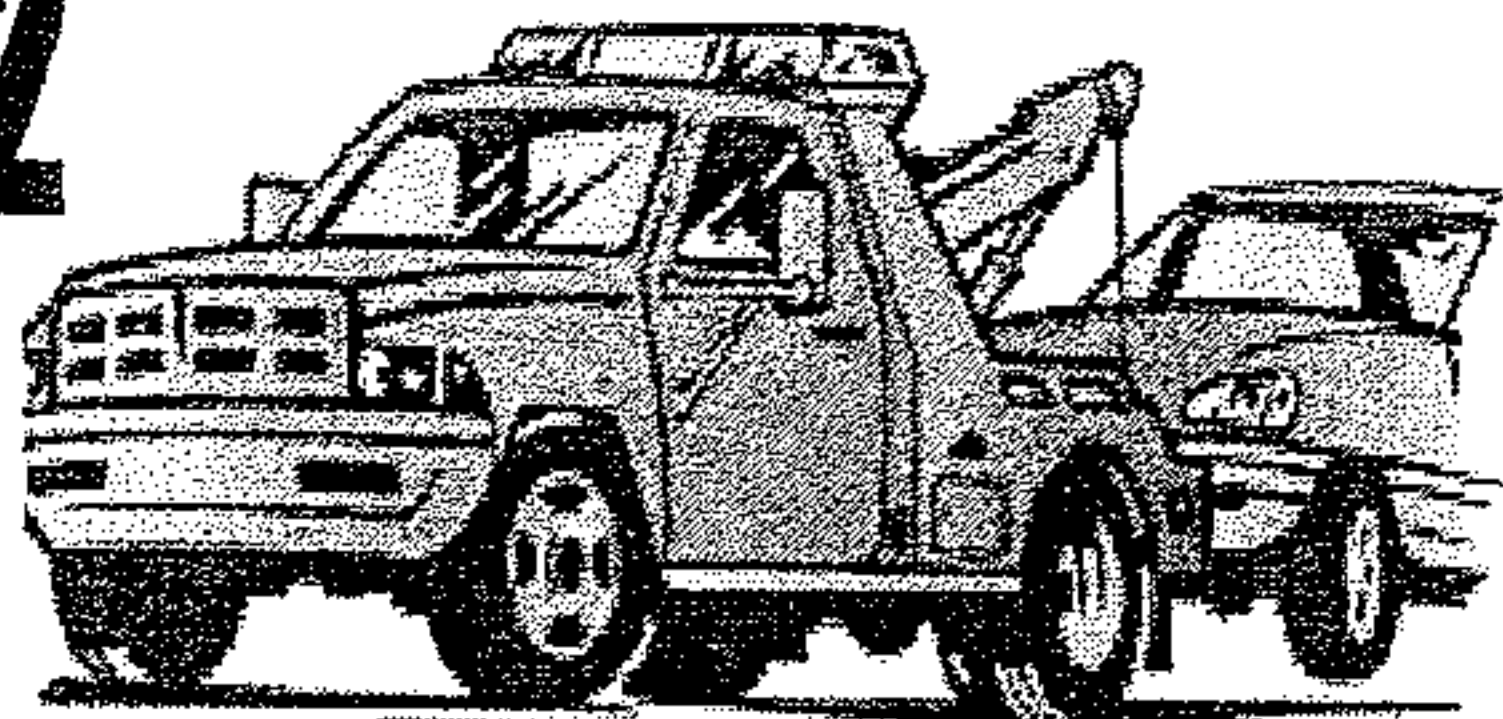

Stabbing

Jerry Kile, 68, Maple Hill Road Loudon, was charged with Aggravated Assault.

Corporal Rondel M. Branam LCSO, was advised by Loudon County Dispatch that there was a male who was at Fort Loudon Medical Center who stated he had been stabbed on Watkins Road in Loudon, TN. Upon arrival to the Fort Loudon Medical Center Deputy made contact with the Victim.

Upon speaking with victim it was learned that he was at his residence of Watkins Road working on a dump truck. Victim stated that Jerry Kile pulled in to his driveway and began arguing with him. During the argument Jerry allegedly threw a beer can and a sack in victim yard at which point victim told him to pick the items up. Jerry refused according to victim and at that time he came down from the dump truck. As victim got down to the ground he noticed Jerry had a knife in his hand and he began trying to run away from Jerry. Victim stated that he fell to the ground face down and at that time Jerry began stabbing him in the head, neck, face, and arms with the knife. Victim was able to get away by crawling between Jerry's legs and fled the area on foot. Jerry also fled the scene in a vehicle after the incident. While victim was trying to bandage his wounds he received a phone call

from Jerry. Jerry told victim over the phone "I told you I was going to get you". Victim then left the residence because his family saw how bad the injury was and he was taken by his daughter to Fort Loudon Medical Center for treatment. Investigator Charlie Cosner did respond to the Hospital and spoke with victim and took pictures of his injuries. Deputy did observe several severe lacerations to the back and left side of victim head from a cutting instrument. There was also a laceration to the left side of victim head near his eye, one under his chin near his throat, and one to his left forearm. Deputy did observe a black and white Chevrolet hat belonging to victim that was blood stained, had a cut to the left side of the mesh, and a cut to the left side of the bill that went completely through the bill laying on the counter in the Emergency Room he was in. The hat was taken in to evidence by this officer and placed in to Evidence Locker #2.

Investigator Jeff Russell and Deputy Brian Smith did respond to the residence where the events occurred and did attempt to locate the alleged suspect at multiple different residences in the area but no contact was made. Jerry Kile was arrested.

Herb

William Russell, 22, Hardin Cemetery Court Friendsville, was charged with Sim-

ple Possession.

Deputy K. Palmer LCSO, observed a green Toyota Tacoma traveling North on Highway 95 South. Deputy observed the driver and passenger were not wearing their seatbelts. Deputy stopped the vehicle on Highway 95 South at the Co-op. Deputy made contact with the driver Mr. William Jackie Lee Russell. Deputy asked Mr. Russell for his license, registration, and insurance.

While speaking with Mr. Russell Deputy could smell a strong odor of marijuana emitting from the vehicle. Deputy then asked Mr. Russell to exit the vehicle. Deputy asked Mr. Russell if there was any marijuana inside the vehicle at which time he stated yes. Mr. Russell stated there was about 2 grams inside his jacket pocket in the vehicle. Mr. Russell also stated there was a marijuana grinder and a marijuana pipe inside the vehicle. Deputy did locate a clear plastic baggy with a green leafy substance believed to be marijuana inside Mr. Russell's jacket. Deputy also located two marijuana grinders in the glove box. Deputy located the marijuana pipe

next to the gear shifter. Mr. Russell was placed under arrest for simple possession. The passenger of the vehicle was issued a citation for seatbelt law. The vehicle was released from the scene to the passenger. Mr. Russell was transported to the Loudon County Jail. Mr. Russell was also cited for seatbelt law. This did occur in Loudon County TN.

tal images and expanded data fields, and also led to near-instant results for queries.

During the last 15 years or so, additional file categories have been added, including identity theft, gangs, known or

suspected terrorists, and violent persons.

Currently, the database is organized into a total of 21 files and contains 12 million active records entered by local, state, and federal law enforcement agencies—and it handles an average of 14 million transactions a day. NCIC serves more than 90,000 criminal justice and law enforcement agencies, along with judges, prosecutors, corrections officers, court administrators, and a variety of other criminal justice officials by providing information that can help apprehend fugitives, locate missing persons, identify convicted sexual offenders, uncover weapons used in crimes, locate and return stolen property, and more.
