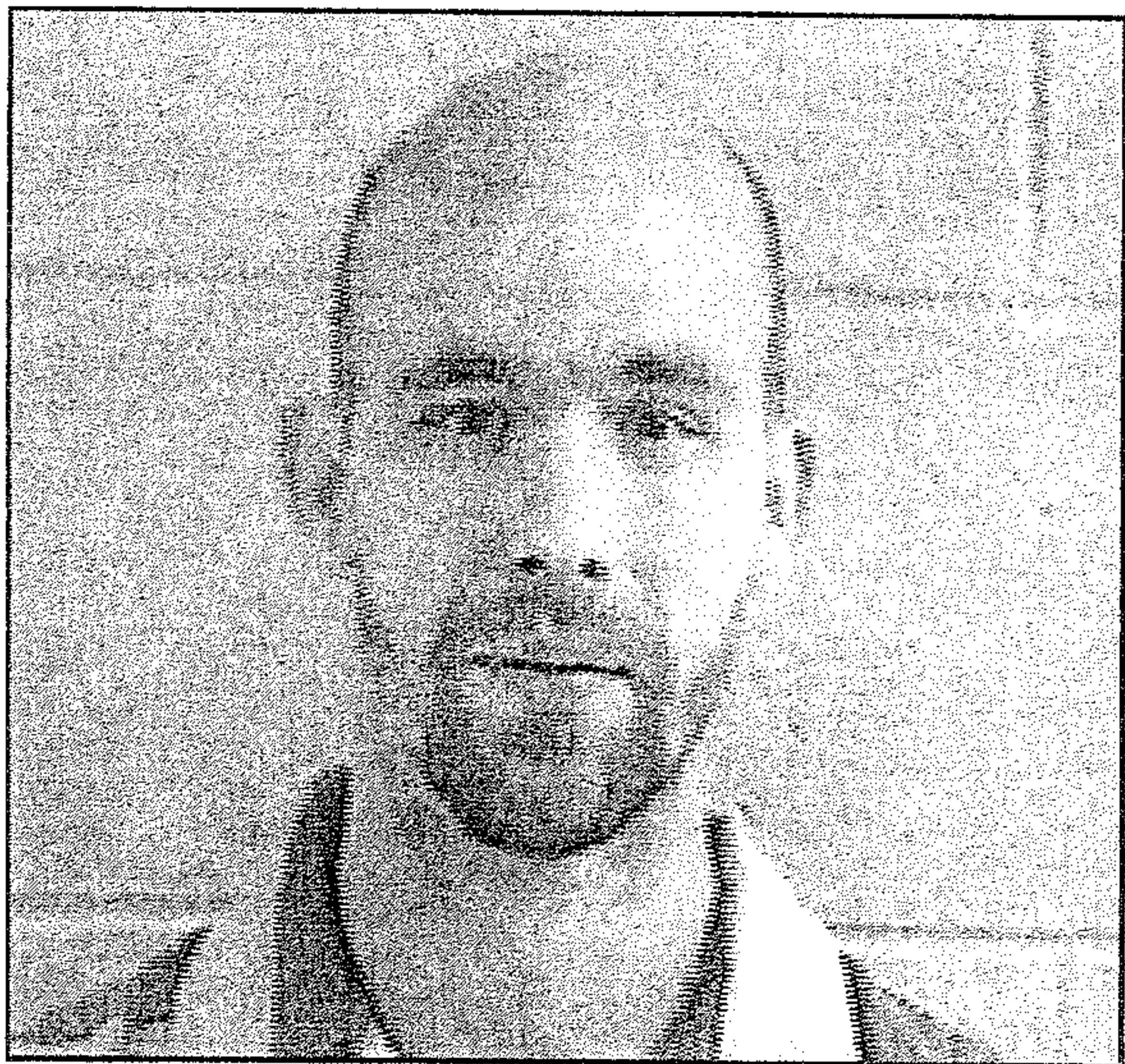

## Former Science Hill High School Booster Club President Indicted for Theft

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Kimberly Charles, the former president of the Science Hill High School Boys Basketball Boosters.

The Comptroller's Office began its investigation after booster club members and Johnson City Schools

reported questionable transactions in the boosters' bank records.

During the period June 2015 through April 2016, Charles stole at least \$6,150 from the booster club and used the money for her personal benefit. During this time, Charles handled many of the booster club's financial responsibilities.

**Duo**

Burlen Ballard, 49, Mulberry Street Loudon, was charged with Violation of Order of Protection.

Chasity Lynn, 29, Mulberry Street, Loudon, was charged with Poss. of Drug Para., and Contraband in a Penal Institution.

Affiant observed the defendant, Burlen Ballard, operating a blue Saturn sedan on W Broadway in Lenoir City. Affiant paced the defendant traveling 40 mph in a 30 mph speed zone. Upon stop at the Pilot gas station located at 700 E Broadway and having ran the defendant's information through Loudon County Dispatch Center it was determined that the defendant has existing bond restrictions, re-

stricting him from having any contact with Chasity Lynn, a passenger of the Saturn at the time of the traffic stop. Mr. Ballard signed a copy of the Loudon County General Sessions Court Order Granting Bail for Abuse Cases agreeing to the terms of an order of protection as a condition of his release. Being in the presence of Ms. Lynn he thereby violated that order of protection. This did occur in Loudon County, Tennessee.

County Correctional Facility. Upon arrival to the jail he was asked if he had anything on him that would be considered contraband upon his entry to the facility. He stated that he may have something

in his shoe. Upon search in the jail a small plastic baggie with a white crystal type substance believed to be crystal methamphetamine in his right shoe. He was then made aware that he was being charged with Possession of Schedule II. This did happen in Loudon County.

**Former ETSU Tennis Coach Indicted for Theft and Forgery**

The Tennessee Comptroller's Office has released an investigation that has resulted in the

indictment of Yaser Zaatini, the former Director of Tennis and coach at East Tennessee State University (ETSU). The investigation was initiated after the ETSU Department of Internal Audit reported financial discrepancies in the tennis program.

Investigators determined that from September 2011 through February 2017, Zaatini misappropriated at least \$45,540 from ETSU and often provided fabricated or altered documents to the ETSU Athletics Department. Zaatini used a variety of

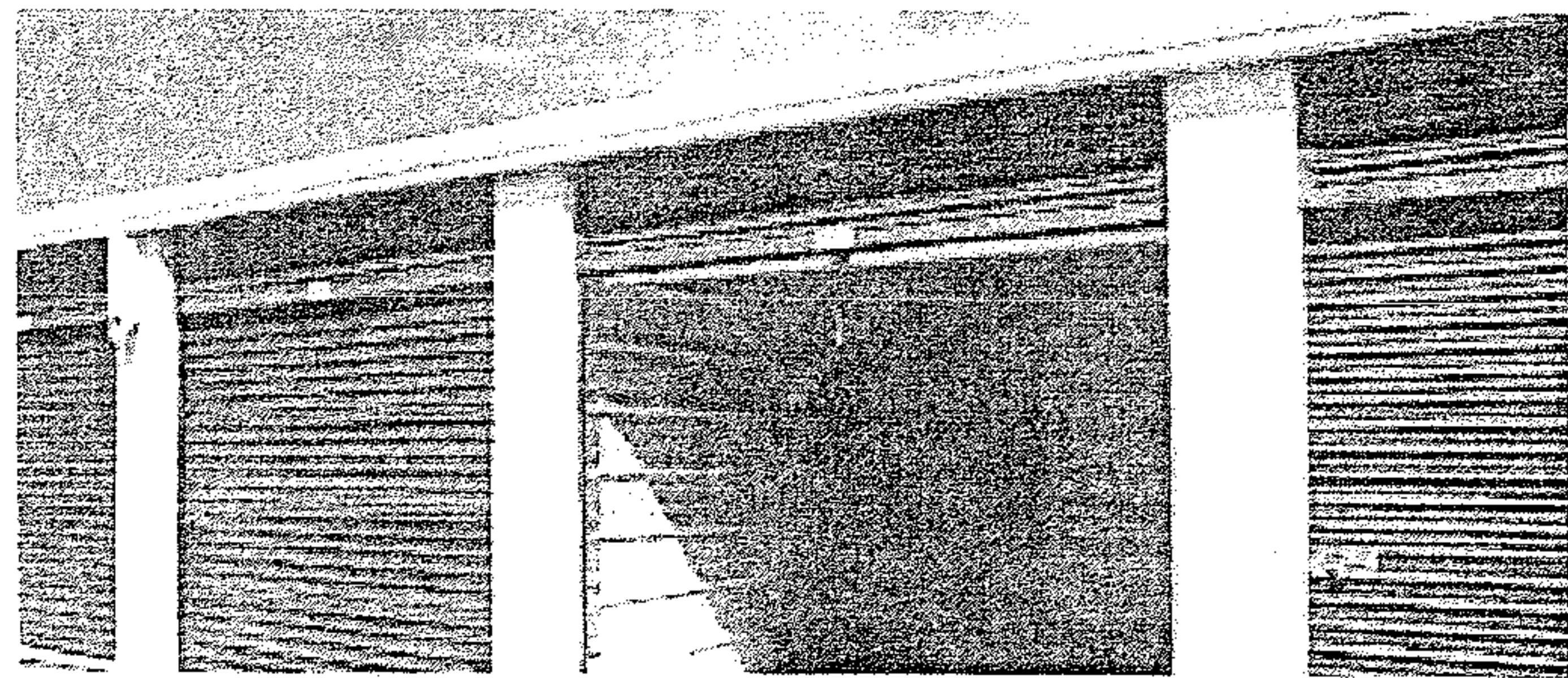

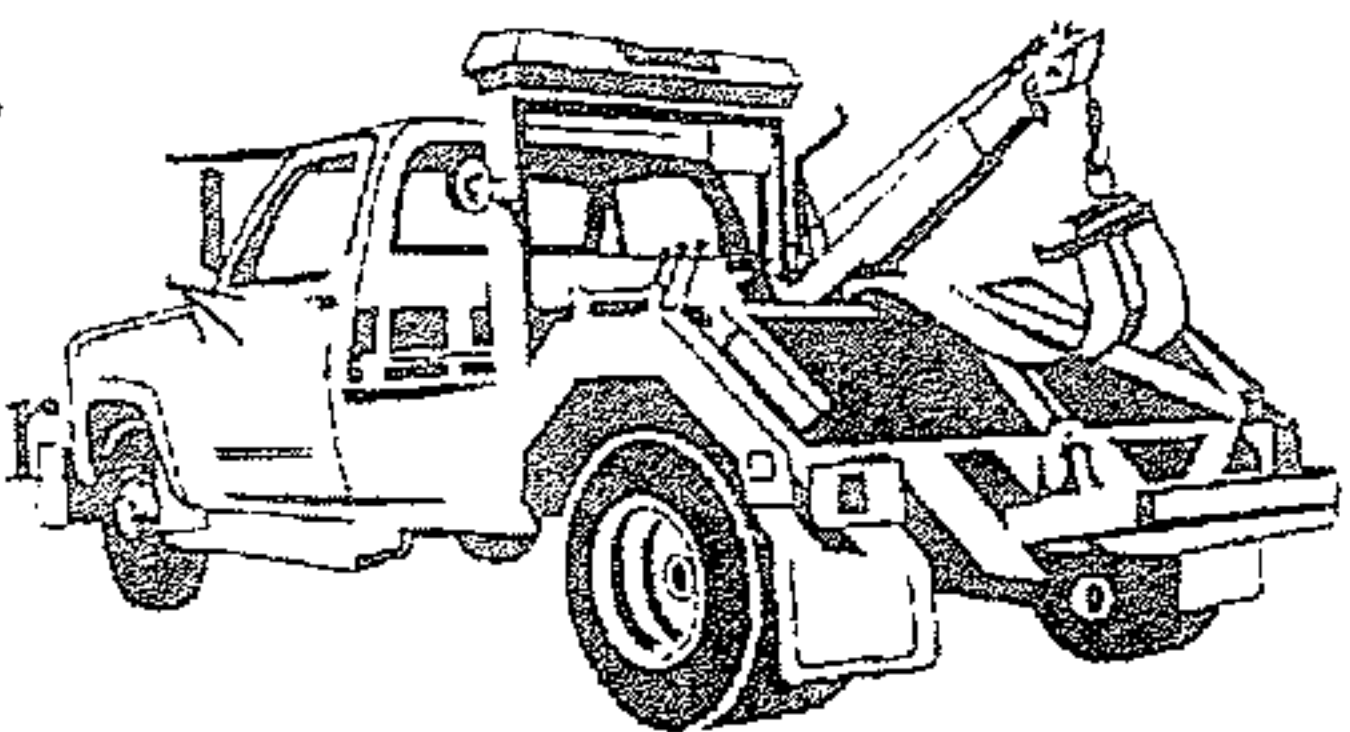

**Theft**

Investigators determined that Charles used three schemes to perpetrate the theft.

Charles purchased a prepaid cash card with booster club funds and used the card to pay for a relative's college fees, and purchase Mary Kay products and meals at Perkins Restaurant & Bakery. She also failed to deposit cash collected during a booster club fundraiser, and withdrew cash from the booster club bank account which was not used for the club's benefit.

Booster club board members questioned Charles about some of these issues in 2016, and she apparently stated that she had made some mistakes with the boosters' funds. She made a \$1,000 deposit into the boosters' checking account in July 2016, but she has made no other repayments since that time.

In November 2017, Kimberly Charles was indicted by the Washington County Grand Jury on one count of theft over \$2,500.

"Booster clubs are required by state law to safeguard funds and adopt a policy for handling money and other property," said Comptroller Justin P. Wilson. "These policies must ensure that financial responsibilities are divided between multiple people, and supporting documentation is maintained for purchases and withdrawals. I am encouraged to note that booster club officials have indicated their intention to correct these weak-

nesses."

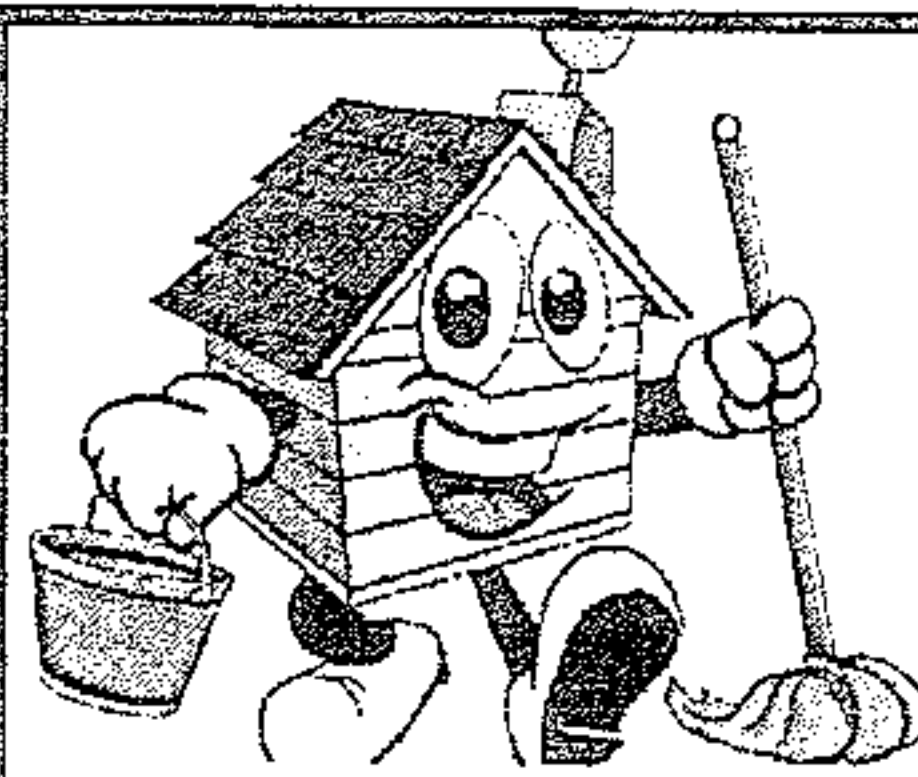

**Sex Offender**

Matthew Justice, 29, White Wing Road Lenoir City, was charged with Violation of Sex Offender Registry, and Assisting other Agency. Cpl. Pete McGinley LCSO, responded to White Wing Road to attempt to locate Mr Matthew Justice.

Mr. Justice Has two arrest warrants. First warrant Violation of Sex Offender Registry out of Loudon County Tn. The second warrant, Monroe County warrant Violation of Probation. Mr. Justice was found at White Wing Rd. and arrested without incident and transported to the Loudon County Jail. This did happen in Loudon County Tennessee.

Elizabeth Davis, 27, Woodland Drive Loudon, was charged with Public Intoxication.

Deputy Anderson LCSO, responded to the area of Hwy 321 South at Tellico Parkway in reference to a intoxicated suicidal person. While enroute Deputy was advised a motorist had almost struck the person. Upon arrival Deputy made contact with Elizabeth Davis, the offender in the roadway. While speaking with the offender Deputy observed an odor of an alcoholic beverage emitting from her persons. The offender stated she drank one

Budweiser beer.

The offender agreed to perform SFST and performed poorly. The offender strongly stated she did not want to harm herself. Based on the totality of circumstances the offender was taken into custody and transported to the Loudon County Jail without incident. All occurred in Loudon County, TN

methods to misappropriate the money.

Zaatini fabricated and submitted at least 65 fraudulent student athlete per diem documents, which often appeared to contain copies of student athletes' signatures. The student athletes told investigators that they had neither signed the documents nor received the per diem payments. Zaatini received money to which he was not entitled.

Investigators also revealed that Zaatini fabricated at least 67 fraudulent documents for reimbursement claiming that he paid for tennis racquets to be restrung while traveling with the team. Investigators determined that Zaatini never incurred or paid these expenses.

Additionally, Zaatini inflated the amounts he paid for tournament registration fees, and he fabricated and submitted fraudulent petty cash documents to obtain student athlete meal money from ETSU.

Zaatini told university officials that he used the

misappropriated money to fund the tennis program, but investigators could not find any evidence that the funds Zaatini fraudulently obtained by creating false documents benefited the ETSU tennis program in any way.

The investigation also found that Zaatini failed to report at least 10 days of leave that he used

in 2016 at a cost to the university of \$3,787. An internal audit revealed that Zaatini failed to report any leave during a nine-year period ending in 2014.

Yaser Zaatini resigned from ETSU on March 16, 2017. On November 3, 2017, Zaatini was indicted by the Washington County Grand Jury on

one count of theft over \$10,000 and 22 counts of forgery.

"Travel reimbursements must always be carefully scrutinized," said Comptroller Justin P. Wilson. "When documents appear suspicious, it's important to ask additional questions."
