
From January 2011 to November 2015, Fortune conspired with others to distribute, and possess with the intent to distribute, 280 grams or more of crack cocaine. During this period, he made regular trips from Johnson City to Winston-Salem, North Carolina, to obtain



This long-term investigation was the product of a partnership between the Johnson City Police Department and Federal Bureau of Investigation. Former Assistant U.S. Attorney Nick Regalia participated in the prosecution and Assistant U.S. Attorneys David Gunn and Christian Lampe represented the United States at trial.



Former Gallatin Employee Charged with Theft

An investigation by the Tennessee Comptroller has found that former Gallatin administrative assistant Jennifer Morris stole at least \$1,173 from the city recorder's office.

Investigators determined that Morris stole the money between June 2016 and December 2016 by withholding cash that she collected and by taking funds from her cash drawer.

Morris concealed her actions by manipulating the city's accounting system. Also, in at least one instance, she removed an entire page of duplicate receipts from the city's manual receipt book. 
