Comptroller's Office Launches Redesigned Property Assessment Data Webpage

Easy to Use, Mobile Friendly, New Features

The Tennessee Comptroller's Office has redesigned its most popular webpage with a new look and simplified search component. The updated webpage also features a responsive design for display on mobile devices.

The Tennessee Property Assessment Data (formerly Real Estate Assessment Data) webpage receives more than 20,000 visitors per day. The page allows Tennesseans to search for property values and other key

information in counties across the state.

The top of the updated page has a simple property search function where users can select a county and then search for a property address, owner name, or parcel id. The page uses a smart fill technology to help visitors find results quickly.

The page also includes more search options for users who want to identify properties by subdivision, sale date, parcel classification, etc. A map of Tennessee allows users

to quickly access information within a particular county.

Other new features include individual property pages that display building sketches and photos, if available. Users can also export and download information in a variety of formats including Excel, CSV, and PDF.

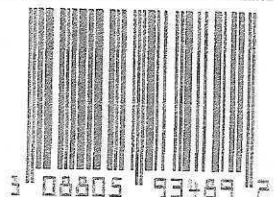

Lonnie Moats, 56, Cox Road Loudon, was charged with Sexual Battery

Deputy Bengel LCSO, responded to Cox Rd for a Sexual Assault call. Upon arrival Deputy spoke to the Victim/Complainant. Victim stated that while at work, the day prior, she had seen a customer wearing a shirt with Scott Newman's name on it. Victim texted/asked her boyfriend who Newman was and he accused her of having an affair with Newman. Victim went on to state that she sent a text to the Offender, Lonnie Moats, to inquire about who Newman was. Moats was not informative and dismissed the question. This morning, victim was in the kitchen preparing for dinner when Moats came in. Victim once again asked Moats who Newman was and had a brief conversation about him. Victim informed Moats about her conversation with her boyfriend and that he had accused her of an

affair with Newman. Moats approached victim, bumped his chest against her chest, and with his right hand groped victim left breast. While Moats approached victim he simultaneously stated "If you are going to have an affair with someone its going to be me". Moats took off to his bedroom and shut the door. Deputy made contact with Moats, still in his bedroom, and while interviewing him he was not very cooperative. After several minuets of asking suggestive questions, Moats admitted to being in the kitchen and his conversation with victim. Moats described the conversation ending abruptly but did not elude to why. When Deputy asked a direct question to Moats about anything else taking place he advised he wanted to speak to an attorney. Moats was subsequently arrested for Sexual Battery and transported to the Loudon County Jail. Said events occurred in Loudon County, TN.

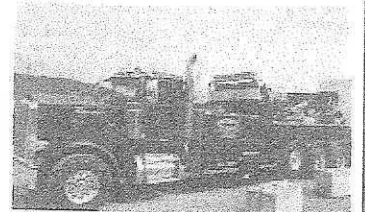

Charges

Nicholas Holmes, 23, Victoria Drive Knoxville, was charged with DUI, Tampering/Fabricating with Evidence, Expiration of Certificates and Plates, Simple Possession, Violation of Implied Consent, and Driving on Roadways Laned for Traffic.

Loudon E911 received multiple calls on a reckless driver on I75 south bound. The complainants stated the vehicle was a blue Honda Civic failing to maintain it's lane. Deputy Huskins, and Sgt. Rogers LCSO, made contact with a vehicle matching the description at the 76 mile marker. While observing the vehicle it did fail to maintain it's lane crossing the fog line multiple times. Deputy Huskins also verified with Dispatch that the vehicle

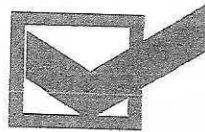
had an expired registration. Upon traffic stop the vehicle did not brake for approximately a half of a mile before it stopped in the fast lane around the 72 mile marker. Deputies successfully moved the vehicle to the emergency shoulder. Upon contact with the driver, Mr. Nicholas Holmes, Deputy noted he had constricted pupils and a very dry mouth consistent with Narcotic use. When Deputy Huskins stepped away from the vehicle Sgt. observed Mr. Holms then reach down inside the front of his jeans. Deputy did conduct ARIDE testing with Mr. Holms and he did show signs of Narcotic Impairment. Deputy noted his pupils had little to no reaction to light. His right nostril was irritated, bleeding and coated with a blue residue. Mr. Holms did consent to a vehicle search which did

produce a THC wax pen as well as a blue circular pill stamped "M7730". Based on the totality of the circumstances Deputy took the offender into custody for DUI and Simple Possession. After placing Mr. Holms in he back seat of his vehicle, and retrieving the TN Implied Consent advisement, Deputy returned to find Mr. Holms chewing on something and had blue residue in his mouth. Mr. Holms refused

to supply a blood sample. Once at the jail, after being Mirandized, Mr. Holms stated he did retrieve one blue pill from his pants and ate it while Deputy was at the rear of the vehicle. Mr. Holms admitted to taking at least one pill prior to being traffic stopped. Mr. Holms further stated he had more pills in his underwear, four blue pills were recovered. Said did occur in Loudon County, TN.

Braydon Corley, 18, Cate Lane Lenoir City, was charged with DUI, Driving on Roadways Laned for Traffic, Prohibited purchase/Poss. of Tobacco Product, Simple Possession, and Poss. Of Drug Para.

Deputy Jackson LCSO, observed a Silver Honda Civic, TN tag # DA01468, swerve across the center line several times, almost completely going into the opposite lane of travel at one point. Deputy conducted a traffic stop on the vehicle on Highway 72, at the intersection of Prospect Church Road. Deputy made contact with the driver of the vehicle, Braydon Corley (offender), who appeared to be nervous, and was not making much sense. Mr. Corley stated that he was going to pick up his friend who worked in Knoxville. When asked why he was in Loudon travelling toward Roane County, he stated he had just dropped his girlfriend off in the area of Davis Ferry Road. Deputy also

asked, why he passed the interstate, and he stated he was going by his house first, however he stated that he lives in Lenoir City just past JB's. Mr. Corley gave Deputy consent to search the vehicle. Upon searching the vehicle, several empty containers for THC vapes were found, along with several nicotine vape pens; also found was a jar that Mr. Corley admitted was used to store marijuana. While searching the cupholder/console area of the vehicle, Deputy located a cigarello wrapper under a drink. Contained in the wrapper were two pills believed to be pressed Fentanyl, bearing the markings "M/30", along with a cigarello. Located in the same area was a cut straw with residue. Along with the above listed evidence, another cigarello, which he referred to as "wrappers" was located on Mr. Corley's person. Mr. Corley was placed in custody, and transported to the jail. The vehicle was towed by James' Towing. Mr. Corley consented to Standardized Field

Sobriety Tests, which were conducted by Deputy Harrison 959, along with ARIDE. Deputy read Mr. Corley the TN Implied Consent form, and he consented to a blood draw. The blood draw was performed at Fort Loudon Medical Center. This occurred in Loudon County, TN.

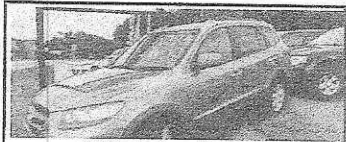

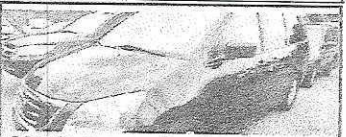

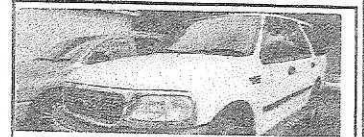

successful webpage is not only easy to use but also adaptable to a desktop computer, phone, or other mobile device," said Comptroller Jason Mumpower. "This page hosts millions of visits each year, and I'm confident that the user experience will be much improved with this new design."

The Tennessee Comptroller's Office maintains property assessment data for 85 of Tennessee's 95 counties that utilize the state's IMPACT Computer-Assisted Mass Appraisal (CAMA) system. The other 10 counties, including Chester, Davidson, Hamilton, Hickman, Knox, Montgomery, Rutherford, Shelby, Sumner, and Williamson, operate their own CAMA systems. The Tennessee Property Assessment Data webpage links users to these counties' websites for property assessment information.

Investigation Details Several Issues within Newport Utilities

Problems Center Around Installation of Broadband and General Operations

The Tennessee Comptroller's Office, working in conjunction with the Tennessee Valley Authority Office of Inspector General, has completed an investigation into Newport Utilities (utilities) which provides electric, water, wastewater, and broadband services in the City of Newport and surrounding areas.

Beginning in 2016, the utilities began installing a broadband system in its service area. As part of the original business plan, utilities management planned to fund some of the initial construction and maintenance costs with an interdivisional loan from its electric division. Newport Utilities and TVA executed an agreement in September 2017 which allowed the electric division to loan the broadband division up to \$3.3 million for capital expenditures associated with the broadband project. Investigators determined that Newport Utilities exceeded that amount by at least \$4,692,654.

In May 2017, the Comptrol-

ler's Office had also reviewed a detailed business plan for Newport Utilities and could not determine if the plan was feasible based on certain assumptions and methodologies in the plan, including failing to consider the impact of market competition.

Utilities management also failed to establish a separate accounting unit for its broadband division to track revenues and expenses despite advice from consultants, regulators, and its external auditing firm. A separate accounting and record keeping system is also required by state law.

Additionally, utilities management did not document that competitive bids were solicited for certain broadband related construction, supplies, and other services. For example, in one instance a company tasked with installing fiber in individual homes ordered at least \$519,545.80 in supplies that were billed to the utilities. Investigators found no evidence that the utilities had either a contract with this vendor or that the supplies had been competitively bid. A subsequent analysis performed by the utilities concluded the vendor charged more than double the price of its competitors in some instances.

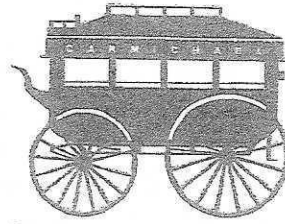
The investigative report also describes several other issues which are summarized below:

The Newport Utilities Board of Directors' employment decisions resulted in avoidable settlement payments totaling \$900,000 to its former managers.

The former general manager, who resigned on January 22, 2020, approved unallowable work of at least \$160,739.36 on an Appalachian Regional Commission grant. The grant was for a broadband project along a 10.73 mile route for the Hartford and Grassy Fork communities in Cocke County; however, work was performed outside the grant-approved route using the grant money.

The utilities paid inflated rental and administrative fees of at least \$102,175 to rent a portion of a commercial building for storing broadband installation supplies.

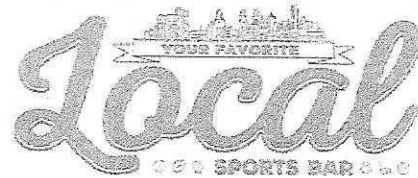
