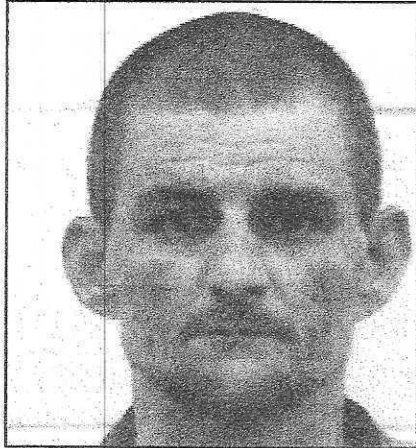

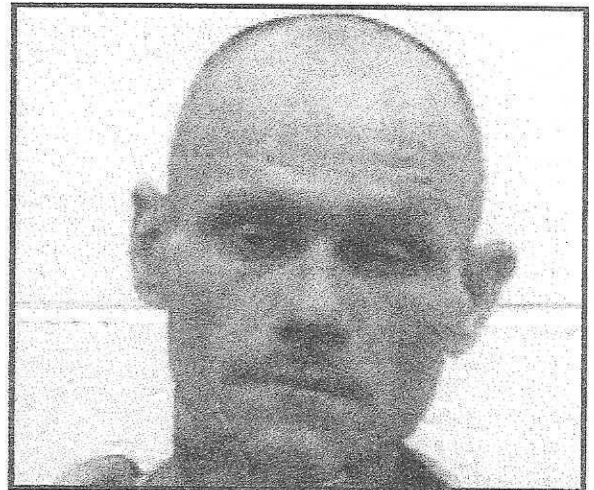

Chicago Man Charged with Federal Firearms Offenses

Found In Possession Of More Than 20 Guns And High-Capacity Magazines Following "Gun Show" Firearms Purchases

Quintin Lewis, 31, of Chicago, IL, was arrested today, in Knoxville, Tennessee for committing various federal offenses, including being a felon in possession of firearms, possession with intent to distribute narcotics, and possession of firearms in furtherance of drug trafficking.

Lewis appeared in the United States District Court for the Eastern District of Tennessee, before the Honorable Jill E. McCook, United States Magistrate Judge, and pleaded not guilty to the charges.

According to the February 27, 2022 criminal complaint on file with the Court, Lewis's arrest fol-

lowed investigative activity at two recent local "gun shows" and the subsequent execution of a search warrant at a Knoxville area apartment that resulted in law enforcement officers seizing a total of 20 firearms, including a fully auto-

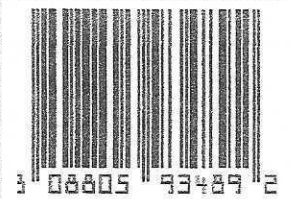

Andrew Crossno, 37, Trenton Street Harriman, was charged with Simple Possession, Expiration of Certificates and Plates, and Signals for Turn.

Kathryn Fyfe, 32, Trenton Street Harriman, was charged with Simple Possession x3.

Deputy Green LCSO, was observing traffic traveling north on Interstate 75 near MM 78. Deputy observed a white Chrysler PT Cruiser displaying indications of criminal involvement. Deputy followed behind this vehicle to observe. Deputy observed this vehicle make several lane changes without properly signaling. This vehicle also had an expired registration plate. Deputy conducted a traffic stop at the Waffle House on Hwy 321. Deputy made contact with both occupants who immediately appeared nervous. This nervous behavior continued after advising both occupants Deputy only intended to issue a warning citation for the traffic offenses which lead him to believe the occupants were engaged in criminal activity. Deputy requested both occupants outside of the vehicle to which they agreed. As the front right passenger, Kathryn Fyfe exited the vehicle Deputy observed her attempt to conceal a small dark box under a pillow on top of the seat. Deputy

asked both occupants if there was anything illegal inside of the vehicle in which they both denied. Deputy requested consent from the driver, Andrew Crossno, to conduct a search of the vehicle to which he gave an indirect answer, eventually stating he did not grant me consent. Having reasonable suspicion there was illegal contraband located inside the vehicle, Deputy requested K9 Sgt. C. Hutchens to respond to his location to deploy his K9. Ms. Fyfe inquired as to what the next procedure would be. Deputy advised her Mr. Crossno denied consent to search the vehicle so both parties would be temporarily held while awaiting a K-9 to perform a sniff of the vehicle. Ms. Fyfe freely stated she possessed a personal amount of Marijuana inside her purse inside the vehicle. Deputy conducted a probable cause search of the vehicle and recovered a small amount of Marijuana inside of a grinder inside Ms. Fyfe's purse along with a prescription bottle with the label scratched off containing 18 round white pills with the imprint "AN 627" identified as Tramadol. Deputy also recovered the small box under the pillow which contained a spoon with burn marks, filters, approximately .3 grams of a grey gravel substance believed to be Heroin (awaiting TruNarc), and several syringes. Both parties stated

they had knowledge of what they believed to be heroin inside the vehicle but neither claimed ownership of it. Ms. Fyfe did claim ownership of the prescription medication and marijuana. Deputy could not establish the sole owner of the heroin and paraphernalia therefore both parties were taken into custody and charged with Simple Possession of Sch. 1. Ms. Fyfe was

charged with Simple Possession of Schedule 1, Schedule 4, and Schedule 6. Both parties were transported to Loudon County Jail without incident.

Once on scene at the jail, prior to entering the facility, Ms. Fyfe stated she had a small amount of Marijuana inside her bra. The total weight of the suspected Marijuana was 6 grams.



Corporal Z. Frye LCSO, responded to Zion Ridge Rd in reference to a physical domestic. The caller stated she was assaulted by her husband and he hit her across the face with a chair. On scene Deputy made contact with, Complainant and victim. Victim stated that she and her husband, Larry Keeton, had gotten into a verbal argument. She further stated that the argument then turned physical and he began screaming and getting in her face. She stated she began to push him away and one point he threw an object striking her in the back of the head. She stated she wasn't sure what he threw but thought it may have been a cell phone. Deputy did observe a large laceration to the back of her head that was

bleeding. She also stated he then picked up a kitchen chair and struck her across the face with it. Deputy did observe her upper lip to be extremely swollen with a laceration on the inside and outside of the lip. Deputy then made contact with Larry Keeton. He stated they had gotten into an argument because she wanted pills from him. He stated she had been throwing him all over the house all night and that she caused all those injuries to herself.
