## Suspended Driver Charged by LCPD After Suspicious Driving

## Charles Phelps, Member Of A Prison Gang, Sentenced To 156 Month For Conspiracy To Distribute Methamphetamine

On March 14, 2022, Charles Phelps, 36, currently of Nashville, Tennessee, was sentenced to 156 months by the Honorable J. Ronnie Greer, in the United States District Court for the Eastern District of Tennessee at Greeneville.

As part of the plea agreement filed with the court, Phelps pleaded guilty to an

indictment charging him with one count of Conspiracy to Distribute 50 Grams or More of Actual Methamphetamine, U.S.C. 21 U.S.C. §§ 846, 841(a)(1), and (b)(1)(A). Following his release from prison, Phelps will be on supervised release for five years.

According to the written plea agreement filed with the

court, Phelps, a member of a prison gang led by co-defendant Charles Elsea, Jr., conspired with gang members and others to distribute large quantities of methamphetamine into Tennessee. One of Phelps' roles was collecting and delivering money for the organization. On February

**Chase**

Javis Dean, 38, Franklin Street Alcoa, was charged with Reckless Endangerment x2, Evading Arrest, and Driving on Revoked/Suspended License.

Corporal Z. Frye LCSO along with Deputy C. Lane and other Loudon County deputies were stationed on I-40E shoulder at the 369mm on-ramp for an incoming pursuit by Cumberland County SO. Cumberland County gave a vehicle description of a white Chevy Tahoe and advised speeds in excess of 100mph, driven by a black male with an orange shirt. At the 369mm Cpl. observed the white Tahoe to swerve to the shoulder of the interstate in an attempt to exit at the 369 exit and then

quickly swerve back onto the interstate continuing to travel at speeds close to 100mph. When the Tahoe swerved back onto the interstate from the exit ramp it came within a few feet of striking both his stationary patrol vehicle and Deputy C. Lane's patrol vehicle. Cpl. then initiated pursuit of the vehicle and Cumberland County units terminated from the pursuit. The pursuit continued into Knox and Blount counties. The vehicle eventually wrecked at the intersection of N Wright Rd and Burroughs Rd in Alcoa. When Cpl. arrived at the vehicle the driver was not in the vehicle. Alcoa units along with Blount Co were able to detain a black male running through a yard a few blocks from the wreck scene. The male matched the

description that Cumberland Co provided as the driver of the Tahoe. The male was identified as Javis Dean. Inside the Tahoe was located a credit card with Javis Dean on the card. Blount County used a K9 to track from the vehicle and the K9 tracked to the exact location that Javis Dean was located at. Also shoe prints were located on the ground leading from the vehicle to where Dean was

located and the shoe prints matched the shoes that were on Dean. Javis Dean's actions placed Cpl. and Deputy C. Lane in imminent danger by driving his Tahoe at speeds of 100+ mph and nearly striking their patrol vehicles. Dean was found to have a revoked DL for a previous DUI. Dean is charged with Reckless Endangerment (X2), Felony Evading and Driving on Revoked License.

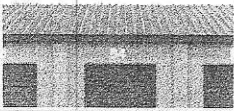

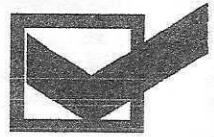

16, 2020, Phelps was traffic stopped with \$119,000 in cash, concealed in the spare tire of his vehicle. The money was being transported out west to purchase pounds of methamphetamine. The money was seized by local law enforcement during the traffic stop. The investigation spanned the country, with multiple local and federal agencies working together to identify persons involved.

The criminal indictment was the result of an investigation by the DHS-HSI, DEA, USPS, and with the assistance of Tennessee Department of Correction Office of Investigations and Conduct; Elizabethton, and Carter County Joint Drug Task Force; Huron Undercover Narcotic Team with the Michigan State Police; the Arkansas Highway Patrol; Missouri Western Interdiction Task Force with the

Kansas City, Missouri Police Department; California Visalia Police Department. This investigation was led by HSI Special Agent John Bulla.

Assistant U.S. Attorneys Meghan L. Gomez represented the United States at sentencing.

This investigation is part of an Organized Crime Drug Enforcement Task Forces (OCDETF) investigation. OCDETF identifies, disrupts, and dismantles the highest-level drug traffickers, money launderers, gangs, and transnational criminal organizations that threaten the United States by using a prosecutor-led, intelligence-driven, multi-agency approach that leverages the strengths of federal, state, and local law enforcement agencies against criminal networks.
