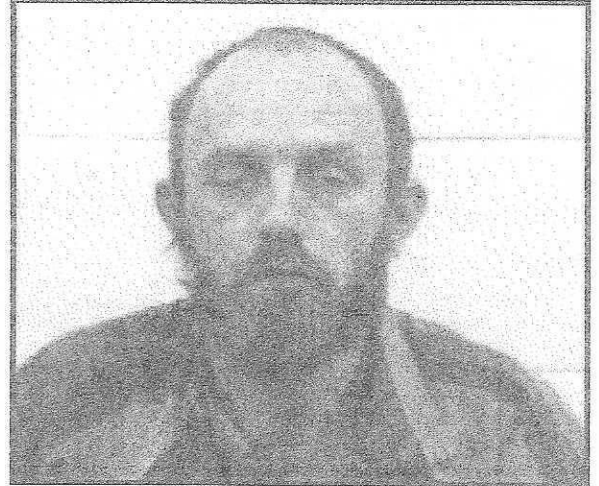

DEA National Prescription Drug Take Back Day

Dispose of your used, unwanted, and expired medicine safely on April 30th, 2022

On Saturday, April 30th, from 10 a.m. to 2 p.m., the U.S. Drug Enforcement Administration will provide the public the opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Location information is available from the DEA, along with items that cannot be accepted. This ser-

vice is free and anonymous, no questions asked.

This April's event is DEA's 22nd nationwide event since its inception 11 years ago. Last spring, Americans turned in nearly 744,082 pounds of prescription drugs at nearly 4,982 sites operated by the DEA and almost 5,000 from its state and local law enforcement partners.

The DEA will now

accept vaping devices and cartridges at any of its drop-off locations during National Prescription Drug Take Back Day. It is important to note that DEA cannot accept devices containing lithium-ion batteries. If batteries cannot be removed prior to drop-off, DEA encourages individu-

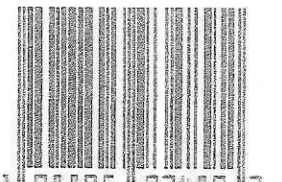

Ruth Tippens, 53, Homeless, was charged with Poss. Of Drug Para., Mfg/Del/Sale or Poss. Of Meth, Light required on motor vehicle, and Driving unregistered vehicle.

Corporal Z. Frye LCSO, observed a green Honda Accord traveling on Hwy 70 E without a functioning passenger side headlight and the registration came back

expired since October 2020. Upon traffic stop Cpl. made contact with the male passenger. Upon check of his name and DOB, he came back to have 5 active warrants out of Knox Co. He was placed under arrest and transported to Knox Co. Cpl. then spoke with the Driver, Ruth Tippens. She stated she was aware of her registration being expired but stated she was living out of the vehicle

and did not have a chance to renew the registration. Consent to search the vehicle was given and in the driver side door Cpl. located a small metal box and inside was approximately 3.5 grams of a crystal substance believed to be methamphetamine. Tippens did state it was meth when asked. Also located inside Tippens' purse was a small metal box with one cut straw with powder residue and several small baggies with

powder residue. Tippens was placed under arrest for Possession of Methamphetamine, Possession of Drug Paraphernalia and cited for Lights Required on a Motor Vehicle and Driving an Unregistered Vehicle. The vehicle was towed and a hold for proof of ownership was placed. Tippens was then transported to the Loudon County Jail. This all occurred in Loudon County, TN.

Bad Mix

Sherina Crabtree, 36, Horace Taylor Road Maryville, was charged with DUI, Violation of Implied Consent, Simple Possession, and Contraband in Penal Institution.

Deputy Clay Jenkins LCSO and Deputy Michael Phillips, came into contact with a red Honda Accord pulling into a parking spot at 12505 Hwy 72 N (McDonalds) after being flagged down by an unknown driver advising the female driving the vehicle was intoxicated. Deputy then spoke to the driver Sherina Crabtree who appeared lethargic, had slurred speech, and could hardly hold her eyes open. Deputy Jon Sartin LCSO arrived on scene and performed Standard Field Sobriety Testing in which Ms. Crabtree performed poorly. Ms. Crabtree admitted to officers that she had smoked Mar-

ijuana earlier in the day and took a few Hydrocodone pills that morning. Ms. Crabtree consented to a search of her vehicle in which a small marijuana joint was found inside of a cigarette pack in the passenger side floor board. Ms. Crabtree was read TN Implied Consent and refused a blood draw. She was then taken into custody and transported to the Loudon County Jail by Deputy Will Jenkins. Before entering the jail Deputy found in his backseat 2 blue circle pills (imprint C1) Clonazepam. He then asked Ms. Crabtree if she had anything else illegal before entering the jail and she said no. Once inside of the jail, 9 more Clonazepam pills were found on Ms. Crabtree as she was attempting to put them in her vagina.

All of this did occur in Loudon County.
