Camper Sold and Stolen; One Charged

Former Leapwood Volunteer Firefighter Withdrew \$12,087 from VFD Account

Leapwood VFD serves Adamsville in McNairy County

An investigation by the Tennessee Comptroller's Office has found that a former Leapwood Volunteer Fire Department firefighter made unauthorized ATM cash withdrawals from the department's bank account totaling \$12,087.49.

The former firefighter used the department's debit card, which was issued in

the name of the department fire chief. The debit card was mailed to the chief's home after the department's bank changed its name. The fire chief stated the former firefighter, who was his son, took possession of the new debit card along with the associated pin number once they arrived in the mail.

The unauthorized withdrawals were made at various ATMs be-

tween September 1, 2019 and October 31, 2019. In February 2020, the former volunteer firefighter admitted and apologized for his improper actions after he was shown a bank security photo of him making a cash withdrawal. The former firefighter continued to serve with the Leapwood VFD until

The results of the investigation have been shared with the District Attorney General for the 25th Judicial District. It should be noted that while the death of the former firefighter prevents his criminal prosecution, his death does not abate any civil cause of action that Leapwood VFD might otherwise have against the estate or personal representative of the former firefighter.

"It's important that volunteer fire departments provide oversight over their finances," said Comptroller Jason

Mumpower. "In this situation, a simple review and reconciliation of the department's bank statements might have detected this improper activity sooner."

Cpl. Anderson LCSO, responded to Bimbos in reference to a theft. Upon arrival, Deputy made contact with the victim. The victim stated she had purchased an RV camper (see list) on 04/05/22 from Josiah Delgado, the offender, for \$6500 dollars cash. The victim stated she had inspected the RV at The Storage Yard 5607 Hwy. 321 N. with the offender in lot #223. The victim stated on this date she went to retrieve the RV and it was gone. The victim stated she had last seen the RV on 04/10/2022. The victim then stated she called the offender multiple times with no answer. The victim produced new paperwork showing her to be the owner. The victim also stated she had been in touch with The Storage Yard and they told her they have cameras but would not be able to help until the next business day. They put LT. in contact with the individual that hired them to tow the camper, LT. spoke with the male and he informed him that he spoke with a about purchasing the camper last week around Thursday. He met with him at Loudon Hospital due to Mr. Sanchez' daughter allegedly being in the hospital. There Mr. Sanchez wrote victim a bill of sale for the camper and \$4,000.00 was given as payment for it. Victim 2 then went to the storage facility and attempted to get in using a pin code that Mr. Sanchez gave him but it did not work. Mr. Sanchez gave him another pin number to try and it did not work either. Mr. Sanchez came to the storage lot with victim and the wrecker driver and at that time someone was leaving the lot which allowed them to enter through the open gate. The wrecker hooked up to the camper and victim 2 was given keys that were supposed to be for the camper and all parties went their separate ways. When victim 2 got to his grandfathers where he is storing the camper he attempted to use the keys to enter it. The keys did not work for the camper. LT. have spoken with the victims as well and exchanged information for them to work out returning the camper to the victim. 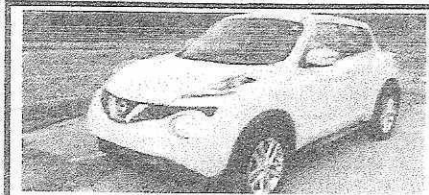
