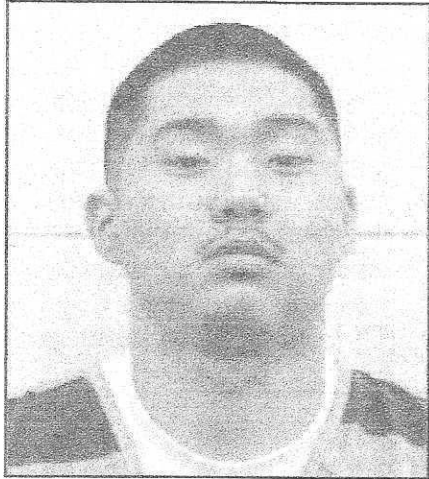

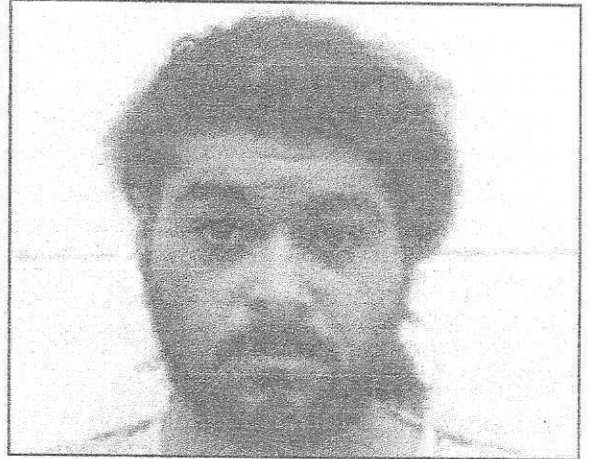

TDOT Halts Highway Construction for the Holiday Travel Period

No Lane Closures on Interstates and State Routes

Road construction won't delay travelers during the Christmas and New Year's holidays. The Tennessee Department of Transportation (TDOT) is once again halting all lane closure activity on interstates and state highways in anticipation of higher traffic volumes across the state. No

temporary lane closures will be allowed for construction on Tennessee roadways beginning at 11:59 p.m. Monday, December 23, 2024, through 11:59 p.m. on Wednesday, January 1, 2025.

AAA expects an estimated 2.7 million Tennesseans to travel between December 21 and January 1 with 2.58 million of them driving.

"Safety is our top priority and with so

many people expected to travel Tennessee roadways during the holidays, we want to keep traffic moving and get everyone to their destinations," said Deputy Governor & TDOT Commissioner Butch Eley. "As always, please wear your seatbelt, reduce your speed, avoid distractions, and move over for emergency

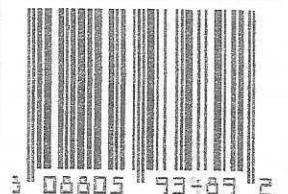

Claude McCorkle, 30, Farmer Road Kingston, was charged with, Simple Possession.

Deputy Harrison LCSO, was dispatched to a wreck with no injury on Interstate 40 westbound in the area of the 368 mile marker. Loudon County Dispatch advised a 3rd party caller stated they observed a silver vehicle strike the guard rail but could not stop to check on them. Once in the area, the deputy made contact with the

vehicle on Interstate 40 westbound at the 364-mile marker. The deputy made contact with the driver, Claude McCorkle who stated he was in the number one lane as his vehicle veered off the roadway to the left, and as he attempted to correct back onto the highway, his vehicle spun out causing him to strike the guard rail on the right shoulder. While speaking with McCorkle, the deputy could smell the odor of marijuana emitting from his person and the vehicle. The deputy asked McCorkle when

the last time he smoked marijuana in the car was and he stated earlier in the morning. McCorkle also stated there was a small amount of marijuana in the vehicle between the driver seat and the center console. Once Deputy Slattery arrived on the scene, the deputy conducted a probable cause search of the vehicle. While conducting the search, the deputy located a small amount of marijuana where he said it would be in the vehicle. McCorkle told Deputy Slattery he was also in possession of cocaine in a small black wallet

inside the vehicle which the deputy did locate. At this point, McCorkle was placed in custody, and during a search of his person Deputy Slattery located another small clear baggie of white powder substance in his right pants pocket. McCorkle was read Miranda and transported to the Loudon County Jail by Deputy Slattery. Money makers arrived and impounded the vehicle. Narcotics was notified and the total amount of both white powder substances was approximately 1.7g. This did occur in Loudon County, Tennessee.

Wreck

Zackary Davis, 26, Macedonia Road Loudon, was charged with, DUI, Violation of Implied Consent, and Open Container.

Deputy Jackson LCSO, responded to a wreck at Steekee Road. Loudon County Dispatch told me they received an automatic crash alert notification in this area. While en route to the location, Dispatch advised that the neighbor called in and told them two males had fled from the vehicle. Upon arrival at the crash site, the deputy saw a red Dodge Charger that appeared to be totaled, in the ditch. The deputy looked in the vehicle to see if there were any other passengers and noticed an almost empty 750 ml bottle of tequila on the driver's side floorboard. While the deputy was at the vehicle, Deputy

Davis, saw the two occupants walking back to the site. Upon Deputy Davis making contact, the driver was identified as Zackary Davis. Deputy Davis, and Jackson, noticed that Zackary had bloodshot eyes, and was emanating the odor of an alcoholic beverage from his mouth, especially when he spoke. The deputy asked Zackary if he would consent to Standardized Field Sobriety, and he refused. Zackary admitted that he lost control of the vehicle, causing the wreck. Due to the circumstances, Zackary was taken into custody. I read him implied consent, and he refused. While reading him implied consent, he spontaneously admitted to drinking alcohol and driving. The deputy transported him to the jail, without incident. This occurred in Loudon County, TN.

Brian Cho, 24, Lucerne Street California, was charged with, Man/Sell/Del/Resale Sch. II.

Jhon Urrutia, 35, Smokey Crossing Way Seymour, was charged with, Man/Sell/Del/Resale Sch. IV. Trooper Fletcher THP, traffic stopped a Gray KIA Telluride on I-75 N around the 72 MM for following too closely and suspicion of illegal window tint (32%). 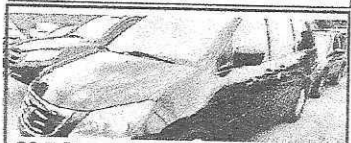

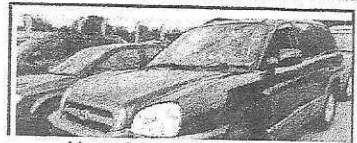

Except for a few long-term closures that must remain for safety, all construction-related closures will be suspended during the holiday period. Workers may still be on-site in some construction zones. Drivers should obey all posted speed limits, particularly in construction areas. Slower speeds are necessary in work zones due to the temporary layout of the roadway and will be enforced. Drivers convicted of speeding through work zones where workers are pres-

ent face a fine of \$250 to \$500, plus court fees and possibly increased insurance premiums.
