## Jonathan Bash Sentenced To 21 Years Imprisonment For Distribution Of A Fentanyl Analogue Resulting In Death

Jonathan Bash, 25, of Chattanooga, Tennessee, was sentenced to 252 months' imprisonment by the Honorable Curtis L. Collier, United States District Court Judge for the Eastern District of Tennessee at Chattanooga, after distributing para-fluorofentanyl, resulting in the overdose death of Charlotte Gallant. Following his incar-

ceration, he will be on supervised release for five years.

As part of the plea agreement filed with the court, Bash pled guilty to distributing para-fluorofentanyl, a fentanyl analogue, that resulted in the death of 19-year-old Charlotte Gallant, in violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(C). According to the plea agreement, Bash sold a fentanyl ana-

logue to a young man who shared it with his girlfriend, Ms. Gallant. According to filed court documents, Bash misrepresented the drug as ketamine, a commonly abused "club drug" that is often used for its perceived anesthetic and hallucinogenic effects. Both the young man to whom Bash sold the fentanyl analogue and

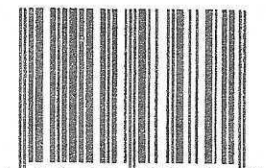

### DUI+

Jacob Dailey, 24, Homeless Loudon, was charged with DUI, Disorderly Conduct, Resisting Arrest, and Assault.

Deputy Stanley LCSO, responded to a call regarding a Reckless Driver in the area of Highway 72 near Malone Road. Upon arrival, Deputy observed a Red Chevy pickup truck parked in the lane of travel. A white male subject, later identified as Jacob Dailey, was seen walking in the on coming lane of travel beside the truck. Deputy Stanley as well as State Representative Lowell Russell, who was on scene at the time of his arrival, attempted talking

to Jacob and get him out of the road way for his and our safety. Dailey seemed very anxious, and was fidgeting while talking with him. Due to my observations of Dailey's speech, facial expressions, and mannerisms. Deputy believed Dailey to have been under the influence of narcotics.

Deputy Stanley and Mr. Russell continuously tried to get Dailey out of the roadway, in which he refused verbal commands. At that point the deputy attempted to detain Dailey where he then resisted and fled on foot West on Highway 72. A foot pursuit ensued. It appeared during one point in the foot pursuit, Dailey attempt to

gain access to a bystander's vehicle. Dailey then started running in the opposite direction. Dailey then fell to the ground beside another bystander's vehicle. Deputy then gave him verbal commands to get on his stomach. Dailey started to get up again, in which the deputy deployed my Taser and struck him the Taser probes. After the Taser activation, Dailey attempted to crawl under the bystander's vehicle. At that time deputy Stanley along with Loudon City Officers Kelley, Cogdill, and off Duty Loudon County Corrections Deputy Ramsey were able to place Dailey into custody. Dailey continued to resist officers while attempting to place him in the back of a patrol vehicle. Deputy was informed by Cpl. Hawkins that Dailey was kicking him throughout the encounter.

Dailey was then transported to the Loudon County Jail by Cpl. Hawkins. The red Chevy truck was retrieved by James Towing. All events occurred in Loudon County.

Charges as follows: Driving Under the Influence, Resisting Arrest, Assault, and Disorderly Conduct. Standardized Field Sobriety Tests were not conducted on scene due to Dailey's combative behavior.

Deputy was later informed by Representative Russell about the events leading up to the incident. Mr. Russell advised that the red pickup truck that was BOLOD out previously by Monroe County Dispatch. Mr. Russell advised the vehicle in question had approached his from behind at a high rate of speed on Highway 72. Mr. Russell then advised Dailey had passed him in the oncoming lane and cut him off. Mr. Russell advised Dailey had reached speeds of 110 miles per hour and would slow down to 45 miles per hour occasionally. He also advised the truck veered over to the opposite lane and stopped on two different occasions. Shortly after that point the vehicle had stopped again on Highway 72, and Mr. Russell awaited for law enforcement arrival.

William Umstead, 57, Hurst Circle Lenoir City, was charged with Domestic Assault.

Deputy Brockwell LCSO, arrived at Hirst Circle for a physical domestic. When deputy arrived on scene he spoke with a female (the victim). She stated that her boyfriend, William Edward Umstead (the offender), lunged at her and tried to hit her when she was recording his behavior. When the deputy came in contact with the victim she was crying and breathing heavily. She then stated that they both drank some alcoholic beverages and he tried to leave to grab some food. That is when she grabbed his keys and hid them to prevent him from leaving. Umstead became very irate towards the victim when he could not find his keys. The victim then showed me a video recording of Umstead coming into her

room and breaking her door. That is when he confronted her about his keys being missing and sat down on the bed in front of her. Ms. Gallant overdosed. The young man suffered serious bodily injuries but ultimately survived the overdose. Paramedics were unable to revive Ms. Gallant, who died shortly after ingesting the drug.

"This is a tragic case. Using any kind of narcotic acquired on the streets or even from a friend, regardless of how the drug appears to be marketed, can unknowingly lead to the use of fentanyl, and the effects can be lethal," said United States Attorney Francis M. Hamilton, III. "Our office will continue to prosecute these cases to bring justice to the community and the families of the victims, including Ms. Gallant and her family."

"The U.S. Postal Inspection Service values our law enforcement partners and the U.S. Attorney's office in the Eastern District of Tennessee who brought justice to this

investigation," said Tommy D. Coke, Inspector in Charge of the Atlanta Division. "This case sends a clear message that the U.S. Postal Inspection Service along with our law enforcement partners will work tirelessly to protect the communities we serve by combating the flow of deadly drugs like fentanyl and holding drug traffickers accountable."

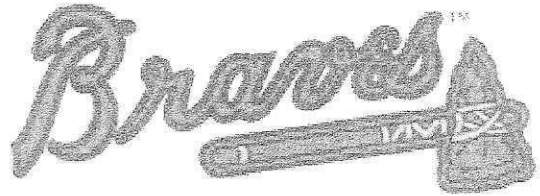
