Charged

Jason Hawk, 50, Michael Lane Madisonville, was charged with, Mfg/Sell/Del/Resale Sch. II, Mfg/Del/Sale or Poss. of Meth, and General Session Capias.

William Riden, 62. Riden Road Greenback, was charged with, Violation of Probation, and Maintaining a Dwelling Drugs Sold.

Investigators with the Loudon County Sheriffs Office executed a search warrant at Riden Road, Greenback, TN. Entry to the residence was made by Loudon County Swat, who came into contact with two subjects inside the residence, Jason Hawk and William Riden. Both subjects were detained and a search of the residence was conducted. Upon searching the residence, units recovered a small black bag in an unoccupied room. This room

was located adjacent to Mr. Hawk's bedroom. The room was full of miscellaneous items and appeared to be used for storage. Located inside of the black bag was approximately 25.5g of an orange powder substance, 15.1g of a teal powder substance, 1.3g of a clear crystal-like substance, 5 round blue pills, and 5 oval blue pills. Both powder substances were tested using a TruNarc device which tested positive for "Butyryl Fentanyl" and the clear substance tested positive for Methamphetamine. The pills are awaiting analysis from the TBI Lab. In Mr. Hawk's bedroom units recovered digital scales and a blender with a teal powdery residue, believed to be used to distribute Fentanyl along with \$765 in US currency in various denominations, believed to be the proceeds of drugs transactions. Upon en-

tering Mr. Riden's room, investigators observed a large quantity of drug paraphernalia scattered throughout the room including syringes (new and used), burned tinfoil, baggies with apparent drug residue, etc. There was evidence of the use of controlled substances in every room of the residence. Mr. Hawk and Mr. Riden were transported to Loudon County Jail without incident. Mr. Hawk is being charged with

with Manufacture, sell, delivery of schedule 2, Manufacture, sell, delivery of Meth, and unlawful drug paraphernalia. Mr. Riden did state he owned the property of 470 Riden Road. Investigators believe this residence is primarily being used for the use and distribution of controlled substances, therefor,

Mr. Riden is being charged with Maintaining a dwelling where drugs are used and sold.

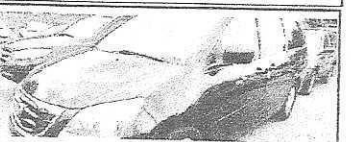

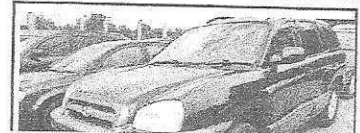

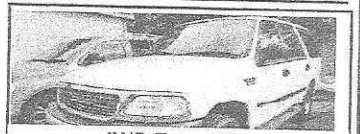

The 114th General Assembly honored a Knoxville-based Tennessee Air National Guard unit as they seek to secure the next generation of air refueling aircraft.

House Joint Resolution 36, sponsored by State Rep. Lowell Russell, R-Vonore, recognizes the 134th Air Refueling Wing of the Tennessee Air National Guard (TANG) stationed at McGhee-Tyson Air National Guard Base (ANGB) and urged the U.S. Air Force to select the unit to receive the KC-46 Pegasus.

"The men and women of the 134th Air Refueling Wing have demonstrated unwavering dedication in service to both our state and nation for decades," Russell said. "The cutting-edge facilities at Mc-

Ghee-Tyson ANGB make it clear that this unit is the ideal choice for the KC-46 Pegasus."

KC-46 Pegasus, a new tanker aircraft developed by the U.S. Air Force, will replace the aging air refueling fleet of KC-135 Stratotankers, which first entered service more than 60 years ago.

In recent years, McGhee-Tyson has made significant improvements in preparation for the potential arrival of the KC-46, including a \$134 million 10,000-foot runway, and a \$32.4 million maintenance hangar to house the tanker. The unit also published a KC-46 conversion study in 2022, highlighting the benefits of placing the tankers at McGhee-Tyson ANGB.

The 134th Air Refueling Wing of the Tennessee Air National Guard has been

based out of the McGhee Tyson ANGB since 1957.

Russell was joined by several lawmakers on Feb. 11 to present the resolution to senior military officials of the unit and Tennessee Air National Guard. You can read the entire resolution here.

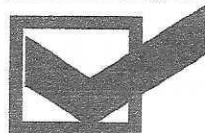

Timothy Palaske, 55, Hampton Place Circle Loudon, was charged with, DUI.

Deputy Ryne Miller LCSO, was traveling on Highway 72 when he witnessed a blue Chevrolet Malibu traveling in the same direction on Highway 72. The deputy witnessed the vehicle swerve into the opposite lane of travel crossing the double yellow line. The vehicle then corrected and reset in the proper lane and began turning into the ORNL on Highway 72. The deputy initiated a traffic stop there, and upon approaching the vehicle, identified the driver as Mr. Timothy Palaske. While speaking with Mr. Palaske, the deputy noticed an odor of an alcoholic beverage emitting from the vehicle and that he had bloodshot and glassy eyes. When asked to present his Driver's License, registration, and proof of insurance, Mr. Palaske handed him two credit cards along with his ID. The deputy then asked Mr. Palaske if he had had anything to drink or taken any prescription drugs to which he answered, "No".

The deputy then asked Mr. Palaske to step out of the vehicle to which he complied. After exiting the vehicle, the deputy noticed the same odor of an alcoholic beverage emitting from Mr. Palaske's person. Sgt. Pesterfield then arrived on scene to assist with Standardized Field Sobriety Tests (SFSTs). Tim performed poorly on Horizontal Gaze Nystagmus, exhibiting all of the available clues. Mr. Palaske couldn't remain in the instructed position when being instructed on how to complete the Walk and Turn. He used his vehicle to balance and couldn't remain upright on his feet. The Walk and Turn was attempted three separate times and each time he started the test too soon and almost fell. Due to Mr. Palaske's intoxicated state, and inability to maintain his balance, the tests were terminated for his safety. The deputy then placed Mr. Palaske in custody for DUI. Implied consent was read and subsequently refused by Mr. Palaske. Mr. Palaske was then transported to the Loudon County Jail without further incident.

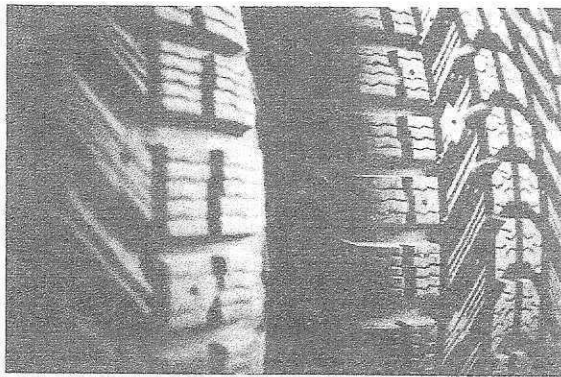
