Two Charged in Connection to Overton County's Afterschool Program

An investigation by the Tennessee Comptroller's Office has resulted in the indictments of two women after they received at least \$22,620 in improper compensation for time they did not work. Both women formerly worked for the Overton County School System's afterschool program.

The investigation began after the Overton County Director

of Schools identified and reported these issues to the Comptroller's Office.

The investigation's findings include:

Samantha Stephens, who served as program coordinator at AH Roberts Elementary School, improperly received at least \$9,010 in compensation by reporting 336.5 hours of time not worked.

Deborah Roddy, who also served as a

program coordinator at AH Roberts, improperly received at least \$13,610 in compensation by reporting 450.5 hours of time not worked.

A family member of Roddy, who worked as a program employee at Hilham Elementary School, and also served in the summer school program, improperly

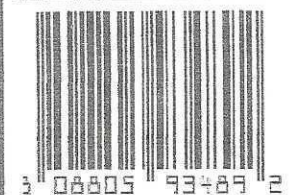

Justin Wiles, 30, Wade Road West Loudon, was charged with Domestic Assault. Deputy Brockwell LCSO, alongside Deputy Davis, arrived at Wade Road West for a domestic. When we arrived on scene, Deputy Davis spoke with the first offender, Justin Wiles, about the domestic. The deputy spoke with the second offender, Kaitlyn Mills, about what happened. Mills stated that her and her boyfriend, Wiles, were out drinking and hanging out with some

friends. When they got home the argument continued and that is when her and their child went into the bathroom to get ready for bed. She then stated that she broke something in the shower and that is when Wiles got mad once again and through a flowerpot at her but missing her in the living room. The argument continued and both Wiles and Mills stepped outside. When they were outside Mills stated Wiles threw a rock at her hitting her in the upper right arm. This is when Mills called dispatch that there was a domestic. Mills did have injuries corresponding with this story. The deputy then spoke with Deputy Davis and got Wiles

Charles Eldridge, 63, Old Sugarlimb Road Loudon, was charged with Domestic Assault.

Cpl. J. Sartin LCSO, was dispatched to Old Sugarlimb Road in reference to a physical domestic.

According to the report, Upon arrival, the deputy could hear arguing in the house and knocked on the door multiple times before Mr. Charles Eldridge answered it. The deputy had Mr. Eldridge step outside and he detained him. The deputy then read Charles his Miranda Rights and asked him what had happened and he kept saying nothing happened. Deputy Brewer and Sgt. B. Smith talked to the complainant and victim. Deputy Brewer stated the complainant and victim said Charles slapped a beer out of the victim hand then he grabbed the victim by his collar and began jerking him around and was also jerking him around by his jacket.

The victim stated he was in fear of his brother and did not feel safe around him. Charles was taken into custody for Domestic Assault and transported to the Loudon County Jail.

Melody Shaver, 55, Shaw Ferry Road Lenoir City, was charged with, DUI, Poss. of Drug Para., Tampering/Fabricating with Evidence, Expiration of Certificates and Plates, and Motor Vehicle Window with Tinting, Reflecting, or Sun Screen Material.

Trooper H. Singh, THP, was sitting stationary at the mile-marker 366 facing northbound and observing westbound traffic. The trooper noticed a white, four-door sedan coasting and traveling much slower than the rest of traffic. As the vehicle passed his location, the trooper observed all four windows to be heavily tinted. The trooper merged onto the interstate and caught up to the vehicle. The vehicle abruptly exited at exit 364

and the trooper activated his lights. The vehicle slowed and continued exiting off the interstate. The trooper noticed that the vehicle jerk a couple of times as it exited. It eventually came to a stop on northbound SR 95. The trooper made a passenger side approach and immediately noticed the subject to have a slur in her speech. As the subject was still seated in the driver's seat, he noticed her to be restless, and make apparently uncontrolled fidgety movements that appeared to not serve a purpose.

The trooper identified the subject through her Tennessee driver's license as Melody Dawn Shaver.

The trooper had her step out of the vehicle to further investigate and he immediately noticed her staggering as she walked to the front of

his vehicle. She did agree to perform SFSTs. Melody did disclose that she has some medical issues (rods and screws in her back/legs) and that she has unequal pupil size. During HGN, the trooper had to stop and start over because she kept moving her head and leaning her head back. She also had an inability to concentrate. During the walk and turn, she had trouble maintaining her balance during the instructional phase.

At times, she was able to stand in the position without issues. She proceeded to miss heel to toe, step off line, raise her arms for balance on both sets. She also made an improper turn. During the one leg stand, she put her foot down numerous times and raised her arms for balance numerous

times. ARIDE testing was also conducted and during the modified Romberg, she had an internal clock of 17 seconds. She also swayed side to side approximately 4 inches. Lack of convergence was observed in the right eye, and she also missed every finger to nose. Due to the totality of the circumstances, the subject was arrested for DUI. After a blood draw was conducted, the rear seat of my vehicle was checked prior to the subject entering it and it was clear. Once the trooper arrived at the jail and the subject was removed from the vehicle, the trooper noticed a glass pipe with burn marks and residue that was on the floorboard between her feet. Said events occurred in Loudon County, Tennessee on a public roadway.



received at least \$1,800 in compensation by reporting 90 hours of time not worked.

Investigators determined that Samantha Stephens and Deborah Roddy conspired to individually report five days per week working in the afterschool program, when they were actually working two or three days per week by alternating days with one another.

The investigation also

found the former afterschool director inaccurately reported attendance data. The number of students reported to be attending the program did not affect the program's revenue or the former director's compensation.

Based upon this investigation, in January 2025, the Overton County Grand Jury indicted Samantha Stephens and Deborah Roddy on theft charges. These charges can be viewed in the investiga-


tive report.

"Those responsible for approving and signing timesheets should take extra steps to ensure they are accurate," said Comptroller Jason

Mumpower. "Adequate oversight is important to prevent fraud, waste, and abuse.

Nathan Pol, 42 Chatuga Way Loudon, was charged with, Domestic Assault.

Deputy Miller LCSO, responded to a 911 Hang Up call at Chatuga Way. Upon arriving at Chatuga Way, the deputy was flagged down by a male, the son of the offender, who told the deputy that there had been an assault at his house and that he was looking for his sister as she had run away. The deputy informed the other responding Deputies of the girl and asked the male to return home.

Upon arriving at the house, the deputy came into contact with 3 individuals exiting the house with their belongings. A female the offender's sister, informed the deputy that there had been a heated altercation and that she had been struck by her brother who was still in the house. The deputy was informed by the sister's adult children, that the offender's 14-year-old daughter was suicidal and that she had run away from the house.

The 3 individuals stated that the daughter had come downstairs, grabbed a kitchen knife, and announced she was going to kill herself. One of the individuals stated

she took the knife from the daughter and then Nathan Pol began spanking the victim on the buttocks and the small of the back.

When the female believed that Nathan had gone too far with his discipline of the daughter the victim attempted to stop Nathan. Nathan proceeded to punch the victim and pull her to the ground. The deputy did witness a distinct laceration on the victim nose that was consistent with this statement. The male then began striking Nathan in the back of the head in defense of the victim.

Her version of events was consistent with the three individuals version of events. Due to the totality of the circumstances, Nathan was determined to be the primary aggressor. 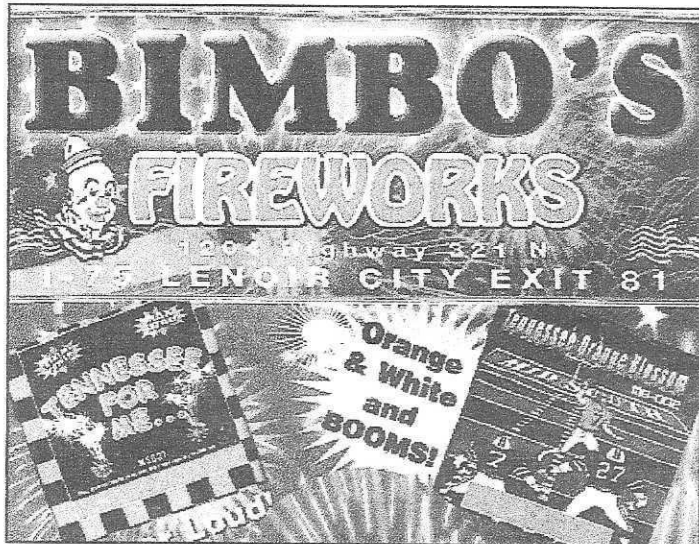

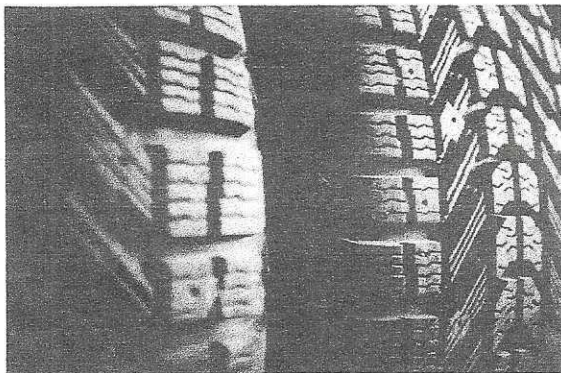
