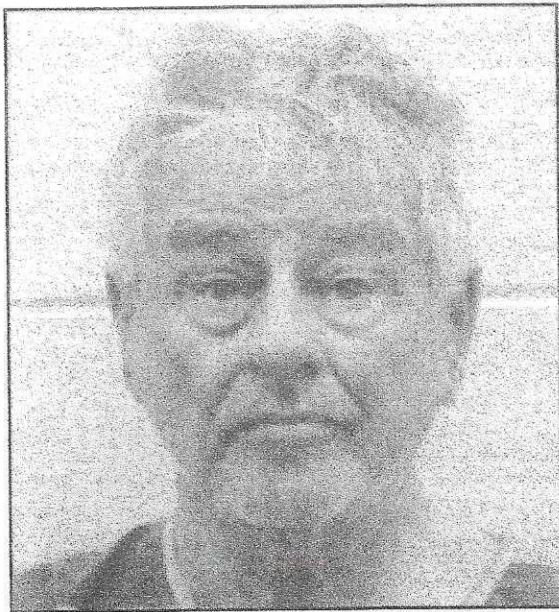

Safety Concerns Related to Fraudulent Compounding Practices Associated with Weight Loss Drugs

The Federal Bureau of Investigation (FBI) warns the public of noncompliant healthcare providers, to include pharmacies, weight loss clinics, and medical spas, engaging in fraudulent compounding practices

by unlawfully misrepresenting compounded weight loss drugs. These misrepresented drugs can pose safety risks and significant health consequences to patients, such as gastrointestinal disorders, nervous system disor-

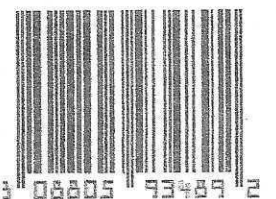

Cassandra Belcher, 26, Pennsylvania Avenue Etowah, was charged with, Theft of Property, Poss. of Drug Para., and Public Intoxication.

Joshua Hooper, 46, Pennsylvania Avenue Etowah, was charged with, Public Intoxication, and Poss. of Drug Para.

Deputy Owens LCSO, observed a male sitting in the driver seat of a vehicle at the Love's Truck Stop, and the male appeared to be nodded off or passed out at the wheel. The car was running, and the deputy was concerned that the male may have been under the influence of an intoxicant or having a medical emergency. The deputy knocked on the driver's side window, and the male woke. The deputy explained why he was making contact, and the deputy asked the driver to step out of the vehicle. The driver, identified as Joshua Hooper, immediately stated he was tired. Joshua was hesitant about stepping out of the car, so the deputy explained that he wanted to make sure he was not under the influence and able to operate the motor vehicle. Joshua stepped out of the car. A check of Joshua's identification revealed his driving status to be revoked. While talking to Joshua, he seemed to be nodding off while leaning against his car. The deputy asked Joshua if anything illegal was in the vehicle, and he said there was nothing illegal in-

side. The deputy asked if he could search the car, and Joshua denied consent to search the vehicle. The deputy asked Joshua if a K-9 would alert on his vehicle, and he was adamant about not letting me or a K-9 search the car. Joshua then came clean and said there may have been some paraphernalia in the vehicle. As the deputy was speaking to Joshua, a woman exited the store and walked over to the car. The deputy explained why he was making contact with Joshua, and the deputy identified her as Cassandra Belcher. The deputy asked Cassandra if there were anything illegal inside the car, and she admitted there may be foil inside the car that contained heroin. A search of the vehicle revealed multiple glass pipes that were used to smoke heroin and cut straws that were used to snort heroin. Cassandra admitted to using those items for that purpose. Tubes that were used to smoke heroin and a scale were also located inside the car. Cassandra and Joshua admitted to using heroin earlier in the day, and it is believed they both used while at the store as both seemed to dose off while sitting on the patrol car. The paraphernalia was taken and placed into evidence at the Sheriff's Office. After placing the two under arrest, Cassandra admitted to Officer Valletto that she had stolen knives from the store. Four knives were stolen, totaling \$59.09. Cassandra and Joshua were transported to the Loudon County Jail without incident.

Charged

Aastra Fielder, 37, Homeless, Chicago, was charged with, Mfg/Del/Sale or Poss. of Meth, and Poss. of Drug Para.,

Officer J. Green LCPD, was traveling northbound on US Highway 321 N when he observed a grey Honda Odyssey failing to maintain its lane in the far-right lane of travel. The officer observed the vehicle with his dash camera on and continued to see the failure to maintain the lane. The officer then initiated a traffic stop on the vehicle at Verizon on Highway 321. During initial encounter the officer spoke with the (Driver) and Aastra Fielder (Passenger) about the failure to maintain the lane and the driver stated that he was having some trouble seeing out of his left eye, but everything was fine. While speaking with the occupants the officer could smell the odor of marijuana emitting from the vehicle. Officer C. Fine arrived on scene, spoke with the occupants, and stated he could smell the marijuana. On our second approach to the vehicle, the officer asked the driver if he had any

marijuana in the car and he stated "no, but I do smoke it inside the vehicle". The officer then asked the driver and Ms. Fielder to step out of the vehicle for a probable cause search to which they both complied. While searching the vehicle the officer located a grey and pink backpack in the passenger seat floorboard along with a pouch on a key chain. The officer opened the pouch and located two pipes with residue, 1.9 grams of meth in one baggie, 0.5 grams of meth in another baggie, 0.4 grams of heroin, and three cut straws with residue. Inside of the backpack the officer located another glass pipe with residue, but it was broken.

The officer then asked who the narcotics and paraphernalia belonged to, and Ms. Fielder stated that it was all hers and the driver had nothing to do with any of it. Ms. Fielder was placed into custody and transported to the Loudon County Jail, the meth was sent to evidence along with the straws and pipes and the heroin was sent for destruction. All the above did occur in Loudon County, Tennessee without further incident.

Deputy Parks LCSO, was dispatched to Pond Creek Rd. (Marathon) in reference to a drunk driver. Monroe County Dispatch had advised a subject had urinated in the Sweetwater Weigels parking lot and then left and was believed to be under the influence. The deputy located the red Ford Escape parked unoccupied in the parking lot of the Marathon. Mr. David Griffith exited the store and was returning to the vehicle when the deputy made contact with him. Mr. Griffith appeared unsteady on his feet and lethargic. 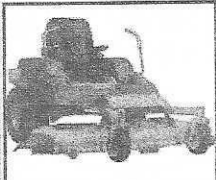

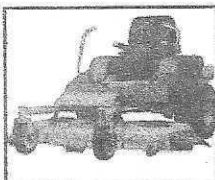

ders, cardiac disorders, psychiatric disorders, and death.

Noncompliant healthcare providers are selling fraudulently compounded drugs claiming to contain semaglutide, the active ingredient in Ozempic and Wegovy, in combination with other ingredients. Some healthcare providers are using compounded mixtures of unknown drugs that do not contain semaglutide, drugs with high levels of impurities, and unsafe or unapproved drugs.

Healthcare professionals

at medical spas, pharmacies and weight loss centers in multiple states sold fraudulently compounded semaglutide drugs. Testing of the compounded drugs revealed some of the misrepresented compounds did not contain semaglutide and had large percentages of unknown drug impurities.

A southern-based medical spa and weight loss clinic offered and sold their own weight loss medication, which was compounded in Georgia. The compounded mixture had an "animal grade" semaglutide with vi-

tamin B12, which is incompliant with FDA regulations.

A Southeastern state issued an Order of Summary Suspension1 to an identified pharmacy due to alleged patient safety concerns. The pharmacy filled more than 1,000 prescriptions daily and employed many pharmacists and technicians with little to no pharmacy work experience. In the first seven months of 2023, the pharmacy generated millions of dollars by selling fraudulently compounded and generic versions of high dosages of semaglutide combined with

vitamin B6 to healthcare providers.

TIPS TO PROTECT YOURSELF

Avoid suspiciously low prices of weight loss drugs sold by unlicensed healthcare providers.

Be cautious when purchasing any pharmaceutical drugs online and buy only from licensed pharmacies.

Consult with your medical provider before using any pharmaceutical weight loss drugs.

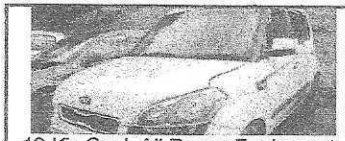

way. Deputies checked the area but did not find anyone walking on the interstate. Later, at approximately 2321 hours, the communications center received two more reports that the same man was running into traffic in the same area.

The callers said the man was standing in the lane with his arms spread open and that he ran at a car and punched the window as it passed.

Upon arrival at the area, the deputy witnessed a man

standing on the median side of I-40 right before the I-75 split. When the man saw deputies, he turned and attempted to walk away. The deputy ordered the man to stop multiple times before he complied with his request. When the man stopped, the deputy detained him using handcuffs for his safety, deputy safety, and the safety of motorists passing through the area.

The deputy identified the man as Mr. Charles Kirkland, who was sweating profusely, making incoherent state-

ments, chewing his tongue, and moving erratically. The deputy asked Mr. Kirkland if he had consumed anything illegal, which he denied. He said he had been on the interstate for more than a day after an unidentified man was giving him a ride and attempted to rape him.

Mr. Kirkland's actions were consistent with someone under the influence of methamphetamine. Due to his intoxicated state, Mr. Kirkland posed an imminent danger to himself and others while also unreasonably annoying those in the vicinity.
