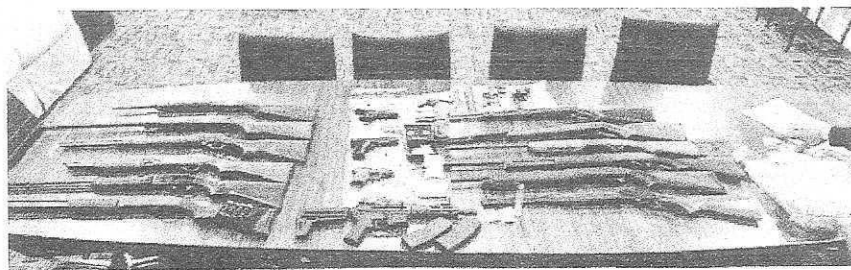

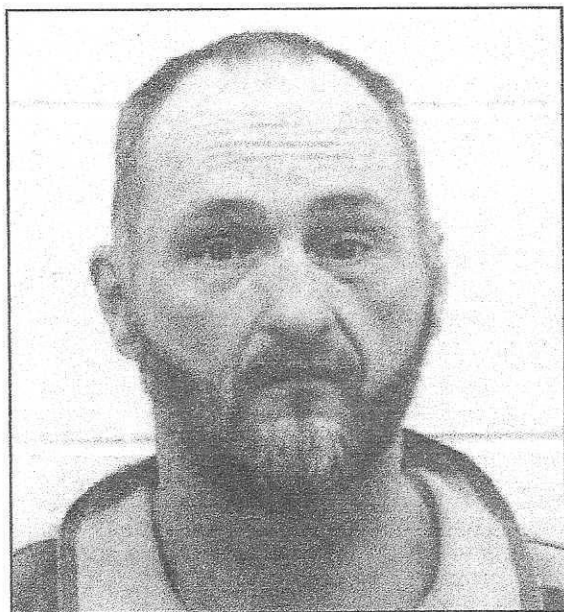
## UPDATE: DRUG TASK FORCE SEARCHES PROPERTY OFF OF BEALS CHAPEL ROAD – Finds Guns, Illegal Drugs, and Makes Six Felony Arrests



On Monday morning (March 3rd), a joint effort between the 9th Judicial Drug Task Force (JDTF), Loudon County Sheriff's Office, and Blount County Sheriff's SWAT successfully shut down a major drug operation at 14420

Beals Chapel Road, property belonging to Mike Brown. This location has been a hub of criminal activity for several years, with frequent law enforcement calls, sustained drug use, and a suspected haven for stolen property. **see Raid pg. 2**

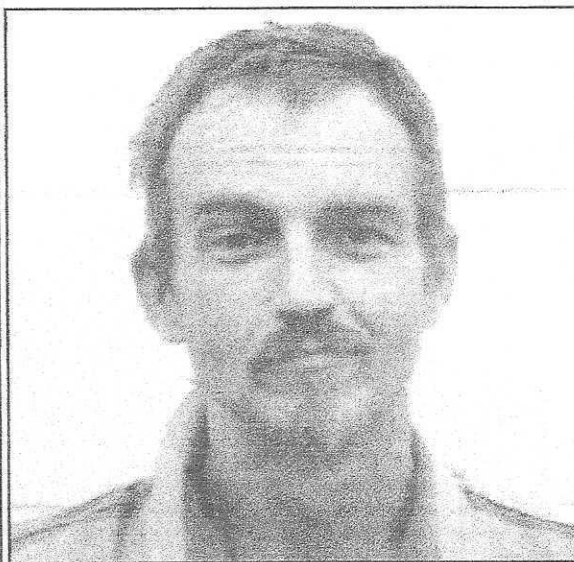

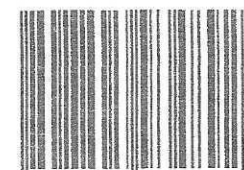

Using standard narcotics investigation tactics, Agent Fritts and other DTF agents gathered information to obtain a search warrant for the suspect property and, in a coordinated effort, the SWAT teams from Loudon and Blount County provided the necessary support to safely execute the search warrant. Upon entry, law enforcement encountered eight individuals and uncovered an assortment of illegal items: over 100 grams of methamphetamine, 20 firearms, Fen-tanyl, cocaine, oxycodone, psychedelic mushrooms, marijuana, and various prescription pills. Six individuals were arrested on felony

drug charges, with additional charges related to firearms, especially considering the criminal backgrounds of several suspects.

The DTF Deputy Director Brendan Deboer stated that, "This operation is a huge win for the community, which has suffered from the ongoing decline in the area caused by this criminal activity." Deboer applauded that work and professionalism of Agent Fritts and the other DTF agents, as well as the assistance and cooperation of the Loudon County and Blount County Sheriff's Offices.

The individuals arrested were: Michael Brown, Jennifer Helton, Daniel Queen-er, Cheryl Stockton, Michael Nalls and David Hensley.

Jamey Bookout, 43, Jackson Ferry Road Greenback, was charged with Domestic Assault, and Interfere with Emergency Call.

Officers responded to the Inn of Lenoir, regarding the complainant stating that her neighbor, came to her, asking her to call 911 because she had been beaten up. After making contact with the complainant, Officers then made contact with the victim who stated to officers that her husband, (Jamey Bookout), and her were in a verbal argument when he shoved her to the floor. She then stated that she got back up and got her phone out, saying she was going to call the police, in which Jamey grabbed her by the arm and shoved her chest again, causing her to fall to the floor again, and then took her phone from her hand and threw it somewhere in the apartment. Contact was made with Jamey who denied all the above and stated that nothing was going on between them and no physical altercation occurred. Their 5-year-old son was in the residence during the incident and stated to officers that his daddy shoved his mom to the ground and threw her phone. The victim did have red markings on her left arm and chest area that were visible to officers upon inspection of injuries. Adrian Patton, 44, Bird Road Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, Simple Possession, and Driving while in Possession of Meth.

Deputy Watson LCSO, observed a blue pickup truck traveling on Highway 70 without registration lights. The deputy attempted to stop the vehicle at the intersection of Highway 70 and Brandywine Drive. The deputy activated his emergency lights prior to the vehicle turning right onto Brandywine Drive but the vehicle continued at a slow speed several hundred feet down Brandywine Drive. The deputy activated his siren and the vehicle stopped in front of Brandywine Drive. The deputy made contact with Adrian Patton

(Offender/Arrestee) in the driver's seat of the vehicle. The deputy asked Mr. Patton why he continued to drive after his emergency equipment had been activated and he responded that he was attempting to find a well-lit area. However, Mr. Patton passed two streetlights that illuminated the area. While speaking with Mr. Patton, the deputy determined that he could not provide proof of insurance and that the vehicle was unregistered. The deputy wrote Mr. Patton a citation for each offense and advised him that due to the infractions the deputy would be towing his vehicle. While completing an inventory of the inside of the vehicle for valuable items, Sgt. Pesterfield discovered two baggies of what is believed to be narcotics in the passenger

side floorboard. The deputy placed Mr. Patton into custody without incident. Mr. Patton was transported to the Loudon County Jail without incident.

The deputy weighed the two substances and found that Mr. Patton was in possession of 30.70 grams of what is believed to be meth-

amphetamine and 3.00 grams of what is believed to be heroin/Fentanyl. Mr. Patton was operating a motor vehicle with over 5 grams of the crystal-like substance. The items were placed into the drug box. The vehicle was towed from the scene by Money-makers. This did occur in Loudon County, TN.

3.7%, while December's rate was revised to 3.7%.

In a year-to-year comparison, statewide unemployment for January went from 3.2% to 3.7%.

Tennessee continued to outperform the U.S. unemployment rate in January and was three-tenths of a percentage point below the national rate of 4%. The U.S. rate

fell one-tenth of a percentage point from a month ago and is up three-tenths of a percentage point from its January 2024 rate of 3.7%.

Over the past year, Tennessee employers added 21,500 jobs. Government accounted for the biggest gains, followed by the Mining, Logging, and Construction and the Leisure and Hospitality sectors.

Between December 2024 and January 2025, total non-

farm employment in Tennessee decreased by 10,100 jobs. The largest decreases were in the Private Education and Health Services, Accommodation and Food Services, and the Transportation, Warehousing, and Utilities sectors.

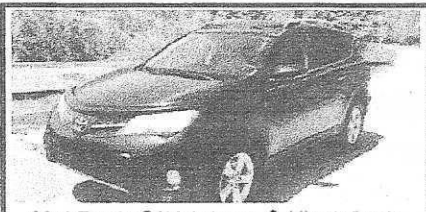

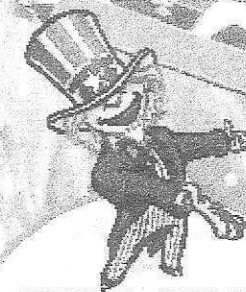

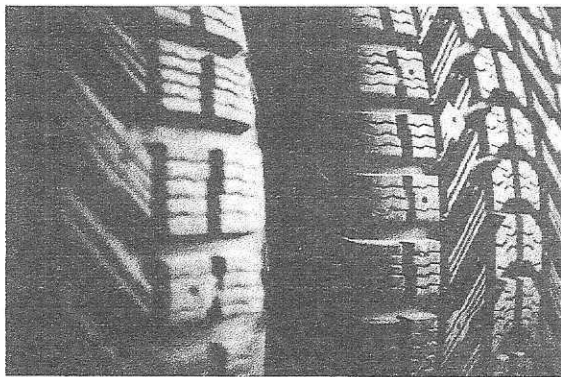
