**Loudon County Criminal Court
Grand Jury Report
April 14-15, 2008**

This is the Grand Jury report for the April 2008 term of the Criminal Court in Loudon County, Tennessee as reported by the Grand Jury on April 15, 2008.

The Grand Jury examined the following facilities and noted items in need of attention or consideration:

Loudon County Courthouse

1. Handrails are needed at the steps located on the east side (Cedar Street) of the courthouse coming up from the sidewalk.
2. Rubber treads on stairs leading to the 2nd floor are in need of repair in places. Some treads are not lying flat on the step, which has caused tripping.
3. Carpet in courtroom is worn.
4. Water leak in Public Defenders room has not been fixed, although Mrs. Niles noted that the maintenance department had been working on it.

Note: Per Mrs. Niles, incidences of individuals tripping have been reported in regard to items 1 and 2.

Loudon County Courthouse Annex

1. Noted installation of the elevator is underway.

Justice Center

1. We strongly recommend that the Security Evaluation recently completed for the Justice Center and Courthouse be reviewed and recommendations considered.
2. The Clerks office appears to have run out of space. Individual workspaces are small. The cubicle system, while providing for individual work areas, encompasses much of the floor space, allowing for only 18" to 20" of passageway in one area.

Note: Per Mrs. Niles, the invoice for these cubicles has not been paid due to incomplete installation and corrections yet to be made.

Loudon County Jail

1. Trustees Shack needs a solid ceiling installed in order to utilize the space as needed. Officer stated that the room could not be utilized as sleeping quarters due to the exposed piping in the ceiling.
