## Press Release By U.S. Attorney Relating To November 2024 General Election

The United States Attorney's Office announced today that Assistant United States Attorney (AUSA) Mac D. Heavener, III will lead the efforts of the Office in connection with the Justice Department's nationwide Election Day Program for the upcoming November 5,

2024, election. AUSA Heavener has been appointed to serve as the District Election Officer (DEO) for the Eastern District of Tennessee, and in that capacity is responsible for overseeing the Office's handling of election day complaints of voting rights concerns, threats of violence to election officials or staff, and

election fraud, in consultation with Justice Department Headquarters in Washington.

The Department of Justice has an important role in deterring and combatting discrimination and intimidation at the polls, threats of violence directed at election officials and poll

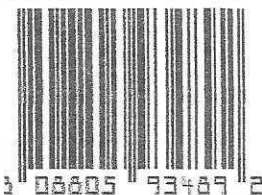

Giovanni Gonzalez, 21, Foute Town Road Lenoir City, was charged with, DUI, and Man/Sell/Del/Resale Sch. VI.

Officer Carroll LCPD, responded to the area of N C Street along with Officer Miller in reference to a possible

wreck in the area. Upon their arrival, they observed a black Mazda 3 displaying TN Tag # 135BJFR that was sitting in the driveway of that N C St address that looked like it had been involved in an accident. There was a hispanic male subject standing beside the vehicle, as well as, a witness that advised he observed the hispanic male

subject exit the driver seat of the vehicle. While speaking with the driver of the vehicle, who was identified as Giovanni Gonzalez, the officer noticed a strong odor of alcohol emitting from his person, as well as watery, bloodshot eyes. While speaking with Mr. Gonzalez, he advised that he was driving the vehicle, and that he had "about 5 beers." Mr. Gonzalez agreed to perform Standardized Field Sobriety Testing. During the Horizontal Gaze Nystagmus, Mr. Gonzalez had lack of smooth pursuit, Nystagmus while eyes were at Maximum Deviation, and Onset Nystagmus prior to 45 degrees. During the Walk and Turn, Mr. Gonzalez started the test before being instructed to

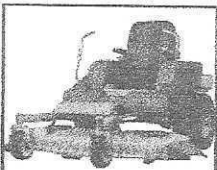
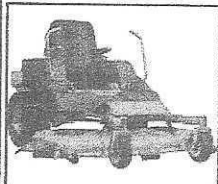

workers, and election fraud. The Department will address these violations wherever they occur. The Department's longstanding Election Day Program furthers these goals and also seeks to ensure public confidence in the electoral process by providing local points of contact within the Department for the public to report possible federal election law violations.

Federal law protects against such crimes as threatening violence against election officials or staff, intimidating or bribing voters, buying and selling votes, impersonating voters, altering vote tallies, stuffing ballot boxes, and marking ballots for voters against their wishes or without their input. It also con-

tains special protections for the rights of voters, and provides that they can vote free from interference, including intimidation, and other acts designed to prevent or discourage people from voting or voting for the candidate of their choice. The Voting Rights Act protects the right of voters to mark their own ballot or to be assisted by a person of their choice (where voters need assistance because of disability or inability to read or write in English).

In addition, the FBI will have special agents available in each field office and resident agency throughout the country to receive allegations of election fraud and other election abuses on election day. The local FBI field office can be reached by the

public at (865) 544-0751.

"Every citizen must be able to vote without interference or discrimination and to have that vote counted in a fair and free election," said United States Attorney Francis M. Hamilton III. "Similarly, election officials and staff must be able to serve without being subject to unlawful threats of violence. The Department of Justice will always work tirelessly to protect the integrity of the election process. AUSA/DEO Mac Heavener

will be on duty in this District while the polls are open. He can be reached by the public at the following telephone numbers: (423) 823-5009 or (423) 218-6652."

Please note, however, in the case of a crime of violence or intimidation, please call 911 immediately and before contacting federal authorities. State and local police have primary jurisdiction over polling places, and almost always have faster reaction capacity in an emergency.

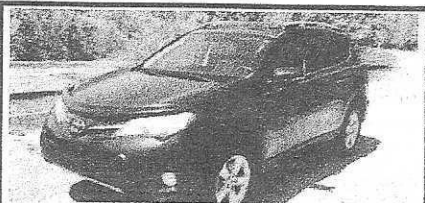
