The United States Attorney's Office announced today that Assistant United States Attorney (AUSA) Mac D. Heavener, III will lead the efforts of the Office in connection with the Justice Department's nationwide Election Day Program for the upcoming November 5, 2024, election. AUSA Heavener has been appointed

to serve as the District Election Officer (DEO) for the Eastern District of Tennessee, and in that capacity is responsible for overseeing the Office's handling of election day complaints of voting rights concerns, threats of violence to election officials or staff, and election fraud, in consultation with Justice Department Headquarters in Washington. The Department of

Justice has an important role in deterring and combatting discrimination and intimidation at the polls, threats of violence directed at election officials and poll workers, and election fraud. The Department will address these violations wherever they occur. The Department's longstanding

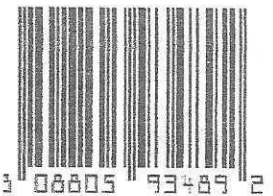

### Agg. Assault

Tatyana Belous, 35, Devyn Lane Lenoir City, was charged with, Aggravated Assault, and Resisting Arrest.

Deputy Watson LCO, responded to Devyn Lane in reference to a traumatic injury. Upon arrival, the deputy made contact with Deputy C. Bowen (Complainant) who is a neighbor of the residence mentioned above. Deputy Bowen stated that Tatyana Belous (Offender/Arrestee) came out of Devyn Lane yelling about her husband, (Victim) hitting his head. Deputy Bowen stated that once he made it over to the

residence, he noticed that the incident seemed suspicious so he contacted dispatch and requested law enforcement to respond.

Deputy Bowen entered the residence and observed priority medics giving medical attention to a white male with a large laceration on his head. The deputy observed a large puddle of blood on the floor along with pieces of a pot that shattered. The deputy attempted to speak with the victim, however, he appeared to be groggy and suffering from a head injury. The deputy attempted to speak with Tatyana and she kept walking away from him. Tatyana made the follow-

ing summarized statements about the incident; the victim had brought a bottle upstairs for one of the children and upon returning to the bottom of the steps, Tatyana was tripped by a child and dropped a pot containing dirt and a plant from the second story and striking the victim in the head.

Due to the distance that the pot had been thrown and the domestic history that was made known to the deputy while investigating, the deputy contacted Detective S. Mills and made him aware of the incident. Detective Mills arrived on scene and began processing the scene. Detective Mills and Bowen concluded that it was highly unlikely that the pot could travel the distance it did by accident and strike the victim.

While investigating, the victim had been transported to Tenova Turkey Creek for further medical treatment. Cpl. Dishner responded to the hospital and made contact with the victim, who stated that Tatyana had become irate at him for closing the bedroom door of one of the children and that they were in a verbal altercation

when he was hit in the head while walking away. Due to the evidence and testimonies, the deputy determined that Ms. Tatyana Belous had committed the offense of aggravated domestic assault. While attempting to make arrangements for the children to be supervised by a trusted neighbor, Tatyana refused to place her 5-month-old into the bed and Deputy Phegley had to carefully remove the child from the arms of Tatyana while the deputy escorted her out of the bedroom. Tatyana started resisting and screaming for her other children at this time and was placed into custody after a short struggle. The deputy escorted Tatyana out of the residence while she continued to resist and scream for her neighbors. Tatyana was secured in the deputy patrol vehicle and transported to the Loudon County Jail. Detective Mills completed a DCS referral (1489851252) due to the kids being present during this incident. Tatyana was not cooperative in order for Deputies to gather the children's information and the victim was still in the care of the hospital. This did occur in Loudon County, TN.

## Burglary

Hector Domingo-Sales, 30, Connor Lane Lenoir City, was charged with, Public Intoxication, and Burglary.

Officer Garren LCPD, was dispatched to a call for a suspicious person at West 7th Ave. Upon arrival, the officer witnessed a hispanic male, later identified as Hector Domingo-Sales, in the driveway with the witness/victim.

Hector was immediately detained by Officers until further investigation could be completed. Officer Sparks and Lieutenant Butler spoke with the victim about the incident. The victim, a resident of the listed address, stated that him and his partner/victim 2, were inside the house, when they suddenly heard a loud noise coming from the driveway around 2:30am.

Victim 1 said that once he made it outside to investigate the noise, he witnessed Hector opening and closing the driver side door to a gray, 2012 BMW X5 that was parked in the carport of their residence. The BMW X5, bearing TN Registration 504BJFR, belonged to victim 2, and they

advised the car was parked unlocked in the carport, but did not have the key fob inside of it so it was unable to be started. Victim 1 told the Officers that he approached the vehicle to ask Hector what he was doing and immediately called 911. Victim 1 stated he saw Hector in the Drivers seat, trying to press the push start button of the vehicle and start the car. Victim 1 believed that Hector had entered the vehicle with the intent to steal it, because he did not have the effective consent from the property owner to occupy the car. When asked by Officers what he was doing at the above address, Hector could not seem to provide any information about his whereabouts and what he was doing at victim 1 residence. Based on the statement from victim 1 and the lack of effective consent from the property owner, along with the observation of the Officers on scene, Hector was then placed under arrest for Burglary and Public Intoxication. This incident did occur within Loudon County, Tennessee







**Local District Attorney General named the 2024 Pat McCutchen Honoree**

The Tennessee District Attorneys General Conference (TNDAGC) has awarded District Attorney General Russell Johnson its highest honor – the Pat McCutchen Award.

“The Pat McCutchen Award is presented to an individual who best exemplifies the goals and ideals of the Tennessee District Attorneys General Conference and their efforts to improve the quality of justice for all Tennesseans,” explained TNDAGC Executive Director and past Pat McCutchen awardee Stephen D. Crump. “Gen. Johnson couldn’t be more deserving of this recognition.”

The Pat McCutchen Award was first established in 2000 in honor of the late Conference Executive Director and District Attorney General for the 19th Judicial District. The award is presented annually at the TNDAGC’s three-day fall training conference. Last year’s

recipient, District Attorney Gen. Dave Clark of the 7th Judicial district presented Gen. Johnson with the award. During the ceremony, Gen. Clark said Gen. Johnson was a “true Tennessee statesman,” who has “committed his life to public service.”


Gen. Johnson serves as the District Attorney General for the 9th Judicial District – Loudon, Meigs, Morgan, and Roane Counties. He was first elected in 2006 and has since been elected to two more terms. Prior to his service as DA, Johnson served in the Tennessee House of Representatives for three terms. In FY22, he served as the President of the TNDAGC Executive Committee.



**Election**

Election Day Program furthers these goals and also seeks to ensure public confidence in the electoral process by providing local points of contact within the Department for the public to report possible federal election law violations.

Federal law protects against such crimes as threatening violence against election officials or staff, intimidating or bribing voters, buying and selling votes, impersonating voters, altering vote tallies, stuffing ballot boxes, and marking ballots for voters against their wishes or without their input. It also contains special protections for the rights of voters, and provides that they can vote free from interference, including intimidation, and other acts designed to prevent or discourage people from voting or voting for the candidate

of their choice. The Voting Rights Act protects the right of voters to mark their own ballot or to be assisted by a person of their choice (where voters need assistance because of disability or inability to read or write in English).

In addition, the FBI will have special agents available in each field office and resident agency throughout the country to receive allegations of election fraud and other election abuses on election day. The local FBI field office can be reached by the public at (865) 544-0751.

“Every citizen must be able to vote without interference or discrimination and to have that vote counted in a fair and free election,” said United States Attorney Francis M. Hamilton III. “Similarly, election officials and staff must be able to serve without being subject to un-

lawful threats of violence. The Department of Justice will always work tirelessly to protect the integrity of the election process. AUSA/DEO Mac Heavener will be on duty in this District while the polls are open. He can be reached by the public at the following telephone numbers: (423) 823-5009 or (423) 218-6652.”

Please note, however, in the case of a crime of violence or intimidation, please call 911 immediately and before contacting federal

authorities. State and local police have primary jurisdiction over polling places, and almost always have faster reaction capacity in an emergency.
