## Former Employee Indicted for Theft from Kingsport's Bays Mountain Park

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Mark Kilgore, the former Program Coordinator for the City of Kingsport's Bays Mountain Park & Planetarium (BMPP).

The investigation began after City of Kingsport officials reported questionable transactions to the Comptroller's Office.

Kilgore, who was responsible for BMPP finances, misappropriated at least \$31,370 in cash from parking fees collected by BMPP employees.

Investigators determined that Kilgore altered cash collection totals on daily gate house deposit sheets and removed the cash before it was deposited. Kilgore concealed these alterations by voiding cash receipts in the

city's receipt system, predominantly using other employees' access information. This allowed deposits to match receipt system daily collection totals.

Additionally, investigators identified other questionable voided receipts totaling \$19,250. Due to a lack of documentation supporting voided receipts and manage-

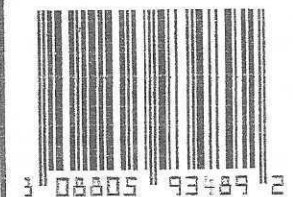

Loudon City Police was dispatched to the address of Carding Machine Rd - Big Red Car Wash, owner of the car was (complainant) stated to our central dispatch a vehicle sitting on the property for over an hour, Tan Nissan Altima Tag of 862BNWN. Officer Luna upon arriving on scene, and observed a vehicle matching the description, sitting next to a

vacuum station, running with the lights on.

Officer Luna was approached by the complainant stating the female driver hasn't moved. Officer Luna approach the vehicle observing a female sitting on the driver seat, the officer attempted to make contact with the driver knocking on the driver's window several times with the officer hand and flashlight, she appear to be asleep. Vehicle was running with lights on and key were seen in the ignition.

After several attempts

female woke up and roll down her window. Female later identify as Erica McCloud.

Upon interaction, the officer notice several signs if impairment, which lead the officer to believe Erica was under the influence of alcohol. An strong odor of alcohol and two alcoholic beverages were observed in the cup holders, two small bottles of 99 Proof - 49.5% Alc./Vol., according to the label on them, on of them was empty the other one was more than half empty, plus an additional 4 full bottles of the

same brand inside a plastic bag.

Given the aforementioned signs of impairment, the officer asked Erica to step out of the vehicle and she was asked to perform standardized field sobriety test.

The test included the Horizontal Gaze Nystagmus (HGN), Walk and Turn, and One Leg Stand tests, all of which Erica McCloud did not perform satisfactorily. Erica was placed under arrest and transported to the Loudon County Jail.

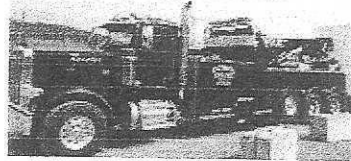

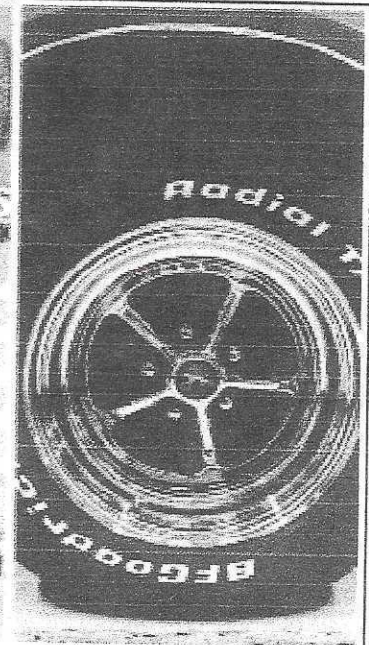

Tamara Gardner, 40, Pillar Court Virginia, was charged with DUI.

THP. H. Singh THP, was on the right shoulder of westbound Interstate 40 observing westbound traffic. The trooper noticed a white compact utility vehicle traveling at a low rate of speed in the right lane. The trooper estimated the speed to be approximately 45 MPH and verified it to be 46 MPH with his rear antenna of radar unit. Another SUV passed the location and attempted to get his attention about said vehicle. The trooper merged into traffic and observed the white utility vehicle's driving. The trooper noticed it was swerving in its lane and failed to maintain its lane. The trooper activated his emergency lights, and the vehicle was slow to stop. At one point, the vehicle was on the right shoulder and nearly ran into the guardrail. The vehicle finally came to a stop. The trooper observed the driver to have slurred speech and bloodshot/watery eyes. There was an obvious odor of alcohol on her breath. The trooper had her step out of the vehicle and observed an open Mike's Hard Lemonade

can on the floor between the driver's seat and driver's door. The defendant had urinated on herself and had soiled clothing. She was also unsteady exiting the vehicle. The trooper identified her through her Virginia license as Tamara Lavon Gardner. The trooper asked her how much she had to drink, and she stated just one Mike's Hard. She also stated that she was heading home to Virginia Beach and initially thought she was still in Virginia. She agreed to perform SFSTs. The trooper observed lack of smooth pursuit along with distinct and sustained nystagmus at maximum deviation. The defendant moved her head throughout the test and had trouble focusing on the stimulus. The trooper also observed her to be sway during HGN. During the walk and turn, the defendant lost balance during the instructional phase. She missed heel to toe and stepped off line numerous times on both sets. She also made an improper turn. During the one leg stand, the defendant put her foot down numerous times, raised her arms for balance, and even used the front of his vehicle to balance herself. Gardner was placed under arrest.

Jessica Houghton, 43, Robinson Circle Lenoir City, was charged with Violation of Probation.



ment oversight, investigators were unable to determine if these voided receipts were for authorized and appropriate purposes.

Mark Kilgore's employment with the City of Kingsport was terminated on February 23, 2022.

Based upon this investigation, in October 2024, the Sullivan County Grand Jury indicted Mark Kilgore for one count of theft of \$10,000 or more, one count of violation of the Tennessee Personal and Commercial Computer Act of 2003, and one count of identity theft.

"City officials should ensure they provide oversight to the people responsible for preparing deposits," said Comptroller Mumpower. "Kilgore was responsible for preparing daily deposits, reconciling collection records, and receipting funds. Allowing one person to

have exclusive control over all financial duties increases the risk of fraud, waste, or abuse."

**Three Indicted in Knox County for Theft from Emergency Rental Assistance Program**

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of three people after investigators determined they misappropriated funds from the Knox County Emergency Rental Assistance Program. The program allows county residents who were negatively affected by the pandemic to receive rental and utility payment assistance.

The investigation began after Knox County officials reported questionable transactions to the Comptroller's Office.

Investigators determined that Amanda McKay, who worked for Knox County Grants and Community Development, misappropriated program funds totaling at least \$79,679. McKay used false client information to have rental and utility payments sent to herself and her former husband.

Investigators also questioned another \$9,073.24 that Amanda McKay received from the program. The funds were not authorized through the normal approval and payment process.

Additionally, Jennifer Harper, who worked for the Knoxville-Knox County Community Action Committee (KCCAC), and her husband, James Harper, misappropriated program funds totaling at least \$12,800. Investigators believe they used a false rental agreement to

apply for and receive rental assistance.

Based upon this investigation, in November 2024, the Knox County Grand Jury indicted Amanda McKay, Jennifer Harper, and James Harper on a variety of charges including theft. The full list of charges can be viewed in the Comptroller's investigative report.

"Knox County and Knoxville-Knox County Community Action Committee officials should take steps to ensure their oversight and internal control systems are effective to prevent misappropriation," said Comptroller Mumpower. "I'm pleased to note the deficiencies that contributed to these acts are already being corrected."
