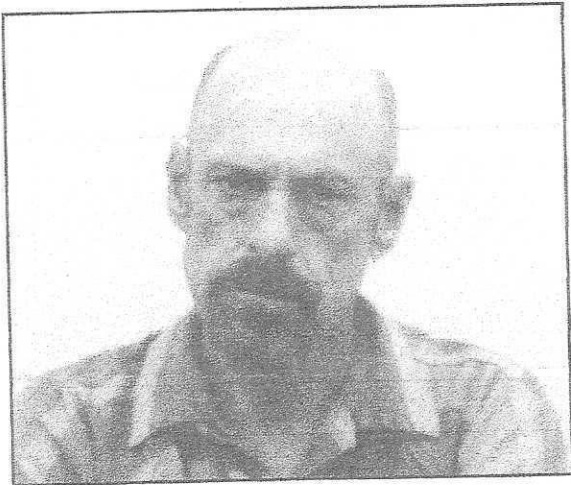

## Pain Clinic Owners Sentenced For Role In Operating Pill Mills In Tennessee And Florida

Clyde Christopher Tipton, 63, of Tazewell, Tennessee, was sentenced to 50 months in prison by the Honorable Thomas A. Varlan, United States District Judge for the United States District Court for the Eastern District of Tennessee at Knoxville. Tipton was the final defendant to be sentenced in a sprawling pill mill case that resulted in

the federal criminal convictions of approximately 140 defendants. Following his incarceration, Tipton will be on supervised release for 3 years.

As part of the plea agreement filed with the court, Tipton pleaded guilty to three counts in the superseding indictment: one count of conspiracy to launder money in violation of 18 § U.S.C. 1956(h), and two counts of con-

spiracy to defraud the United States and pay healthcare kickbacks in violation of 18 U.S.C. § 371. In February 2020, four co-defendants were found guilty at trial for their roles in operating or using pill mills to distribute opioids: Sylvia Hofstetter, 60, of Miami, Florida, Cynthia Clemons, 52, Court-

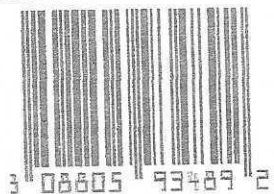
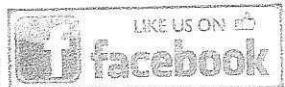

### Agg. Assault

Mario Gonzalez, 58, West Lee Highway Philadelphia, was charged with Aggravated Assault x3.

Deputy Brockwell LCSO, arrived at Highway 11 West, Sunrise Motel, for an armed person call. Dispatch notified the deputy that the offender, Mario Gonzalez, was threatening to kill people and walked toward the complainant with a knife. When the deputy arrived on the scene, the complainants waved the deputy down and said the male was sitting down holding the weapon in front of room #7. The deputy observed Gonzalez sitting in a chair in front of the room holding an object in his right

hand. The deputy drew his department-issued firearm and had Gonzalez at gunpoint. The deputy gave Gonzalez multiple verbal commands to drop the weapon which he obeyed. The deputy then detained Gonzalez by handcuffing him to further the investigation. The deputy then retrieved the item Gonzalez had in his possession, and it was an edged blade attached to a wooden handle approximately 4 feet long. The deputy spoke with the complainants, who were the victims. The victims were identified. They stated that they were outside playing cards and Gonzalez was talking out loud to himself threatening to kill people and sharpening a knife. They then stated that Gonzalez got up

holding the weapon and asked if they wanted to fight. That is when they all went inside and called 911 because they were in fear for their life. The deputy then spoke with Gonzalez, who had a strong odor of an alcoholic beverage coming from his person, about the incident that occurred. He refused to give any information. The deputy placed Gon-

zalez under arrest for 3 counts of Aggravated assault and Cpl. Wallen transported him to the Loudon County Detention Facility without further incident. A witness statement form was completed by two of the victims about the events that occurred. The weapon was seized and placed into evidence. This did happen in Loudon County, TN.

James Greene, 65, Hidden Valley Circle NC. was charged with, Mfg/Del/Sale or Poss. of Meth, Poss. of Drug Para., DUI, and Violation of Implied Consent.

Deputy Brockwell LCSO, arrived for a suspicious person at Watt Road (TA Truck Stop). Dispatched informed the deputy that a newer model Ford F150 was harassing the truckers by honking their horn and yelling at them. When the deputy arrived on the scene, he observed the described vehicle driving without lights on and exited the TA Truck stop pulling onto Watt Road. The vehicle then took a right into the BP gas station without using its blinker. The deputy initiated a traffic stop and came in contact with the driver, James Greene, and asked for



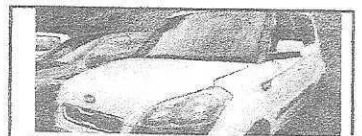

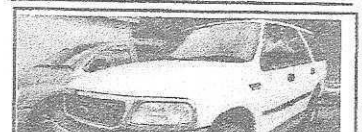

**Pill Mills**

ney Newman, 48, and Holli Womack, 51, all of Knoxville. Three other co-defendants, Luigi "Jimmy" Palma, 61, of Miami, Florida, Luca Sartini, 64, also of Miami, Florida, and Benjamin Rodriguez, 49, of Delray, Florida, have previously pleaded guilty to various counts of the superseding indictment and been sentenced for their roles in operating pill mills in Tennessee and Florida.

Tipton's filed plea agree-

ment, as well as the evidence presented at trial against Hofstetter, Clemons, Newman, and Womack, established that the pill mills owned and operated by Tipton and various co-defendants distributed over 11 million tablets of oxycodone, oxymorphone, and morphine that generated over \$21 million in revenue, with a corresponding street value of \$360 million. The conspiracy involved four separate clinics in or near Knoxville, Tennessee, each of which was a pill mill. A

pill mill owned by Sartini, Palma, and Rodriguez, operating in Hollywood, Florida, gave rise to the Tennessee pill mills. The stipulations and evidence demonstrated that, as law enforcement shut down hundreds of pill mills in South Florida, the Florida co-defendants planned the move to East Tennessee where a large percentage of these clinics' opioid-addicted customers lived. The three tabbed Hofstetter to run the Tennessee pill mills. She and Tipton later opened compet-

ing pill mills in Knoxville.

Palma and Sartini were sentenced on December 14, 2023, to 120 and 130 months in prison, respectively. Rodriguez was sentenced on January 22, 2024, to 65 months in prison.

U.S. Attorney Francis M. Hamilton III of the Eastern District of Tennessee and Special Agent in Charge Joseph E. Carrico of the Federal Bureau of Investigation (FBI) made the announcement.

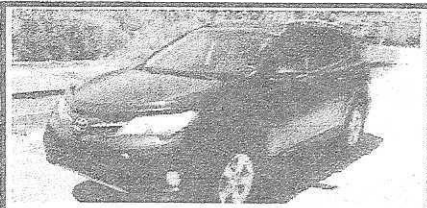

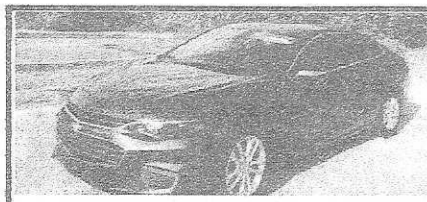

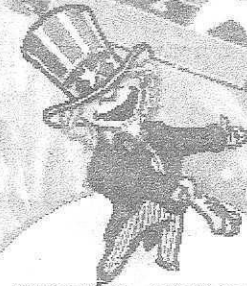
